COKE OIL PRODUCTION TO EXCEED HALF MILLION BBLS. THIS MONTH

Coke County will produce more than a half million barrels of oil Curtis Walker Buys during October. Records in the office of Sun Pipeline department at Local Hdwe. Store Silver indicate that firm alone will handle 483,000 barrels this month. That does not include production in the east half of the county, including the Bronte and Ft. Chadbourne fields.

All the 483,000 barrels mentioned above will come from Coke county wells, except 700 barrels from the Paramore lease in Nolan county and 3,500 from the McCabe and Nail wells in Mitchell county.

Athough a large per cent of the crude is produced from Sun leases, that company also buys all the oil produced in the west half of the county and the McCutchen field east of Robert Lee.

The Millican field west of Edith will produce 74,497 barrels this month. October has 23 producing days and the allowable in the Millican field has been restored to normal since expansion of the gas plant has brought flaring under control.

The McCutchen field will produce about 18,000 barrels of oil divided as follows: Aurora Daisy McCutchen, 3,680; Union Daisy McCutchen, 9,200; Union Elizabeth McCutchen Estate, 4,64666; and Union Jim McCutchen, 46 barrels.

Sun also gathers production from the Lygay field south of the river Midland, district superintendent. at Silver and from the new producers being completed outside the Sun block west of Siver. Sun will to Silver by auto. A luncheon meetget 34 barrels of oil from the Arledge field this month. Sun has its own pipeline extending from Silver to Atlantic Pipeline station south of Bronte. However, Sun is part owner of a huge new pipeline extending from East Texas which wil be in operation the first of the year. At that time oil now going to Bronte will be pumped to connect with the new pipeline in Scurry county.

Purchase of the Robert Lee Hardware by Curtis Walker was announced this week. The business has been owned the past few months by Ray Shafer.

The stock is being invoiced and Mr. Walker planned to open up for business the middle of the week. He will make a formal announcement in next week's Observer. The business will be conducted as the Walker Hardware.

Mr. Shafer has not announced his plans for the future, but he and his wife may decide to again engage in the grocery business.

New Wells - During the twelve months ending August 31, 1952, the Texas oil industry drilled 17,000 new wells, at a cost of over \$700 million. Most of the heavy expense of drilling these new wells was paid from earnings plowed back into the development of the State's oil resources.

Transportation - The total mileage of Texas' trunk pipe lines for oil and finished products is over 29,000. This low-cost transportation system is a major factor in the maintenance of the low prices you pay for petroleum products.

products, which had transported a daily average of 722,600 barrels in the year ending August 31.

Production - Production has reached a record level. Texas currently is producing about 46 per cent of all the crude oil produced in the U.S. In the year ending August 31, Texas production totaled about 1,015 million barrels. There are now 133,800 producing oil wells in Texas.

Reserves - Proved oil reserves in Texas of 18 billion barrels represented 57 per cent of the U.S. total at the beginning of 1952. During 1951, the last year for which figures are available, proved reserves increased two billion barrels. These are developed oil reserves and the figure is important: developed reserves supply our needs currently and provide reserve capacity that is immediately available when we need it.

Refining - The Texas refineries will have a big year. They now employ, in round numbers, 46,000 Texans, and process about 28% of all the oil refined in the U. S. The daily refining capacity of all Texas refineries exceeds 2,000,000 barrels. A program to expand and improve these facilities has been general throughout the industry.

Taxes - The Texas oil industry continues to be the largest tax-payer in the State. Through the year ending August 31, gross production taxes alone on Texas oil and natural gas amounted to more than \$137 million; in addition, the industry pays large amounts in other taxes.

In brief, the Texas oil industry during the past year continued to do its part in meeting the demand for oil. It has expanded pipelines to provide low-cost transportation. It has improved facilities for making more and better petroleum products for your use. Today, two gallons of gasoline do work that required three gallons in 1925; and the gasoline costs no more than it did then.


