# TRIMBLE SUIT FOR \$325,000 IS SET ASIDE

A district court judgement for \$325,000 in favor of Jack Trimble against E. P. Dannelley has been set aside by Judge Joe L. Mayes.

The court's ruling was made following a written request filed by attorneys for both parties. Marvin C. Hanz of San Angelo represented Trimble, while the defendant's counsel was D. L. Case of Dallas.

# ROBERT LEE MAN VICTIM OF FIRE

A verdict of "accidental death by suffocation" was returned by Justice of the Peace J. B. Holbery in the death at San Anglo early Saturday of Leonard E. Meredith, 51, former Robert Lee resident.

Meredith's burned body was found in a cabin at Willard Courts, 8 E. 30th St., in San Angelo, following a fire which destroyed the structure about 1:30 a. m. Saturday.

Holbery theorized Meredith went to sleep with a lighted cigarette in his hand. His body was found about two feet from the bed, indicating that he had attempted to escape the flames, Holbery said.



## Sen. Johnson Says Tidelands Claim Goes Back to 1836

(Lyndon B. Johnson, Senior Senator from Texas, presents his personal comments on matters affecting Texas every two weeks. His news letter, mailed directly from Washington, will be a regular feature carried in this column.) Dear Folks:

Congress is getting around to the so-called tidelands issue again and we hope that this year we can finally get justice for our State.

It's hard to find an issue that has been so confused by propaganda and wild claims as this one. Sometimes it's impossible to keep all conflicting statements straight. I think that as Texans we ought to take care of this once and for all.

In the first place, the argument has nothing to do with "tidelands." The real issue is the so-called "submerged lands" under the water below the low tide mark. We Texans claim those submerged lands for a distance of ten and one-half miles (three marine leagues) out from the shore line.

That claim goes back to 1836 when Texas fought to win its independence from Mexico. Once we were an independent Republic, our legislature set our boundaries seaward at a point beginning three marine leagues from the mouth of the Sabine River.

When we decided to enter the United States nearly a decade later, we had a public debt of \$10,000,000. We offered to turn our public lands over to the United States if it would pay that debt. This offer was turned down so we reversed it and offered to pay our own debt if the United States would let us — as a state — keep our public lands.

That offer was accepted and written into the Annexation Agreement by a resolution of Congress. We paid our public debt and nothing has happened since then to change the resolution of annexation. It has never been repealed or amended by Congress.

For nearly 100 years, nobody questioned that the obvious fact that our public lands included the submerged lands ten and one-half miles out to sea. That was the position taken in one court decision after another. As late as 1945, the Interior Department took the position that the submerged lands just off the shore belonged to the states.

But about that time, some federal officials realized that there might be valuable oil in the submerged lands. They entered suit and finally got a Supreme Court decision that the Federal Government had "paramount rights" in the matter. They did not — as some people claim — get a decision that the "title" belonged to the Federal Government. The Supreme Court refused to pass upon that question.

What we are trying to do now is to get the title cleared up and the rightful ownership of Texas confirmed. It is an issue that means a lot to us. The revenues from such lands are set aside for the education of our children and they are important.

But even more important is the question of justice to Texas. There are far greater questions involved in this issue than mere money. Those lands are ours by solemn and binding agreements. Our title has been confirmed by Treaty, by Congressional resolution, and by Court decisions dating back over the years. We cannot permit them to be taken away at the last minute



We of the Texas Delegation are determined that Texas shall receive its just due. We will fight this out to the end and I believe we will win.


