## LOCAL FIRMS **LOSE \$193 ON BAD CHECKS**

A smooth operating check swindler beat Robert Lee business firms out of \$103 over the weekend. Clyde Turnbuille, 40, has been charged with the crimes and is being held by authorities at Santa Fe, New Mex.

The fellow turned up in Robert Lee Saturday, said he was an oil field driller and wanted to hire a crew. He also made reservations for an apartment at A. B. Sheppards.

He had previously been at the Bronte bank where he opened an account by depositing a draft for \$150 on a Ft. Worth bank. During his check cashing operations here he showed his deposit slip on the Bronte bank and told his story of having a drilling job.

Checks cashed in Robert Lee included \$50 at Coffey's Station, \$10 at Y-Courts, \$33 at Herry's barbecue, \$40 at Baker's Grocery and \$60 at Roach's.

Genie Baker was suspicious of the man and contacted the Bronte bank early Monday. Bank officials contacted the Ft. Worth bank and learned tht the check Turbuille had deposited was phoney. Sheriff Paul Good was notified and warrants were sworn out for the man's arrest.

The man was last seen here about 10 a. m. Sunday when he left the Coffey Station with his wife and two children. He was driving a 1948 blue 2-door Ford. Turbuille said he worked in the oil field here seven years ago, but nobody seemed to remember him.

## **HELEN WEAVER** WAS VICTIM OF

Robert Lee has been terribly shocked and deeply grieved, along with thousands of West Texans, in the tragedy which took the life of Mrs. Harry (Helen) Weaver.

She was the victim of an explosion just before 9 a. m. Wednesday near the home of her mother, Mrs. Ralph Harris, in San Angelo. Mrs. Weaver was fatally injured from the shattering explosion, apparently from a bomb in the car she was attempting to start.

She had started to Shannon hospital to visit her mother, who is a patient there. It was apparent that a high explosive bomb was set off as she turned on the ignition or starter.

Mrs. Weaver was rushed to the hospital but died within a few minutes from horrible wounds about the body. The car, a Chevrolet owned by Mr. Weaver, was demolished and effects of the blast were felt for some distance. Funeral services have been set for 2 p. m. Friday from Emmanuel Episcopal Church in San Angelo.

Mrs. Weaver, always referred to as "Helen" by her friends, was a daughter of the late Ralph Harris. The family were early ranchers in West Texas and owned a big spread south of Robert Lee. Fifteen years ago they acquired the former Saul Ranch above Robert Lee.

Helen ran cattle for many years and took a personal hand in looking after them.



It should also be remembered that Poll Taxes must be paid by the same date. If you want to vote in any elections this year, you must have a poll tax receipt and they can't be issued after Feb. 1.
