

1 TO 3 INCHES RAINFALL FOR COKE COUNTY

Coke County's longest dry spell (4 inches in the past 10 months) was broken this week with local showers which deposited as much as 3 inches of moisture in some localities. Robert Lee and Bronte gauged about 21/2 inches.

The rains started Sunday afternoon when Robert Lee received 11/2 inches and the territory to the northeast and around Bronte got as much as 2 inches.

> Sunday's storm swept in from the southwest soon after 3 o'clock. Rain was preceded by a heavy wind and swirling dust. Some small buildings were damaged and at least 16 TV antennas in Robert Lee were blown down. Roof was blown off Fred McDonald's tenant house a mile south of town, and a corrugated stock barn at the school ground was leveled. The wind was just on the verge of causing extensive damage here.

> Readers attention is directed to the SCS rain table in this issue. While 1954 moisture amounted to 14 inches, there was scarcely none to mature crops which had a good start from 101/2 inches of rain in April and May.

Sun Oil Company will get a decrease in its Coke County tax bill this year. The cut includes a 30% reduction in assessed valuation of and Mrs. L. M. Simth. Mr. Blair the Millican field west of Edith, and a 5% cut in the Jameson field at Silver.

> The agreement was reached Monday when oil men appeared at a hearing before the Coke County Commissioners Court. Present at the session were D. C. Keever and Henry Lee, Sun; Ed Bartelle, Perkins-Prothro; and R. T. Conner. Humble. Also Harry Pickett, oil and utility evaluation engineer who is hired by the county on a commission basis. Commissioner J. W. Service was chairman in the absence of Judge Jeff Dean.

> Sun has also requested a similar reduction in the Millican field on its assessment in the Robert Lee school district. School trustees and the Sun representatives held a three-hour session Monday, following the meeting at the court

> No agreement was reached, according to information received by The Observer. School officials pointed out that an estimated decrease of \$800,000 in the school's taxing valuation would deal a serious blow to successful operation of the school and retire a bond issue of \$295,000 which resulted in the recent completion of a fine new school layout.

> School trustees say Sun tax men had previously endorsed the bond issue and indicated taxing values would remain at least at the present level.

> Their new argument is that oil properties are assessed too high in comparison with ranch and farm land and other property in the

> A budget showing the amount of funds to be required to run the school during the coming year will be prepared and filed with the Sun tax office in Dallas. Another session to discuss the matter further has been set for May 30.

> At the county tax parley, Pickett announced 221 new oil wells were completed last year. He had adjusted his valuation schedule to comply with Sun's request. Pickett said he didn't know whether or not the cut was justified, but he accepted the report filed by Sun

> New wells will add 41/2 million dollars in taxing value this year, Pickett said, after allowing for the Sun cut backs. He estimated all property in Coke County this year will be assessed at more than 291/2 million dollars. All but 41/2 million of this come from oil hold-

Humble and Perkins-Prothro agreed to stand their share of the 4½ million dollar increase, after commissioners divulged plans for spending the countys' tax money. it was pointed out that \$70,000 in bonds floated during the late 30's to bolster the WPA porgram needed to be paid off, as well as almost a similar amount in outstanding machinery time warrants. Only big project to be completed by the county the coming years is the court house. An estimated \$50,000 or more in addition to the \$300,000 bond issue will be required to furnish and equip the court house.

Mr. Brown worked in the Coulson Drug store in Sterling City when he was a young man. He is remembered by many people here and was a brother of Mrs. W. M. Millican and Miss Naomi Brown. The latter has helped care for her brother the past year or more.





Organization of the Coke County Soil Conservation District Dates to 1946

The land owners went to the range conservation and erosion polls on June 10, 1946, and cast control within its boundaries. their ballots for the formation of the Coke County Soil Conservation District. Following the formation of the district on October 16, 1946, the first Board of Supervisors was organided. The original board consisted of R. B. Allen, chairman; C. N. Webb, vice chairman; W. C. Shamblin, secretary; and Bryan Yarbrough and W. E. Burns, members. Four members of the original board are still serving the land owners of the district. Guy Denman was elected for a term following Mr. Allen's desire to be released from such duties. Mr. Denman moved out of the district and Robert W. Walker was elected to fill the vacancy. Last October Mr. Walker was elected to a new five year

The objective of the district is to use each acre of land according to its capabilities and treat each acre of land to keep it permanently productive.

The area of the district is 470,-237 acres, of which 453,466 acres are devoted to agricultural production. The other 16,771 acres are taken up by towns, roads, highways and lakes.

As of May 1, 1955, 354,569 acres, or 79 per cent of the land in the district was under agreement with the local district. The 354,569 acres is included in 346 district agreements. These agreements were developed by the land owners and operators with the assistance of the Soil Conservation Ser-

Rainfall in the Coke County **Soil Conservation District**

By A. V. SHEPPARD Work Unit Conservationist

Fifteen and a half inches of annual rainfall is the amount recorded by the Soil Conservation Service at Robert Lee during the six year period, 1949 to 1954. This is only 78 per cent of our normal expected annual rainfall. Of the six years records which have been maintained, 1949 is the only year we have received our average or above of rainfall since the district was organized, when 24.6 inches was recorded. The last 5-year average is 13.7 inches.






