



Ennis Adams rode horseback over the country, carrying the petition which was presented to the Legislature asking for the formation of the county. All legal requirements were met, and the county was duly created. Section one of an Act of the

Legislature of the State of Texas, approved March 13, 1889, reads: Be it enacted by the Legisla-

ture of the State of Texas: That a new county, to be called Coke County, is hereby created out of Tom Green County, to-wit:

The Act was in six sections. It defined the boundaries and required the calling of an election of county officers within thirty days after the Act should be approved. A committee was named in the Act to supervise the calling of the election. This committee was, D. T. Fairley, Z. W. Withers, and T. A. Collier. The new county was required to pay its pro-rata share of Tom Green's outstanding indebtedness.
