### New Residents May Vote In Presidential Election

Voters who have lived in Texas less than a year must apply for a ballot during a 15-day period beginning Friday, Sept. 6, if they want to vote for President and Vice President in the coming general election, County Clerk Mrs. Winnie Waldrop announced today. Applicants must appear in person at the county clerk's office.

This will be the first time that persons having less than a year's residence in the state will be able to vote in a presidential election, Mrs. Waldrop said. A law passed by the Texas Legislature last year permits a voter who moved to Texas from some other state less than a year before general election day to vote for President and Vice President,

### Vehicle Inspection Begins in Texas

AUSTIN — The 1969 vehicle inspection period began Sept. 1 in Texas according to Colonel Wilson E. (Pat) Speir, acting director of the Texas Department of Public Safety.

"More than six million vehicles are expected to receive the compulsory inspection prior to the April 15, 1969, deadline," Speir said. Inspections may be performed at any of the almost 5,500 vehicle inspection stations in Texas, each of which displays the official vehicle inspection station sign. Texas law requires inspection of the brakes, lighting equipment, horns and warning devices, mirrors, windshield wipers, front seat belts in vehicles where seat belt anchorages were part of the manufacturers original equipment on the vehicle, steering (including power steering) and wheels and rims (not to include the removal of the wheel from the vehicle) on all motor vehicles registered in the state. Special inspection provisions apply to trailers, semi-trailers, pole trailers or mobile homes having a loaded gross weight in excess of 4,000 pounds.

The minimum fee is \$1.75. This does not include the cost of repairs or adjustments necessary to enable the vehicle to pass inspection.

Speir said the new vehicle inspection sticker will be a two and one-half inch square replica of a DPS patrolman's badge with red background. Motorists are urged to have the 1969 inspection performed as soon as possible to insure that their vehicles are mechanically safe for fall and winter driving.

immediately before his removal to Texas or that he would have been eligible to vote in the presidential election in the state where he formerly lived if he had remained there until election day.

Mrs. Waldrop said that a person who had been issued a voter registration certificate, voter identification card, or other document showing that he was a registered voter in the state from which he moved should take this document with him when he goes to the county clerk's office to apply for a ballot. If he does not have written proof of his registration, it will be necessary for the clerk to obtain verification of his voting eligibility from the voter registrar or other appropriate election official at the place of his former residence before he will be accepted for voting.

Applications must be filed with the clerk by 5 p.m. on Friday, Sept. 20. However, the voters will not actually vote until the period of Oct. 21-Nov. 1, when they will return to the clerk's office and cast their ballots. Mrs. Waldrop said that each applicant will be given written notice informing him whether his application has been accepted after the clerk receives a reply from the voter registrar in the state of former residence.

Persons voting in the presidential election under this special procedure need not be registered as voters in the county where they now live.

Mrs. Waldrop emphasized that this voting procedure applies only to persons who will have lived in Texas less than a year on election day. If a person moved to Texas before Nov. 5, 1967, he must be registered with the county tax assessor-collector in order to vote in the general election on Nov. 5, and he will vote in the regular manner on election day. However, only those persons who became residents of Texas after Oct. 1, 1967, may register at this time, and they must register by next Oct. 5 in order to vote in the election on Nov. 5. Registration for persons who became residents on or before Oct. 1, 1967, closed last Jan. 31.

### Sam Williams Completes Course

Sam Williams, owner of Williams Funeral Homes in Robert Lee and Bronte and ambulance service operator for Coke County, recently completed a three day course entitled Initial Emergency Management and Transportation of the Sick and Injured. The course was held in San Angelo.

Sponsors were the Texas State Department of Health and the committee on injuries of the American Academy of Orthopedic Surgeons, in cooperation with Shannon Hospital. It was designed especially for ambulance attendants, nurses, firemen, policemen, safety engineers, volunteer rescue teams, emergency squads and other groups interested in emergency care.

Approximately 17 physicians taught various phases of the course, including fractures of the spine, arms, legs, head injuries, chest and abdominal injuries, eye and facial injuries, radiation hazards, circulation, bleeding and strokes, emergencies involving children, electrical power lines, and childbirth.

"What is Emergency Care" was the topic of a special lecture by Dr. Charles A. Rockwood Jr., chairman, Department of Orthopedic Surgery of the University of Texas Medical School at San Antonio.

A diploma authorized by the executive committee of the American Academy of Orthopaedic Surgeons was awarded Williams upon successful completion of the course.

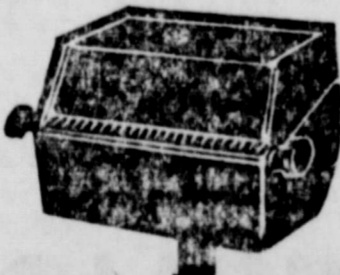

### How Does Your Food Measure Up

Aging folks need "growing food" just like the kids do. One grows "old" when he ceases to produce new body cells, so you can totter at 60 or be a young 80, depending largely on how well you eat to repair yourself.

To a large extent, you can control aging by persistent good "or bad" habits.

Many older citizens need better diets. For a recognized standard that provides information for choosing the right food, use the "Daily Food Guide" available from my office.

There are two angles to this growing-older problem. One is physical, and the other is mental. Food has a lot of bearing on both angles. Some of the old ideas must be discarded if the good protective foods are going to be eaten regularly.

Don't get food-cranky about what you eat. Don't try to live on "tea and toast" or "bread and butter." Don't let vitamin pills suffice for food unless your doctor prescribes them.

Don't be a "meal-skipper." Don't refuse to try new textures in food. If chewing is difficult, cube-it, chop-it, mash-it, or grind-it to help the work of your teeth. Don't be a snacker. Three "squares-a-day" can add the variety in foods necessary. Don't be an over-eater. We need less food as we add years.
