Wristwatches are awarded the top 12 individuals that have not won a watch previously. A. J. and Edwin joined Lane in receiving one of the twelve watches awarded.



### **High Court Says Retry Land Suit**

Texas' Supreme Court refused Wednesday of last week to review the decision of the Court of Civil Appeals that a condemnation suit involving land in the basin of E. V. Spence Reservoir must be retried.

Mrs. Helen Harris Wilcockson appealed a Coke County juy's award of \$545,580 for 4,014 acres of land needed in construction of the lake, plus a flowing easement on another 442 acres.

Mrs. Wilcockson's appeal stated that the award was not big enough and did not take into full consideration the oil production on the land.

The 3rd Court of Civil Appeals ordered a re-trial, and the Supreme Court agreed.

And even though the UCRA did not build the Robert Lee Dam, the organization's board of directors has spent untold amounts of time and money studying and promoting a dam on the Colorado River in Coke County.

The UCRA was created by an act of the Texas Legislature in 1935 for the purpose of administering the waters of the upper portion of the river and its tributaries.

In addition to its work in supplying Robert Lee and Bronte with a good water supply, UCRA built the North Concho Lake near San Angelo and assisted the towns of Carlsbad and Christoval

The Warren killing about put an end to fence cutting in Coke County and things were settled down considerably by the time the homesteaders began to arrive.

The homesteaders came by wagon, by horseback and on foot, driving their animals, bringing all they had with them. Many lived in dugouts or half dugouts at first and others in tents. They had to live on the land for three years according to the Homesteaders Law.



> After the election the process of moving began. People did not remove the contents of their houses, but rode to Robert Lee in the houses. There was no courthouse to be moved and county offices were placed in various rented buildings. The county clerk and county attorney moved into a rented small frame building with what records they had managed to salvage from the Hayrick fire, but two weeks later, Jan. 27, 1891, this building burned, destroying the remaining records.

> The courthouse was build in Robert Lee in 1891, and remained in use for 65 years. On Oct. 30, 1956, a 10-1 majority of Coke voters approved issuance of \$300,000 in bonds to build the new courthouse which serves today. It was dedicated Oct. 13, 1956. A \$250,000 bond issue to build a courthouse was turned down in 1947 by Coke voters, 543-130.

posed of 249 separate items. Included in the huge equipment were belly dumps that could transport, with a heaping load, 55 cubic yards of earth at a time. There also was a loader that could fill one of these monsters in less than a minute, and when one was loaded and pulled away, another took its place. Over the face of the dam or in the jaws of the core trenches, huge tractors, scrapers, graders, water wagons, plows and rollers crawled like a bed of ants. At times this work went on around the clock under the glare of flood lights operated by portable light plants.

Beside the rolling stock, there were root rakes, air compressors, drills, generators, and a steam jenny, and eight pumps delivering millions of gallons of water to soften ground or wet the embankment to required compaction.



### Bond Issues Finance CRM

lorado River Municipal Water District borrowed its first money 18 years ago to finance the initial increment of a multi-city water supply including Lake J. B. Thomas, pipelines, wells, etc. Three expansions and four bond issues have pushed to \$53,600,900 the amount of revenue bonds that the District has issued to stay ahead of demands for water in West Texas.

The District got its biggest break when it needed it most right at the start. Union Securities, represented by Joe King, a former Fort Worth resident, put together a package of \$11,750,-000 revenue bonds at an effective rate of 2.48, a remarkable offering even in the face of the market at that time inasmuch as the District had no operating history. at all. It was not much more than an idea and a set of plans. Ironically, within 30 days of sale of the bonds, the market went up sharply.

The District came back in 1958 to issue another \$4,600,000 in revenue bonds to finance an expansion of the system on the west end, principally a pipeline to parallel the section between Martin County and Odessa. The market had changed sharply and this issue to Union Securities went at an effective rate of 4,123. (The District later retired \$1,-000,000 of this issue when plans for ground water purchases did not materialize.)


In 1963, a quickie issue for \$2,750,000 on a 6-year payout was shepherded through Eastman-Dillon, Union Securities for an effective rate of 2.4939. This was to finance the pipeline from Lake Thomas to Sun Oil Company's water flooding projects in Coke County.

The big issue to finance what has become known as the 1966 Construction Program (Lake E. V. Spence, pipelines, diversion works) came in two stages. In September 1966, the District issued \$30,000,000 at an effective rate of 4.96 to Eastman-Dillon, Union Securities. When a costly diversion works and rising costs proved this not quite adequate,

> The next and perhaps the biggest problem of all was how to get the water from the river into the side storage, especially when a flush flow was beginning. Here a battery of high capacity pumps came into play.

> At a cost of \$365,186, the District has constructed a pump station that catches water from the river and boosts it ino the reservoir. One pump with 1,500,-000 gpd capacity will operate when the river is at its lowest, joined by a 5,000,000 gpd unit when the river flows somewhat more. 

Water does not have to be 70 feet deep at the spillway before it can be spilled below to satisfy various demands.

The structure has three service outlets which could let out as much as 50,000,000 gallons per day. One is a 60-inch conduit, while two others are 24-inch pipes. The big pipe and one of the 24-inch outlets will pick up water at elevation 1815.5 feet, dump it into a valve tower half way between the lip of the spillway and the center line of the dam. The Colorado River Municipal Water District sells only raw water, with one exception. That exception was occasioned by the rising waters of Lake E. V. Spence, which will inundate riverbank wells that supplied water for Humble's repressuring project.

The District then had to make arrangements to furnish water from the lake, but this called for a filter plant costing \$96,000. In time this will be recovered through sale of water to the operator.

A correlative structure combined the intake and drip trap facility for Union Texas Petroleum Company at a cost of \$89,000. Union's gas lines go under the lake, and the change in temperatures causes liquids in the gas to condense. These are trapped in a vessel at the installation, then pumped vertically to surface storage.







Over 600,000 large mouth black bass have been put into the water at Robert Lee in the last two weeks, bringing the total number of bass stocked past the million mark. 



In 1913 an engineer named Stanley was interested, along with a Dr. Piersen, English capitalist, who would finance the enterprise. The late S. A. Kiker, long time county commissioner from the Bronte precinct, told me the story, which I wrote and saw published in a number of daily papers in the thirties.





Ivie was with Freese and Nichols, Consulting Engineers, when he joined CRMWD in 1952. He was on duty when first deliveries of water were made. Soon he was brought to headquarters by Spence, who made him Assistant General Manager in 1959. Ivie helped work out much of the complicated rate formulae of the District, checked construction on expansion projects in 1958 and 1963, the latter when he pushed the "six months miracle" to get water from Lake Thomas to Sun Oil Company 55 miles away in the space of half a year. In effect, he was Director of Operations for Spence. Directors lost no time in naming him to the top post when Spence died in April, 1965. He figured prominently in securing a compromise which freed the per mit and opened the way to the new lake. During his career he has pressed for numerous improvements, including automation of the system. In assuming his duties as Gene-

After the war, he returned to A & M in 1924 to earn a Master's Degree in Civil Engineering with a major in City Management, and immediately San Angelo named him City Manager. Later he resigned to enter private business, then served as Big Spring City Manager, 1931-1941, leaving this post for World War II service. Colonel Spence's service as Post Engineer at Camp Swift was rated the most outstanding in the Eighth Corps area. Governor Coke Stephenson named him to the State Board of Water Engineers, Governor Beauford Jester elevated him to the Chairmanship and Governor Allan Shivers appointed him Interstate Water Compact Commissioner, from whence he came January 1, 1951, to be General Manager of the newly formed CRMWD as it prepared for a \$12 million construction program.

His years as a City Manager, as well as that at state levels, had qualified him for a continuing effort to keep this area in water. Before Lake J. B. Thomas, the first CRMWD reservoir was started, he explored possibility of diverting much of the Deep Creek shed into it. This eventually led to a proposal for a second lake in 1956, a project that took another nine years to firm into a permit and three more to build.

While pushing a state water plan for Governor Jester, Spence warned leaders in this region, "you never get up with your ater." When urging a decision to file for a second lake, he admonished, "You can't fool around about tying up this water. .. I cannot over emphasize the need for this water for West Texas." Although steeped in practicalities of engineering and economics, he was imaginative and perceptive. He secured an amendment to the permit when oilfield Continued on Page 6







Workers To Bring Water To West Texas

These three members of the board of the Upper Colorado River Authority have worked for untold hours and spent money from their own pockets to develop water resources in Coke County.

These three men have served long years on the board of directors of the UCRA. They have devoted their time, money and energies to making water available to West Texas for its growth and development. Their influence as officers and directors of the UCRA should be remembered each time a citizen of Robert Lee or Bronte turns on the water tap in his home, for they are the ones who worked to provide adequate city water supplies to both towns.

L. T. Youngblood and Gerald C. Allen have served as members of the UCRA board since its beginning in 1936. Cumbie Ivey was appointed a member of the board in 1948.

During 33 years Mr. Allen and Mr. Youngblood have served and during the 21 years Mr. Ivey has served, these men have worked to get a dam built on the Colorado River. It was their efforts that kept the water rights in Coke County and this area intact and made it possible for the Colorado River Municipal Water District to complete the dream for a dam in this area.

Of more immediate importance to Robert Lee and Bronte is the backing of these men in getting the UCRA to finance Mountain Creek for Robert Lee and a pipeline from Oak Creek Lake for Bronte.

Mr. Youngblood was chairman of UCRA from 1945 till 1964, and was vice chairman prior to 1945. Mr. Allen was secretary-treasurer till 1964 when he became chairman of the board.




