





OF BONDS BY THE STATE OF NEW MEXICO FOR THE PURPOSE OF CONSTRUCTING AND MAIN-TAINING A SYSTEM OF STATE HIGHWAYS.

Amend, S. B. No. 161; Approved June 10, 1912.

STATE OF NEW MEXICO

Section 1. For the purpose of providing payment of the cost of the construction and maintenace of a system of state highways, the State of New Mexico is hereby authorized to incur an indebtedness in the manner provided by this Act, in the sum of five hundred thousand dollars.

Section 2. Immediately after the is sue of the proclamation of the Govenor as provided in Section 8 of this Act, the State Treasurer shall prepare five hundred suitable bonds of the State of New Nexico in the denomination of one thousand dollars each to be numbered from one to five hundred inclusively, and bear the date of July 4, 1913. The total issue of said bonds shall not exceed the sum of five hundred thousand dollars and they shall bear interest at the rate of four per cent per annum from the date of issuance thereof. JOINT RESOLUTION NO. 6.

PROVIDING FOR AMENDMENT OF SEC. TION (5) ABTICLE TWENTY-ONE (XXI) OF THE CONSTITUTION OF THE STATE OF NEW MEXICO.

H. Sub. S. J. R. No.5. Filed May 29, 1912

BE IT RESOLVED BY THE LEGISLA-TURE OF STATE OF NEW MEXICO-That Section Five (5) of Article Twenty-one (21) of the Constitution of the State of New Mexico, to-wit:

"This state shall never enact any law restricting or abridging the right of suffrage on account of race, color or previous condition of servitude; and in compliance with the requirements of the said act of Congaess, it is hereby provided that ability to

read, write, speak and understand the English language sufficiently well to conduct the duties of the office without the aid of an interpreter, shall be a necessary qualification for all state Islature."
