# GERMAN ROYAL FAMILY GROUP

#### MONEY IS DESPISED TRASH Love, Kindness, Baseball and "Movies" Make Isle of Guam a Paradise, Says Captain Brackett.

Chicago .--- There is a tiny speck on the map of the South Seas. It is found by drawing a line due east 1,500 miles from Manila. At the end of the line is the world's only Utopia. 320 square miles in extent, where money is not needed, used or desired.

It is the island of Guam. Capt. W. Brackett, United States marine corps, vice-governor and chief justice of the little island, visited the marine headquarters of Chicago and smiled a bored smile at the mention of money.

"Money is just so much metal or paper." he said, and waved his hand in repudiation of everything that can be purchased. "Over in Guam everybody is happy and no one wishes for money. Guam is the one spot of complete content in all the world because it has no money system."

Not even a system of exchange or barter obtains among the 13,000 brown-skinned men who make up the island's population

"Nature has given the inhabitants everything they can wish," the captain explained. "Their good food grows on trees before their doors. They bulid their own huts and occasinally weave garments for themselves. That ends their work. They are not lazy, but they do not work. Every one is happy there. Kindness and love and baseball and moving pictures are all there is to life And what more could be wished?

"We established a moving picture show," Captain Brackett said. "and the natives are wild over it. It gives them the only motive they have for doing work, and now every woman on the island has taken to raising chickens, as ten hen's eggs will secure admission to the show. The baseball games are free.





These dibbles must be used with great care in planting bulbs, such as onions, because they are apt to leave a hollow space beneath the bulb and thus defeat the very object desired. Often roots will be sent out from the base without being able to reach the soil, for seedling plants which have a against the root and leave no air space whatever. The acompanying cut shows three popular styles of wooden dibbles, which anyone can make.

How to Break Up Brooding.

The best and quickest method of breaking up broody hens is to build a cage entirely of laths, without any solid floor to it, and hang or fasten the cage up outdoors where the air can pass through it. A ben treated in this way will be broken from setting in a very few days and it is not necessary to deprive her of food or water nor to nearly drown her in a tub of water, as is done too often. Broody hens should not be starved, but fed all they will eat. Heavy feeding starts them laying quickly after their broodiness has been ended. Starving them delays egg production much longer.

### **Returns From Good Seed Bed.**

There are very few farms on which additional labor expended in preparing seed, bed would not yield handsome returns. It costs but 15 cents per acre to harrow land, and about 35 cents per acre to disk land. For \$1 land can be double disked and

harrowed twice. One bushel of wheat or barley, two bushels of corn or onehalf bushel of flax increase per acre will pay for this extra work.

in youn; corn-usually before the corn is more than six or eight inches high. This insect is probably the most serious insect pest of corn in the early spring. We cannot reach this insect with poisons, so that where this pest is serious we must resort to farming methods to control it. It is usually more serious on bottom land, especially when the corn is planted early. If the planting is delayed until May, most of the adult beetles have laid

their eggs and the damage is not great. Some farmers make it a practice to plant much more corn than is necessary so as to get a good stand in spite of these insects.

The damage is thus distributed and it is easier and cheaper to thin out the corn than to replant. in regard to this name "bud-worm." Most farmers use it in referring to the southern corn root-worm. This is also sometimes known as the "spiker" or "drill-worm." I have heard farmers call it all of these names. It is the small white or yellowish-white worm with black head that eats the roots and kills the bud

in young corn-usually before the corn is more than six or eight inches high. This insect is probably the most serious insect pest of corn in the early spring. We cannot reach this insect with poisons, so that where this pest is serious we must resort to farming methods to control it. It is usually more serious on bottom land especially when the corn is planted early. If the planting is delayed until May,

most of the adult beetles have laid their eggs and the damage is not great. Some farmers make it a practice to plant much more corn than is was getting somewhat anxious. A pernecessary so as to get a good stand sistent ring came at the front door. in spite of these insects.


