County employees to get pay hike

Castro County Commissioners on Monday approved a budget for fiscal year 2007 which gives county employees a \$150 acrossthe-board raise - welcome news since it's been several years since they've gotten raises.

"Initially we approved a \$100 raise, but because we went with an insurance plan that costs less than in previous years, we added the \$50," said County Judge Bill Sava. This year the quote for employee insurance was more than \$8,000 per employee - it was

well over \$7,000 last year. Instead the commissioners approved a plan that costs \$6,951 per employee, which includes changes in the deductible and co-pay.

"We have worked hard on this budget," Sava said. "I'm truly proud of the commissioners. They made some hard decisions and made them in the best interest of Castro County.

"We talked about needing to keep our salaries competitive with the counties that surround us. We hope that realizing that they're

drawing a fair compensation and being competitive with other counties will help us hold on to the employees we have and be an encouragement to them to want to said. stay in the county."

In addition, this year's budget of 3,553,392 includes provisions for two new cars for the Sheriff's Department.

The budget calls for a rate of .6990 cents per \$100 valuation, up slightly from last year's rate of .68.







What's the Law?

There are ways to stop a debt collector

Q. I owe a company money from about ten years ago. I have not heard anything for about five years, but now a debt collector is calling me day and night. He also is calling my sister. I tell him I don't have the money and can't afford to pay, but he will not stop harassing me. What can I do?

A. First, if the debt is that old, there may not be any legal action the debt collector can take. After four years, most debts are barred by what is called the "statute of limitations." This means if a lawsuit is filed, you could have it dismissed.

There is no law, however, that prevents a debt collector from asking you to pay a debt, even if legal collection of the debt is barred. You can stop the debt collector from continuing to harass you in several ways.

First, under federal law, if you send the debt collector written notice demanding he stop all further communication with you, he must stop. He still has the right to sue, but in your case, that alternative is barred by the statute of limitations.

Another way to stop a debt collector is to make it clear that you do not intend to pay, and that his calls are just a waste of time. For example, if you get very upset every time a debt collector calls, the debt collector begins to think that you will pay, to avoid being harassed. Your conduct almost encourages more bad conduct by the debt collector. On the other hand, if you are polite and calm, and slowly and carefully explain that you recognize that you owe the debt, but cannot afford to pay and believe that it is barred by limitations, the debt collector will soon realize calling is waste of time. Debt collectors make money by collecting money. A debt collector cannot afford to spend a lot of time on the phone with someone they know is no going to pay.

Finally, I should point out that under the law, a debt collector never has the right to harass, threaten, or otherwise abuse you. If that happens, let the debt collector know you know your legal rights and you expect he wills top. If he does not, consider speaking with an attorney or a filing a complaint with the Federal Trade Commission.

Q. The other day, a friend came to see me at work. After he left, my employer asked how I knew him. I



said he was an old friend. The next day I was fired. My employer told me he had "problems" in the past with my friend, and did not want me working in the store. Is this legal?

A. As far as the law is concerned, your employer doesn't even need a reason to fire you. Unless you have an employment contract for a set period of time, Texas law treats you as an employee at will. This basically means you may be fired, or quit, at any time, for any or no reason.

Q. If a guardian is appointed for an incapacitated person, what is the authority of a second person holding a durable power of attorney. Is the power of attorney automatically revoked? If not, can the new automatically revoked?

A. The appointment of a guardian automatically terminates any grant of authority given under a power of attorney.

Q. We are being sued. We just want to be prepared for the worst. If we lose and the person suing gets a judgment against us, what assets can he take? After appropriate papers are filed can the sheriff come in and load up everything? Can he take things like our furniture, clothing, or car?

A. If you are sued and lose, the creditor may obtain what is called a "writ of execution," which allows the constable to take only "non-exempt" property to satisfy the judgment. In Texas, a person's home and wages are "exempt." Personal property, such as home furnishing, wearing apparel, and your car are all "exempt" if their combined value is under \$30,000 for an individual, or \$60,000 for a family. This means the creditor may take your furniture, clothing or car only if the value exceeds the statutory limits.




Q. I have worked for the same company for two years. Recently, they changed our compensation schedule, and I now make much less than I did. Is this legal? Can they just change my pay whenever they want?

A. Basically, without an employment contract or a union, your employer may change your pay whenever it wants. The only limitations are that they pay at least minimum wage, comply with overtime laws, and not unlawfully discriminate. The other side of the coin is that you may ask for a raise or quit whenever you want. About all I can suggest is for you to talk to your employer, and see if you can negotiate a better salary. If you cannot, you must either work under the employer's terms or look for another job.


Q. While applying for financial aid at the local college I encountered a problem. I have lived with a man for eight years and we have a child together. We are not married and do not file taxes together. We own a home together, but all other accounts are held separately. Are we common law married? Should I apply for financial aid as single or married?

A. Based on what you say you do not have a common law marriage. To have a common law marriage you must agree to be married, hold yourself out as married, and live together as married. That you have a child and live together isn't sufficient to establish a common law marriage, unless you both agreed to be married. You cannot be forced into a common law marriage.





Cotton futures on the New York Board of Trade settled lower Thursday on speculative selling as the market continued to digest losses from earlier in the week. Turnover was subdued, and the overall disinterest in trading kept the price range confined.

USDA reported net sales of U.S. cotton in the week ended Sept. 14 totaled 220,300 bales, four percent less than the previous week but 66 percent more than the four-week average. Turkey was the primary buyer at 51,500 bales while El Salvador was second with purchases totaling 32,800 bales. Colombia came in third with acquisitions of 29,000 bales but was

Export shipments of 75,500 bales were 18 percent more than the week earlier but 25 percent less than the four-week average. Major destinations included "The market is trading Mexico, China, Indonesia, and Colombia.

> "This was a widely spread out sales effort that seems to infer that if China doesn't want to buy raw cotton then other destinations will; only to spin and then sell the yarn to China," one trader said. "The shipment total of 77,600 bales seemed to be missing a digit in front of it, but I double-checked, and last week really was a bad one for cotton shipments."

> On the spot cotton scene, online trading by producers in Texas, Oklahoma, and Kansas in the week ended September 21 totaled 2,459 bales compared to the previous week when 4,793 bales were traded. Average prices received by producers in the most recent week

ranged from 44.00 to 48.00 cents per pound compared to 44.97 to 48.63 cents per pound the previous week.

In other news, many Delta farmers have been pleased with yields from nonirrigated fields. Although it is early in the harvest season, averages between 600 pounds and 900 pounds per acre have been reported from non-irrigated fields. However, production from fields that received minimal rainfall during the growing season has only ranged from 250 pounds to 400 pounds per acre. Producers there have just begun picking irrigated land, and yields of between 1,000 pounds and 1,400 pounds per acre have been reported.

According to USDA's Sept. 14 classing report, more than half of the cotton samples from Louisiana and Mississippi were classed as Middling White leaf 3 and better. Average staple length, however, was slightly shorter than desired at 33.7 for each state. Quality likely will be adversely affected from rains in the area earlier this week. and a prolonged period of warm, sunny weather is needed to bleach any discolored fiber in open bolls.

jewelry is called "bling," not "blink." Wonder if the Subscribe Today \$21.00/year within



Deaf Smith Electric Cooperative (DSEC) has filed an application with the Public Utility Commission of Texas (PUC), seeking approval to build a 115-kV transmission line extending approximately 18.3 miles. The new transmission line will begin at the existing Castro County Interchange in Castro County (owned by Southwestern Public Service Company [SPS]). From the Castro County Interchange the line will go north approximately 1.0 mile, paralleling the east side of an existing SPS transmission line to the south side of State Highway (SH) 86, just south of existing Substation 21. The proposed transmission line will then continue west approximately 17.2 miles along the south side of SH 86 to the east side of SH 214. The new transmission line will then parallel the east side of SH 214 continuing north to existing Substation 18 (approximately 0.1 mile). Along the route of the proposed transmission line DSEC plans to construct a new substation, Substation 22. The majority of the new transmission line as well as the proposed Substation 22 will be located in Parmer County, Texas. Approximately one-third of the line will be located in Castro County, Texas.

Deaf Smith Electric Cooperative has selected two alternative transmission line routes to be considered by the Public Utility Commission of Texas, described as follows:

Preferred Route (Route 1) consisting of line segments A, B, and D. The preferred transmission line route, wills start one mile west and one mile south of the intersection of State Highway (SH) 86 and FM 1055, in Castro County at an electrical interchange facility owned by Southwestern Public Service Company, (Castro County Interchange). From the Castro County Interchange the transmission line will proceed north approximately one mile to the south side of SH 86; then the line turns west and continues along the south side of the SH 86 right of way for approximately 17.2 miles, crossing over County Road (CR) 505, FM 1524, an SPS 69kV transmission line, the Castro-Parmer county line, and continues west along the south side of SH 86 past CR 28, FM 1172, CR 25, CR 24, CR 23, CR 22, CR 21 and CR 20 to the intersection of SH 86 and SH 214; then the line turns north and continues along the east side of SH 214 right of way approximately 1/8 mile, crossing SH 86 and terminating at an existing electrical substation, (Existing Substation 18), owned by Deaf Smith Electric Cooperative.

Alternate Route (Route 2) consisting of line segments A, F, and D. The alternate transmission line route (Route 2) will start one mile west and one mile south of the intersection of State Highway (SH) 86 and FM 1055, in Castro County at an electrical interchange facility owned by Southwestern Public Service Company (Castro County Interchange). From the Castro County Interchange the transmission line will proceed north approximately one mile to the north side of the SH 86; then the line turns west and continues along the north side of the SH 86 right of way for approximately 17.2 miles crossing over County Road (CR) 505, FM 1057, a DSEC 69kV transmission line, the Castro-Parmer county line and continues west along the north side of SH 86 past CR 23, FM 1172, CR 23, CR 21 and CR 20 to the intersection of SH 86 and SH 214; then the line turns north and continues along the east side of SH 214 approximately 1/8 mile and terminates at an existing electrical substation (Existing Substation 18) owned by Deaf Smith Electric Cooperative.

A new electrical substation (Proposed Substation 22) is proposed to be located adjoining SH 86 along the route of the transmission line approved by the Public Utility Commis-

The estimated cost of these transmission facilities is approximately \$5,820,000, of which \$3,815,000 is for transmission facilities and \$2,005,000 is for substation facilities.






