Months of July and August Months of Military Manuvers; Portales Direct Line Between Two Fields

Monday Fred Luper received an inquiry from the com-mander of the 8th Corps Aerial Air Service asking for an aerial landing field at Portales.

During the months of July and August there will be great military maneuvers all over the country, as this is the period of the citizens training camps. The 8th Corps Aerial Air Service comprises Texas, New

Mexico, Arizona and Colorado. Portales is on a direct line between the Kelley Field at San Antonio and the Ft. Logan Field at Denver. During these maneuvers there will be con-siderable flying of military planes between the two fields, and a landing field at Portales will gain some wide publicity.

The requirements of the field are an area 300 yards square, free from obstructions and should be marked with white rock "PORTALES" so that it can be seen from the plane before landing. It should also be equipped with a weather vein.

He is contemplating using part of the old pumping plant building for a factory, install a power crusher and an oil burning evaporator. Mr. Schumpert is a first-class sorghum maker and the Valley grows the proper cane for syrup. This enterprise will add another feather in the cap of Portales as an industrial center and dollars to the bank roll of the farmers who plant cane for the factory.

Governor Lindsey says that he has completed the pur-chase of the old pumping plant power house and that the prospects look good for a real industrial center there. He is working on the establishing of a canning plant in the building, which, with the syrup factory and the sweet potato curing plant, will make this a lively place.

Last Saturday a News representative visited the Portales school building and found that the new school board had been busy repairing and remodeling the main building. An outside entrance has been put into the basement from

the east side. The rooms in the bacsment have been floored and given a general overhauling, adding much to the efficiency and convenience of the Manual Training Department and the Gymnasium. In cutting this entrance through the foundation it was found that there need be no fear as to the foundation of this building not standing. County Board of Education Places Seven District Schools Under Consolidation


On Monday of this week the County Board of Education in called session, effected the consolidation of seven districts, said districts being Rogers, No. 33; Inez, No. 91; Friendship, No. 99; Mt. Vernon, No. 105; Longs, No. 34; Plainview, No. 36; Carter, No. 37.

These schools during the past term employed ten teachers. and have a total enrollments of 200 pupils. Some of them had fallen so low in attendance that they would have had to be discontinued this year.

Five teachers will be employed in the consolidated school and four trucks used for transporting the children, giving them high school advantages. The old buildings will be utilized for the consolidated school which will be at Rogers. This district embraces an area of 160 square miles, and is in the richest agricultural section of Roosevelt county.
