## Roosevelt County Fair, Portales, Oct. 3 and 4

### DEMOCRATIC RALLY AT COURT HOUSE

#### Much Enthusiasm Displayed by Portales Audience for Candidacy of Judge Hanna.

The Democratic rally at the court-house last Saturday night was well attended, and much enthusiasm was displayed when the picture of Judge Hanna was placed on the speaker's stand.

The first speaker of the evening was Attorney Carl Hatch of Clovis. Mr. Hatch is a young man of no mean ability as an orator and he had the audience with him from the start. Mr. Hatch paid tribute to the record of Senator Bursum for the past five months, and stated that he was doubtless the greatest man in New Mexico if he had accomplished half of what he claims since he has been in the United States Senate. He took his record and threw some very interesting light on the same. And in comparison, Judge Hanna shown as the star in the east.

Judge Sam G. Bratton followed. Judge Bratton is a favorite with Portales audiences and received quite an ovation when he mounted the speaker's platform. The Judge analyzed the amendments to be voted on in the coming election, making them clear to all.

He then dwelt on the candidacy of Judge Hanna and Senator Bursum. He stated that he did not know till the other day that there was a statute of limitation on reputation in New Mexico. He stated that the Republicans of New Mexico were demanding that Mr. Bursum's candidacy be considered on his record of the past five months and not on his past record in New Mexico. He stated that according to his claims of his Washington record he was doubtless responsible for the free air breathed by the citizenship of New Mexico. This record was analyzed and made clear that his real accomplishments were very few.

After the speaking a motion was made that a Hanna Club be organized. This was done and Judge A. J. Goodwin was chosen as chairman and Mrs. Coe Howard as secretary.

ROSWELL, Sept. 12.—Through the efforts of Sheriff John C. Peck and several deputies, a large still was found in the hills of Lincoln county near Picacho, and the owner, R. C. Shank is now in the county jail. In the cave which was located about twenty miles south of Picacho, was found a complete outfit and several gallons of mash were taken by the officers. The owner was taking no chances and the opening of the cave was so small that it was necessary for the officers to take the barrels apart in order to get them out of the cave. A complaint has been filed against Shank before U. S. Commissioner Savage.

### The Greatest Agricultural and Educational Exhibit of the State to Be Held First Monday and Tuesday in October.

At the mass meeting held at the court house Friday night of last week it was unanimously decided to hold a Roosevelt County Fair in Portales on Monday and Tuesday, October 3rd and 4th, of this year.

While the time is short the body represented at the meeting took the dilemma by the horns and dehorned it, threw and hog tied it till it can no longer buck the fair movement.

Prof. J. S. Long was chosen as chairman of the meeting and he presided in a business like way, bringing the workings of the meeting down to business.

Of her vast area, 85 per cent of which is subject to cultivation, only 4 1/2 per cent is under cultivation, and notwithstanding this, she is a vast storehouse of grain and dairy products. Her grain crops tax the railroad facilities to market same. Her dairying interests brings hundreds of thousands of dollars into the county annually.

Her irrigation district is undergoing a development which is startling the older sections of the country. The sweet potato industry alone is bringing us national reputation. The possibilities are beyond the dreams of the most imaginative. Her probabilities are a peanut butter and by-product factory, a sweet potato and vegetable canning factory.

And as a health factory, the entire county rivals the famous fountain of youth and goes it one better—it is real.

### 85 Are Drowned In Floods Which Hit River Farms

TAYLOR, Texas, Sept. 13.—As the flood waters of the San Gabriel river and Brushy Creek recede in Williamson and Milam counties the list of dead now amounts to 85. However, all reports are unofficial and made by messenger or people passing thru the inundated districts. The limited telephone and telegraph facilities of the smaller surrounding communities were almost completely wiped out by the flood and tornado.

The flood victims were found mostly along the San Gabriel river, a usual typical stream that rises in Burnet county and crosses Williamson and Milam counties to empty into the Little river. Brushy creek took the toll of life south of Taylor.

The newspapers here compiled the list of dead. While the newspaper men said that all of the dead reported had been reliably accounted for, they could not vouch for the exactness of the list. However, attempts at verification proved almost futile but the few that were verified stood as reported. Names were available in only a few instances.

### WHEAT PLANTING NOW UNDER WAY

#### 5.5 Inch Rainfall in September Guarantees Good Wheat Crop In Roosevelt County.

Farmers of Roosevelt county are busy making arrangements for wheat planting. Latest reports are that there will be in excess of 7,000 acres of wheat planted this fall.

In the past fourteen days Roosevelt county has had a rainfall of 5.5 inches, according to the weather report by E. P. Kuhl, observer for the department of agriculture.

Monday evening the rainfall in Portales was 2.15 inches. This rain extended practically all over the county. Reports from the Rogers district show a good rainfall in that settlement. From Kenna the report shows a good rainfall all the way.

About five o'clock the streets of Portales were running rivers, the water reaching to the sidewalk curbing all over town.

A number of tourists were caught in the storm and had to lay over in Portales for the night.

Farmers from the rural sections of the county were water bound and could not return home Monday night.

September rain gives the necessary moisture for the culture of wheat and this rain insures the planting of a large area in this county this fall.

Roosevelt county is the banner agricultural county of the state and the skeptics are invited to watch her development for the next twelve months.

HIGH SCHOOL NOTES

The High school has enrolled 156 to date, 68 of these are boys and 88 girls. Since in many good High schools the per cent of boys in attendance does not exceed 25, we feel that we have a splendid record for holding the boys in school. This, perhaps, is due to the excellent courses we are offering in Vocational Agriculture and Manual Training.

The Vocational Agriculture class has about 25 members, in two sections, each section working in a half day. Many interesting and profitable experiments and trips are being planned for these two classes.

The Home Economics work is also starting off in good shape under the direction of Miss Marie Garrett, who enters into the work in such a way as to compel interest and enthusiasm among the students of that group.

Work in other departments is also progressing nicely, in fact every department deserves special mention because of the splendid work being done. All teachers seem to be well prepared for the work being taught, and results are already apparent.

About 25 boys are reporting for football work out and in spite of the loss of several of last year's team, it is believed a good showing is being made, and a good team will be developed.

The High school is working now on an exhibit for the County Fair which we hope will exceed all previous exhibits along the line of school work.

The Senior class organized recently with a class roll of 33 members. Others enrolling will perhaps increase the number to 35 or more. At this meeting the following officers were elected:

President, Reed Murrell; Vice President, Howard Kenady; Secretary-Treasurer, LaVon Brown; Sergeant at Arms, Everett Dupuy; Faculty Adviser, Prof. R. A. Young.

The school is now organized and at work, therefore patrons and friends of the school are cordially invited to visit in any of the departments or classes.

SENATOR BURSUM ADDRESSES AUDIENCE

Monday afternoon Portales had the honor of entertaining a United States Senator, in the person of Hon. H. O. Bursum.

The Portales Concert Band gave a concert on the court house lawn in his honor just before the speaking.

Senator Bursum was introduced by Capt. T. J. Molinari, who in a few well chosen words paid tribute to his old friend, now Senator H. O. Bursum.

Senator Bursum, a man unfamiliar to a number of our readers, except by public reputation hasn't the appearance of the polished politician of fiction, but rather the western frontier character, who has been accustomed to deal with problems in western style.

While not a polished orator, the Senator made an excellent talk dealing with the problems of the day as he saw them.

He stated that industry was scared and the producer without aid, destruction threatened. He stated that the world war called upon producers to produce to the utmost capacity to carry on that great struggle, and that they responded nobly.

He stated that the livestock of the nation was seriously threatened by the slaughter of the young stock and heifers. That now there was a shortage of 15,000,000 head over 20 years ago, and unless the slaughter is checked it will mean a national disaster. That there are now no cattle on the ranges of Montana and the Dakotas and that the Texas range is 50 per cent short.

He eulogized President Harding for his untiring efforts to obtain relief from this state of affairs through the National administration.

He also dwelt on the debt of the nation to the soldier boys and stated that they would receive just recognition for their services.

From an oratorical standpoint the audience was disappointed.

After the conclusion of the speaking here the Senator and party left for Clovis where he was billed to speak at six o'clock.

The groom is the popular young manager of the parts department of the Universal Motor Co., at this place, and is a very deserving young man.



PRAIRIE DOGS ARE BEING EXTERMINATED

Under the direction of V. Van Gieson of the Biological Survey, Townships 3 south 36 east and 37 east of this county are being worked out in an eradication campaign against prairie dogs. Preparations for this work have been in progress for several weeks; contracts between the land owners and the Survey have been signed; and the work started a week ago Monday at the farm of Doc Hensley north of Inez. During last week excellent results were had, owing to the dry weather. It is estimated that in some sections of the worked out land the kill will run as high as 90 per cent.

### CONGRESSMAN COCHRAN OF NEW YORK REBUKES PRESIDENT HARDING

Congressman Cochran, of New York, presented an interesting constitutional question to the House on August 20. It will be remembered that President Harding personally appeared in the Senate July 12 and participated in debate, advocating a postponement of action upon the soldiers' bonus bill. Mr. Cochran's resolution with reference to this incident explains itself.

WHEREAS, On the 12th day of July, in the present year of our Lord, 1921, the Hon. Warren G. Harding, President of the United States, appeared before the Senate, having then before it for consideration as unfinished business Senate Bill 506, "to provide adequate compensation for veterans of the World War," and "standing at the Vice-President's desk," then and there addressed to it verbally, without notice to this House and in its absence, a communication, which appears in the Congressional Record of that day as part of the regular proceedings of the Senate; and

WHEREAS, The Constitution of the United States, which empowers the President to address recommendations respecting legislation to Congress, does not authorize him to address such communications to either House of Congress to the exclusion of the other; now, therefore, be it

Resolved, That such exclusion of this House from the right conferred upon it by the Constitution to share in all communications which the President may address to Congress respecting legislation is an unconstitutional violation of its rights, an illegal invasion of its privileges, and an unwarrantable injury to its dignity.

The Republican majority quickly disposed of this troublesome matter by voting to "lay it on the table."—Washington Searchlight.

When this bill came up for recommitment, although 5th on roll call, Senator Bursum passed, and after it was irrevocably lost, he reconsidered and voted for it.

### BAD CHECK ARTIST

of food. No engine develops its maximum power with the wrong kind of fuel and the human engine is no exception to the rule.

Proper food is not a matter of quantity or even price as many of the most valuable foods are not high priced nor in the "luxury" class.

"Pep" giving foods are those that contain what is known as "vitamines," and should be included in every diet. They produce health and growth. They are milk, butter, yolk of eggs, and the leafy vegetables, such as spinach, cabbage, and lettuce, fresh fruits and whole grains.

There are five main groups of foods and one of each should be included in the diet of each normal persons every day. They are:

Group 1. The mineral and acid class, the body regulators, including spinach, lettuce, peas, string beans, tomatoes, turnips, carrots, cabbage, onions, fruit.

Group 2. The portien class, the tissue builders, including lean meats, poultry, fish, oysters, milk, cheese, dried vegetables, cocoa, nuts, custard ice cream.

Group 3. The starchy class, that give heat and energy, including flour, meal mixtures, bread and crackers, macaroni, rice, tapioca, cereal breakfast foods, potatoes.

Group 4. The sugar class, that give heat and energy, including syrup, honey, preserves, jellies,

dried fruits, candy, sugar, frozen

ices. Group 5. The fat class, that give heat and energy, more heating per quantity than sugar or starch, including, butter, cream, lard, salt pork, bacon, chocolate, vegetable oils.

If you have a tendency to be too fat, go lightly on groups 3, 4, and 5 and substitute largely from 1 and 2, the repair and regulator foods.

Similarly if you are thin and without energy, specialize on the starch sugar and fat forming foods, and portien foods—never forgetting group 1—the regulator.

Take the same care in selecting your food that you do in selecting your clothes and you'll be surprised at the difference. Your natural inclinations may not always be an indication of what is best for your system.

# REPUBLICANS PLAYED LAST CARD IN BURSUM DEFENSE

(Special Correspondent).

WASHINGTON, Sept. 12.—When President Harding sent a letter to Senator McCormick, reviewing and praising his own administration for the announced purpose of its being used in the New Mexico Senatorial campaign, the Republicans played their last card in behalf and defense of Senator Bursum.

The main point of the President's letter is the claim that his administration is reducing expenses and next year he believes the aggregate of taxation may be reduced to \$3,500,000,000 a year.

The best way to answer this is to quote Senator Reed Smoot, (Rep. Utah), recognized as one of the financial authorities of the Republican Senate, who in a speech made five days before the President's letter was written at a meeting of the Rotary Club in this city said, as reported in his public press:

"Senator Reed Smoot told how he predicted in 1918 that the expenses of the government would never be less than \$500,000,000, and stressed how the Treasury Department denied this statement at the time.

"I tell you now," said the Senator, "that within seven years from now the taxes of this country will be \$5,000,000,000."

The facts concerning the achievements of the Harding administration up to the time of the recess of Congress, together with what it had failed to accomplish, were accurately set forth by Chairman George White of the Democratic National Committee in a public statement issued at the time of the recess as follows:

"After four months and two weeks, the extra session of Congress called to 'save the country' has quit its job for a month without having passed a single remedial measure unless the Agricultural Bill should justify its supporters in projecting government into private business.

"Neither of the major measures, tariff and tax revision, for which primarily the extra session was called, has been complete. As passed by the House, both of these bills were so badly constructed that they have been widely denounced by the Republican press, by Republican spokesmen in and out of Congress, especially by Republican business men and admittedly will have to be rewritten by the Senate. As evidence of Republican dissatisfaction in Congress fifty members of the House voted to recommit the tax bill for revision.

"Business and industrial conditions today are admittedly worse than they were when Congress was called together. The demand for remedial measures is even more urgent, but Congress displays a light-hearted unconcern about the distressful situation of the country.

"The people who voted for a change last November must certainly realize by this time that they got too much of it."

Despite Mr. Harding's expressed satisfaction with the Republican administration in both branches, the fact remains that when he took office there were a million of men out of work due largely to the failure of a Republican Congress, which had been in power two years, to enact needed reconstruction legislation advocated by a Democratic President. There are now six million men out of work, or, to give exact figures from the Department of Labor, 5,735,000.

Nothing that President Harding or any Republican spokesman can say can wipe out or change the reactionary record of Holm O. Bursum, either as a politician in New Mexico or a Senator in Washington.

He has voted for every bill increasing appropriations, but

voted against letting farmers and ranchmen have fertilizers and agricultural implements free of duty. He did not vote for the Soldier's Bonus Bill until his vote was not needed to recommit the bill and thus kill it and work of all, he voted in committee to white-wash Senator Newberry of Michigan, who had been convicted in the Federal Court and sentenced to the penitentiary, but escaped through a decision of the Supreme Court that the Corrupt Practices Act did not apply in the primary election.

The attempt made to substitute the record of the Republican Party, as set forth in the President's letter, for the Record of Senator Bursum does not better the matter because that record is worse than Bursum's for the reason that it includes the record made by the House as well as by the Senate.

## COUNTY BOARD OF EDUCATION EMPLOYS AUTO MECHANIC

The County Board of Education has employed Neil Rockey to care for the trucks used for the transportation of the school children of the county.

Mr. Rockey is a first class mechanic and will be stationed at Floyd. His duties will include the visiting of each district using trucks once a month for inspection of same.

He will carry an extra engine and if he finds one which needs overhauling, he will take it out and put the extra in, thus giving the greatest efficiency to the

trucks without loss of time. He will then take the removed engine to the shop and give it a general overhauling.

This should save the Board of Education considerable in the upkeep of the school trucks.

**WOMANS CLUB HOLDS  
OPEN MEETING TO  
DISCUSS AMENDMENTS**

The Woman's Club held an open meeting at the court house Wednesday afternoon at 3 o'clock. The meeting was called to order by Mrs. Arthur Jones. Minutes read by Mrs. Jack Wilcox.

The meeting was then turned over to the leader for the afternoon, Mrs. Lindsey.

J. A. Fairly was on the program to discuss 1st amendment but as he was not present a standing vote was taken and every one in the house voted for amendment No. 1.

Mr. Priddy discussed the 2nd amendment and said if you wanted Japanese to own land next to you, and be your neighbor, vote for it; otherwise kill this amendment.

Arthur Jones spoke on the 3rd amendment and said, really he didn't know very much about it, but he was "agin it." This amendment calls for the state superintendent of education to hold office indefinitely.

Captain Molinari explained the 4th amendment, saying he believed it to be class legislation and unfair. This amendment gives opportunity for fraud in that all soldiers are exempt from \$2,000 taxes. A father who owned \$4,000 of taxable property in the state, and who had two sons in war could deed \$2,000 of property to each of his sons, provided of course they had no property, and thereby escape his own taxes. This system could lower the taxable property in the state and raise taxes on the remainder while, to the soldier who had nothing it gives nothing.

On the 5th amendment, Jack Wilcox took the floor to explain. He said it wasn't the first job this Woman's Club had given him he said that he had been setting out trees and turning ice cream freezers all summer, but that he was glad to be of service to the ladies. Mr. Wilcox explained under the present laws when corporations wanted to raise the rates it was up to the state to prove they should not be raised. At the same time the state has no power to get possession of the Company's books.

If we pass this amendment the corporations will have to show that the raise is justifiable before there can be a raise in rates.

In the 6th amendment, Judge Lindsey explained that this is a very necessary change. That it simply puts the business of the state in a business way. He explained the budget system fully and said this was one of the most important amendments. Other bills have been passed similar to this but the legislature could and did repeal them but if this is put as an amendment to the Constitution it cannot be changed without a vote of the people.

Coe Howard was called upon to explain the 7th amendment. Mr. Howard said the land commissioner handled something like 12,000,000 acres of land and that in it there was too much chance for graft for one man. This amendment calls for a non-partisan board of three members which will insure a more fair handling of this land.

Supt. Palm took the floor on No. 8. Mr. Palm said in the last 10 years New Mexico had jumped from 47th to the 23rd state in the Union in point of education. If this 8th amendment carries, we'll likely go backward as fast as we have gone forward. Roosevelt county is now using 11 1/2 mills, but under this amendment she cannot use over 10 mills, without the written consent of the County Commissioners and State Tax Commission.

Judge Lindsey spoke in behalf of No. 9. Under the present law cities cannot vote bonds only at regular election times, this might work a hardship on fast growing cities. With this amendment, these cities could call special elections.

No one spoke on No. 10. Mrs. Coe Howard merely read the synopsis of the amendment, saying it

called for county superintendents to hold office indefinitely.

R. G. Bryant spoke on the 11th amendment. Mr. Bryant said "Vote against it!" "It would soon bankrupt the state. It is with difficulty that we now meet expenses, and it is time to curtail expenses. Again it is not necessary at this time." This amendment is for the \$2,000,000 road bond issue, and is receiving very little encouragement in this side of the state. It is not that the people are opposed to good roads, but this amendment does not give the people a chance. It is automatic in its operation and there would be no end to it.

**WHERE WILL IT  
BE LOCATED?**

There is considerable interest being expressed as to the location of the new High school building. While several locations have been proposed, it seems to be the general opinion that the building should be placed where tourists can see it and be impressed with the educational advantages of Portales.

It has come to the ear of the News reporter that a number favor placing this building at the foot of the street running from the square to the highway leading to Elida.

While the News is not trying to say where this building should be located, it would be glad to have the building located where tourists, both auto and by train,

**NEW YORK WORLD  
ON SENATOR BURSUM**

On September 20 the voters of New Mexico will elect a United States Senator to fill the vacancy caused by the resignation of Albert B. Fall to accept a seat in the Harding Cabinet, and normally is in a state of panic. That is the explanation of the extraordinary letter sent to Senator McCormick over the signature of President Harding.

Mr. Harding, of course, did not write this letter, which professes to be a reply to one from Senator McCormick congratulating the President on the success of his administration. It is a campaign document which was prepared for the President's signature and might have been written by Sen-

ator McCormick himself. Only a Senator could have inspired that tribute to the "monumental accomplishments which has marked the work of the extraordinary session down to the time of its recess."

The country has some very definite notions of its own about that "monumental accomplishment." The Senators and Representatives have been hearing about it during their visit to the home folks since Congress took a vacation, and what they have heard is not especially reassuring. As one of them who returned to Washington to avoid further embarrassing questions from his constituents told the sad story to a World correspondent, "the folks back home are hot" and "everything is in a hell of a fix."

The administration does not urgently need a Republican Senator from New Mexico. In fact it has more Republican Senators than it knows what to do with. But it recognizes in the New Mexico election the first referendum since March 4 on the policies of the administration and the record of the Sixty-seventh Congress. Hence Mr. Harding's pathetic desire to explain to the voters how incompetent the Democrats were, how badly the war was managed and how valiantly the Republicans have struggled against overwhelming odds to make everything right.

Mr. Wilson is still damned by his Republican critics for having ventured to ask the country in 1918 to give him a Congress that would support his policies, but it is a different matter when a Republican President writes a partisan letter to help bring about the election of a Republican Senator in New Mexico when an adverse vote would be construed as a rebuke to the administration.

We need not quarrel with those little idiosyncracies of politics which are common to both parties. What is important about the Harding letter is its implication

That would not happen unless the Republican leaders were frightened, and the Republican leaders would not be frightened if they felt that the country shared any part of Mr. Harding's complete satisfaction with the achievements of Congress and of the Administration. With Congress slacking on its job, with no definite programme for tax reduction or for the general relief of business, with 6,000,000 men out of work and public opinion becoming more and more critical, normalcy is afraid of the ballot box even in New Mexico.—New York World.

**BURSUM IN WASHINGTON**

**The Emergency Tariff**

Under the guise of a farm relief measure, the Old Guard machine rushed through an emergency tariff bill, to raise certain rates until the permanent tariff bill could be passed. Two highly important amendments will serve to show Bursum's attitude.

**The Reed Amendment**—This was intended to give the farmers cheaper machinery, the full text being as follows:

Whenever it is established to the satisfaction of the Secretary of the Treasury that merchandise upon which an import duty is levied by the United States is being commonly exported from the United States and is being commonly and generally sold in the countries to which exported at less than the same class or kind of merchandise is being generally sold or offered for sale in the United States, then the Secretary of the Treasury shall issue an order suspending and setting aside any import duty or tariff upon the importation of the same or similar articles of merchandise into the United States, said order to remain effective so long as the condition aforesaid exists.

Upon this amendment Bursum voted nay. Lodge and Smoot voted yea; Borah and Kenyon voted yea.

**The Dye Embargo**—The Senate Committee reported an amendment which favored the new dye monopoly by placing an embargo upon everything in this field not obtainable in the United States. Upon this Bursum voted yea. Lodge did not vote; Smoot, Borah and Kenyon voted nay.

It will be noted that this is the second time that even Smoot was unable to go the limit Bursum did. —Washington Searchlight.

### NO. 1

**JOINT RESOLUTION PROVIDING FOR THE AMENDMENT OF SECTION 2 OF ARTICLE VII OF THE CONSTITUTION OF THE STATE OF NEW MEXICO.**

H. J. R. No. 15, Appr. Feb. 15, 1921. Be it Resolved by the Legislature of the State of New Mexico:

That Section 2 of Article VII of the Constitution of the State of New Mexico, be and the same is hereby amended to read as follows:

"Sec. 2. Every citizen of the United States who is a legal resident of the State and is a qualified elector therein, shall be qualified to hold any public office in the state except as otherwise provided in this Constitution. The right to hold public office in the state of New Mexico shall not be denied or abridged on account of sex, and wherever the masculine gender is used in this Constitution, in defining the qualifications for specific offices, it shall be construed to include the feminine gender. Provided, however, that the payment of public road poll tax, school poll tax or service on juries shall not be made a prerequisite of the right of a female to vote or hold office."

The Legislature may by enactment change, alter or enlarge the powers and duties of the State Corporation Commission created by Section 1 of this Article for the control and regulation of corporations and may change or alter the provisions for the enforcement of its orders. Until the Legislature shall otherwise provide any order made by the commission fixing or changing any charge or rate or relating to any matter within its authority shall be binding upon the carrier, or company, or person to whom the same is directed and shall be enforced by the Supreme Court according to the terms of such order unless changed or modified by said court on a hearing applied for by such carrier, company or person within a reasonable time limited in such order. Upon any hearing or proceeding in any court upon any order issued by the commission within the scope of its authority the burden of proof shall be upon the carrier, company or person to whom such order is directed to show the unreasonableness of any charge or rate fixed or requirement specified in such order and such court may of its own motion and shall upon request of any interested party require or authorize additional evidence.

### NO. 7

**JOINT RESOLUTION PROPOSING AN AMENDMENT TO ARTICLE XIII OF THE CONSTITUTION OF THE STATE OF NEW MEXICO, ENTITLED "PUBLIC LANDS."**

S. J. R. No. 11, Appr. March 12, 1921. Be it Resolved by the Legislature of the State of New Mexico:

Section 1. That Article XIII of the Constitution of the State of New Mexico be amended so as to read as follows:

"ARTICLE XIII PUBLIC LANDS"

"Section 1. All lands belonging to the State of New Mexico, and all lands granted, transferred or confirmed to the State by Congress, and all lands hereafter acquired, are declared to be public lands of the state to be held or disposed of as may be provided by law for the purpose for which they have been or may be granted, donated or otherwise acquired.

"Section 2. A permanent Commission to consist of three members, not more than two of whom shall belong to the same political party, is hereby created, which shall be known as the "State Land Commission."

"Section 3. The members of the Commission shall be appointed by the governor, by and with the advice and consent of the Senate, and shall be subject to removal only for cause. Each member shall hold office for a term of six years from and after his appointment, and until his successor shall have been duly appointed and qualified; Provided that the three members of the Commission first appointed and confirmed shall immediately qualify and classify themselves by lot so that one of them shall hold office for two years, one for four years, and one for six years, from and after January 1st, 1923, and thereafter one Commissioner shall be appointed every two years; Provided, however, that the members of the Commission first to be appointed shall be appointed during the regular session of the legislature to convene in the year 1923, and provided further, that until such Commission shall be duly appointed and qualified as hereinabove provided, the Commissioner of Public Lands elected at the general election in the year 1920 shall continue to act as Commissioner of Public Lands with all the powers and authority heretofore exercised by him.

"Section 4. The State Land Commission shall select, locate, classify, and have the direction, control, care and disposition of all public lands, under the provisions of the Acts of Congress relating thereto and such regulations as may be provided by law.

"Section 5. The Commission shall annually elect one of its members Chairman, and shall appoint a Chief Clerk, and such other officers, assistants, and subordinates as may be requisite and necessary for the proper

**THE CONSTITUTIONAL AMMENDMENTS**

This issue contains the constitutional amendments in full, read them carefully, so that you may be able to cast an intelligent vote on September 20th.

Following is a synopsis of the amendments:

No. 1. This amendment provides equal rights to women in that they may hold office in New Mexico.

No. 2. Provides that no one ineligible to citizenship in the United States may hold title to land in New Mexico.

No. 3. This provides that the Superintendent of Public Instruction may serve more than two terms in rotation, if the people so desire. This amendment conflicts with No. 6.

No. 4. This provides for an exemption from taxes of \$2000.00 for all honorably discharged soldiers, sailors, marines, and army nurses, or the widow of such, who served in the armed forces of the United States while regularly engaged in war.

No. 5. This amendment puts teeth in the Corporation Commission. At present they have no power to enforce their rulings.

No. 6. This conflicts with amendment No. 3, in that it provides that the governor take the oath of office on the 1st day of December, instead of the first day of January. If you want either one of these amendments you will have to vote against the other.

No. 7. This provides for the creation of a land commission composed of three members instead of one and two members to be of one political faith and the other of the opposite political faith. The present land commission is one man who has control of millions of public land money. This will cause extra expense in the operation of this department but it may also provide for the elimination of graft and a more just and economical administration of this vast department.

No. 8. This amendment provides that not to exceed ten mills may be levied for school purposes. In a greater portion of the state this would cut the school term to five months or less. This is the amendment the school interests of the state are fighting.

No. 9. This relates to municipalities, and the voter should obtain the opinion of experts on that line before casting a vote for or against same.

No. 10. This provides that the county superintendent may serve more than two terms.

No. 11. This is the amendment providing for the \$2,000,000 road bond. Until a means of building permanent roads is devised, this bill should be killed.

Elsewhere in this issue you will find them in full, and you should make a study of them between now and September 20.

**HUMAN BEINGS SOLD ON THE BLOCK IN BOSTON**

Boston, Mass., September 9.—The auction block for men who are without work, but seeking it, was resumed on Boston common today. A woman auctioneer, Miss Viola Roche, held the hammer on the men, who were again stripped to the waist, related their several abilities to labor and called for bids.

The crowds which thronged around the band stand contained many women who took an active part in the bidding. Unlike the auction of yesterday, work for a week or more at wages that carried as high as \$25 a week was obtained by several men.

The party of unemployed went from their west end headquarters to the common through the noon-day crowds in the business district, gathering a considerable audience as they went. The first three men to be put up found jobs among the bidders, two getting two weeks work with board, clothing and pay at the rate of \$25 a week from theatrical producers, and another \$25 a month with food, clothing and lodging for undescribed labor.
