WHAT TYPE YOUR BLOOD? YOU MIGHT WANT SOME OF SAME TYPE SUDDENLY

At a recent session of the Eastland-Callahan County Medical association it was proposed that a "blood pool" be made available in the two counties as a defense measure. This program has been carried out in Chicago, New York and other cities and in every instance has proved to be of untold value to the public.

Only last week in Eastland a resident of that city who was in a hospital in Dallas needed a transfusion of Type Four blood. Eighty Eastlanders of a list of 200 had this type, and several volunteered for the kindly service and went to Dallas to give aid.

Beginning at 8 o'clock on Thursday night of this week at Graham Sanitarium, Cisco, an expert technician will be ready to serve all who call between 8 and 9 o'clock. This will continue through Saturday evening.

Only a very small amount of blood is required and only a slight needle prick is necessary to obtain it. There is no pain. The charge will be 50 cents—actual cost of materials.

Each person would receive a small card with his type, name and address, Wasserman test. This card carried on the person could be the means of saving his or her life in event of an accident where the person required a transfusion.

A printed list of all persons typed, with their types, will be available to every physician in both counties, will be given to state highway patrol officers and also placed in key points throughout Eastland and Callahan counties.

One interesting fact not generally known is that blood types never change after the sixth month of birth.

EAST COAST GAS PRICES UNDER FIRE

(By United Press)

WASHINGTON, Aug. 26.—The senate commerce committee today ordered an investigation of the Atlantic seaboard gasoline shortage and starting a public hearing Thursday.

Coincidentally, Price Administrator Leon Henderson announced the government would act "within 48 hours" to stabilize east coast gasoline prices.

185,000 ACRES LEASED SINCE LAST MARCH

DALHART, August 26.—Five major oil companies and several other smaller companies have leased more than 185,000 acres in Dallam county since March, 1940, a check of county records reveals.

The Texas company has taken approximately 12,000 acres; Pure Oil company, 70,000 acres; Gulf Oil corporation, 60,000 acres; Stanolind Oil and Gas company, 4,000 acres and Sinclair Prairie Oil company, 2,000 acres. Tom Collins of Hartley has taken 13,000 acres, which is reported to be for the Stanolind.

Most of the acreage has been taken on 10-year commercial leases with rentals of 25 to 50 cents an acre per year.

27 TEXANS TO DIE IN LABOR DAY HOLIDAY

AUSTIN, Aug. 26.—The Texas Safety Association Tuesday forecast 27 Texans will be killed, 71 permanently disabled and 900 others injured in traffic accidents during the Labor Day week end holiday period.

The forecast, based on this year's accident trend and the toll taken during the same holiday period last year, was made in connection with a "patriotic appeal" to help the defense program by preventing accidents.

NEW YORK, Aug. 26.—Dress shops locked out 60,000 employees today in a dispute between contractors and jobbers over how much each should pay toward a 10 per cent pay increase recently granted workers.

MUD, RAIN AND REDS HAMPER AXIS FORCES

(By United Press)

The air-borne, mechanized and naval forces of Great Britain and Russia seized the important oil and transportation centers of Iran without serious resistance, as the German offensive in Russia struggled against rain and mud under battering Red army counter-blows.

Moscow reported that strong Soviet counter-offensives on the central front led to a bitter street battle in which a large, unnamed White Russian city was recaptured.

The Germans claimed advances on the Leningrad front, with the capture of the rail junction of Lugo, 90 miles west of the city.

Severe fighting continued on the Lower Dnieper river, in the Odessa area, with Russians reporting the destruction of a Rumanian division and defeat of two others outside of Odessa.

At Vichy more than 100 members of parliament met in a rump session to organize opposition to the Petain regime.

Japanese cabinet met to consider increasing American and British efforts to halt Japanese expansion. A "bitter debate" on foreign policy was reported.

TROOPS TO SINGAPORE.

SINGAPORE, August 26.—The British empire's formidable fighting strength in the Far East again was increased today, soon after Prime Minister Churchill's pledge of support to the United States in the event of trouble with Japan in the Far East. Besides the largest single body of Royal Air force personnel to arrive here in more than a year, transports disgorged strong Indian reinforcements at Malayan ports.

(There were twenty-four private banks and exchange brokers, including one at Dallas, but none at Fort Worth.)

E. M. Pease was governor of Texas at a salary of \$4,000. Heads of other state offices drew salaries of \$2,500 down to \$1,000. Supreme Court Judges received \$4,500 each; District Judges \$3,500 and District Attorneys \$1,000. (The best I can figure out from listing there were 146 counties in Texas.)

Total receipts of the government of the State of Texas, May 31, 1888, were \$2,844,532.19. Total value of all property assessed, \$170,005,545. Tax on some at \$15 per \$100, was \$255,008.31. Cost of meeting of State Legislature for the year 1886 totaled \$70,661.83. (Governor Coke Stevenson estimates it will cost Texas \$100,000 for a special thirty-day session of the present Legislature.)

EDSON'S WASHINGTON COLUMN

One Man Labor Department Pacifies Hawaiian Labor Troubles by Application of Horse Sense

WASHINGTON—The whole U. S. Department of Labor for the Territory of Hawaii came to Washington on leave the other day, but before you conjure up any mental image of a host of bureaucrats on a junket, please be advised that the department in Hawaii consists of Mr. Howard Durham—which is a pleasing variation from the usual pattern of a government office holding anywhere from a couple of dozen to a couple of hundred.

Durham, a young lawyer of 35, went to Honolulu from San Francisco a few years ago as an inspector for the wages and hours division of the department, but when he got there the department started shooting other problems at him. Before he knew it, he was representing not only the wages and hours division, the child labor division, and the conciliation service, but he was also administering the Walsh-Healy act covering construction projects for Army and Navy expansion, and starting an apprentice training program for defense industries.

The interesting thing about Mr. Durham is he seems to have won the confidence of both the employers and employees of the island's industries, and in a manner which shows what can be done in administering these new labor laws, in seeing that everybody gets a square deal. Even Samuel Wilder King, the Republican delegate from Hawaii to Congress since 1925, admits that Durham's management of these controversial matters has been well done.

GETTING back to Mr. Durham, his method of handling these situations was to go quietly to the employers and explain the laws, then help set up working conditions that brought operations within the scope of the labor statutes as to minimum wages, overtime provisions and hours. More than 3000 individuals got nearly \$100,000 in extra pay, but the publicity on the awards and settlement of the cases was kept at a minimum. Nobody had any chances to crow about great victories or defeats.

Longshoremen's and stevedores' disputes gave most trouble and the biggest feather in the Durham Hawaiian cap was the working out, with a Maritime Labor Board mediator, of what is now referred to by Delegate King as a model stevedore labor contract for the Castle & Cooke Terminals, Ltd., one of the biggest factors in Hawaiian industry.

Under the terms of this contract, for the first time under the American flag, if not for the first time in the world, stevedores are given a guaranteed 40 hours of work a week, year in and year out, whether work is available or not. The way this worked out, Honolulu stevedores received a guaranteed average wage of \$2140 a year in 1940, and all uncertainty as to employment was ended.

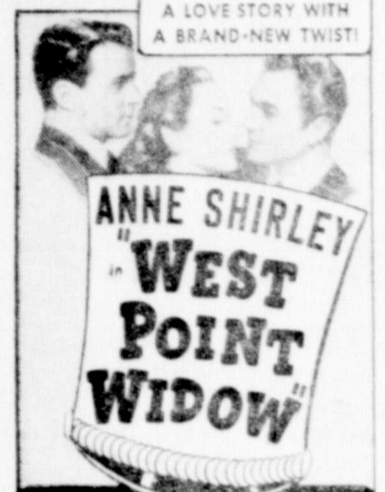
