SENATOR O'DANIEL HAD BIG LEAD AT 12:30 A.M.

SEVERAL DAYS MAY ELAPSE BEFORE FINAL COUNT IS IN; COKE STEVENSON DISTANCED COLLINS

True to form, United States Senator W. Lee O'Daniel at 12:30 o'clock this morning was leading far ahead of his opponents...

Percentages of the vote counted at 12:30 a. m. were as follows:

W. Lee O'Daniel, 45.98. James V. Allred, 33.60. Dan Moody, 19.22.

The actual votes counted gave O'Daniel 206, Allred 138,242, Moody 78,076 and 4,939. A total of 410,463 votes.

In the governor's race Coke Stevenson had 787 votes, while Hal H. Collins could only get a total of 110,758 -- which seemed to be Governor Stevenson's election.

For lieutenant governor John Lee Smith 69,442, Beck 58,037 and House 50,463. Vote seems to indicate a run-off.

NEW TAX PLAN IS OFFERED

WASHINGTON, July 25.—Sen. Ed C. Johnson (Democrat, Colorado) today proposed substitution of a plan calling for income tax payments in monthly installments for the "withholding" method incorporated in the \$6,270,960,000 war revenue bill.

The withholding plan, proposed by the treasury and approved by the house, came in for criticism by members of the senate finance committee yesterday and Johnson contended a monthly installment requirement would meet most objections.

Under the house bill, employers beginning Jan. 1 will deduct 5 per cent from workers' pay checks each payday, the money to be paid to the government as an advance on 1943 taxes.

EASTLAND SCHOOL BOARD DROPS FOOTBALL COACH, BAND DIRECTOR, MUSIC TEACHER THIS YEAR

EASTLAND, July 25.—A statement made by the local school board this week sets forth plans for the coming school year.

Because of present economic conditions and the fact that many Eastland citizens are temporarily residing in areas where defense work is plentiful, it will be necessary that local expenses be cut considerably, according to members of the board.

The drop in scholastic census of course means a drop in state aid to the school.

Board's Statement. "The local board, at two recent meetings, has been wrestling with the problems arising from the war activities and resulting migrations of Eastland residents and school patrons."

"The scholastic census has disclosed that there is a marked decline in the number of children of school age, since a number of parents have left to accept temporary employment in defense projects. With this resulting reduction in enrollment, there will be a corresponding reduction in the amount of funds allotted for school maintenance by the state school board.

Some loss in tax collections is also anticipated unless the citizenship responds patriotically to the appeals of the equalization board now in session.

"Various plans of retrenchment have been suggested to and surveyed by the trustees. They first considered reducing expenses by combining the two ward schools. This would result in the saving of about \$500.00 per year in teachers' salaries, janitor hire and utility bills. However, this plan was finally rejected because of the resulting inconvenience to the small first and second grade pupils whose parents were without transportation facilities.

"Since some economy had to be effected, it was finally voted to do without a football coach, a band leader and a music teacher for the coming year. In so doing, about the same saving is accomplished as the closing of one ward school.

"For the past several years the school's football schedule has resulted in a loss of expenses exceeding the gate receipts by several hundred dollars. As much as the board hated to eliminate this very popular and worthwhile activity, it was felt that perhaps this would cause the least inconvenience and affect the general school work less than any other plan.

"The school board has recently worked out a refunding of the bonded debt whereby a substantial saving in interest charges has been obtained."

The board ends its statement by saying: "If the citizens will respond to our appeal for a liberal and sympathetic program of tax reductions and tax payments within the school district, and in entrenchment, there is no reason why our public school work cannot be continued on the high plane it has heretofore occupied."

PRESIDENT ROOSEVELT TO FIGHT INFLATION BY EXECUTIVE RULE RATHER THAN WITH LEGISLATION

WASHINGTON, July 25.—Congressional sources familiar with White House plans disclosed today that President Roosevelt has virtually decided to meet inflationary trends in wages, farm prices and rents by executive action instead of legislation.

Still subject to an eleventh-hour change, the president's reported decision was reflected in what amounted to an unofficial congressional recess until September.

Members of both senate and house scattered to their homes for a long-needed rest and to strengthen political fences in preparation for the fall elections. Leaders remained behind in event the president should find it necessary to change his plans but they, too, are expected to leave shortly.

It was learned Mr. Roosevelt has been advised by his legal experts that section one of the price control law gives him sufficient authority to block all general wage increases which he considers "inimical to the public interest."

He also has been advised, it was said, that general rent control would be possible to all practical purposes under the present law. But prevention of further increases in farm prices presents a more difficult problem.

The president, it was learned, was urged by his legislative leaders this week to take the fight against inflation in his own hands if possible.

He had suggested that congress enact a short resolution empowering him to "fix prices and control wages," with as great dispatch as possible, warning that the inflation crisis will be at hand in another month. Leaders replied that the committee to which the resolution would first be referred probably would require that much time to question Price Administrator Leon Henderson.

Tips On How To Avoid Mowing Machine Break-Downs



Lubricate pitman every half hour. This is a high-speed moving part, and rapid wear develops unless it is frequently lubricated. Use a high quality lubricant that is adhesive and will stick to its job and not be thrown out by the centrifugal force of the rapidly turning pitman.



Lubricate crankshaft bearings once an hour. Bearings wear out quickly unless adequately lubricated. Lubricate pawls inside wheels once a season. Watch for end play in wheel bearings, and eliminate by making adjustments.

Watch for and eliminate end play in the pitman as soon as it develops. If these few tips are carefully followed, the farmer can avoid the more common "mowing machine" break-downs, and save metal and repair bills.

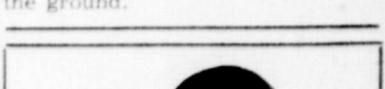

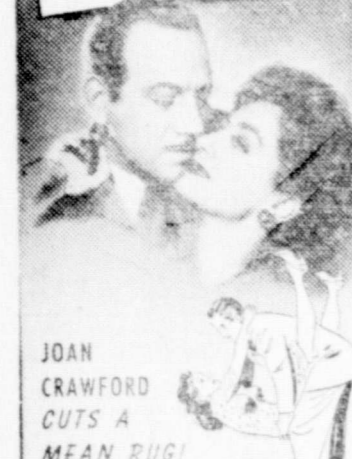

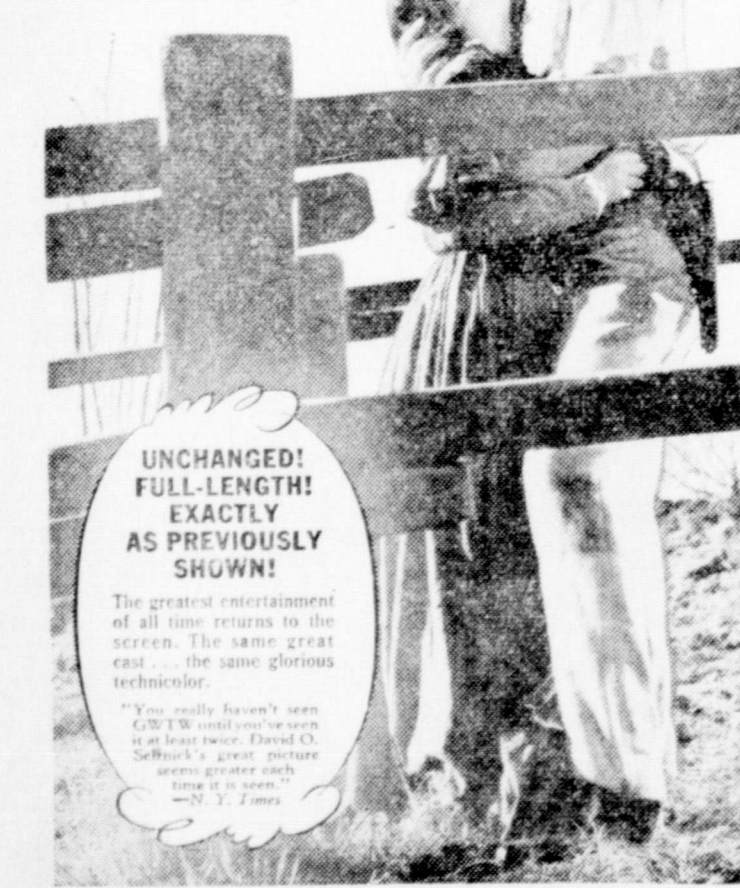

cent of parity, the 1919-1929 average or the levels prevailing last Oct. 1 and Dec. 15, whichever is higher.

In a discussion of this phase of the inflation problem at the White House earlier this week the precedent established by President Abraham Lincoln in suspending the constitutional provision for habeas corpus was discussed.

The talks did not contemplate suspension of habeas corpus by Mr. Roosevelt but rather surveyed the powers of the president to act in time of war for the preservation of the nation.
