David A. Metcalf, native born Ciscoan and graduate of Cisco high school, who served almost three years with the army air forces, left today for New York City for a short visit with friends at Roosevelt Hospital, that city. He will return to Cisco in time to enter Cisco Junior College on January 27. He was in his first year at Junior College when drafted.

Metcalf, a corporal when discharged from the service recently at Camp Fannin, is a son of Mrs. Iva Metcalf, who resides on east Tenth street.

Metcalf served with the Ninth air force in Europe for 21 months, working in basic communications, teletype and flight operations. He was in Scotland and England for three months and in Germany about five months. The rest of the overseas time was spent in France and Luxemburg. He stated that the most interesting organization to which he was attached was the 363d fighter squadron.

To the Citizens of Eastland County:

"After due deliberation I have concluded to make the race for sheriff of Eastland county.

Nation's Labor Trouble is Moving Toward New Crisis

Course in Auto Mechanics Opens Eastland County Amvets Organize; Here on Jan. 7 Ask For Charter

At a meeting of owners and managers of the various automotive concerns of Cisco, held at the chamber of commerce Wednesday night, it was decided to bring a school for advanced auto mechanics to Cisco.

The short twenty hour course will be given here by the division of extension, University of Texas, beginning Monday night, Jan. 7, 7:30 o'clock. Meetings will be held at the chamber of commerce.

The course will be in engine tune-up and automotive electricity. Fundamentals of electricity, how the automotive units are built and operate, repair procedures and use of testing equipment will make up the contents of the course.

Class discussions and demonstrations will be of practical nature and tie in directly with the mechanics' every-day work and problems. Blackboards, films, charts and models will be used for instructional purposes.

On the job assistance will be available to class members during their regular working hours. This service includes assistance in the use of testing equipment in the shop, and diagnosis and repair of troubles that might exist in automotive electrical units.

The course will be conducted here by Elmer Frede, automotive instructor from the trade and industrial extension division of the University of Texas.

Mr. Frede has many years of experience in the automobile business, has attended various factory and trade schools and has received special training in the teaching of vocational and trade subjects. The courses are being held on a state-wide basis and Mr. Frede comes here from Lubbock, where 53 men were enrolled in class groups.

All mechanics of Cisco and vicinity are invited to be present for the Monday night meeting. Veterans of world war two who are again entering the trade are especially invited to be present.

A fee of two dollars per person for the entire course will be charged. This includes the cost of a reference manual which becomes the property of the enrollee. Mr. Frede stated there is nothing else to buy.

Each class will last about two hours and meetings will be held Monday night of each week until the course is completed.

The course is being made possible here through the cooperation of Cisco Junior College and the chamber of commerce.

EASTLAND, Jan. 3. — The second meeting of Eastland county world war 2 veterans known as the "AMVETS" was held the 30th of December in the court house.

There were about sixty-five veterans representing all of Eastland county at the meeting. Also present were George R. Porter, of Ft. Worth, state commander of the "AMVETS," Clay Smith of Ft. Worth representing the Small War Plants Corp. of Dallas, and Hank Woods of Ft. Worth representing the Ft. Worth Post, with Mrs. Tom Lovelace, Sr., state historian of Amvets council. Mrs. Clay Smith and Mrs. Hank Woods of Fort Worth were visitors.

The meeting was opened by Temporary Chairman W. A. Leslie with the reading of the minutes of the first meeting. Chairman Leslie then introduced George R. Porter, state commander, who explained the purpose of the Amvets and told of some of their accomplishments.

Mr. Woods of the Ft. Worth Post gave a short talk on the benefits of the Amvets, and Clay Smith gave a very interesting talk on surplus commodities available to veterans.

A discussion was called by Chairman Leslie for the election of post officers. A motion was made and passed to nominate officers to serve for a period of not longer than three (3) months. The following officers were elected: W. A. Leslie, acting post commander; Harry C. Hall of Carbon, acting finance officer; Tom Lovelace, Jr., acting executive secretary.

The meeting closed with the collection of dues and the signing of the request for a post charter.

The next meeting of Eastland County Amvets will be held the 13th of January, at 2 o'clock Sunday afternoon, in the K. of P. lodge hall, over White's Auto Store.

Secretary's Statement.

Tom Lovelace, acting secretary, has issued the following statement:

There may be misunderstanding in the minds of some veterans about this post being an Eastland county post. What we are striving to do is to get at least one post organized in the county; after this is accomplished we are going to help organize local posts for each town in Eastland county.

If you are a member of the Eastland county post at the time your local post is chartered, you can then transfer your membership to your home town post. We hope to have a permanent county post and at least once a month have a meeting of all local posts.

The nation's labor trouble moved toward a new crisis today. Sixty-eight thousand Western Electric company employes began striking at 10 a. m. CST, with the first workers leaving their jobs in New York and New Jersey.

In addition, the first of 10,000 workers who threatened to paralyze the New England industrial city of Stamford, Conn., began leaving their jobs shortly before noon.

The Stamford walkout was a city-wide sympathy strike called in an effort to effect a settlement in Yale and Towne's 57-day-old labor dispute.

The Western Electric company strike was one of half a dozen disputes which threatened to paralyze major industries unless agreements can be reached on wage demands. Union leaders expected Western Electric employes across the nation to walk out.

There is a possibility the Western Electric strike may be supported by a sympathy walkout of 250,000 telephone operators who use Western Electric equipment.

Even more critical walkouts loomed, however, in the nation's steel and meat packing industries. Government experts were continuing efforts to head off the Jan. 14 steel and Jan. 16 meat packing walkouts scheduled by CIO unions.

There also was a possibility of a strike by the nation's shipworkers. No progress was reported in the General Motors walkout. The glass workers walkout continued. And there was little progress toward a settlement of the oil industry dispute.

U. S. Spending Declined Rapidly At War End

WASHINGTON, Jan. 3. (UP) — Government spending in the first six months of the 1946 fiscal year totaled \$38,574,000,000 — a drop of almost \$10,000,000,000 from the same period of the previous year, the treasury announced today.

The drop was due mainly to the mass war contract cancellations which followed Japan's surrender in August.

Fred Vinson Has More Bank Book Worry Than You

WASHINGTON, Jan. 3. — If you think you had bank-book troubles Dec. 26, give a thought to Fred Vinson and his duty after Christmas.

His treasury department statement for that day has just been released. It is worth looking at, for two reasons: First, the contrast (the deals in hundreds of billions); and, second, the similarity (this debt is big, too.)

It shows that the gross public debt through Dec. 26 was — take a deep breath — \$278,432,185,872.41.

This compares with the debt on Dec. 26 of last year of — don't breath quite so deeply — \$231,649,425,291.80.

It also shows that the treasury's net receipt for December through the day after Christmas were \$3,601,475,281.32. This compares with \$4,720,755,485.68 for the corresponding period of 1944.

But here's a bright side. Expenditures, total expenditures, including public debt retirement, were \$4,052,780,408.06 for December through the 26th, and this compares with \$6,720,098,233.81 for the corresponding period last year.

BULGING WITH MONEY.

FT. WORTH, Jan. 3. — Tarrant county bank deposits passed the \$40,000,000 mark on Dec. 31, the 10 banks of the county reported Thursday in response to calls for statements of condition of state and national banks. The all-time record deposit figure was \$400,678,054.51, a gain of nearly 15 per cent over the previous high, which was reported last.

TO AID STRIKERS.

NEW YORK, Jan. 3. (UP) — A group of prominent Americans, including Mrs. Eleanor Roosevelt and churchmen of all faiths, has been formed to give financial aid to the families of striking General Motors workers, it was announced today.

Texas Produced Bint Announces 752,355,189 Barrels Oil in 1945 Commission, Pre. 4

AUSTIN, Jan. 3. — The engineer department of the oil and gas division of the State Railroad Commission has reported in a statistical review of 1945 that Texas produced 11,000,000 more barrels of oil in 1945 than during the previous record year.

The department explained to Railroad Commission Chairman Olin Culberson that some figures for November and December had to be estimated to bring the figures up to Jan. 1.

During 1945 Texas produced 752,355,189 barrels of oil. Production for 1944 was 741,126,397 barrels. There were 101,859 producing oil wells in the state as of Dec. 31, 1944, compared with 103,239 wells on the same date in 1945, the report said.

The amount of carbon black produced in 1944 was 483,278,373 pounds, compared with 662,912,593 pounds in 1945. Texas had 92,200,995 pounds of carbon black stored in 1945, against the 1944 storage figure of 54,558,974 pounds.

The report estimated that the total sweet, sour and casinghead gas production in Texas for 1945 was 2,648,069,745,000 cubic feet, approximately 213 billion cubic feet more than the year previous.

TRAITOR JOYCE DIES.

LONDON, Jan. 3. — William Joyce, notorious "Lord Haw Haw" of the German air waves, died a traitor's death this morning on the gallows of Wandsworth prison. The 40-year-old American-born Joyce, who sold his voice to Adolf Hitler as a radio propagandist at the outset of the war, was executed shortly after 9 a. m.

JEWISH PLOT DENIED.

FRANKFURT, Ger., Jan. 3. — Judge Simon Rifkind, adviser on Jewish affairs to General McNarney, U. S. commander in the European theater, today described as "poppycock" reports that a "world-wide Jewish conspiratorial arrangement" was behind the infiltration of Polish Jews into the American zone.

Gate Receipts at Cotton Bowl Game Total \$154,999.40

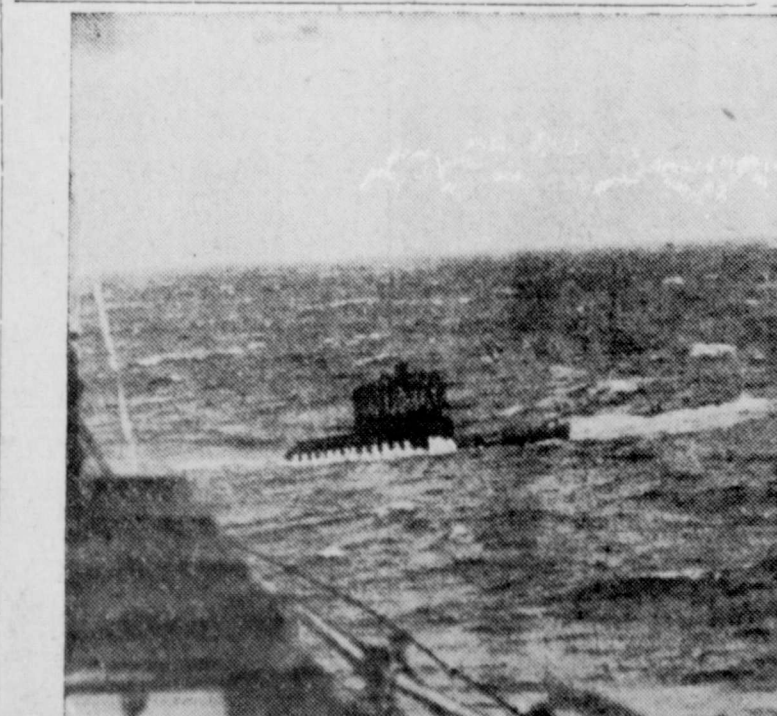
DALLAS, Jan. 3. — All Cotton Bowl records for gross receipts and spoils for the competing teams were broken in the tenth annual classic here Tuesday, Game Director James H. Stewart says.

The attendance only equaled that for the 1941 game between Texas A. & M. College and Fordham because there were no more seats to sell. Both games were sellouts. The seating capacity is 45,507.

A difference in the scale of prices raised the total take for the 1946 party and the split for the teams despite the fact that the tax now is 20 per cent compared with 10 per cent when the Aggies met the Rams.

The gross gate this year was \$154,999.40.

Stewart declined to give actual figures on the amount harvested by the contesting teams, but each collected 42½ per cent of the net and he admitted that \$55,000 apiece would miss the mark not more than a few hundred dollars.

DANGER SIGN FOR LABOR.

(Ft. Worth Press)
Stating the administration's position on the ability-to-pay issue in wage negotiations, Reconversion Director John W. Snyder says: "Whether wage increases can be granted, and to what extent, can in the final analysis only be judged by asking a common-sense question — How much of an increase can the individual company afford to pay if it is to meet its payroll and stay in business? If a company cannot stay in business, obviously it cannot continue to employ workers."
If we were a labor leader — and from that point of view only — we would want to take a good second and third and fourth look

at such a policy before cheering it. Especially, since the policy is one that would be administered and enforced, not by labor and management, but by government. That being the ultimate purpose of the administration.

While Mr. Snyder speaks of increases in this matter, which primarily affects successful industries, where might that policy finally lead labor?

We say again — ours is not just a profit system.

It is a profit and loss system.

More businesses fail than succeed.

To repeat from the record: nearly one-third of new business enterprises fail in their first year. Another 14 or 15 per cent fail in their second year.

And very nearly 70 per cent are gone by the end of five years.

Now, apply to labor, over the long haul, the Snyder philosophy of "how much can the individual company afford to pay if it is to meet its payroll and stay in business?"

What would the government

agency, empowered by law to enforce its decisions, do when the losers come up? Might it not rule that wage cuts were necessary for the losing industries to meet their payroll and stay in business and maintain employment? The answer could very logically be yes. And the decision would rest in the government.

We think one vital thing is being overlooked by both administration spokesmen and labor leaders in this whole consideration. It is the element of risk capital. From such capital — the accumulated savings of those who are willing to take a chance — comes the payroll in losing ventures which are being operated in the hope of ultimate success.

Nothing could be more unfair to the worker than that he should be paid less than a good living-wage just because a company employing him was losing money.

But it could happen under the governmentally administered principle enunciated by Mr. Snyder — the principle of how much can the individual company afford to pay if it is to stay in business?

And that's the danger — not to capital, but to labor.
