

Swifts fall in 'almost perfect' final

with LaRue LaPoynor winning in overtime, 47-43. Backus, playing in his second state championship game, paced the Swifts with 12 points and was named to the all-state tournament team.

It was *THE* almost perfect basketball game. Can you imagine a basketball game, in the 1980's, with no whistles — for ANYTHING — in the first quarter, the first 6:02 of the second quarter, in the last 5:15 of the third quarter? No whistles for a foul, a turnover, a rebound fumbled out of bounds.

And to add to a true basketball lover's delight, overtime.

Both teams — Nazareth and LaPoynor — played their hearts out for 35 minutes Saturday in the State Class A finals in the Frank Erwin Specials Events Center in Austin. It was a shame from the very onset that one of the teams would have to lose. It was a matter of someone having a little better luck, something small that would matter a great deal in the end, that would prevent one of these teams from being the best team in the state.

The biggest shame was that Nazareth, the team that forced the bigger and perhaps more talented LaPoynor Flyers to play a different brand of basketball, really did only two little things wrong all during the game.

Those two little things brought the world crashing down on the Swifts, leaving them one win short of the state title for the second consecutive year after a 47-43 loss to the Flyers.

The loss probably ended a personal dream for Nazareth coach Joe Lombard — the dream of a double championship in boys and girls basketball in the same year.

"I don't know if I'll be back next year with the boys or not," Lombard said Saturday. "It's awful tough — this year was so important to me because it's so tough coaching both teams. I don't think I want to coach both teams next year."

Coach Carl Dunklin was still in a bit of shock an hour after the game.

"It was a Cinderella win and a Cinderella season for us," Dunklin said of his unranked LaPoynor club. "I looked at Naz Thursday and I said to myself, 'They have no weakness.' They're so fundamentally sound — they take care of the ball, shoot the ball well, block out and rebound. The only thing they lacked was something you can't coach — quickness."

Cinderella reared her ugly duckling head at the most untimely spot in the game, with five seconds left in regulation, as Nazareth was trying to set up a last second shot with the game tied at 40.

Ricky Backus, who led the Swifts with 12 points, was dribbling the ball against a trapping flyer press near midcourt. He collided with LaPoynor guard Randy Hurd and was charged with walking. Kerry Pettie got the inbound press and put up an airball from 17 feet as time ran out.

"We told them to call time out with :15 left unless they had the opportunity to go ahead and penetrate and try to score," Lombard said. "Ricky was trying to do just that, when he was called for walking...I guess it was just a judgment call on whether he got fouled or walked."

That little thing prevented the Swifts from a chance to win the game in regulation. The other little thing that went just wrong cost the Swifts a gold medal.

Trailing 42-41, Naz went into a control game, content again to run down as much of the clock as possible, but flyer Curtis Steger knocked the ball away from Chris Gerber, then missed a six footer with :30 left. Darryl Street got the offensive rebound, and put in a seven foot follow-up and was fouled by Backus. Street canned the free throw to put the Flyers up by four, 45-41, with :25 left to play. Backus cannot

Late run fills ballots

Several contested races will mark the ballot April 6 in elections for city, school and hospital officials in the county.

In the Dimmitt city race, incumbents Wayne Collins and Ferne Jones will be uncontested in their try for new terms as mayor and municipal judge, respectively.

Four persons, incumbent David Hays, former City Manager Garnett Holland, Jim Naylor and Jack Thompson, have filed for the two seats open on the Board of Aldermen.

Eight persons will be running for two spots open on the Dimmitt School Board. 12-year veteran Charles Wales, current Board president, will not be seeking re-election.

Incumbent Glenn Odum will be joined by Kellie Proffitt, Randy Schumacher, Johnny Hucks, Richard Hunter, Carter

Townsend, Cheryle Pybus and Teddy Smithson on the ballot. Seven persons will be running for the three seats up for

grabs in the county-wide Hospital Board race. Incumbents James Welch, (Continued on Page 12)

CCHD-Nursing home bill should pass

A bill that would authorize the Castro County Hospital District to operate a nursing home has been passed by a Texas House committee, and will soon be heard by the full House.

Former Texas Speaker of the House Bill Clayton, now working for Capital Consultants of Austin and lobbying for the legislation, said the bill should pass the House without any problems, and also expects few problems in the Senate.

Among other items, the bill outlines the power of the hospital district, which operates Plains Memorial Hospital in Dimmitt and the county ambulance service. A move started over a year

ago to establish a new nursing home in Dimmitt after several county residents voiced displeasure with the former owners of South Hills Manor, now under new ownership and known as Canterbury Villa.

PMH administrator Marshall Cook said a nursing home run by the CCHD would run as a competitive operation, and would require the construction of a new building.

Cook said the hospital-operated facility would offer several advantages in care, but would not share its staff with PMH.

Savings would come from sharing administration, laundry and kitchen facilities, according to Cook.

Family sued for 'wrongful death'

Unspecified damages are being sought in a wrongful death suit filed by the 242nd District Court in Hale County by the family of three Hart residents killed in a Dec. 1 traffic accident near Plainview.

Named as defendant in the suit is the estate of Robert Anthony Gonzales, also of Hart, who was also killed in the accident on SH 194.

According to the suit filed by Lubbock lawyer Mike Millsap, Gonzales was the driver of a 1984 Chevrolet pickup that crossed the highway's center line and collided head-on with

the 1981 Camaro driven by Josie Garcia.

Gonzales was eastbound, Miss Garcia westbound at the time of the accident. The suit alleges negligence on the part of Gonzales.

Miss Garcia and two of her step-sisters, Patricia and Lee Centeno, were killed in the accident. Two other passengers in the Camaro, Elvira Centeno of Hart and Susan Garcia of Plainview, were injured in the wreck, which occurred about 9 p.m. eight miles west of Plainview.

After Nazareth's Swifts and LaRue LaPoynor's Flyers went to their dressing rooms at halftime, with the Swifts leading 22-20, the PA announcer commented: "Ladies and gentlemen, even though it's only halftime, I think you will agree that we're watching one of the best-played championship games in the long history of Class A basketball."

It was a Texas-size claim, but accurate, and the crowd of 8,500 agreed with applause.

The Swifts had scored on each of their first six trips down the court, and were controlling the tempo of the game

— something which seven-time state champion Snook had been unable to do against the Flyers in the semifinals.

There had been only one foul in the first half, and no free throws. There had not even been a whistle blown in the entire first quarter.

When LaPoynor's Randy Hurd stepped to the line with 5:15 remaining in the third quarter, the announcer reminded the crowd: "This is the first free throw of the game." Only five free throws were taken, and two were made — one by each team.

Commissioners seek courthouse cleanup

Castro County's Courthouse will be getting a facelift in the near future, as county commissioners agreed Monday to advertise for bids for refurbishing work.

According to County Judge Polly Simpson, caulking is coming out from around windows all around the courthouse, and mortar between the marble blocks has worked out in some places.

"Plus, it's dirty, and needs to be cleaned," Mrs. Simpson said.

The commissioners have budgeted up to \$30,000 for the work, which is expected to include cleaning all outside surfaces, inspecting mortar joints, caulking where needed, and repairing of stone and metal.

Commissioners are hopeful the work can be done for less than \$30,000 budgeted for the project.

Commissioners also agreed to divide with the City of Dimmitt the cost for a new vehicle for the Volunteer Fire Dept.

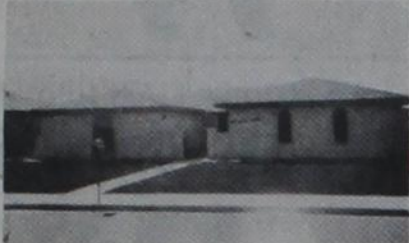

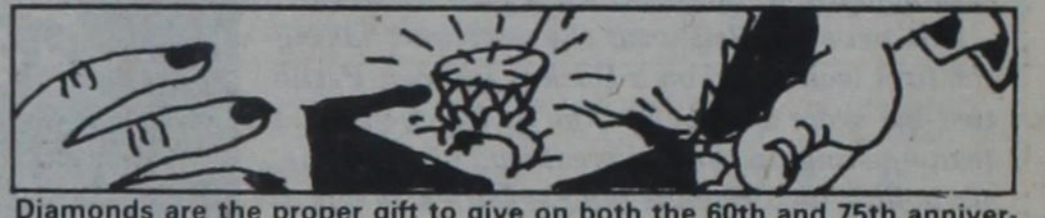

ed a 14-footer with :14 left to play, then fouled after LaPoynor inbounded.

The foul was just the fourth of the half on the Swifts — their fourth of the game, all on Backus — and LaPoynor broke Eddie Pace clear, into the forecourt, for the final layup of the game on the ensuing inbound pass.

Pettie had led LaPoynor in its upset of Snook Thursday, but the 6-4 senior took just 11 shots in the game, canning six of them, as Naz had as many as four people between him and the goal anytime he had the ball.

"Our main objective was to try and stop 20 (Pettie)," Gerber said. "We doubled on him, and had our top people (the ones who play the point in the Swifts 2-3 zone) come inside to help out."

Pettie got just one dunk in the game, with 5:04 left in the third quarter after making a steal, but the Swifts said it didn't bother them.

"Coach had talked with us before the game, because he thought (Pettie) would slam one sometime," Gerber said. "It was just like a 30-footer. It just counted two points."

In fact, the Swifts did counter with a Randy Leavitt tip-in just 20 seconds later to re-establish a four-point lead.

Naz never trailed until the overtime, taking the first lead at 2-0 on a Backus jumper. Pettie tied the score at 2, before the Swifts went on a tear, opening up their biggest lead of the game, six points, on a Backus jumper with 4:44 left in the opening quarter at 10-4.

Pettie had six of the 12 LaPoynor points in the first quarter, but just 12 for the game that saw Nazareth slow the tempo against a much quicker Flyer team.

"I felt our guys played really well," Lombard said. "We did everything we wanted to do, we defended them just exactly the way we wanted. The zone did its job containing Pettie."

"We sure didn't want to slow it down," Dunklin said. "We want to run the ball when we get the chance, but Nazareth made us play it their way."

Making LaPoynor play the game its way made the Swifts an even ball club with the Flyers ("Give LaPoynor credit — they've got a fine ballclub with maybe better talent and more quickness overall," Lombard said). Naz shot 49%, LaPoynor 46; rebounds were even at 26.

"We ended up being two evenly matched ballclubs," Lombard said. "Turnovers hurt anytime, especially at the end of the game. It was a clean game, but we just didn't make the big play at the end of the game like we needed."

"We need to give credit to our three seniors — Gerber, Backus, and Russell Hoelting," Lombard said. "They played hard all year and deserved to win. They practiced hard and showed outstanding leadership."

"We had a hardworking team," Lombard continued. "We weren't very pretty — maybe we won them ugly — but our leadership carried over to help all of our team. We've got a bunch of good young kids, but it's going to take more than just talent for them to get back down here next year. It won't be easy for us."

BOY! WHAT A SEMIFINAL GAME!

The tone was set for an outstanding state tournament Thursday morning when the Swifts overcame a seven-point deficit to down Munday 44-42.

The opening game of the tourney saw two teams looking as if the cobwebs weren't quite shaken, out from waking up at 5 a.m. to prepare for the 8:30 a.m. game.

★★★★

"I thought all along we'd win — I thought all along we had the better ball club," said a relieved Lombard. "We just didn't play for the first three quarters. We just didn't perform like we were capable through the third quarter."

Hailed as a hero was Gerber, who went scoreless through the first half as Leavitt came off the bench to keep the Swifts close to the Moguls in the second quarter with six points.

Gerber had five points in the third period

and six more in the fourth quarter, including two free throws with :12 left that sent the Swifts into Saturday's championship tilt.

The senior guard had hit just 1 of 5 free throws in the game when he was fouled by Anthony Stinnett with just eight seconds left.

"My first three or four free throws were bricks," Gerber admitted. "I just relaxed and shot (the free throws) like I was in practice."

Gerber swished the two charity tosses after a Munday timeout, then went down to help Backus guard Dent Offutt.

"I thought for sure they would let (Offutt) take the shot," Gerber said. "I was helping off on him. My man (J. B. Jones) was wide open, and the only chance I had was to get a piece of it (the ball)."

Jones had put up a similar 15-footer with 12 seconds left to tie the game at 42, but Gerber blocked the last shot, which sailed harmlessly to Backus along the right baseline to seal the semifinal win.

Nazareth almost didn't have a chance to have any last-second heroics as the Moguls broke open a contest that had been tied a dozen times to forge a 42-35 lead after three quarters. Most of the ties had been in the early going as the teams suffered through bad-luck shooting stretches in the first half as shots that would normally fall with no trouble bounded out of the basket.

Munday forged a 10-8 lead and maintained that lead through halftime as the Swifts were denied shots at the very end of the first and second quarters (the shots were in the air before the buzzer sounded, but the clock had run out, triggering the red floodlights under each basket that signal the end of each period).

Nazareth came back to take a 28-27 lead, but Munday jumped to a seven-point advantage, 35-28, at the end of the third quarter.

The fourteenth lead change of the game came with 4:36 to play, as the Swifts outscored Munday 10-2 in the early going of the fourth quarter to grab a 38-37 advantage. After Steffens had missed a free throw, Russell Hoelting rebounded and missed, then Steffens rebounded and was fouled by Kregg Sanders. Steffens put in the free throw to give the Swifts their first lead of the fourth quarter.

Frank Stinnett then put in a free throw to tie the score again, and Munday took its last lead, 40-38, on Collier's inside shot with 2:29 left.

Hoelting then canned two free throws to tie the game at 40 with 1:48 left, then partially blocked Collier's shot on the other end. Steffens was fouled on the ensuing rebound, and made the front end of the one-and-one to put the Swifts up 41-40 with 1:26.

Freshman Chris Schmucker made his only point of the game with :30 left, canning the front end of a one-and-one to put the Swifts ahead 42-40. Jones shot with :12 left then set the stage for the Gerber heroics.

"I think we just played a little harder in the fourth quarter," Lombard said, "as if we realized we had to do it now or it would be too late. I just think we played with some confidence and intensity (in the fourth quarter). In the first three quarters, the firmness wasn't there."

Heat after workout could be dangerous

Plunging into a hot tub or sauna after a vigorous workout can be dangerous, warns a medical expert on physical fitness.

Alan Herd, M.D., professor of medicine at Baylor College of Medicine, warns that a hot shower, whirlpool or sauna after strenuous exercise can result in dizziness and fainting.

During physical exercise, the heart must beat harder and faster to pump blood to the muscles, Herd explained. Some blood vessels in exercising muscles will expand to increase blood flow to the heart.

"The hot environment can dilate all the blood vessels and blood will collect in the legs because the muscles are relaxed. This, and the fluid lost during exercise can cause a person to collapse from the decreased blood pressure," said Herd, who is director of the Sid Richardson Institute for Preventive Medicine of The Methodist Hospital.

Just as he encourages people to warm up before exercise, Herd recommends a cool-down period immediately after exercising, and waiting at least half an hour to one hour before entering a hot environment.

The longer the warm-up, the less rise in blood pressure and the less amount of work the heart has to do, Herd said. The cool-down is equally important.

"It is the movement of the muscles during the cool-down that keeps the blood returning

to the heart and prevents sudden loss of blood flow back to the heart," Herd said. "That would be dangerous to people who are overheated and tired and suddenly stop moving. They could collapse and lose consciousness."

Herd sees no cardiovascular benefit from a sauna or hot bath.

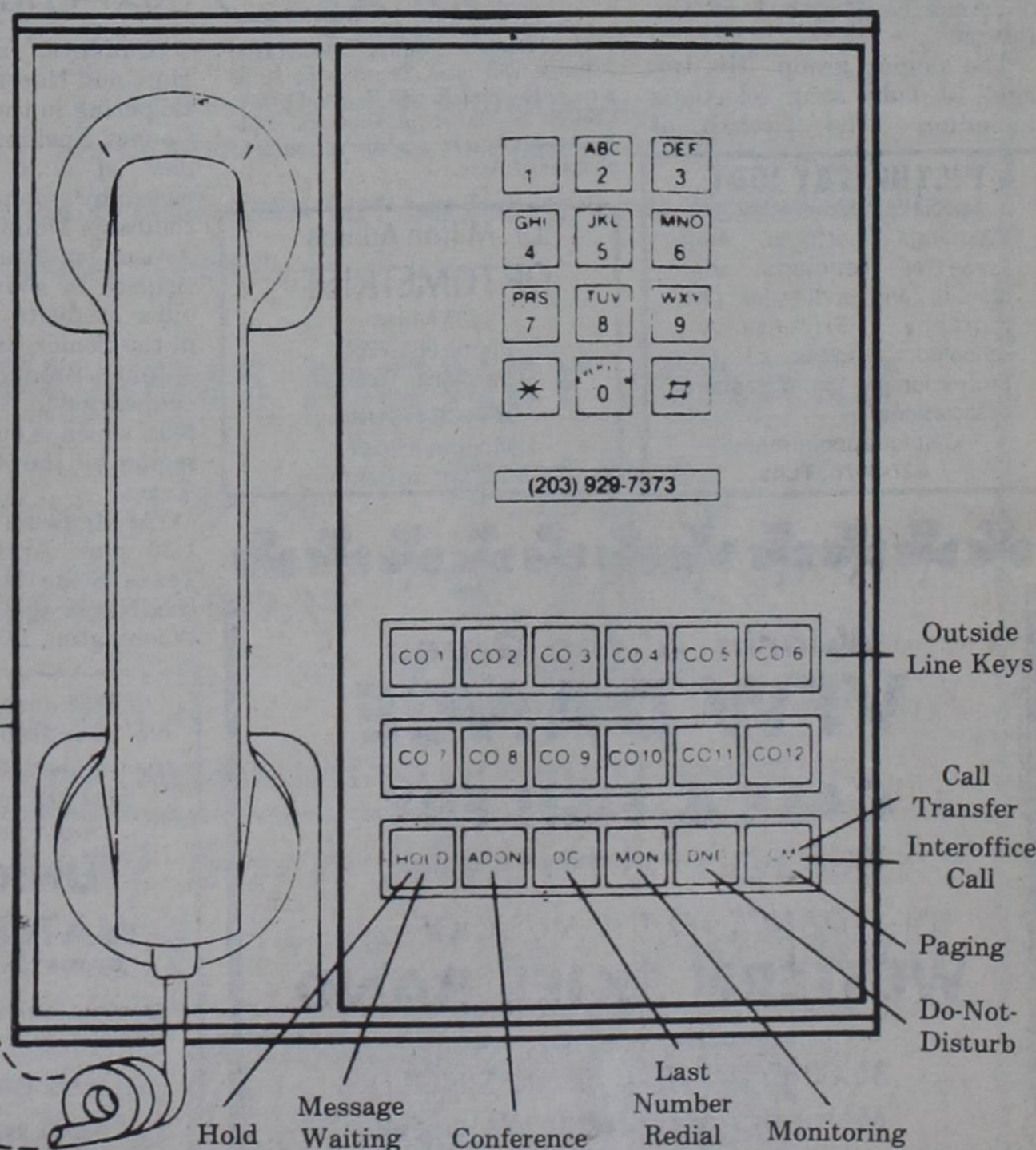

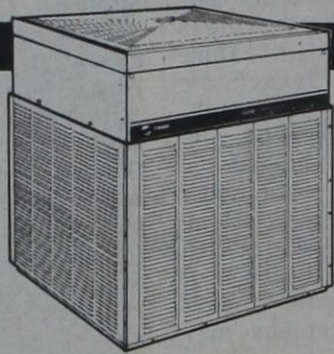

Use drip method for windbreaks

With the Running Water Soil and Water Conservation District windbreak program in full swing, now may be the time to discuss the watering of these trees after they are planted. One of the most efficient ways would be a drip irrigation system.

A drip irrigation system consists of a water source, filter, pressure regulator, cut-off valve, mainlines, lateral lines, driplines and emitters. Each of these items will be briefly discussed in the following paragraphs.

The water source should be dependable and in enough quantity to operate the system that is installed. The system may be adjusted to fit the water supply by varying the emitter size and by using valves to operate only a portion of the system at one time.

A filter is essential for most systems. It removes debris and grains of sand that would render the emitters inoperative. A 1/2" filter has a capacity of up to 5 gallons per minute, 3/4" filters up to 10 gpm and 1" filters up to 20 mpg.

A pressure regulator is needed on some systems, depending on the type of emitter used and the pressure available. Pressure pumps will provide 25 to 40 PSI. Rural water systems and municipal water systems will usually provide 40 to 60 PSI.

A cut-off valve on a system is essential. A gate valve or hydrant can be used as the cut-off valve. The main line of a system can be either poly hose or PVC pipe. This line can be either laid out on the surface or it can be buried. The size of this line depends on the length, flow rate and available pressure. The minimum size that should be used should have a flow velocity of less than 5 feet per second. Lateral lines will connect main line with the drip lines. Lateral lines can be either poly hose or PVC, but PVC should be buried, while poly hose may be either buried or laid out on the surface. Drip lines are usually poly hose and these can be laid out on the surface or buried. When planning

drip lines, add 10% extra to the length to allow the line to be "snaked" which allows for contraction and expansion of the line.

Emitters come in numerous types, shapes and designs. The most common sizes are one gallon per hour, and two gallons per hour emitters. Emitters smaller than one

gallon per hour clog easily and those that are larger than two gallons per hour require a larger drip line or more main or lateral lines. The cost of the various components of a drip irrigation system will vary among the different suppliers.

LaPoynor committed only five fouls and Nazareth four during the game. Nine of the 13 players who saw action in the game went foul-less.

The Swifts held the edge until the final 2:26, but never by more than four points. LaPoynor went ahead by two points twice in the final 2 1/2 minutes, but when the buzzer sounded, the score was tied — for the ninth time.

The Swifts were the better shooters, hitting 48.8% of their shots to the Flyers' 46%. But the Flyers took five more shots and made two more baskets.

It was still a one-point game until LaPoynor's Darrell Street stole the ball and made a three-point play with 25 seconds to go in overtime. That was the big play that won the championship.

High school basketball just doesn't get much better than that. None of the other championship games that followed Saturday matched the Nazareth-LaPoynor game for precision play and closeness.

They'll be talking about that game for years to come.

Other state tournament highlights:

Best transition play: By the Sweeny Bulldogs, in their Class AAA semifinals game against Ingleside. A Sweeny player tipped an Ingleside pass near the mid-court line, sending the ball bouncing out of bounds. But another Sweeny player leaped after it over the boundary line, got a hand over

it and back-handed it the entire width of the court to a teammate. The save set up a three-on-one fast break that saw a behind-the-back pass and a slam dunk, all in a six-second span. (Sweeny went on to win the Class AAA championship.)

Biggest fall: By the Snook Blue Jays, who were going for a national record of eight consecutive state championships until they lost to LaRue LaPoynor, 60-52, in the Class A semifinals. (Some called it an upset; it wasn't. LaRue LaPoynor has won four state championships in seven trips to the finals since 1972, and this year's Flyers were that much better than the Blue Jays.)

Biggest comeback: By the Brownsboro Bears in their semifinals game against Seminole. In their quick-ambush fashion, the Indians built a 20-point lead over the Bears, 27-7, midway in the second quarter, but Brownsboro climbed back and won it, 63-56.

Biggest single quarter: First quarter of the Class AA semifinals game between Morton and Pilot Point, with 52 points scored as Tony Mauldin's Indians ran and gunned their way to a 34-18 lead.

Where the Best Team Lost: Grapeland's victory over Morton in the Class AA championship game. Coach Tony Mauldin's Indians went cold and could hardly buy a basket — even on layups and put-ups — as Grapeland won, 63-56.

Most Awesome Team: Houston Madison, which won the Class AAAAA state championship while extending its record to 40-0. The extremely disciplined Marlins looked like a major-college team, and were even more imposing because of their uniformly shaved heads. No team came closer than 14 points of them all year, and their second five could probably have won the state championship.

Biggest Hot Dog Team: The Lamesa Golden Tornadoes, who tried a lot of dunking and rough-housing but very little passing, setting up or blocking out. Whoever got the inbounds pass usually was the one who put the ball up. It worked against New Braunfels in the Class AAAAA semis, but not against Bay City in the finals.

Most Frustrating Loss: Nazareth's to LaRue LaPoynor in overtime in the Class A championship game.

Biggest Contingent of Non-Contestants: Probably the Dimmitt crowd.

DOOR-TO-DOOR SALES CONTRACTS

If you buy more than \$25 worth of merchandise from a door-to-door salesperson, make sure you are protecting your rights as a consumer by getting the appropriate paperwork, says consumer economics expert Bonnie L. Piernot.

"The salesperson must provide a fully completed contract including the date of the sale, name and address of the seller, and a statement in large business type explaining the right to cancel within three days by written notice," explains the Texas A&M University Agricultural Extension Service specialist.

The salesperson must also give you two copies of a separate "notice of cancellation" form. The contract and notice must be in the same language the salesperson uses in the sales pitch, she says. If the sale was made in Spanish, for example, then the contract-notice must be in Spanish.

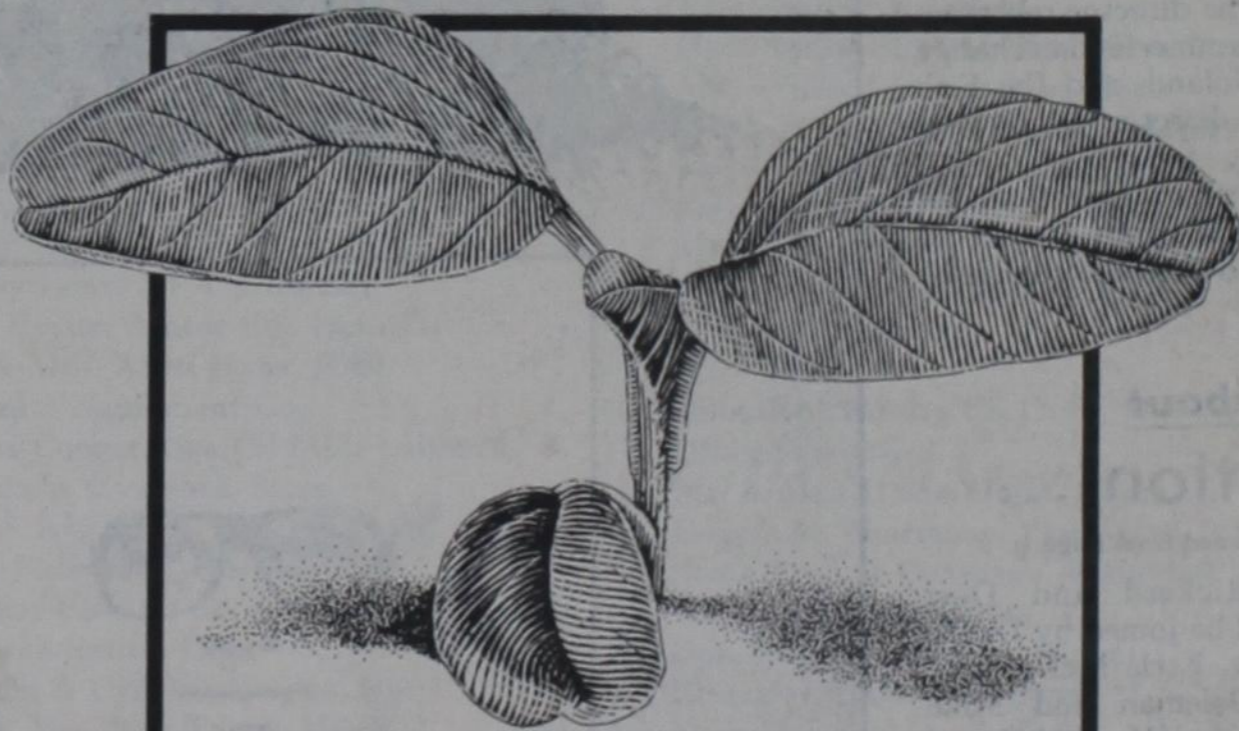

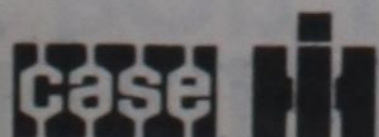

Police Calls

BUYERS CAN CANCEL

What if you decide you don't want or can't afford the merchandise you bought from a door-to-door salesperson?

You can cancel if you don't delay, says a Texas A&M University Agricultural Extension Service consumer economics specialist. A Federal Trade Commission ruling allows a three-day "cooling off" period to cancel if the purchase is \$25 or more.

This rule applies only to door-to-door sales and not to in-store sales, says Bonnie L. Piernot. Also exempt are sales of insurance and securities, as well as phone and mail orders.

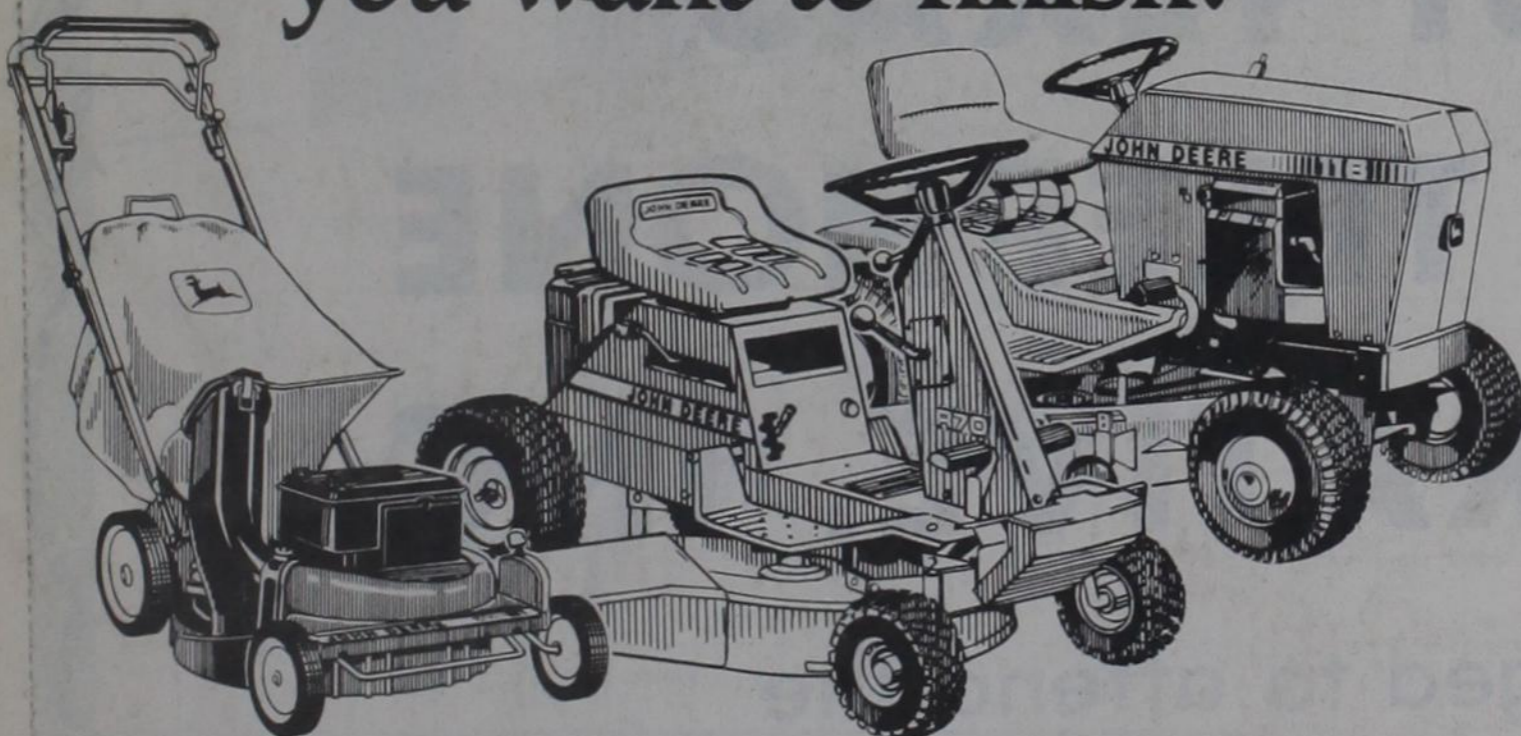

The cost will be divided between the hospital, county and city, and will probably not be purchased until October.

"That's when your (county) fiscal year starts, and that would be better for us, too," Cook said.
Commissioners also agreed to consider a petition presented by Butch Merritt for a new county road near Hart.

Pct. 1 commissioner Curtis Snitker said the biggest problem would be the amount of

money it would cost to haul in fill dirt to cross a lake on the proposed right of way.

Commissioners also tabled action on deeding a portion of the county road that extends from NW Fifth to the airport because none of the residents of the street or the City of Dimmitt were present at the meeting.

The residents who live along the stretch from Halsell to Youts St. had gone before the City Board of Aldermen Mar. 4 to ask the city to pave the street, but they were told by city officials they would have to get the road deeded to them by the county.

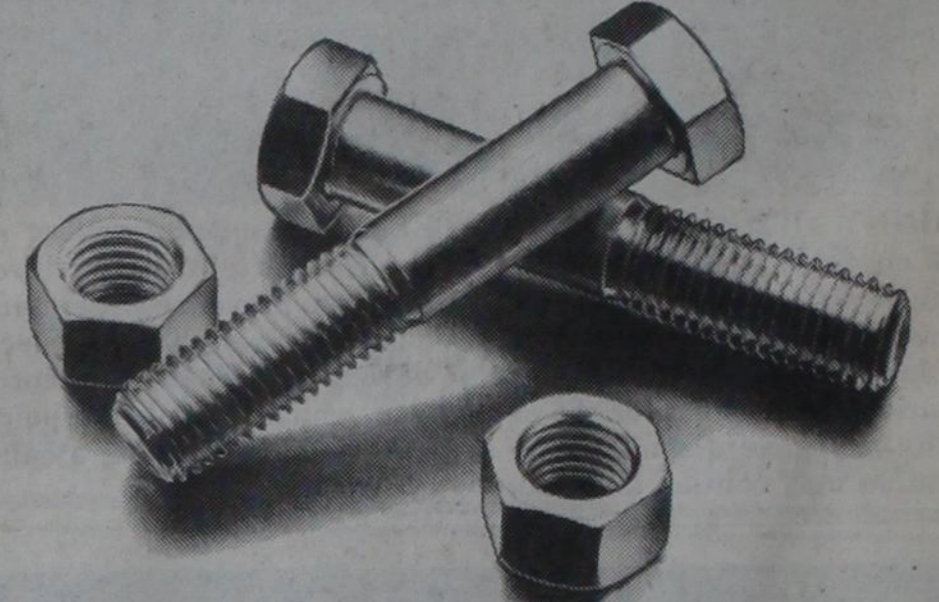

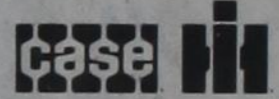

Pheasant coordination meeting set here Friday

An effort to coordinate pheasant hunting activities in the county will begin this Friday with a noon meeting at Ann's Steak House in Dimmitt.

"We just want to get everyone together to feel each other out," said Don Sheffy, who is coordinating the effort on behalf of the Dimmitt Chamber of Commerce and the Dimmitt Kiwanis club.

"There's a lot of money we are leaving out there," Sheffy said, "and I think we can probably centralize booking for land, advertise the amount of land available, and realize a better outcome for everyone in the years to come."

According to figures supplied by the Chamber and the Texas Parks and Wildlife Service, 3,000 hunters are in

Castro County during the traditional two-week long season in December, and spend a total of \$450,000 in the county during the two weeks on food, lodging, hunting leases and other needs.

"There were several ideas last fall, but they came out too late to do anything with," Sheffy said of the county's largest tourism attraction. "The Kiwanis (who had the largest organized hunt in the county since starting the project several years ago, but no longer have land available to lease to hunters) still get calls, the Chamber gets calls, and individual farmers get calls. I know a lot of farmers would rather not have to put up with leasing and making arrangements for hunters, but still want to reap the benefits

of leasing their land to pheasant hunters. We want to make the pheasant season as beneficial to everyone that we can. Anyone who is interested is sure invited to the meeting."

Social Security

...in Castro County

If you get Social Security benefits and worked last year, and earned over the annual earnings limit, you are required to file an earnings report with Social Security by April 15. Social Security officials suggest that the report be used as much for planning purposes as for reporting purposes.

This is because the document is designed to record how much you earned over the limit last year and how much you expect to earn in 1985. Your benefit is then adjusted to reflect excess earnings — past and estimated — and you won't accumulate an overpayment — benefits to which you are not entitled.

Few people have trouble reporting last year's earnings. However, Social Security has discovered that a great many people have problems estimating the amount of earnings they expect during the current year.

The result is that more than 70% of the overpayments in 1984 are expected to be caused by underestimating earnings on the annual earnings reports. The repayment procedures generally involve deductions from future checks or a lump-sum payment.

In any case, overpayments are a headache for all concerned — you relying on your monthly checks and SSA, who is charged with administering an efficient program with a minimum of waste of public funds. For this reason, current emphasis is on the prevention of overpayments.

If you work, you are urged to take the time now to assess your work plans for the year, if possible. You may compare last year's work with this year's estimate to get an idea of the effect your estimated work will have on your benefits. If you need help, the nearest Social Security office will be glad to help either by phone or in person.

Another good way to prevent overpayments is to report any change in earning levels as

soon as they occur. Some people wait until the next earnings report is due. Their report of earnings results in a discovery of a significant overpayment caused by the lower level of earnings estimated earlier.

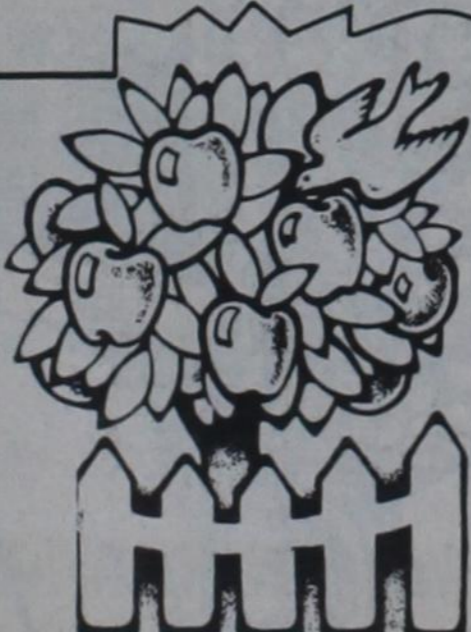
