Parliament had fixed the succession in the following order: 1, Princess Mary of Orange, eldest daughter of James II.; 2, Princess Anne of Denmark, the youngest daughter of James II.; 3, William of Orange, son of Mary, the eldest daughter of Charles I. In the failure of heirs to these, the succession was limited to the electress Sophia of Hanover, granddaughter of James I., and mother of him who became George I.

The most conspicious figure in the reign of George I. was Sir Robert Walpole, the first prime minister of Eng land.
