250th Anniversary of George I. London, May 28.—Since the accession of George V. to the throne much has been printed in the British papers concerning the four Georges who preceded him. In this connection it is interesting to note that today is the two hundred and fiftieth anniversary of the birth of the first of that name. George I. was the first sovereign of the Hanoverian line. His accession to the throne of Great Britain and Ireland came through his mother, the granddaughter of James I. Parliament had fixed the succession in the following order: 1, Princess Mary of Orange, eldest daughter of James II.; 2, Princess Anne of Denmark, the youngest daughter of James II.; 3, William of Orange, son of Mary, the eldest daughter of Charles I. In the failure of heirs to these, the succession was limited to the electress Sophia of Hanover, granddaughter of James I, and mother of him who became George I. The most conspicuous figure in the reign of George I. was Sir Robert Walpole, the first prime minister of England. The fact that George could speak no English, while his ministers could speak no German, taken with the other fact that George hated to live in England and spent much of his time in Hanover, gave to the office of prime minister, that Walpole was the first to hold, the important character that it has since retained.

Naval Wedding at Newport. Newport, R. I., May 28.—A fashionable wedding in naval circles took place today, when Miss Marianna Fullam, daughter of Capt. William F. Fullam, U. S. N., who commands the battleship Mississippi, became the bride of Austin Lowmyer Sands, a member of a prominent Newport family. The ceremony was performed early this afternoon by the Rev. Stanley Hughes, rector of Trinity Church, in the presence of a distinguished company.

Cecil's Brother Gets Appointment to  
Federal Office.

dent Taft today sent to the senate for

District of Texas.

Lyon is a brother of Cecil A. Lyon,  
the reputed representative of the Taft  
administration in Texas, and the  
appointment of his brother is regarded  
as significant, following the naming of  
Congressman Gordon Russell, a dem-  
ocrat, yesterday, as judge of the same  
district. The appointee is a million-  
aire lumberman and owns or controls  
thirty-two lumber yards in Texas. Col.  
Lyon, the brother of the man named  
today, is reported to have strongly  
urged the appointment of Henry Mc-  
Greedy of Bonham, a republican, over  
whom Russell was named judge.

### STRAY TOPICS FROM LIT-TLE OLD NEW YORK.

New York, May 28.—Mayor Gaynor still keeps up his good work in cutting out yards and yards of red tape in the transaction of public business and simplifying the work of the various municipal departments. Some time ago the Board of Aldermen adopted the resolution permitting a certain enterprising dentist in Harlem to maintain a carriage man in uniform on the sidewalk in front of his office. When the resolution reached Mayor Gaynor for his approval, he promptly returned it to the board with his veto and the following explanation: "This resolution is wholly unnecessary. Dr. — may dress his men, and also himself, in any costume he sees fit without permission of the board of aldermen."

The statistics contained in the annual report of the trustees of the Brooklyn Public Library throw an interesting light upon the relative demand for books in the various sections of Brooklyn and greater activity in schools, clubs and debating societies. This experience is by no means new, however, as the statistics of nearly all libraries in cities with a large foreign population show practically the same state of affairs. The foreigners seem to have a greater desire to educate themselves than the native Americans.

Practical jokers belong to one of the most dangerous classes of lunatics and the law should treat them as such. All of them have a distorted sense of humor, an unflinching evidence of paranoia, which makes them a danger to the community. Hundreds of human lives have been destroyed and many more endangered by the insane "okes" of these lunatics and every year many thousands of dollars worth of property is destroyed by the acts of these fiends. One of these "practical jokers" lit his cigarette while passing through one of the streets in Williamsburg and threw the burning match into a baby carriage in which an infant was peacefully asleep. The covers caught fire and the child was seriously burned and probably disfigured for life. Unfortunately, the "joker" was permitted to escape.

The women employed in the jute mills in the Greenpoint district are on a strike and a large police force is kept busy protecting the strike-breakers from the attacks by the striking fairies. Every day there are fights and riots and when the police reserves made their appearance the fair strikers retired to the roofs and from these points of vantage hurled all kinds of missiles at the bluecoats. One of the policemen who had been struck by a brick thrown from the roof of a house nearby the other day ran into the house, and made his way to the roof. He found half a dozen women there, all busy throwing things at the policemen in the streets. When they saw him they scurried away in every direction, slipping through the scuttles and pulling the covers down behind them. Only one of the belligerent fairies failed to make her escape. She was too fat to squeeze through without considerable effort and when she finally managed to get through and placed her feet upon the rungs of the ladder the rungs broke under her weight and she fell, breaking her leg. She was the only one of the women caught by the officer and she had to be taken to the hospital for repairs.

Fishing is pretty good in and around New York. Two boys, one six and the other eight years old, who were fishing in the Hackensack river the other day, caught a roll of bills held together by a rubber band. The roll contained \$42 and the boys were honest enough to divide the money equally and to take it to their respective mothers. After the money was all spent, a man who owns a boathouse on the river, claimed that the money belonged to him. As the money was gone, he had the boys arrested for larceny, but, owing to their extreme youth, the judge discharged them. Ambitious tellers of fish stories, eager to break records, will kindly take notice.

A woman in Patterson, N. J., who married an Italian about four months ago, began a suit for divorce against him a short time ago, charging him with cruelty. His cruelty consisted principally, according to her statement, in stuttering. A special master was appointed by the court and the other day he began to take testimony. The woman said her husband seemed to be all right before they were married. But after the marriage his stuttering became unbearable, especially when he tried to speak in Italian. In answer to a question by the referee, the defendant said: "Tu-tu-bu-bu-bu."

"What does he say?" asked the woman's lawyer. "He hasn't said it yet," replied the official interpreter. The postmaster at Branchville, a prosperous little town in New Jersey, is going begging. A little more than a year ago a postmistress was appointed for the town. A few months after her appointment she became married and resigned her position. As the

government, in spite of the most strenuous efforts, has been unable to find anyone willing to take the postmastership, Mrs. Bevans, the unwilling postmistress is compelled to stick to her job. There is some talk of importing some one to take up his residence there and become postmaster.

The manner in which John W. Gates, the speculator of "I bet you a million dollars" fame, settled a law suit growing out of some stock deal the other day, was truly characteristic of his gambling propensities. After the referee in the case had taken some testimony, Gates proposed to his opponent to flip a coin to determine who should pay the cost of the case. His adversary consented and Gates won. Then his opponent suggested to Gates to flip a coin to determine whether Gates was to receive \$2,500 in settlement or nothing. Gates willingly consented and won again. The counsel informed the referee that there was no further need to continue the hearing, as the litigants had settled the case out of court. They were ready to pay the referee's and stenographer's bills as soon as they were presented.

### FACING THE CUSTOMHOUSE.

Why Women Are Apt to Find Ordeal Trying One.

We American women find the custom law peculiarly oppressive because it is almost the only law with which most of us ever come into contact. We go about our task at home, live out our days and die, without a thought of legal obligations. We are proud of our freedom, too, when we travel, glorying in it, boasting of personal liberty as the very breath of our National existence, demanding, because of it, the overthrow of so many social traditions abroad that our less-favored sisters on the other side regard us with awe and envy. Then we start home. One day a steamship steward knocks at our stateroom door, hands us the Government's printed form of declaration, and the "Notice to Passengers." Suddenly, for the first time in our lives, we find ourselves "bump up against the law." Some of us cannot understand it. We tremble; our hearts beat. We have consultations with friends and strangers. Blood-vurdling stories are told. We can think of nothing else, talk of nothing else. Where have we packed our ne wthings, where our old Will they dig out everything? Will they believe us? Those little presents we have bought in—are they presents until we have declared them? And so on, and so on until our last days become a nightmare compared with which seasickness is a paradise. Neither is there any man to protect us with any of those liberal "interpretations" which stand most of us in stead. We must go through the ordeal as we go through death—alone!—Century.

### MAKING A TEXAS COLONEL.

Broad-Brimmed Hat and White Vest Required, Says Col. Allison.

"No, I never served in the army. They call me 'colonel' because I wear a broad-brimmed hat and a white vest," said Col. Jno. W. Allison of Ennis, Texas, ex-president of the Interstate Cottonseed Crushers' Association, to the Arkansas Gazette.

"In Texas, when a man wears a white vest, separate from the broad-brimmed hat, or the broad-brimmed hat separate from the white vest, they call him 'major.' But when the two pieces of harness are donned at the same time, the title is the same that they gave me.

### NEWS FORECAST FOR THE COMING WEEK.

Washington, D. C., May 28.—The week will be ushered in with the annual observance of Memorial Day throughout the northern states, accompanied, as usual, by the dedication of soldiers' monuments, the decoration of the graves of those who fought and fell in the war between the states, and the numerous sporting and athletic events which in recent years have become associated with the holiday.

President Taft will review the Memorial Day Parade in New York Monday and two days later he is scheduled to pay a visit to Bryn Mawr college to deliver the annual commencement address.

Friday, the birthday anniversary of Jefferson Davis, the only president of the Confederacy, will be widely observed as a holiday throughout the South.

At a banquet to be given in St. Louis Thursday night Joseph W. Folk is expected to announce whether he will be a candidate for the United States senate, or whether he will reserve his strength for the race for the democratic presidential nomination in 1912.

The democratic state primary to be held in Tennessee Saturday will attract general attention, owing to the serious split in the party ranks between the supporters and opponents of Governor Patterson.

Other events that will figure in the news of the week will be the unveiling of an equestrian statue of General Custer at Monroe, Mich., the dedication of the Kentucky state capitol at Frankfort, the celebration of the semi-centennial of the New York Homoeopathic Medical College, the annual convention of the Canadian Medical Association in Toronto and the graduation exercises at the United States Naval Academy and at other leading colleges throughout the country.

Many interesting events and happenings abroad will attract the attention of readers on this side of the Atlantic. The International Court of Arbitration at The Hague is scheduled to begin the hearing of oral arguments for the adjustment of the differences between Great Britain and the United States, growing out of the Newfoundland fisheries case.

The new South African commonwealth comprising the British possessions of Cape Colony, Natal, the Transvaal and the Orange River Colony, will become an accomplished fact Tuesday, on which day the new union government will be formally inaugurated by Viscount Gladstone, the first governor-general.

Other events abroad will include the running of the historic English Derby at Epsom Downs, the observance of the forty-fifth birthday anniversary of King George V., the presentation of the freedom of the City of London to Theodore Roosevelt, former President of the United States, the seventy-fifth birthday anniversary of Pope Pius X., and the meeting of the eighth convention of the World's Women's Christian Temperance Union in Glasgow, at which both the United States and Canada will be well represented by delegates.

## FARM AND STOCK NEWS.

**From the Farm and Ranch.**  
Those who estimate the value of their crops and livestock and ignore the value of the barnyard manure are apt to find the profits of the farm unsatisfactory. The best profits should come from the manure when judiciously used.

Arrange your rotation so you will have grazing for your dairy cows during the winter. Steps should always be taken to have milk and butter all the year. The winter pasture will be needed to maintain the cows when feed is scarce.

The fact that your neighbor has failed with livestock is no reason that you cannot succeed. It ought to be all the more reason for your success. Your neighbor's mistakes should be profitable to you and your failures should be carefully avoided by your neighbors.

The enterprising board of trade at Cleburne (Tex.) has inaugurated a fair and trader day, May 21. Splendid prizes will be given on livestock, fruits, crops and fancy work. This is one way the business men render great

assistance to those who till the soil, and in return, those who till the soil can show their appreciation by patronizing those who encourage better products.

Lack of humus in the soil is always an indication of poor soil. Without a liberal amount of humus, good crops cannot be grown, no matter how much plant food the soil may contain. It is a waste of time and money to use commercial fertilizers when your soil is deficient in vegetable matter.

While the weather is not favorable for other work, the cotton shed should be built. It is unwise to neglect such important matters till they are needed. Thousands of dollars are lost every year by cotton growers in not providing ample shelter for their cotton after it is gathered. It is folly to allow waste after your crop has been produced.

A good saddle horse and an easy saddle are still needed on most farms. There are times when horseback riding is desirable. Whether a quick trip is a necessity of a pleasure, boys and girls usually enjoy it. A good horse for your boy and girl will greatly increase their interest in the home and cause them to get the benefit of association in rural and urban society.

Soil in ideal condition for crops should pulverize and retain its granular texture. When plowed the land should crumble and be "mellow." If plowed too wet the soil granules are apt to be destroyed and the land "piled." This causes the land to "bake" and gradually interferes with future cultivation and the growth of plants.
