

The trial of the doctor began or he eleventh, and lasted more than a nonth. On May 16th the jury brough' n a verdict of guilty of muder in the irst degree, recommending a life entence in the penitentiary.

The sentence was duly pronounced nd the attorneys for the defense per ected the appeal to the supreme ourt which has resulted in a new rial for the accused physician.







The nominations will inlude candidates for governor and all ther State officers, niembers of the egislature, three judges of the su-


