Industries to Work On New N.R.A. Plans

AIR OFFICIAL TELLS OF LOAN TO CHACE GOVE

WASHINGTON, Mar. 8.—Paul Henderson, vice president of the United Air Craft and Transport Co., told senate investigators today that he lent \$10,000 to a post office department official in the fall of 1930, several months after his company obtained a transcontinental mail contract. Henderson testified before the air mail committee the money went to Chace Gove, chief assistant to former assistant postmaster general Glover, to protect Gove's losses in stock market transactions.

He said he endorsed three notes for \$1,000 each for Gove's account on October 10, 1930, two more for \$1,000 each on November 10 and paid all of them himself on November 21. On Dec. 31 he lent Gove \$5,000 and took Gove's note for \$10,000.

"Have those notes been paid?" chairman Black asked.

"They have not," Henderson replied. "I destroyed them within the last year or two in Gove's presence at the Willard hotel here."

Many of our people are too anxious to have the court convict all men and women on the flimsiest evidence AND THEN PETITION THE GOVERNOR TO PARDON BAD CRIMINALS ON THE FLIMSIEST EXCUSES. is a personal verdict returned by Judge D. C. Andrews of the Texas board of pardons. "Through all the ages there have been tyrants, fanatics and overzealous people who argue that the way to stop crime was to enact drastic laws with the heaviest penalties in every case—and sometimes the disposition of lawmakers, trial officers and juries to heed the clamor of said parties has caused more suffering and persecution among the weak and uninfluential than all the wars of the ages."

Judge Andrews goes all the way in his argument for the repeal of drastic laws for minor offenses. This is his argument for a change in criminal procedure: "England at one time had about 20 capital offenses and with such judges as 'Bloody' Jeffries the trials were largely judicial murders and the weak, those not members of the high church of England, were so persecuted that they felt as if their government was what Sherman said of war, while many of those who had a pull with the government committed grave crimes with impunity. Every time that any government has enacted drastic laws against the individual rights of its citizens or made penalties all out of proportion to the offenses, great suffering and persecution among the weak and ignorant and bribery and corruption among the high-ups followed."

Judge Andrews specifically charges, speaking of suspended sentences, that many persons charged with crime have taken their sentences seriously "and have since made good, while others laugh at such sentences like the boy in the blueback speller laughed at the man who threw turf at him in the apple tree and the prison records show that many of them have since become confirmed criminals."

Rep. F. C. Weinert of the Guadalupe-Comal district is the reputed father of the suspended sentence act, the indeterminate sentence act and the parole act. He began his legislative career as a member of the legislature while James Stephen Hogg was governor. He has been the champion of these acts for years. He has been their defender as well as their tenacious protector. He is nearing his 80th milestone. He is a member of the present legislature. Should he remain in the land of the living, perhaps he will be a member of the legislature to be elected by the people in November of this year. If all this happens "the fur will fly under the big dome" in the winter months of 1935.

ADMINISTRATOR HOPKINS ADVANCES HUGE SUM OF RELIEF MONEY

National Relief Administrator Harry L. Hopkins responded to the call of State Relief Administrator Adam Johnson and Gov. Miriam A. Ferguson by advancing the sum of \$750,000 to carry on until bread bonds have been sold. Administrator Hopkins lent a willing ear. State Department of Education Praises Scranton Consolidated Schools

High praise of the quality of work that is being done in Scranton Consolidated school was spoken by Sue B. Mann, deputy state superintendent, in a letter to Supt. B. B. Brummett after the deputy superintendent recently completed a tour of rural schools in the county. "I want to commend you and your teaching staff for the superior work you are doing at Scranton. A more progressive spirit I have not found in any school visited in my district. The students and teachers at the central school appeared to be interested and effective in all phases of your school program."

The consolidated high school at Scranton has been operating under the present system for the past three years, during which remarkable progress has been made. There are at present nine teachers in the system faculty—seven in the central school at Scranton and one each in the elementary schools at Dan Horn and Nimrod.

The school maintains three buses which transport pupils from Haskell, Nimrod and Dan Horn communities. All of these busses have been and are now giving good service, said Supt. Brummett. The school has been classified by the county board of education as a four-year high school. The school curriculum has been adjusted to meet the needs of the rural boys and girls. Courses in home economics and farm mechanics are offered, and adequate equipment for the promotion of work in both departments is furnished by the state department of education.

Preparing And Filing Income Tax Returns

Classes of Taxpayers
We have shown when to file, who must file and how to file. I want now to discuss the conditions pertinent to the various classes of taxpayers who must actually pay an income tax to their Government. Suppose we start with single persons.

If you, a single person, made a net income of less than \$1,000 last year, your Government has decreed that you need not make out an income tax return. If, on the other hand, you had a net income of \$1,000 or more last year and had certain personal exemptions you may deduct those exemptions on your income tax return. Then you clearly understand what are the exemptions for single persons. In the event that a single person maintained dependents in one household and was their "chief support" he or she is entitled to the personal exemption of \$2,500 as "the head of a family." If you come under the "head of a family" status you are entitled to an additional credit of \$400 for each dependent recognized as such by law. The law recognizes as dependents, aged mothers, persons mentally or physically defective, dependent chiefly upon you for support, and dependent children under eighteen years of age. (Other deductions allowed from gross incomes will be found on the blanks obtained from your collector.)

Ancient Relics Found In Egypt

CAIRO—Beer mugs and wine cups used by an Egyptian king who ruled in 3000 B. C. are among the remarkable discoveries just unearthed in the tomb of King Zoser. Excavators of the Egyptian government, who have been exploring the Pyramid Sakkhara, which is erected over Zoser's tomb, came upon great solid stacks of table vessels made of stone. These formed part of the king's funeral furnishings.

There were jugs, cups for wine and beer, and jars which probably contained the perfumed ointments with which the ancient Egyptians anointed their hands in preparation for each meal. The vessels weighed over 60 tons, but the greater part of them were broken in a rock-fall.

Inscriptions in black ink were

found on a number of the vessels, with names, texts and titles in a very early form of hieratic script. These rare inscriptions are of considerable interest to Egyptologists.

Two alabaster sarcophagi were discovered, containing the remains of two royal ladies, obviously members of the king's family. In one sarcophagus was a coffin made of six-ply cedar-wood, indicative of the carpentering skill of early Egyptians.
