BRITAIN TAKES STEP TO STOP HITLER DRIVE

LONDON, Mar. 17.—Great Britain today took the lead in democracy's "stop Hitler" drive by recalling her ambassador to Germany to report on the Nazi "march to the east."

With the swift expansion of Nazi-fascist power alarming every European capital, the government of Prime Minister Neville Chamberlain followed the example of the United States and ordered S. Neville Henderson, its ambassador to Berlin, to return to London. It was believed likely that Hitler also would recall his ambassador, Dr. Herbert von Dirksen, for a "report."

Great Britain's action was viewed as a rebuke to the Nazi destruction of Czechoslovakia. Diplomatic circles believed that France would take similar action.

The French cabinet of Premier Edouard Daladier asked parliament for dictatorial powers to meet the new threat created by Nazi seizure of Bohemia, Moravia, and Slovakia, and by expectations that Hitler would now stand back of his partner, Premier Mussolini of Italy in a move against France in the Mediterranean.

Poland, Rumania and Yugoslavia, the governments were in almost constant consultation in an effort to find safeguards against another Nazi bid that would endanger their own frontiers.

Official sources made it clear the German troops would march into Carpatho-Ukraine, which was taken over by Hungary, if the Hungarians fail to gain complete control of the situation within a short time. There are large numbers of Slovaks, whom Hitler has promised to "protect."

Hitler may return to Berlin tomorrow night or Monday to summon the reichstag to meet next week and hear him discuss the new protectorates.

Today he received a triumphal welcome in Vienna upon his arrival from a tour of disarming Czechoslovakia. Nazi bombing planes flew over Vienna in parade formation and thousands of Nazi demonstrators cheered the German chancellor.

FILIBUSTER ON COLLEGE BILL STARTS TODAY

AUSTIN, Mar. 17.—Senator Joe Hill of Henderson today started a filibuster against the final passage of a bill to raise John Tarleton College at Stephenville and North Texas Agricultural College at Arlington to the rank of senior colleges.

Hill began speaking at 12:30 o'clock after points of order had kept the bill from coming before the senate for two hours and a half.

"I am going out on a dance marathon," he said. "I think that there is such an important principle of state policy involved that I am going to use every means to defeat it with every bit of physical energy I possess."

U. S. DENOUNCES AGGRESSION IN STRONG TERMS

WASHINGTON, Mar. 17.—The United States government today denounced German aggression against the former Czech government in vigorous terms.

Acting secretary of state Sumner Welles, speaking with the full knowledge and approval of President Roosevelt, said that this government "cannot refrain" from making known its country's condemnation of the acts which have resulted in the temporary extinguishment of the liberties of a free and independent people.

Welles declared also that this government has on repeated occasions expressed its condemnation of a policy of military aggression.

He said that "acts of wanton lawlessness and of arbitrary force are threatening world peace and the very structure of modern civilization."

Welles' statement was made after a lengthy conference with the president. It was probably the most vigorous denunciation of another power that this government has issued in written form during recent times.

Make the Census Really Worth Something

Complicated plans are already under way for the 1940 census. It is probably the most important since the government took the first one, in 1790.

The taking of a census every 10 years is provided by the Constitution. The original purpose was simply to determine the number of representatives each state should have in Congress.

The Constitution, stating first the basis for representation, continues: "The actual enumeration shall be made within three years after the first meeting of the Congress of the United States, and within every subsequent term of 10 years, in such manner as they shall by law direct." The first census was, as a matter of fact, taken only about one year after the first Congress assembled, and has been taken every 10 years since.

The actual field work of taking the 1940 census will not begin for about a year, but already careful plans are being made to make it yield not only population figures necessary to apportioning representation among the states, but a vast amount of further data which Congress believes is necessary to any real understanding of our national problems.

The law of 1930 required the Bureau of the Census to cover population, occupation, unemployment, agriculture, irrigation, drainage, manufactures, mines and quarries, and business.

Director William L. Austin is already receiving hundreds of suggestions as to what ought to be included.

First, it should be remembered that since the depression, we have never had an accurate count of the unemployed. Estimates by labor organizations and manufacturers' and business associations are all we have.

So one of the primary jobs of the census, after the basic count of all people, is to find out for the first time how many unemployed people there really are in this country. If possible, it should find out how many of these are able to work if work is offered them.

Then we would at last have something basic on which to mount our guns in attacking the problem. If it should be possible for the census bureau to devise some means whereby this data could then be brought up to date, say once a year, in the future, it would be performing a national service.

Major revelations may be expected. How greatly has the population shifted back toward the country from the cities? How many aliens live among us? What have recent droughts done to the population of states affected? How many transients are there? And so on.

First step in solving any problem is to know the facts. We know all too little about our situation today, and a careful and intelligent census should be of utmost value in giving the light whereby we may better find our way.

Session Nearing For The Surgeons

INDIANAPOLIS, Ind. — The American College of Surgeons will hold a six-state sectional meeting here March 22 through March 24. Distinguished surgeons from all parts of the country will address the sessions, which will be attended by the medical profession at large, hospital trustees, superintendents, nurses and other hospital department employees.

Indianapolis hospitals will hold operative and non-operative clinics for visiting surgeons while the meeting is in session. These will be supplemented by clinical assemblies, scientific sessions, medical motion pictures, and conferences on administrative and professional problems in hospitals.

A session which will be open to the public on the subject of "conservation of health" will close the meeting. Talks will be given on appendicitis, cancer, medicine and the public, medicine and the future, hospitals, and doctors.

Among the surgical problems to be demonstrated and discussed will be gall bladder surgery, evaluation of cancer treatment, hypertension and its surgical aspects, complication of pregnancy, peptic ulcers, and eye, ear, nose and throat surgery.

Among the nationally prominent speakers will be Dr. Howard Naffziger of San Francisco, president of the American College of Surgeons; Dr. George Cline of Cleveland; Dr. Irving Alabaz of New York; Dr. Frederic W. Bancroft of New York, associate professor of clinical surgery, Columbia University College of Physicians and Surgeons; and Dr. Geo. H. Gardner of Chicago, assistant professor of gynecology, Northwestern University Medical school. States included in the conference area are Indiana, Illinois, Ohio, Wisconsin, Michigan and Iowa.
