## DeBruce buys AgriFarms grain elevators

"We ship wheat to the Gulf for export or to California for flour mills," DeBruce said. "Some of it is shipped to Mexico to flour change in ownership. mills there."



## **RV** park on the road again

The RV park envisioned by Frank and Jamie Mendoza remained without a home Monday night after the Dimmitt City Council voted 4-3 to refuse water and sewer service to the land Mendoza owns south of

Ruskin Circle.

Voting to deny the service were council members Bob Murdock, Bill Potts and Roger Malone. On the other side were council members Gloria Hernandez, Paul Wayland and Roy Garcia, which threw the matter into a tie. Mayor Wayne Collins cast the deciding "no" vote, saying, "When a majority of residents in an area are opposed to a project, it's not practical to go ahead."

Twelve residents from that area were at the meeting and all who spoke opposed the idea of an RV park, claiming that when they purchased their homes they understood that the area was zoned in a way that would prohibit trailer houses. Although an RV has a slightly different definition from a trailer house, residents didn't see it that way.

After a heated exchange between Malone and Wayland over what precedent it would set to run the water and sewer lines to the property which is located in See RV, Page 10

## NCC opposes administration's Step 2 cotton program proposal

The NCC is opposing a plan submitted to Congress by USDA that calls for immediate elimination of the Step 2 cotton program.

The proposed statutory changes announced by USDA are

to comply with a recent WTO dispute decision. Agriculture Secretary Mike Johanns said, "By implementing these proposed changes, we are being fully responsive to the WTO decision."

He said this step is essential for the United States "to continue to be a leader in the WTO Doha negotiations, which are crucial to U.S. market access and the long-term prosperity of U.S. farmers and ranchers."

In a letter to Sen. Harkin (D-IA) and Sen. Chambliss (R-GA), chairman and ranking member, respectively, of the Agriculture, Forestry and Nutrition Committee, NCC Chairman Woods Eastland said the Step 2 program is an integral part of the overall cotton title in the Farm Security and Rural Investment Act of 2002 and was constructed to work in conjunction with the other parts of the cotton program. "The approach suggested by the legislation would change the terms and conditions of the cotton program in the middle of the marketing season - something the National Cotton Council has always opposed.

Sales of the 2005 crop have already begun in earnest. Cotton will begin to be harvested across the Cotton Belt well

## **YOUR EYES**

APPLYING EYEMEDICATION

Do you know the easiest way to put in eye drops or ointment? Most people don't. Consequently, they feel awkward, or worse, they don't get the proper of medicine.

Don't try to put in eye drops while lying down. You may get a drop in, but more likely, you'll just miss the eye itself. It's easiest if you work in good light. First, pull down the lower eyelid with your index finger. This will create a small "pocket" in this lower part of the lid. with your other hand hold the bottle of eye drops and gently squeeze the drops into this pocket. Eye ointment also can be squeezed into the pocket. Do your best not to touch the tip of the bottle to the eye. The drop or ointment will then spread

itself over the eye with you normal blinking.

If you feel like you're "all thumbs" when using drops or ointments, it may be best to have someone do it for you. Don't be afraid to ask your eye doctor for help

before this legislation is even considered by Congress.

The approach suggested by the Administration would alter a fundamental piece of the sales and marketing structure for cotton in the United States in mid-stream, harming many U.S. cotton producers, merchants and textile manufacturers."

Eastland urged in the letter that "Congress review options in this matter that are short of the immediate elimination of the Step 2 program.

"We further urge Congress to insist that it receive clear indications of Brazil's intentions before making drastic

changes to a U.S. commodity program.

"The National Cotton Council will continue to work with Congress and the Administration to construct a fair and appropriate response to this decision."

USDA's proposed statutory changes also would change

the export credit guarantee programs by removing a onepercent cap on fees that can be charged under the export credit programs, and terminating the Intermediate Export Guarantee Program (GSM-103).



## Public hearing set for Aug. 11 to get water plan comments

The Llano Estacado Regional Water Planning Group ("Region O") will conduct a public hearing, Thursday, Aug. 11, from 7 to 9 p.m. at the Texas Tech University International Cultural Center, 601 N. Indiana Avenue, Lubbock. The public is invited to attend. (This hearing had previously been announced for July 28, 2005.)

The purpose of the public hearing is to receive comments on the Initially Prepared Llano Estacado Regional Water Plan, which includes the counties of Bailey, Briscoe, Castro, Cochran, Crosby, Dawson, Deaf Smith, Dickens, Floyd, Gaines, Garza, Hale, Hockley, Lamb, Lubbock, Lynn, Motley, Parmer, Swisher, Terry, and Yoakum.

Copies of the Initially Prepared LERWPG plan are available for inspection at the County Attorney's offices and the public libraries in each county listed above as well as the High Plains Underground Water

## Vacation driving tips for the dog days of summer

## Hot-weather driving tips

Summer is here and many drivers will be hitting the road for vacations and weekend get-a-ways.

"Hot weather brings unique challenges," said Ray Palermo, director of public relations for auto insurer, Response Insurance.

"It can present dangerous conditions for both the vehicle and its occupants." Each summer sees more than 7 million car breakdowns on the road and he suggests that most summer breakdowns can be easily avoided.

Before heading out be sure you check out the basics, including: oil, transmission fluid, windshield washer, battery level and strength, tire pressure (including the spare), cooling system (which should be flushed and refilled at least every two-years), belts and hoses and have a well equipped emergency kit and tool box in the trunk.

"Drivers need to stay cool as well," noted Palermo.

"Our studies have shown that 75 percent of drivers are fearful of encountering said they had personally previous 6-months."

Don't escalate aggression on the road by responding to it.

\* Stop periodically to refresh yourself, take along moist towelettes and water.

\* When driving in hot weather it's particularly important to keep an eye on the lights and gauges.

If your temperature gauge moves up, turn off your air conditioner and turn on your vehicle's heater to its highest and hottest setting.

It will be uncomfortable, but it will help draw some of the heat away from the engine.

If you are stopped in traffic put the car in "park" and lightly step on the gas to help circulate coolant.

If the temperature light goes on or if the gauge enters the red zone, immediately pull off the road to a safe spot, well away from traffic.

Do not drive any further not even to the next exit.

Driving with an overheated engine can cause serious damage to the engine.

\* Do not attempt to remove the radiator cap itself.

The pressurized coolant is extremely hot and will spray out with great force. Do not pour water over the radiator or engine, since a change in dramatic temperature could cause damage.

After the engine cools a bit, add a 50-50 mix of coolant and water to the reservoir to bring it up to its proper level.

\* Even when not stranded due to a breakdown, summer heat can pose dangers.

Never leave a child or pet in a parked car in summer heat. Even an outside temperature in the 80s can quickly bring a car interior to well over 140 degrees.

\* Bring a cell phone for emergency calls, but don't use it while driving.

Several weeks ago, the council had tabled a plan to annex the Ruskin Circle property into the city, which would have meant that water and sewer lines would be run there.

Last week, the council looked at a proposal to sell Mendoza land south of the new Pioneer Dairy Lab on highway 385 for the RV park, but the cost to run the sewer was prohibitive -\$58,000 excluding labor.

At that same meeting, the council did agree to sell the Mendozas two acres adjacent to Pioneer on highway 194, but since that time, opposition to that idea has materialized.

In addition, city officials found that sewer lines to that property weren't feasible, due to cost.

Frank Mendoza said he isn't sure what comes next, but is disappointed at the reaction to his proposed RV park.

"From as much opposition as I've had, you'd think I was trying to bring a brothel to Dimmitt," he said. "What we had in mind was putting four or five spaces south of the Ruskin Health Club. We wanted to do something esthetically pleasing. A lot of towns have public RV parks because they see the economic advantage."

Collins did offer the Mendozas a place by city lake south of town but Mendoza said the land was subject to flooding and mosquitos.

In other action, the city agreed to join with the city of Hart to hire a street sweeper at \$50 an hour for a minimum of 50 hours, divided between the two towns.

## What's the Law?

### You can marry at age 14, but only until September 1

Q. How old do you have to be to get married in Texas?

A. As of today, you may marry at age fourteen with parental consent. The age limit will be raised to 16 as of September

Q. I know that the bankruptcy law has been changed and that it is less friendly to consumers. When does the new law take effect?

A. You are correct that Congress enacted major reforms to the Bankruptcy Code. These reforms generally make bankruptcy a less friendly option for consumers. The changes will also probably make it much more expensive to file. The new law does not take effect, however, until October. I strongly suggest you immediately speak with an attorney if you are considering filing bankruptcy. Many attorneys are board certified in consumer bankruptcy.

Q. One of my brothers has lived with our mother for about a year. He pays her a small amount each month to help with expenses. Things are not working out, and my mother wants him out. Can she just throw him out?

A. In my opinion, your brother is a tenant, and your mother is his landlord. This means that she must give him proper notice to vacate, and has no legal right to just throw him out. I suggest she give him 30 days written notice to leave. If he still does not leave, she can file a forcible entry and detainer action in justice court to have him evicted.

Q. You recently wrote that it is legal to marry a cousin in Texas. I thought the law was changed to prohibit this.

A. You are correct. The law that allows a person in Texas to marry a first cousin has been changed. Under the new law, you are prohibited from marrying a first cousin. The new law does not take effect, however, until September 1st.

Q. I bought a car and could not afford the payments. 1 agreed to do a voluntary repossession. Now they are telling my father that he owes over \$3,000 as a co-signer. Is this

A. If someone signs as a co-signer, he basically assumes the same responsibility as the person he signed for. In other words, if you owe the money, your father also owes the money. After a repossession, voluntary or involuntary, the car is sold and the amount obtained at the sale is applied to the debt. If there is still a balance remaining, called a deficiency, you still owe the creditor. For example, if you owed \$12,000 and the car was sold for \$9,000, you would still owe the \$3,000 deficiency. Because you owe the money, anyone who co-signed also owes it. I suggest you ask for an accounting of how much was owed and how much was obtained at the sale to determine if there is really a deficiency owed. If there is you and your father are both responsible.

Q. I want to lease some land. Can I tell the tenant I require a check and will not accept cash? The tenant keeps paying in cash and I do not like carrying around that much money.

A. As a general rule, you can satisfy your financial obligations by using cash or a check. Most people consider cash and checks as the same thing. They are, however, very different. Only cash is legal tender that may be freely exchanged. If a person wants to pay in cash, he or she has the right to do so.

In your situation, however, the lease determines the method of payment. If you want to be paid with a check, you should make this clear to the tenant before the lease is signed and make it a term of the lease. If you do not have a formal lease, you can give thirty-days notice and make it a requirement for the future.

Q. I owe a company money from about ten years ago. I have not heard anything for about five years, but now a debt collector is calling me day and night. He also is calling my sister. I tell him I don't have the money and can't afford to pay, but he will not stop harassing me. What can I do?

A. First, if the debt is that old, there may not be any legal action the debt collector can take. After four years, most debts are barred by what is called the "statute of limitations." This means if a lawsuit is filed, you could have it dismissed.

There is no law, however, that prevents a debt collector from asking you to pay a debt, even if legal collection of the debt is barred. You can stop the debt collector from continuing to harass you in several ways. First, under federal law, if you send the debt collector written notice demanding he stop all further communication with you, he must stop. He still has the right to sue, but in your case, that alternative is barred by the statute of limitations.

Another way to stop a debt collector is to make it clear that you do not intend to pay, and that his calls are just a waste of time. For example, if you get very upset every time a debt collector calls, the debt collector begins to think that you will pay, to avoid being harassed.

Your conduct almost encourages more bad conduct by the debt collector. On the other hand, if you are polite and calm, and slowly and carefully explain that you recognize that you owe the debt, but cannot afford to pay and believe that it is barred by limitations, the debt collector will soon realize calling is waste of time. Debt collectors make money by collecting money. A debt collector cannot afford to spend a lot of time on the phone with someone they know is no going to pay.

Finally, I should point out that under the law, a debt collector never has the right to harass, threaten, or otherwise abuse

If that happens, let the debt collector know you know your legal rights and you expect he wills top. If he does not, consider speaking with an attorney or a filing a complaint with the Federal Trade Commission.

Q. The other day, a friend came to see me at work. After he left, my employer asked how I knew him. I said he was an old friend. The next day I was fired. My employer told me he had "problems" in the past with my friend, and did not want me working in the store. Is this legal?

A. As far as the law is concerned, your employer doesn't even need a reason to fire you. Unless you have an employment contract for a set period of time, Texas law treats you as an employee at will. This basically means you may be fired, or quit, at any time, for any or no reason.
