HOUSTON, Tex., Feb. 9 (UP)—Sheriff deputies today continued their investigation of a 27-year-old woman's story that she was kidnapped by two Negroes in downtown Houston late yesterday who tried to rape her.

Immediately after the woman reported the incident, some 25 deputies, aided by bloodhounds and a volunteer posse of 75, searched the area...

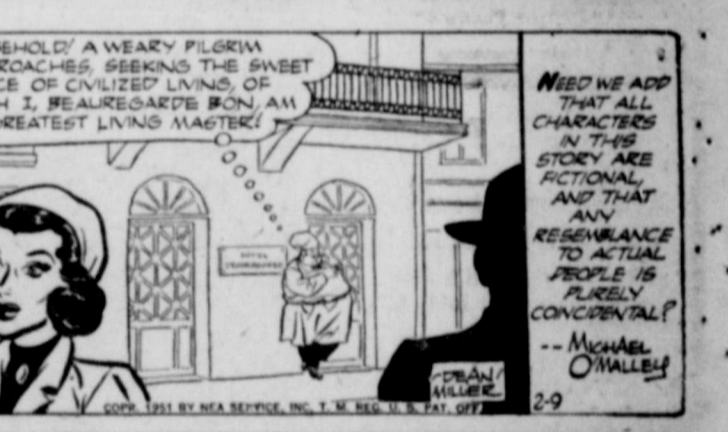
