### Canadians Put Record Price On Newsprint

The price of newsprint topped all records in history Tuesday and threatened to add fifty-million dollars or more each year to the costs of United States publishers.

Two of the big Canadian producers announced price increases of \$10 a ton bringing the New York cost to \$126.

Consolidated Paper Corporation, second largest producer, and Abitibi Paper and Paper Co. third largest, notified their customers of the increase, effective June 15.

What effect this will have on American producers of newsprint is not known. Any relief similar to the Canadian action they might want would have to be sought in Washington.

The price of the newsprint varies according to the point of delivery. Using the New York base, the increase brings the newsprint to \$126 a ton.

The local paper purchases its paper from Abitibi, and in a telegram to the publisher the paper concern said, "The Canadian government has decided not to prevent an increase in the price of newsprint. In view of this we are hereby advising you that effective June 15 our price for newsprint will increase by ten dollars per ton."

Increased cost of labor, materials, pulpwood and the "depreciation in the value of the American dollar."

The June 15 price will compare with a depression low of \$40 per ton during the early thirties and with a previous high of \$120 in the early 20's.

### Thundershowers May Break Heat

Widely-scattered thundershowers may lessen the heat today in Texas. And the weatherman says cooler weather will move in from the northwest today and reach across the entire state by tomorrow.

The cool spell will be particularly welcome to Presidio residents who simmered in 102 degree temperatures yesterday. In West Texas, Big Spring reported dust which cut visibility to four miles yesterday afternoon. And winds hit a peak gust of 38 miles per hour at Dallas and were strong over all but the southern part of the state.

The weatherman says today will be windy again and more dust may be raised. But clouds which moved into the Panhandle yesterday will spread across Texas today and tonight with the rain and the cold front.

The mercury got down to 49 degrees during the night at Dalhart while the high minimum was 75 degrees at Brownsville.

### Chicago Group Protest Radio, TV News Ban

CHICAGO, May 21 (UP)—The Chicago News Broadcasters Association has protested a proposal by Sen. Pat McCarran to ban radio and television news coverage of Senate committee sessions.

Association President Spencer Allen of WGN-TV wrote the Nevada Senator, asking that the group's views be considered during judicial committee hearings on the proposed legislation.

Allen's letter says the bill "would encourage the present trend to withhold or suppress at both national and local levels."

The association said the bill "also is discriminatory in favoring other media of news reporting over radio and television."

### Abilene Police Chief Resigns

ABILENE, May 21 (UP)—Assistant Police Chief Tom Summers of Abilene has been appointed acting chief succeeding Raymond Eakin who resigned yesterday.

The Abilene City Commission held a special meeting to accept Eakin's resignation for the \$399 per month job, but his resignation was a surprise.

Eakin had been a member of the police force since 1941 and city hall sources say if he was under fire "nobody knew about it."

### TRUMAN DOESN'T THINK COURTS OR CONGRESS CAN TAKE AWAY EMERGENCY SEIZURE POWER

WASHINGTON, May 22 (UP)—President Truman says he doesn't think the courts or Congress can take away his power to seize fundamental industries in a national emergency.

Mr. Truman told his news conference that he doesn't believe this inherent, constitutional right of his is at stake in the steel case currently before the supreme court.

However, the President promised to abide by the supreme court decision on steel and said his comments today do not constitute pre-judgment of the court decision.

### LBS Reformed To Operate On West Coast

HOLLYWOOD Calif., May 21 (UP)—The Liberty Radio Network, an outgrowth of the defunct Liberty Broadcasting System, will begin operations in four western states in June with 26 affiliated stations.

Benton Paschall, former LBS vice president and west coast manager, announced yesterday that the new network would begin operating in California, Oregon, Washington and Arizona the first week of next month.

The announcement followed a meeting of representatives of west coast stations formerly affiliated with LBS which ceased operations two weeks ago.

The new network will be incorporated in California, with former LBS president Gordon McLendon of Dallas as president. Paschall will serve as executive vice-president.

Paschall said the network would offer six hours of daily programming, featuring re-creation of major league baseball games, commentaries and newscasts.

"We will add to the 26 charter stations and expand to other states later but will concentrate on the west coast at the outset," he said.

### High School Students Riot

INTERNATIONAL FALLS, Minn., May 23 (UP)—A demonstration by 30 high school students in International Falls, was stopped by tear gas and fire hoses last night after violence broke out at a recreation center.

The students pelted passing autos with eggs after they were ordered out of a restaurant used by the teenagers as a hang out.

The students re-assembled after being dispersed by fire hoses and police finally were forced to shoot tear gas into the mob.

The students threatened to demonstrate again tonight.

NEW YORK, May 23 (UP)—Funeral arrangements have been completed for movie star John Garfield, who died in New York yesterday.

The services will be conducted tomorrow in New York. Garfield, 35-years old, died of a heart attack in the apartment of a friend.

### Mississippian To Be Speaker RJC Graduation

Dr. G. C. Boswell, president of Ranger Junior College, announced that J. B. Young, president of Jones County Junior College, Ellisville, Miss., will deliver the Commencement Address for Ranger Junior College Sunday evening, May 25, 8:00 p.m., at the First Methodist Church.

There are seventy-seven graduates from the college this year. President Young is a member of the Board of Directors and chairman of the Finance Committee of the American Association of Junior Colleges. He began to teach in Jones County Junior College in 1930, became dean a few years later and has been president since 1946. He is a member of the Higher Commission of the Southern Association of Colleges and Secondary Schools, is a member of the National Advisory Commission on Nursing Education, is past president of the Mississippi Association of Colleges and also of the National Council of the Boy Scouts of America, chairman of the Ellisville Chapter, American Red Cross, and a Deacon in the Baptist Church.

CHESTER, Pa., May 22 (UP)—Three crewmembers of a tug boat are missing after the collision between the tug and an oil tanker in the Delaware River at Chester, Pennsylvania.

Four members of the tug Pateo and three men working on barges being towed by the tug were rescued. No one was injured on the tanker Atlantic Dealer.

### General Doesn't Mention Kojé Island Incident

WASHINGTON, May 22 (UP)—The former United Nations Commander in the Far East says an armistice in Korea is up to the Communists.

General Matthew Ridgway told a joint session of Congress that "there rests in Communist hands a logical, reasonable and honorable settlement on equitable terms."

And, he said, if the Reds want to end the war, they will accept it. Ridgway's speech was broadcast nationwide, it will be re-broadcast.

Up to now, Ridgway charged, the Communists have been stalling the truce talks with "blind hatred, vituperative venom and vicious falsehoods" . . . his words.

The former Far Eastern Commander did not say what steps the UN might take if the Reds fail to agree to our terms in Korea.

But he expressed faith that Allied troops can defend themselves against any Communist attack. The Eighth Army, he said, stands "proud, defiant, and confident of accomplishing any mission it may be assigned."

Talking up the recent Communist charges that the Allies are carrying on germ warfare in Korea, Ridgway said these charges are a warning that the Reds, themselves, may be planning germ or gas warfare.

Ridgway denied the Red charges and hinted that the Communists will be in for bitter retaliation if they try germ or gas warfare.

Ridgway did not mention the recent violence at the Kojé Island prison camp.

On Kojé

On Kojé Island, Communist prisoners of war are setting up their own guard system, inside the barbed wire fences.

The Reds in the notorious Compound 76 apparently are out to prevent fellow Reds from escaping and causing more bloodshed.

In the fighting, American and Australian fighter-bombers have carried out one of the biggest raids of the war on Red installations near the North Korean capital of Pyongyang. The allied bombs flattened at least 117 buildings.

At the truce camp in Panmunjom, Vice-Admiral Turner Joy turned over his job as chief Allied negotiator to Major General William Harrison. Joy accused the Reds of blocking a truce at every turn and said there was nothing left for him to negotiate.

He turned over his post to General Harrison with these words: "May God be with you."

### Indiana Town Endangered By Burning Tanks

LOWELL, Indiana, May 22 (UP)—For a while today, part of Lowell, Indiana was in danger from flames set off by a freight train derailment.

Thirty cars of a 69-car train on the Monon Railroad went off the track and smashed the Lowell station. Six of the cars, loaded with alcohol, went up in flames and burning alcohol spilled along the streets of the business district. Firemen brought the fire under control after four hours without any casualties.

### American GI Is Found Guilty Of Killing Germans

A judge in the famous court-room at Nuremberg, Germany, read a verdict this morning—guilty.

But this time, the man facing justice is an American, a 19-year-old GI stationed in Germany.

In the same room where the top Nazis were tried, 10 army officers found private John Vignessault guilty of the murder of two German civilians and of stealing the car of one of his victims.

The young resident of Goff Falls, New Hampshire, showed no emotion as he heard the verdict of the general court martial.

### CONTROL OF SEPARATE, COMMUNITY PROPERTY EXPLAINED

Generally speaking, each spouse has the right to control and dispose of his or her own separate property. You will recall that the separate property of a husband or wife includes property owned by her before marriage, and that which is acquired after marriage is presumed by law to be community property until the contrary is clearly proved.

Azide from the ordinary community estate, there is a class of property known as the wife's separate property.

cial community," which includes all the income from her separate real property, and probably the interest on bonds or notes, and dividends on stocks owned in her separate right. While the husband may have similar assets, the law accords them no particular distinction from ordinary community property.

Although the history of the matter is somewhat confusing, it appears that under present day law the husband has control of ordinary community property; but control of the wife's special community property is reserved to her.

Certain restrictions are imposed upon both husband and wife in exercising and control. For instance, the husband cannot legally dispose of community property in such a way as to defraud the wife, nor can he sell the homestead without her signature and acknowledgement. And the wife's sale or mortgage of her separate real estate stocks or bonds is not valid unless her husband joins with her in the transaction—he must sign and execute the necessary legal papers along with her.

Such limitations appear to be a product of those earlier and more chivalrous days in which the sheltered married woman had little or no contact with the business world. They indicated a desire to protect the little woman from chiseling outsiders, and even against an unscrupulous husband.

A similar intent appears in the laws exempting the wife's separate and special community property from liability for debts incurred by the husband. Such liability is restricted to his separate property and the ordinary community property.

On the other hand, debts incurred by the wife in obtaining necessities for herself or the children bind all property belonging to either party, including the husband's separate property. For other debts which she has power to incur, only her separate and special

community property are liable. All of these distinctions emphasize the advisability of keeping proper records. By doing so the various classes of community and separate property owned by a married couple will always be easily distinguishable. Each category will then receive the special protection afforded to it by our laws.
