'UFO' Is Sighted, Lands in Pasture North of Ranger

An "unidentified flying object" — in appearance and movement a flying saucer — was sighted and successfully landed 3.2 miles north of Ranger on the Caddo Highway late Tuesday.

The time was 6:54 p.m. (CST). The eye-witness: Leo Verger, new employee of The Times and — most important — his camera.

According to Verger's account of the fantastic incident, he was enroute to Breckenridge and was approximately three miles from the city limits of Ranger when the motor of the 1960 Volkswagen he was driving began to sputter and the car's lights flickered, blinked oddly and began to dim out. He was traveling at a speed of about 55 miles per hour but within a half mile the

vehicle came to a dead stop. No motor. No lights.

Verger got out of the car to investigate, thinking there might be a loose connection on one of the auto's battery cables. He opened the hood and as he leaned over to take a look at the battery, he was blinded by an intense flash of light.

Swinging around quickly, he stood paralyzed in awe as he saw a fast-moving, glowing object zooming earthward directly overhead.

Assuming it was a meteor, Verger grabbed his camera from the front seat of the car.

In a matter of less than 10 seconds the object had whooshed down several thousand feet and silently landed in a pasture about 35 yards from the highway.

The Times reporter shot a picture, feverishly reloaded. Again, in only a matter of seconds, the object suddenly blasted upward from its landing spot amid blinding light and billowing puffs of smoke. There was no noise, not a sound — just hot, intense, acrid smoke.

Grass where the flying object had landed was burned to finely powdered ashes by the intense heat.

Verger's second picture showed only the remaining puffs of smoke on the landing site — the mysterious object had returned to the sky at a tremendous rate of speed.

Then his third and final shot caught the object as it raced through the heavens and quickly disappeared — at a fantastic speed, far exceeding that of any known aircraft.

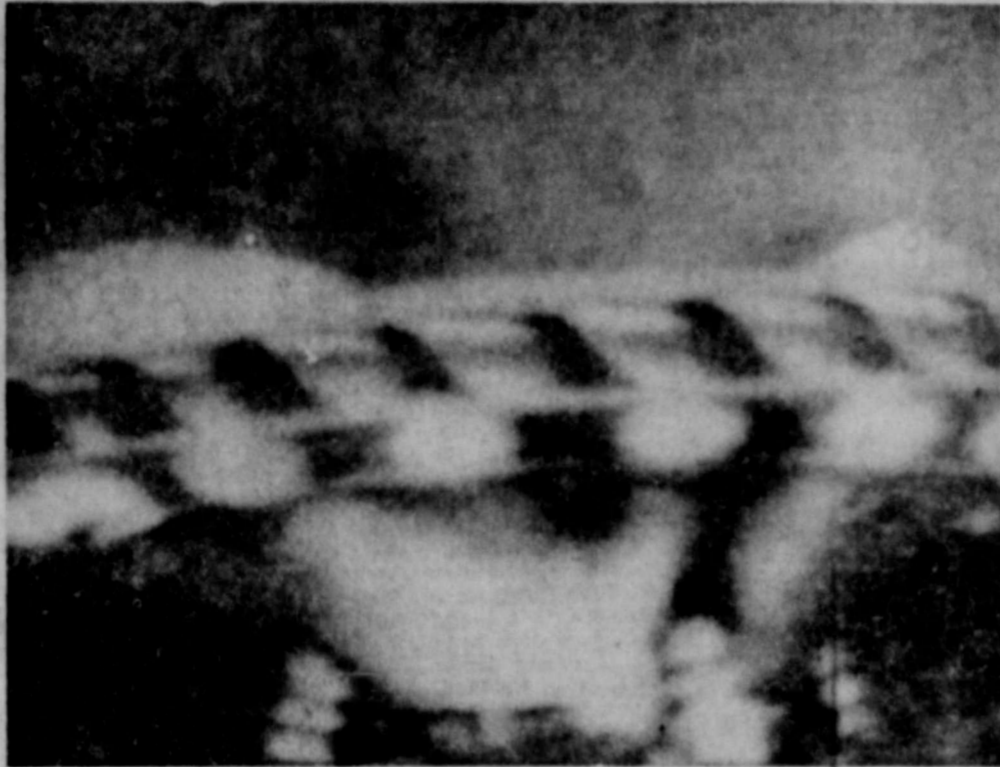
Verger rushed back to Ranger and at 6:40 p. m. he contacted civil defense authorities at Dallas. They were interested, of course, but told the reporter that they were constantly besieged with numerous reports regarding sighting "flying saucers" and various other "unidentified flying objects."

However, when Verger informed the civil defense authorities that he had three photographic shots to verify what he had seen with his own eyes, they requested him to say nothing to anyone and to rush the undeveloped film packs to Wolters Air Force Base near Mineral Wells.

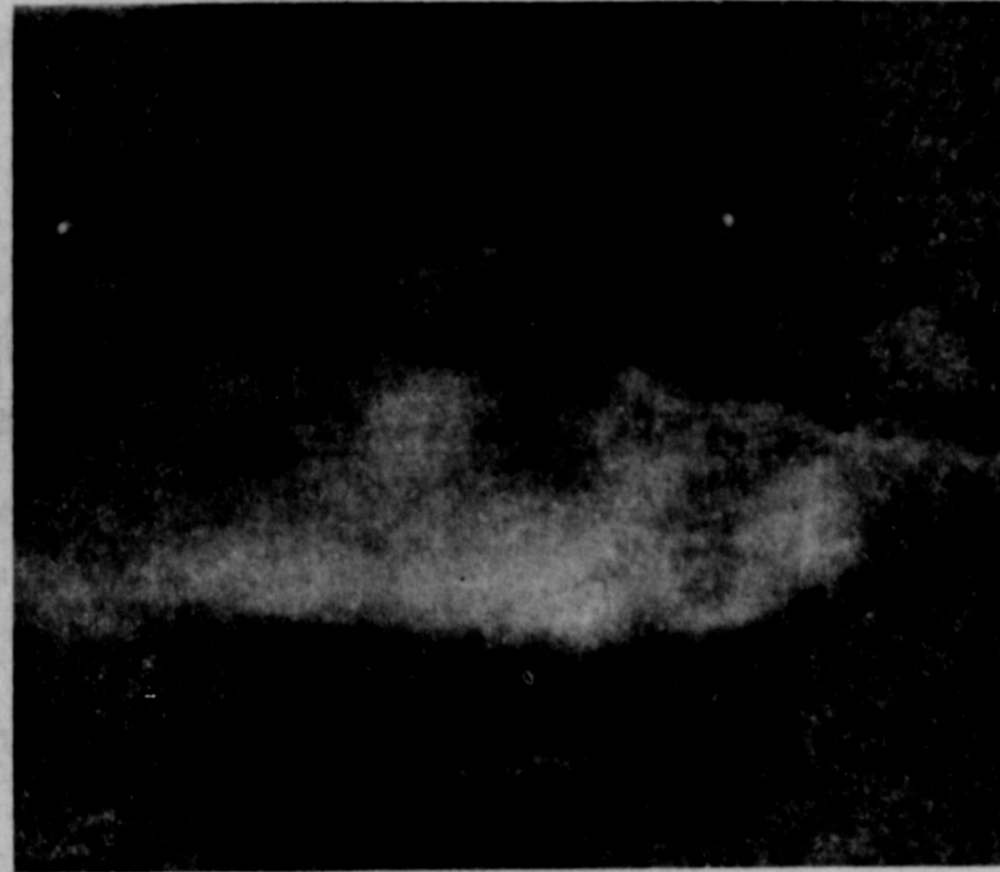
Verger arrived in Mineral Wells at 7:36 p.m. and was received by a half dozen Air Force officers. Even before introductions had been completed, the film packs were rushed to the USAF photographic section laboratory on the base for developing. Verger and three of the officers followed a few minutes later in a Jeep.

The negatives had been developed and printed by 7:50 p.m., and the prints weirdly and uncannily substantiated The Times reporter's amazing story.

At 8:00 p.m., Verger and

six USAF Intelligence officers were flown by helicopter to Carswell Air Force Base, Fort Worth. Then at 12:07 a.m. — little more than five hours after the Times reporter had spotted the "unidentified flying object" — the party landed at Boling Field near Washington, D. C. and was rushed by staff car to the Pentagon.

Verger was interrogated by USAF intelligence officers until Wednesday at 6 a.m. when he was allowed to take a nap and be prepared to return to Texas with a special officer investigating team scheduled to jet off from Boling at 12 noon.

He was kept under armed guard and was refused permission to use the telephone or make any other contacts. He was told that his photos had been classified as "top secret" and were, along with

Present City Commission In Final Meet Thursday

The bi-annual city election will be held next Tuesday, April 6, and three of the four city commissioners and the present mayor will be seeking re-election.

Last regular meeting of the current Ranger City Commission will be held Thursday night at City Hall at 7 o'clock.

The issue of renewing the franchise of Texas Electric Service Co., recently requested by the utility firm, probably will be a topic for discussion.

The present city commission is headed by Mayor Morris Newnham. Commissioners are Fred Bennett, street; J. W. Van Bibber, finance; George Falls, police, and Grover C. McGown, water.

Only incumbent not seeking re-election is Falls.

Mayor Newnham is unopposed as is Commissioner Bennett.

Van Bibber is making a bid for police commissioner against C. J. Davis. Dewey Cox and Doyle Gentry are in the race for finance commissioner, and incumbent McGown is being challenged by Bob Allen for water commissioner.

Voting will be at City Hall

with polls opening at 8 a.m. Balloting will end at 7 p.m. Friday, April 2, at 5 p.m. is the deadline for absentee voting in the city election, far been cast.

City Secretary Avis Jones warned late Tuesday. At that time she reported that only one absentee ballot had thus far been cast.

Five In Race School Board

Qualified voters of the Ranger Independent School District will go to the polls Saturday to elect candidates to fill three places on the RISD board.

Emory Ford, president of the board, is not seeking re-election in the Saturday balloting.

But two other board members — J. D. Nichols and R. V. Robinson — are asking for new terms.

Three other candidates will have their names listed on the Saturday ballot — Billy Rippy, Marvin McGee and Morris Campbell.

Robinson is vice president and Nichols is secretary of the board.

Holdover members include Frances Cox, Herman Stroud and Ross Hodges.

Area voters also will ballot Saturday to elect three members to the Eastland County School board.

County School Supt. G. L. Stamey announces that candidates are Wyatt Jacobs of Rising Star for the Precinct Three post; J. D. Lauderdale of Cisco for the Cisco precinct post; and Melvin Adams of Ranger, for the at-large position.

Holdover trustees are President I. C. Inzer of Eastland and Ross Wilson of Gorman. Trustees Jay Koonce of Rising Star and Frank Coats of Cisco are not seeking re-election this year.

Mrs. Pulley Attends 3-Day Diamond Clinic In Kansas City, Mo.

Mrs. D. E. Pulley has just returned from Kansas City where she attended an intensive, three-day refresher course in diamond grading. This clinic was conducted by the C. A. Kiger Company, one of the major diamond importers, who operate one of only a few diamond laboratories in the world.

"The laboratory itself is unique," says Mrs. Pulley. "It was kept at a constant temperature, the air was filtered to remove dust and it was lighted by specially designed lights so there were no shadows. Conditions were constant so diamonds could be graded at all times under the same conditions."

"We checked diamonds for color under constant light and then matched them against a set of master guide stones. These were checked under special ultra-violet rays for fluorescence. They were checked under a 'diamondscope', which is really a binocular microscope with specially corrected lens that give up to 60 power magnification, for internal markings."

"When you consider that 250 tons of blue rock (that's a pile 10 feet square and 100 feet high) have to be mined, transported, pulverized and sorted to produce the equivalent of one carat diamond — and there is only one flawless diamond in 376 carats — one is surprised that diamonds cost as little as they do. "But, we must thank

House Bill Proposes Creation Eastland County Juvenile Board

A bill to create an Eastland County Juvenile Board has been introduced in the Texas House of Representatives as H. B. 906 by Rep. Wayne Gibbons of this district, according to word from Austin today.

Under the measure, the county could hold an election on the question of creating a juvenile board, which would be composed of the county judge, the judge of the 91st District Court, and a third member to be selected by the two judges.

The bill would empower the Commissioners' Court to decide whether board members should be paid a salary; and, if so, they could be paid a maximum of \$100 per month.

It was understood that the bill would be on the Legislature's calendar as a "local bill."

The proposed act follows:

Section 1. There is hereby

created, subject to a majority vote of the qualified electors in the county, the Eastland County Juvenile Board. The Board shall be composed of the county judge of Eastland County, the judge of the 91st Judicial District, and a third member who shall be selected by the county judge and the district judge. The third member must be a resident of the county and shall serve for a term of two years. The county judge and the district judge shall appoint his successor. The county judge shall be the chairman of the juvenile board.

Sec. 2. (a) The commissioners court of Eastland County shall order and call the election within 90 days after the effective date of this Act for the purpose of approving or disapproving the creation of the board.

(b) Each ballot to be used in the election shall have

printed thereon the following:

"FOR the establishment of the Eastland County Juvenile Board.

"AGAINST the establishment of the Eastland County Juvenile Board."

(c) The order calling the election, publication of notice, procedure for holding the election, and the canvass and certification of returns shall be governed by the provisions of the Texas Election Code.

(d) If a majority of the qualified electors voting in the election vote for the establishment of the board, the commissioners court shall declare the board created and record the results in the minutes of the court.

(e) If a majority of the qualified electors voting in the election vote against the establishment of the board, this Act is of no further effect.

Sec. 3. The commissioners

court of the county shall determine whether the members of the board should receive additional compensation for the duties imposed by this Act, and if so, the court may pay each member of the board, in addition to all other compensation provided by law, an amount not to exceed \$1,200 each year, payable in 12 equal monthly installments.

Sec. 4. The board shall have all the powers conferred on juvenile boards created under Article 5239, Revised Civil Statutes of Texas, 1925, as amended.

Sec. 5. The importance of this legislation and the crowded condition of the calendar in both houses create an emergency and an imperative public necessity that the Constitutional Rule requiring bills to be read on three separate days in each house be suspended, and the Rule is hereby suspended.
