## City suit settled; precincts drawn

Except for the Nazareth Labor Day Picnic Sept. 3, our summer celebrations are all behind us.

Now it's time to turn our eyes toward the Castro County Centennial. Our county will be 100 years old next year.

Actually, the planning has been going on almost a year already, and the Centennial Commission has been holding regular meetings since May. The county commissioners' court appointed Dimmitt Postmaster Bill Sava and me to serve as co-chairmen of the commission.

Right off the bat, we were contacted by an out-of-state production company that offered to come in and stage a big two-week centennial blast for us—for \$35,000.

We told them thanks, but no thanks.

We're going to have a "home grown" centennial celebration that will last all year and go to all our communities. It will be built mainly on existing celebrations — Hart Days, the Nazareth German Folk Festival, Harvest Days, the Fourth of July — and also will include special events at most of our churches and crossroads communities.

If it's to be a successful, meaningful observance, then we've got to have the ideas, input and help of hundreds of volunteers.

That's where you come in. You probably have talents and abilities that the centennial planners don't know about. If you have any special capabilities—or just the desire to be a part of it—we need your help.

The centennial celebration is in the planning and organizing stages now. Working committees are being formed, and we've got a long list of ideas that need to be acted upon, with more ideas surely to come.

Here are some of the things the Centennial Commission has on tap so far:

—A contest to pick an official centennial logo, which will be used by our post offices, newspapers and businesses to call attention to our county's 100th anniversary year. The contest will begin next month and the logo will be unveiled at the annual Dimmitt Chamber of Commerce Banquet in January. Janet Mitchell of Hart is heading up the logo contest committee.

—Construction of a centennial gazebo, or bandstand, on the courthouse square—reminiscent of the bandstand that originally stood there. County Judge Polly Simpson is heading up this project, and is going to need a lot of volunteers to help.

—A "memorial plaza" on the courthouse square, with engraved bricks or granite tiles commemorating past and present families and individuals. Robert Hawkins of Hart is in charge of this project.

—Creation of a Centennial Chorus and a troupe of Centennial Players to perform at special events around the county during 1991. Bill Sava, who will direct the Centennial Players, already has written several original songs and skits based on county historical events and characters. The director and

## DHS ranked among top 10% of schools

Dimmitt High School has been ranked among the top 10% of schools in the state and has been nominated as a contender for special recognition from the Governor's Educational Excellence Committee.

The school is now eligible to contend for excellence awards that include a cash allocation ranging from \$10,000 to \$100,000, presentation of a Texas Educational Excellence flag, and recognition at a formal ceremony at the Capitol in Austin.

DHS's nomination was based on gains in TEAMS scores and SA-

T/ACT scores over the last three years.

DHS Principal R.L. Stockstill revealed that the application asks for information on what initiatives have been exercised by the school to encourage parents to provide an effective learning environment at home; what programs have been developed to encourage parental/community/business involvement; what major factors have contributed to the academic accomplishments of the school; and what obstacles or barriers have been overcome to achieve such success.

## Broadstreet mounts write-in campaign

Harold E. Broadstreet of Dimmitt has filed as an official write-in candidate for county judge in the Nov. 6 general election.

Broadstreet filed as an independent candidate, challenging incumbent Polly Simpson, who was unopposed on the March 13 Democratic Primary ballot. No one filed for the office on the Republican Primary ballot.

"I think our county government has gotten into a rut, and is suffering from tunnel vision, with no new ideas. There's a need to expand their vision for future growth," Broadstreet said.

Broadstreet said he has had some encouragement in his bid from several local citizens.

A resident of Dimmitt for 17 years, Broadstreet moved to Lubbock in September 1987, but moved back to town in September 1989. He is employed as a traffic coordinator (dispatcher) by Braafladt Transport in Dimmitt.

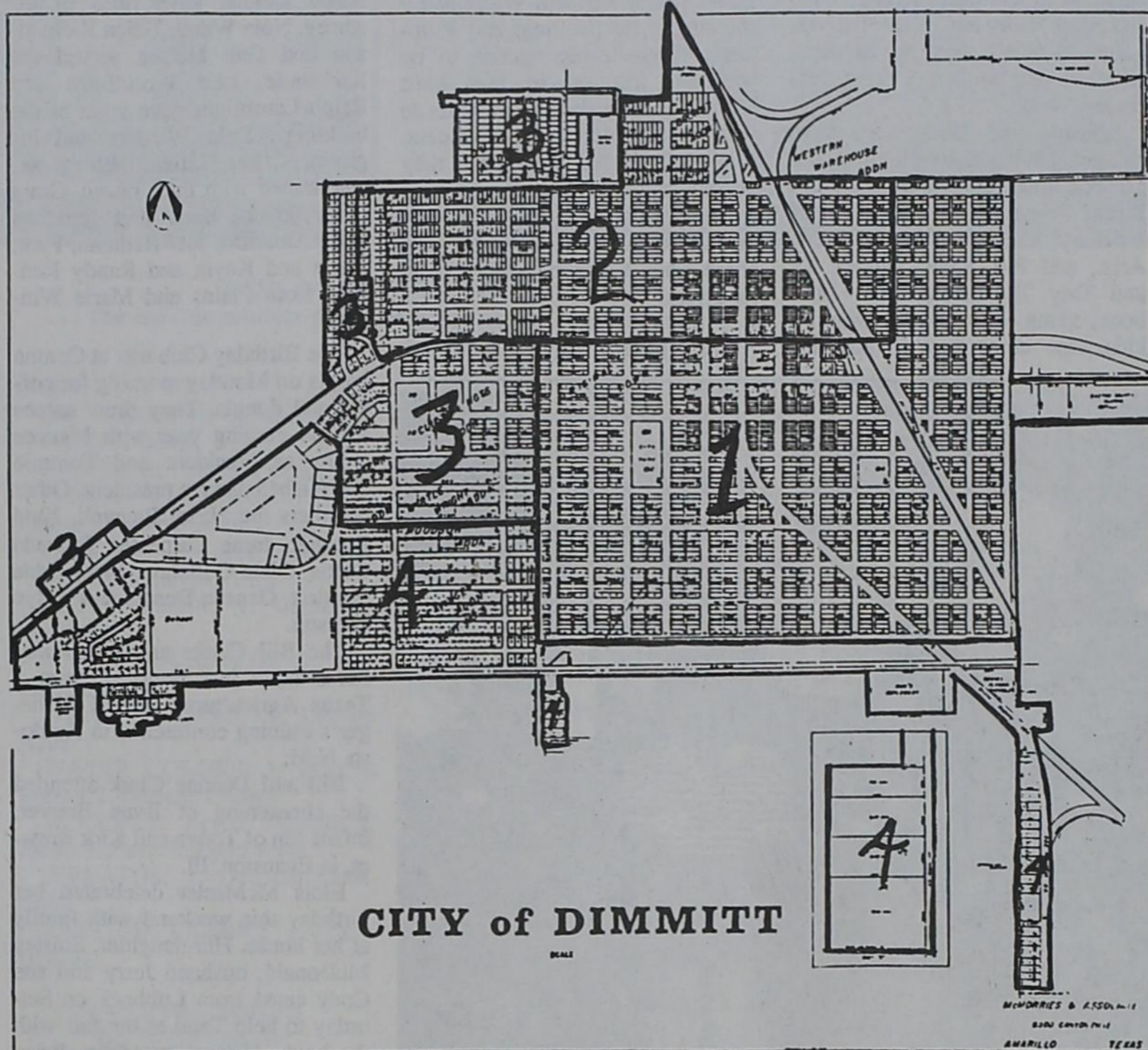
In 1970, Broadstreet retired from the US Marine Corps after serving

21 years, including 17 years as a criminal investigator. He noted that part of his duties included budgeting experience.

"I will do my best, and if I can't, then I'll resign, plain and simple," Broadstreet vowed. "I'll see if I can improve the situation."

## School registration begins today

Summer vacation is nearly over and it is time to go back to school. Registration for the three county schools is starting today.

### Dimmitt

Dimmitt's school registration will be held today and classes will begin Aug. 28.

High school seniors will register between 1 and 1:45 p.m., juniors between 1:45 and 2:30 p.m., sophomores will register between 2:30 and 3:15 p.m., and freshmen will register from 3:15 to 4 p.m. The 1989-90 annual may be picked up during registration.

Registration will start in the auditorium with school pictures being taken, and the dress policy will be in effect.

Dimmitt Middle School will hold registration from 1 to 4 p.m.

At 1 p.m., grades four, five and six will register in the west section of the middle school. Supply list for grades four through six will be available at registration.

Seventh grade registration will be from 1 to 2:30 p.m. and eighth grade registration will be from 2:30 to 4 p.m. at the DMS library.

Middle school students may purchase meal tickets or pick up an application for free and reduced meals during registration.

A general registration for grades kindergarten through third will be from 1 to 4 p.m. at Richardson Elementary School. Bring a copy of your child's birth certificate, shot record and social security number to registration.

### Nazareth

Registration for Nazareth High School students will be Friday. Senior registration will be from 8:30 to 9:30 a.m., junior registration will be from 9:30 to 10:30 p.m., sophomore registration will be from 10:30 to 11:30 a.m., and freshmen registration will be from 1:30 to 2:30 p.m.

Grades kindergarten through eight will register on the first day of classes, Aug. 27 beginning at 8:20 a.m.

### Hart

Registration for Hart schools will be held Thursday.

Elementary students will register between 9 a.m. and noon at the elementary building.

Junior high and high school students will register at the high school library.

Seniors will register from 8:30 to 9:30 a.m., juniors will register from 9:30 to 10:30 a.m., sophomores

will register from 10:30 to 11:30 a.m., and freshmen will register from 11:30 a.m. to 12:30 p.m.

Eighth graders will register between 1 and 2 p.m. and seventh graders will register between 2:30 and 3:30 p.m.

Classes for Hart schools will start Aug. 27.

## Lumbrera to face only Kansas charge

Former Dimmitt resident Diane Lumbrera, accused of murdering as many as seven children, six of them her own, will only face evidence from one of the deaths in her upcoming trial in Kansas, set for Sept. 24.

Kansas Judge Stephen Nyswonger ruled Aug. 16 that evidence from six deaths that occurred in Texas cannot be admitted in Lumbrera's first-degree murder trial for the May 1 death of her son, Jose Antonio, 4, who was already dead when Lumbrera took him into a Garden City hospital emergency room.

Originally, the death was attributed to death by smothering, and Lumbrera was arrested May 5, but a subsequent autopsy ruled the death was by natural causes. Lumbrera was indicted June 15, after 2-1/2 days of testimony determined there was sufficient evidence for a trial.

The Kansas case stimulated interest in the earlier Texas deaths, and Lumbrera was indicted in three of the deaths Aug. 8 by a Parmer County grand jury, following extensive investigation and work by two pathologists, including Dr. Robert Bux. A bond of \$300,000 was set on the Texas charges.

Lumbrera had been free earlier

on \$50,000 bond on the Kansas murder charge, but she opted to surrender that bond and begin counting her jail time against any

Our trip extended from July 24 to Aug. 7. The group landed in Frankfurt, Germany, where we joined our European tour guides, Bill and Sally Wagner, who have lived on the European Continent 26 years and are Baptist Missionaries.

Our first overnight stop was in Kaiserslautern in southwest Germany, where many of the armed forces are stationed. On our first day, we enjoyed a very scenic cruise on the Rhine River and also visited the City of Mainz, which is 2,000 years old, and is the home of the Gutenberg Museum. We saw exhibits about the origins of writing, the printing press and books.

Munich, the capital of Bavaria, is very modern and progressive;

however, it has kept its quaint Bavarian atmosphere. It is a beautiful city. Here, we visited the Residence Museum, where we saw many very elaborate crown jewels. We also went through the Hofbrauhaus (Beer Garden) where Hitler made his first political announcement.

On July 28, we were in Oberammergau, where we saw the "Passion Play," which was definitely the highlight of our trip. The first Passion Play was in 1634 in fulfillment of a vow to perform "the drama of the sufferings and death of the Lord" if the pestilence, which had ravished the village, would cease. The pestilence did cease, and the Play has been given every ten years since 1640. Oberammergau is located in the foothills of the Alps, just a short distance from the border of Austria.

Also located in this area is the Neuschwanstien Castle of the "Mad" King Ludwig. Disneyland was modeled after this "Fairytale Castle." We climbed many, many steps to tour this beautiful castle.

We traveled by van on our trip and enjoyed getting a close look at the countryside in both France and Germany. In Paris, we saw the Louvre, the Eiffel Tower, Notre Dam Cathedral, and had lunch at the famous Maxim's restaurant. On our way to the city of Tours, we drove through the beautiful Loire Valley, where many very pretty chateaux are located. We toured many of them and were privileged to spend the night in the elegant Chateau d' Artigny and the Chateau du Malay. The food was excellent and served so prettily.

We enjoyed a scenic drive through Normandy as we drove to Luxembourg, where we were on Aug. 5. The city is a contrast of the very old with the modern, with a distinctive French flair. They speak both French and German and use Belgian currency. While here, we had Mexican food at Chi-Chi's, and ice cream at McDonald's.

On our drive from Luxembourg to Frankfurt, we stopped at an old German town of Trier, where we saw very old Roman ruins that were very impressive.

We departed from Frankfurt on Aug. 7.

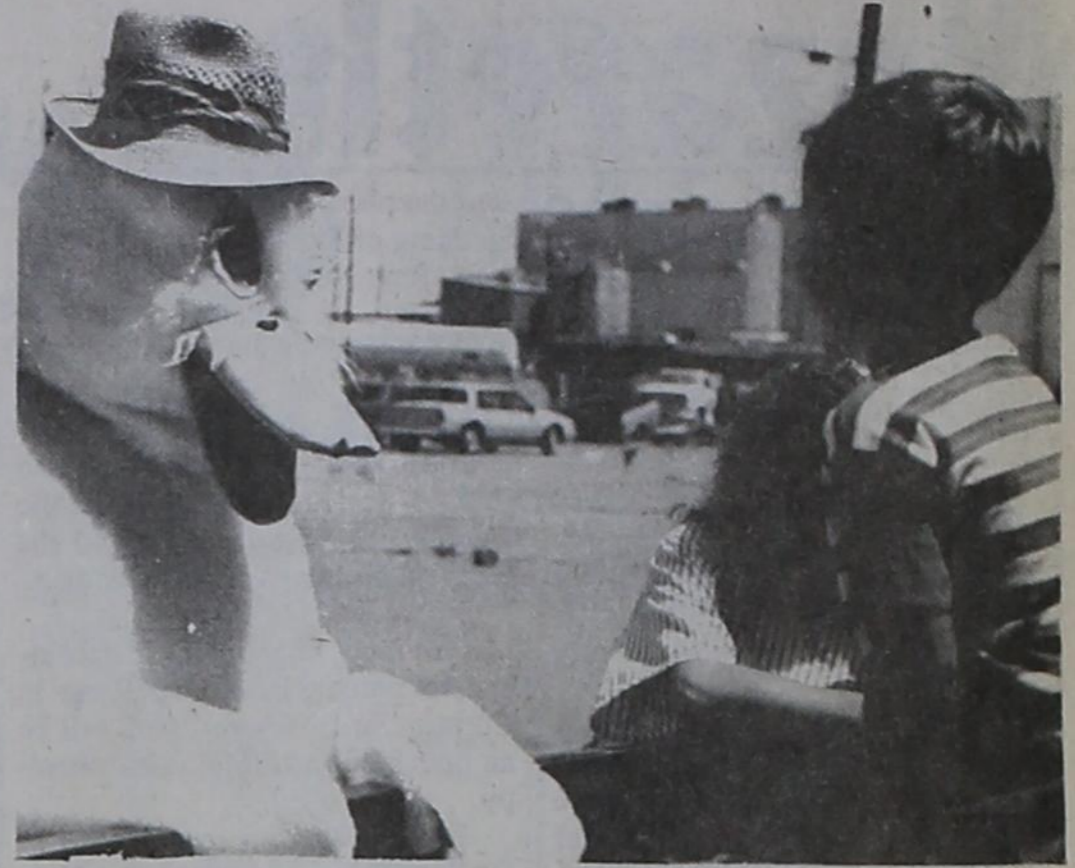
happy birthday during the open house. A buffet supper was served in the evening.

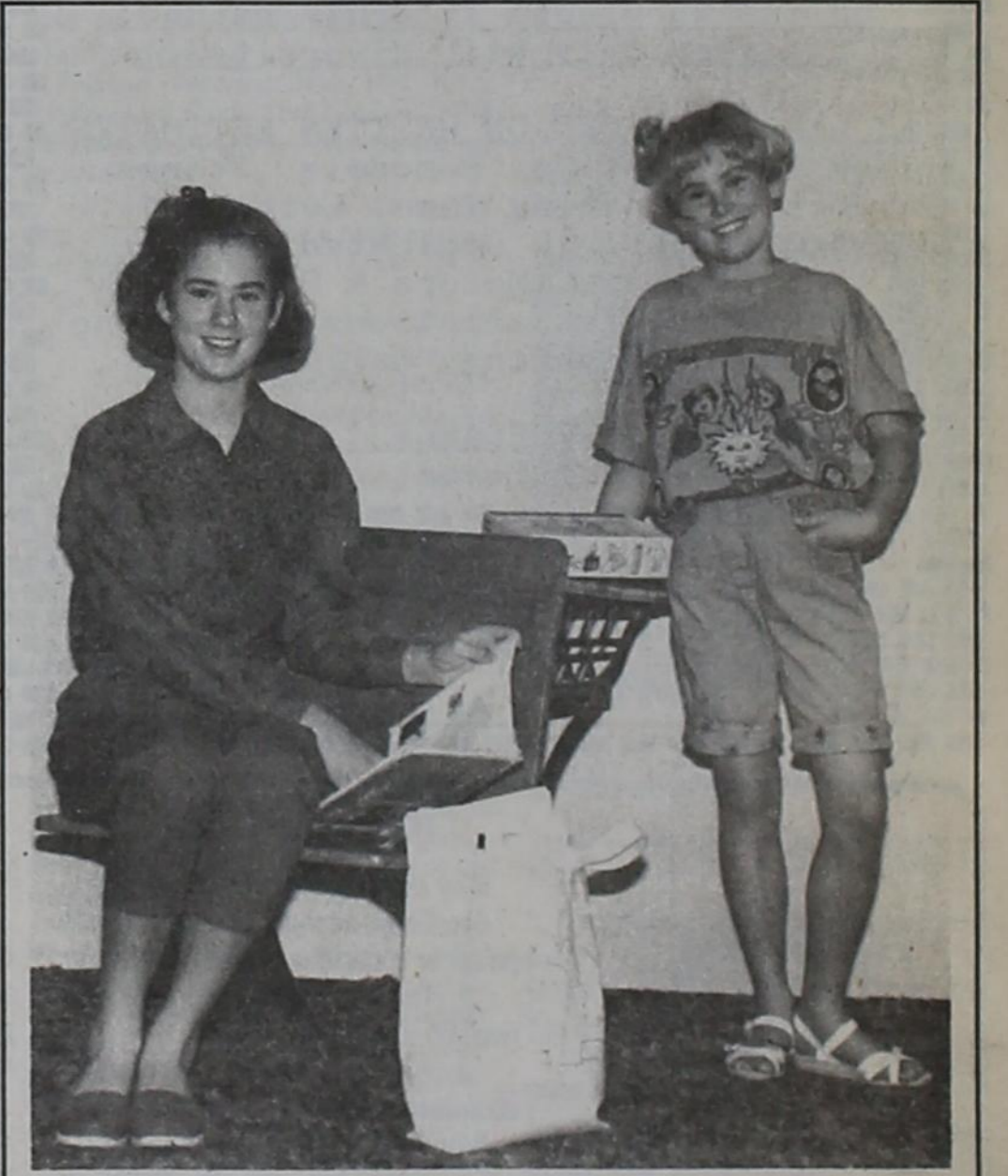

# Immunization rules will change Sept. 1

In preparing children for back-to-school, parents should be aware of new, more stringent immunization rules for all Texas children, which will become effective Sept. 1.

The Texas Dept. of Health is notifying all school and child-care facility administrators about the new rules. Still more changes in the immunization requirements, including a mandatory second dose of measles vaccine, are set for 1991.

Wes Hodgson, epidemiology coordinator for the TDH Immunization Division, said, "The large measles outbreaks which began in 1988 underscored the fact that measles and other vaccine-preventable diseases can pose tragic health threats unless all susceptible people are immunized against them."

Hodgson noted that some parents in recent years have failed to have their children vaccinated. Also, he said that some school and day-care operators have not kept adequate records.

"The result is a growing number of insufficiently immunized children and young adults at risk of measles infection," Hodgson remarked.

He added that currently the law requires all children entering Texas schools or day-care to show proof of immunization at certain ages against polio, tetanus, measles, rubella (German measles), mumps and diphtheria. In addition, the law

requires pertussis (whooping cough) vaccine for all school and day-care children younger than 5.

However, amendments adopted by the Texas Board of Health in June more sharply define, and in some cases change, children's immunization requirements. Among the major amendments are:

\*Beginning Sept. 1, 1990, children and students enrolling in Texas child-care facilities or schools must have received both mumps and measles vaccines on or after their first birthdays.

\*Beginning Jan. 1, 1991, students whose 12th birthdays occur on or after Sept. 1, 1990 will be required to have two doses of measles vaccine, or provide evidence of measles immunity. The two doses must be administered at least 30 days apart, and proof of the second dose will not be required until the child's 12th birthday.

\*Beginning Sept. 1, 1991, *Haemophilus influenzae* type b (Hib) vaccine will be required for children ages 18 months through 4 years.

\*Beginning Sept. 1, 1991, all children and students enrolling for the first time must have received rubella vaccine at age 1 or older.

Hodgson added that persons needing further details about immunization requirements should consult their family physicians, local health departments, or school officials.

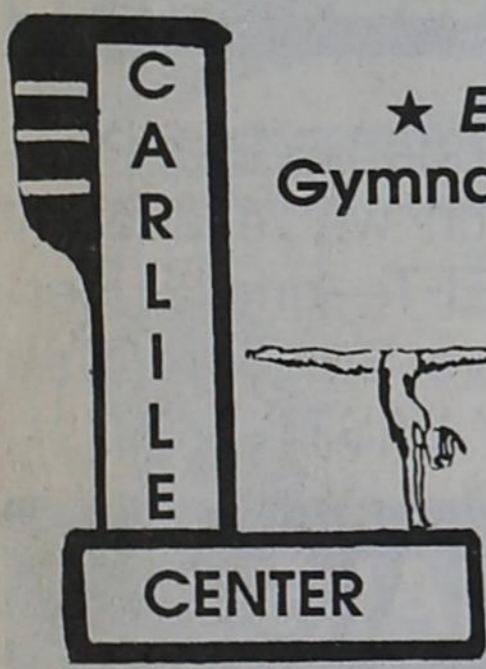

## Bobcats hope to 'fill the gaps'

This year's Bobcats have both experience and promise.

With starters back at nine defensive and six offensive positions, they're expected to be in the thick of the District 2-AAA championship race this season.

And they have a "terrific" attitude, according to Head Coach Army Salinas.

What they *don't* have is numbers.

More than a dozen players who were expected to report for two-a-day workouts, didn't.

That includes six of last year's varsity squad members.

"At one point last week we had only 17 kids who could be classified as varsity players," Salinas said. "We've moved some sophomores up to fill out the squad."

The Bobcats, now in their second week of two-a-day workouts, are looking forward to their first scrimmage Friday evening at Morton, and their annual Picture Day, Ice Cream Social and "Meet the Bobcats" program Saturday evening.

Salinas hopes that some of those who didn't report for two-a-days will change their minds with the start of school next week.

"If they're willing to pay the price these kids have paid, we'd certainly be willing to talk to them," he said.

With Salinas, it isn't just a mat-

ter of filling out a roster.

"The most disappointing thing to me is that these kids who didn't come out will miss all the things a good program can do for them—the camaraderie, the commitment, the discipline, the accomplishment, the feeling of self-worth, the thrill of being part of a winning team," he said. "I know from experience what a good football program can do for a kid, and I know that a lot of the kids who didn't come out are someday going to regret not having done it."

Although he's discouraged about his number of players, "I'm optimistic about our chances," Salinas said.

"Our goal this year is to win district," he told the Lions Club last week. "This is my third year here, and we've knocked on the door our first two seasons. This is the year I want to do it. I want the kids to get to experience that thrill that comes with winning a district championship."

It doesn't bother Salinas that Tulia and Floydada are ranked 1-2 in the district, with Dimmitt third. Both of his previous Bobcat teams blew past their pre-season rankings.

The Bobcats lost only seven seniors from last year's 5-4-1 squad. But the no-shows have increased the number of roster gaps to 13.

That will put a lot more pressure on the returning experienced players.

The Bobcats are fairly rich in returning offensive starters:

—Freddy Martinez, all-district senior quarterback.

—Michael Ethridge, all-district senior split end.

—Johnny Ortegon, all-district senior fullback.

—Robert Ruiz, all-district junior running back and kicker (who is playing tight end this year).

—Ryan Hardee, two-time all-district senior guard.

—Albert Ramirez, senior tackle.

And they're even richer in returning defensive starters:

—Billy Ray Thomas, all-district junior strong safety (who also will play offensive halfback).

—Armando Arce, junior cornerback (who will double as tailback on offense).

—Ethridge, an all-district cornerback.

—Ruiz at defensive end.

—Levi Reynolds, junior defensive end (who also will start at offensive center).

—Hardee, who played tackle on defense last year but who has moved to linebacker.

—Paul Axtell, senior tackle.

—Luciano Quiroz, junior nose



guard.  
—Arthur Velasquez, senior nose guard and tackle (who will play tackle on both defense and offense this season).

That's a lot of experience — especially compared with this time last year, when Hardee was the lone returning starter.

But it isn't nearly as much experience as the coaches were counting on. These 12 make up the entire crop from last year's varsity roster who reported for two-a-day workouts.

Some of these returning starters were pressed into starting roles near the end of last season, Salinas explained, noting that six sophomores started the final two games.

Also returning for duty are juniors Lincoln Stewart (free safety and quarterback) and Juan Martinez

(guard and linebacker), both of whom were brought up from the JV for the last two games last season. Stewart started both of those games as a sophomore free safety.

Others up from last year's JV this season are senior Rodney Kilough and juniors Albert Rivera, Casey Summers, Monty Moore, Coby Heller and Andy Bermea. To

fill out the short varsity roster, sophomores Jeromy Casey, Zach Smith and Chris Hutson have been moved up during two-a-day workouts.

With all returning lettermen now in starting roles, and with many of them doing double duty, "The key is whether we can stay healthy," Salinas said.

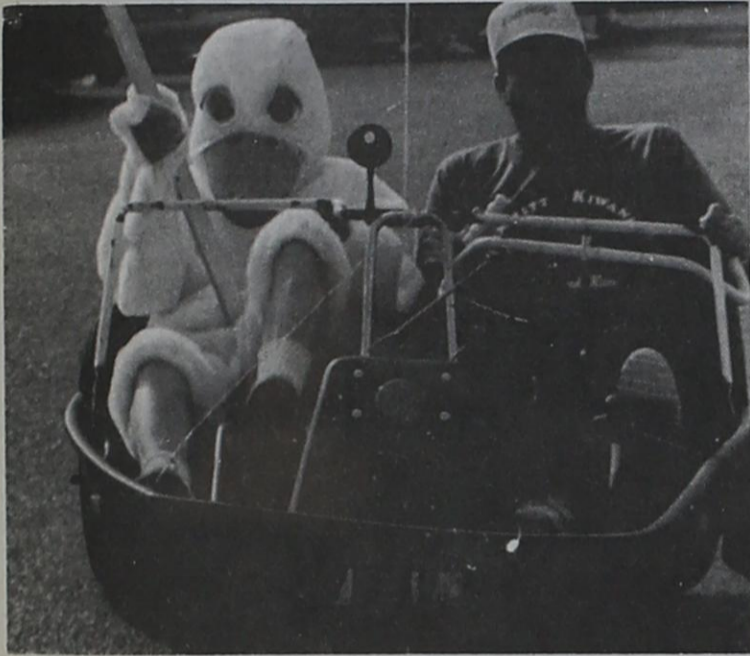

prison time assessed if she should happen to be found guilty.

Lumbrera was not brought to Texas to face the Parmer grand jury, and Kansas authorities have said any extradition proceedings would have to wait until all of the legal proceedings in Kansas are completed.

Castro County Sheriff's Deputy Jerry Bailey reported that, "We presented what evidence we had to show similarities in intent and method, etc., but the judge ruled against (allowing the Texas evidence)."

Bailey remarked that in some instances in Kansas law, prior events can be brought to show intent or method.

"But the judge, in citing case law, decided if he were to allow any of the previous deaths, it would only be the three for which she was already indicted, because there haven't been indictments handed down or warrants issued in the other deaths, yet," Bailey said.

"He (the judge) also felt that if he did allow it (the Texas testimony) in and it did meet some criterion of law, the prejudice of evidence entered would have been so damaging, it would have been hard for the defendant to have a fair and impartial trial, and it would have prejudiced the jury," Bailey explained.

A pre-trial hearing is set for Sept. 13, with jury selection to begin Sept. 19, and the hearing of evidence to begin Sept. 24.

Stockstill said the answers will "most certainly" describe the PIE (Parents Involved in Education) program, the various programs which have addressed the "at-risk" student population (including the SMASH program, no longer in operation), and the recent open house, which featured a "mini schedule" for parents during Public School Week.

Factors Stockstill says have contributed to the school's academic accomplishments center around an emphasis placed on a positive school climate and high expectations from the administration toward teachers and from teachers toward students. He also cited the positive attitude on the part of students and the work ethic displayed by students, and their willingness to accept a challenge and work toward that challenge.

Obstacles Stockstill mentioned include the "entirely human resistance to change," and the presence of an element, which is present in every student body, which has a 'blase' attitude about school. He noted that such an attitude has been addressed through the at-risk programs and through the efforts of personnel who serve as role models and offer counseling for students.

The application also asks for statistical information, including the number of students enrolled in

advanced placement courses and honors courses, which Stockstill felt would be a "very favorable" statistic for DHS.

Other areas of comparison will include percentage of students involved in extra-curricular activities and in community service/volunteer activities, and percentage of teachers earning college credit in their subject areas in the last three years.

Winners of the excellence awards will be notified later in the fall, with the presentation ceremony scheduled for sometime in October.

Stockstill noted that it is an honor for DHS just to be nominated to receive an application, and said that he feels "DHS will compete very well."

# District Court judge hands down decisions

Ricky Joe Garibaldi, 24-year-old Dimmitt resident, was sentenced to serve 15 years in prison and a \$10,000 fine last week in 64th District Court following his plea of guilty to a local jury.

Garibaldi had been arrested for the March 8 burglary of an apartment in southwest Dimmitt leased by the Andy Rogers family. According to trial testimony, Rogers indicated that the family had lived in the apartment several months while constructing a new home in Dimmitt. The Rogers family was in Lubbock as the result of a hospitalization of a family member when the apartment was burglarized. Electronic equipment, women's coats and jewelry items were taken during the burglary. Rogers indicated that all but \$400 of the property was recovered, but that business records taken during the same incident were never recovered.

Among the business records taken was a bank credit card which was later used the same morning at the First State Bank of Dimmitt. Photographs made automatically by the bank teller machine revealed Garibaldi and a co-defendant allegedly attempting to use the card within hours of the burglary. The pictures also verified information contained in a search warrant obtained by the Dimmitt Police Dept. and in confessions later secured by the police.

Garibaldi pleaded guilty Friday to Credit Card Abuse resulting from the same incident, gave up his right to a jury trial and was sentenced by Judge Jack Miller to serve four years in prison.

Also on Friday, Adam Vasquez Lopez, 22-year-old Dimmitt resident and co-defendant to Garibaldi, pleaded guilty to burglarizing the Rogers residence and using the credit card taken in the burglary. Lopez was sentenced by Judge Miller to serve 20 years on the burglary charge and 4 years on the credit card case. On other co-defendant remains jailed and will go to trial in October.

Probation was revoked last Thursday for 22-year-old William

Scott Little, formerly of Truckee, Calif. Little had been convicted in 1979 for piloting an aircraft loaded with more than 500 pounds of marijuana which crashed west of Dimmitt more than 11 years ago.

After a lengthy trial in which a local jury granted probation to Little, he was subsequently convicted in California of offering to sell cocaine and sentenced to four year prison sentence at Folsom State Prison. Following the California incarceration, Little was picked up by local officers and immediately transferred to Dimmitt to face an application to revoke probation filed by County District Attorney Jimmy Davis.

Little was granted credit for the California prison sentence. He was sentenced by Judge Miller to serve six years in the Texas Dept. of Criminal Justice and to pay a \$5,000 fine.

Elodia Martinez, 48-year-old Dimmitt resident, also pleaded guilty before Judge Miller Wednesday to the charge of Tampering with governmental records in relation to food stamp applications.

She received a seven year prison sentence probated for three years and was fined \$300. She must also pay court costs of \$133, probation fees of \$1,440 and the Texas Dept. of Human Services \$670. She will also be disqualified from the food stamp program for seven years.

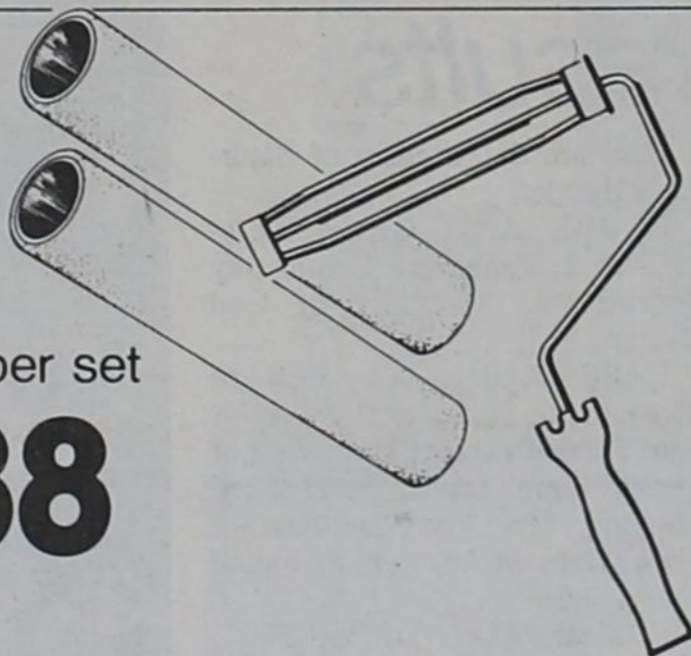

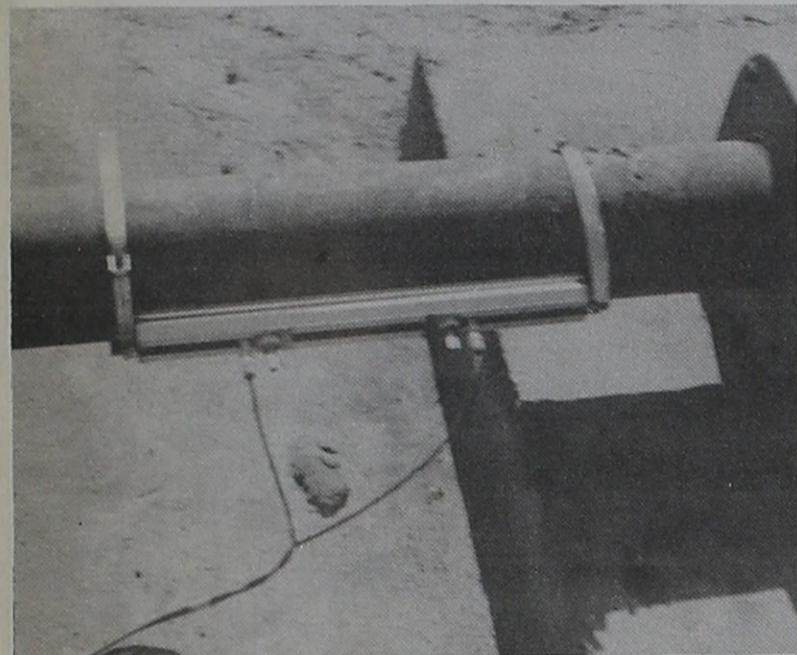
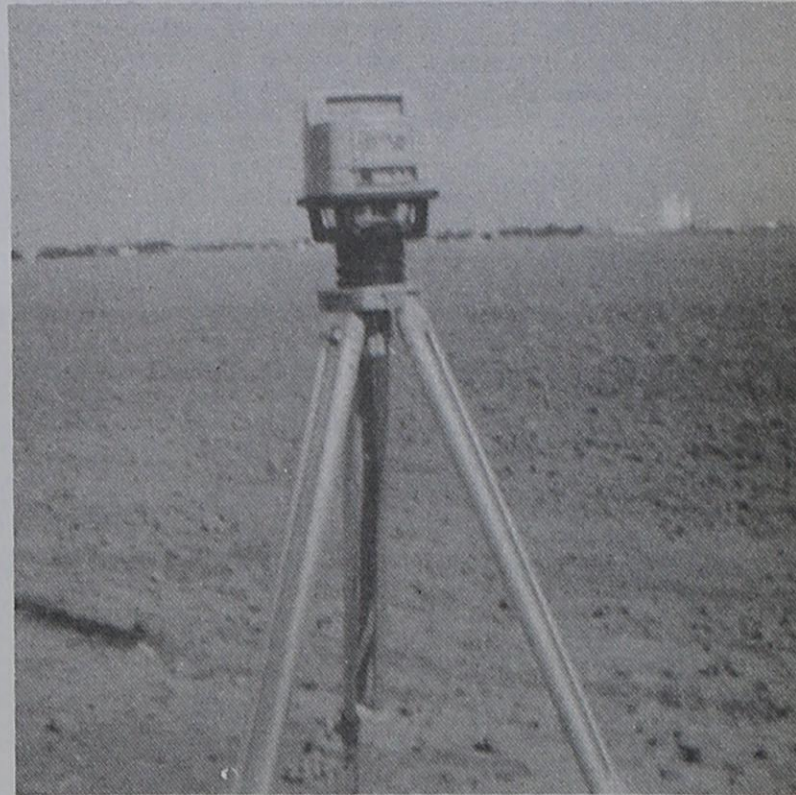

# Running Water Soil and Water Conservation District



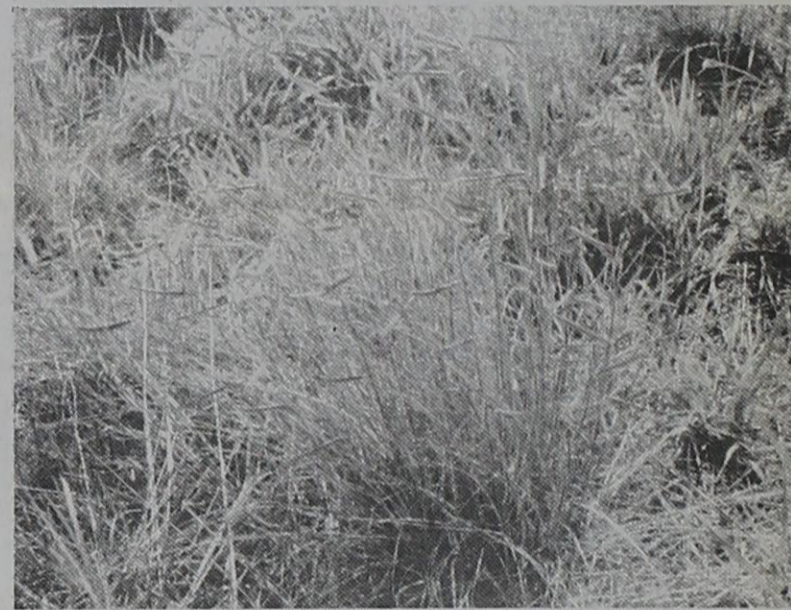
## QUARTERLY REPORT—AUGUST 1990



In May of this year, the Running Water Soil and Water Conservation District, with the assistance of a grant through the Texas Water Development Board, has purchased a Polysonic flowmeter and a Laser Level. With the Polysonic flowmeter, more accurate and precise information can be gathered on what an irrigation well is pumping, than information that is gathered from turbine flowmeters. Irrigation wells no longer have to be shut off and restarted like in the past when the turbine flowmeters were utilized. The Polysonic flowmeter can be used on center pivots, flowline, and at the well as long as there is about 3' of pipe where there is no disturbance, no cooling coils, or outlets. Since June 1, the local SCS office has checked 152 irrigation wells for producers in Castro County with the Polysonic flowmeter. The Laser Level, purchased by the district has been utilized on 12 engineering jobs such as checking out waterways, laying out ditch lines, making elevation maps and determining row directions. With both pieces of equipment the local SCS personnel has been able to provide local producers a quality service as well as making better use of their time. Anyone interested in having their wells and/or center pivots checked should contact their local SCS office in Dimmitt.

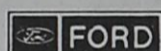


This year the local SCS office has assisted CRP producers in the seeding of about 10,000 acres to grass. At the present time, most of this grass is up and growing and is looking good. This past year, native grasses such as sideoats grama and blue grama were seeded. Castro County has 50,438 acres in the CRP program, with most of these acres established in grass. Again, the district would like to remind all CRP producers, that it is their (the landowner) responsibility to control the weeds that are on their CRP fields. With the moisture we have received lately, CRP producers need to take a good look at their fields and determine if a weed control will need to be applied. CRP producers could be assessed a penalty if weeds from their CRP contracts are allowed to blow on neighboring farms. CRP producers with questions should contact their local SCS personnel in Dimmitt.
