City Engineer Wants a Concrete Viaduct Instead of an Unsightly Steel Bridge on Hill Street

Feeling that a residence section of Fort Worth like that surrounding the Hill street crossing over the railroads should not be marred with an unsightly steel bridge, City Engineer Hawley has prepared plans for the construction of a concrete viaduct, which, beside having various other points of advantage over steel structure, will be more artistic. The plans for the crossing as prepared by City Engineer Hawley provide for a concrete viaduct 140 feet in length, striking the old approaches to the crossing at either side. The main roadway of the crossing will be thirty feet in width, with the street car tracks upon the one side. On the opposite side will be a walk of six feet in width. The arches will be constructed ornamentally as well as substantially.

In favor of the concrete bridge, it is urged that while the first cost will not be in excess of that of the steel, it will be much more durable and will need no repair. Another important point in view of the long delay in the replacing of the destroyed crossing is the fact that the concrete viaduct can be erected in from thirty to sixty days, while the steel structure could not be put in place in ess than ninety days, counting upon the most prompt delivery of the materials.


