The roster of former members of the Light Crust Doughboys is illustrious: Bob Wills, a favorite in musical western films and on the juke boxes, was a leader of the Doughboys, and is credited with composing their song, Eddie Dean, former master of ceremonies, now an announcer with one of the top networks; Leon McAuliffe, a regular favorite once a Doughboy; and the most widely known personality of the Light Crust Doughboys was W. Lee O'Day.

The Light Crust Doughboys have never confined themselves merely to playing tunes—they also sing the songs they play. They have made a number of recordings for Columbia and King records, their most popular being "The Present Light Crust Doughboy," composed by Carroll Hubbard, fiddle; Paul Blunt, steel guitar; Marve Montgomery, standard guitar; Jim Boyce, electric guitar; Artie Glenn, bass; and Jack Perry, drums.

They will be featured entertainers at the Boys Club Rodeo at Lubbock Municipal Coliseum May 8, 9 and 10 beginning at 8 p.m.



Conference Called to Discuss Control of C-T Mosquitoes

An authority on the control of encephalitis, "sleeping sickness," said Tuesday that proper control measures by farmers can virtually eliminate the mosquito reaching epidemic proportions.

Speaking at the annual Texas Medical Association convention in Dallas Tuesday, Dr. C. A. Pifgord, Lubbock public health director, said the disease is most likely to become prevalent in irrigated areas and is unlikely to spread to the north. Panhandle even though the region is dotted with fresh water lakes.

Any encephalitis outbreaks probably will be confined to the South Plains, he said, because the carrier of the virus, the culicoid tarsalis mosquito—prefers to live in irrigation water.

He recommended a dieldrin spray, applied to dry lakesides, ditches, and other irrigation water tanks before the first irrigation water is applied to the fields.

Speaking at the annual Texas Medical Association convention in Dallas Tuesday, Dr. C. A. Pifgord, Lubbock public health director, said the disease is most likely to become prevalent in irrigated areas and is unlikely to spread to the north. Panhandle even though the region is dotted with fresh water lakes.

Any encephalitis outbreaks probably will be confined to the South Plains, he said, because the carrier of the virus, the culicoid tarsalis mosquito—prefers to live in irrigation water.

Quoted by Mrs. Tom Rease, Amarillo Daily News staff writer, Dr. Pifgord identified three types of the encephalitis virus—the Eastern, Western, and St. Louis types—and said last year's outbreak in South Plains last summer was of

the St. Louis type.

In his talk Tuesday, Dr. Pifgord did not define roles of public health service and private owners in the control of encephalitis.

In discussions at public meetings earlier this year in Plainview and other cities in the South Plains, interested citizens were told the primary responsibility belongs to the individual farmer because the main breeding grounds for the disease-carrying mosquitoes are in rural areas where effective public health services are available.

At the earlier meetings, farmers were told that encephalitis would not be a problem if their health department would assist in planning control campaigns, but cost of chemicals and application would probably have to be met by the farmer because federal cost shares are inadequate budget for public health services.

Many cases of encephalitis go undiagnosed, Dr. Pifgord said. Although disease is sometimes fatal (15 deaths were reported in the South Plains last year) cases are often diagnosed as polio, and a light case might be dismissed as a bad cold.

Encephalitis in Texas has been concentrated in the Rio Grande Valley and South Plains, where

accumulated irrigation water provides the preferred breeding place of the encephalitis-carrying mosquito.
