# Welch, Coleman, McDermitt take hospital race

Plenty of new faces dotted governing bodies Monday in the wake of turnovers caused by last Saturday's city school and hospital board elections in the county.

The only county-wide race overall. was the Castro County race created heavier-than-usual voter turnout Saturday. Over 1,300 registered voters in the county voted in the elections.

Two of the three candidates running as a trio in the hospital race, Garland Coleman and Ettie McDermitt, joined incumbent James Welch in gaining seats on the CCHD board. Coleman received 808 votes, Welch 586 and McDermitt 582.

The other members of the threesome, Dr. B. D. Murphy, finished fourth with 491 votes. Mike Foskey received 443 votes, while incumbents Charles Rickerd and Desi Pesina trailed the field with 358 and 255 votes, respectively.

Coleman was the leading candidate in Dimmitt and Nazareth, with 597 votes in Dimmitt and 110 in Nazareth. Welch finished third in Dimmitt, with 365 votes, and Nazareth, with 93 votes. Welch was the leader in Hart, garnering 128 votes, and second in Nazareth with 93 votes. Mrs. McDermitt finished second in the Dimmitt totals with 451 votes, but finished third in Nazareth with 93

with just 48 votes.

Foskey finished fourth in Dimmitt with 356 votes, but was fifth in Hart and sixth in Nazareth, placing him fifth

Murphy placed third in Hart, Hospital Board race, and the with 85 votes, and third in Nazareth with 81 votes. However, Murphy was fifth in Dimmitt with just 325 votes.

> In the Dimmitt school board race, incumbent Glenn Odom was joined by Chervle Pybus in gaining the two, three-year terms open.

> Odom led all candidates with 346 votes, while Pybus edged Richard Hunter, 325-282, for the other seat.

Other candidates included: Carter Townsend, 229; Johnny Hucks, 130: Randy Schumacher, 109; Kellie Proffitt, 94; and Teddy Smithson, 81.

In the Dimmitt city races, Jack Thompson led the fourman field seeking the two open spots on the Board of Aldermen, with incumbent a close race.

Thompson received 389 votes, while Hays was reelected with 371 votes. Challenger Jim Naylor was a strong third with 340 votes, while former City Manager Garnett Holland trailed the field with 221 votes.

Wayne Collins was elected to his first full term as mayor, receiving 587 votes, while Municipal Judge Ferne Jones was re-elected with 526 votes. In Hart's school board race, incumbent Elias Martinez finished fourth in the race for three seats available, with Freddy Upshaw and Ricky Mitchell joining incumbent Larry Lee on the board.

Lee led the five-man field with 212 votes, with Upshaw getting 180 votes and Mitchell 154. Martinez got just 109 votes, while Benny Martinez brought up the rear with 50 votes.

Bill Bell was elected to the Hart City Council, getting 118 votes, while Elizor Castillo received 42 votes. Joe Bailey

## Marker to be dedicated

A Texas Historical Marker for the Summerfield-Dameron Corner in Castro County will be unveiled in a special ceremony Sunday at 2:30 p.m. on SH 86 five miles east of Dimmitt.

Presiding at the unveiling will be Ray Cowsert of Hereford, an attorney and the son of former Castro County Atorney Mark Cowsert. County Judge Polly Simpson will bring the invocation, followed by the presentation of colors by Dimmitt Boy Scout Troop 266.

Clara Vick, a member of the Castro County Historical Commission, will give the welcome and introduce special guests. The unveiling will be performed by Edwin "Goose" Ramey and Roger Haberer. Ray Cowsert will read the marker text, and Castro County Surveyor John Alldredge will deliver the dedication speech.

Russell Moran, Dimmitt attorney, will accept the marker. The benediction will be offered by Castro County News Publisher Don Nelson,

# **Man dies** in feedlot

Terry Ellison, with Superintendent Robert Ryan as an advisor.

Based on criteria mandated by the legislature and the State Board of Education, these three will select the first two teachers to be placed on the career ladder, and who will then also serve as members of the selection committee. Further selection criteria will be developed by this five-member committee and submitted to the board at the May meeting.

Selection of other teachers to be placed on the career ladder will begin immediately after the criteria are approved, and must be completed by the end of the school year.

Ryan told the board that it is possible that all eligible local teachers may be able to receive a portion of the \$45,000 in state funds set aside for the career ladder.

Eligibility is based on having a bachelor's degree and three years experience, along with nine hours credit in higher education courses in the field being taught. Credit is also given for workshop hours on a basis of 15 workshop hours equaling one college hour.

Dimmitt could soon be 22 annex at least a portion of land available along US 385 south of the city.

The aldermen agreed to annex the new Texas Dept. of Highways and Public Transportation site on US 385. and an adjacent site purchased vesterday by Bob Towler Implement Co. for its new building, and to furnish water to the site.

The aldermen are also considering annexing another 10 acres of the tract that belongs to Dan Heard, and obtaining an option on the acreage.

Castro County Economic Development Commission head Jerry Hanners told the board Heard "seemed willing to give a three-year option on the land for a selling price of \$2,500 per acre, and seemed willing to discuss annexing the land.

The board tabled discussion of the proposal at the original Monday night meeting, then reconvened Tuesday and okayed the agreement.

Monday night, Hanners told the board the tract is "present-

# Naz, Mules, Bobcat JV capture Relays titles

In the past, the Bobcat Relays had not been noted for its fine weather.

Saturday, the rain, snow, wind and cold temperatures of the past were absent, and records fell by the wayside in the fourth annual meet at Bobcat Stadium.

18 new records were set in the 30 events held in the varsity boys and girls divisions of the meet, which was captured by Nazareth (girls), Muleshoe (boys), and Dimmitt (JV boys).

Nazareth edged Dimmitt, 90-82, for the girls crown. The margin of victory came in the 880 relay, which the Swiftettes won, while the Bobbies were hampered by a bad handoff and finished sixth. Nazareth received 20 points, while Dimmitt got just two in its worst performance of the season in the event.

Helping Nazareth take the girls crown were Debbie Schmucker, who won the two-mile with a meet record 13:30.41, and Leona Gerber, who took the mile in 6:09.25.

Dimmitt was buoyed by a win in the 440 relay, Stephanie Killingsworth's win in the 200 in a meet record 27.60, and second-place finishes by Stephanie Ryan in the long jump and 100 hurdles, and Cara Odom in the 400.

Marie Pesch of Bovina won the Girls High Point Individual award, as she scored 48 of a possible 50 points, setting new records in the shot (40-03/4), high jump (5-2) and hurdles

(15.33), winning the discus with a toss of 120-41/2, and finishing second in the 100.

Muleshoe was boosted by the performance of Mark Moton, who won the Boys individual honors with 27 points, and their strength in the long-distance races, to rack up 132 points.

Tony Luna blasted the existing standards for the mile and two-mile races as the Mules finished 1-2-3 in the two-mile and 1-2-4 in the mile. Moton captured the 400 meters, placed second behind Ricky Backus of Nazareth in the long jump, placed fifth in the 200 and helped the Mules' 1600 Relay team to first place by over a second over the Swifts.

Nazareth had 88 points for its runnerup finish in the boys division. Russell Hoelting was the only other first-place winner for the Swifts, winning the 100 in 11.17. He set a meet record in the morning preliminaries, 10.82, breaking the record of 11.24 he set last year. Hoelting finished second in the 200 finals to Conder of LCHS, who broke the record of 23.26 Hoelting had set during the prelim with a 22.84 effort. Hoelting finished with a 23.52 in the afternoon finals.

Dimmitt's JV squad took just two first place finishes Saturday (Blaine Gregory in the high jump and Johnny Flores in the long jump), but placed at least one person in every event to take a 47-point win over the Muleshoe JV.

AN ORDINANCE PROVIDING RULES AND REGULATIONS FOR THE OPERATIONS OF THE DIM-MITT MUNICIPAL AIRPORT: PROVIDING AN EXPLANATION FOR THE PURPOSE OF THE ESTABLISHMENT OF THE DIM-MITT AIRPORT ADVISORY BOARD, PROVIDING THAT NO PERSON SHALL USE THE AIR-PORT FOR CARRYING ON OF COMMERCIAL ACTIVITIES, FOR THE INSTRUCTION IN AVIATION IN ANY OF ITS BRANCHES, FOR SALE OF COMMODITIES, ETC. UNLESS FIRST APPROVED BY WRITTEN PERMIT FROM THE DIMMITT BOARD OF ALDERMEN: PROVIDING FOR GENERAL RULES AND REGULA TIONS IN THE USE OF THE AIR PORT: REGULATING THE GROUND AND AIR TRAFFIC REGULATING THE USE OF AIR-CRAFT ENGINES: PROVIDING FOR FIRE REGULATIONS: **REGULATING STUDENT PRAC-**TICE AND FLIGHT TRAINING: PROVIDING FOR CONFLICT IN RULES: PROVIDING FOR A PENALTY OF \$200.00 FOR THE VIOLATION OF THIS OR-DINANCE: PROVIDING FOR A SAVINGS CLAUSE AND DECLAR-ING AN EMERGENCY FOR ENACTMENT OF THIS OR-DINANCE. BE IT THEREFORE ORDERED BY THE DIMMITT BOARD OF ALDERMEN OF THE CITY OF DIMMITT, TEXAS.

The following sections of the ordinance are also hereby published in the Castro County News.

#### **SECTION NO. 9** PENALTY FOR VIOLATION

Any person operating or handling an aircraft in violation of any of these rules or refusing to comply therewith. may at once, be ejected from the airport, or may for any period of time, not exceeding fifteen days, be denied use of the airport by the Airport Manager, and upon a hearing by the Dimmitt Board of Aldermen, may be deprived of the further use of the airport and its facilities for such a period of time as may appear necessary for the protec-

tion of life and property. Any violation of the ordinance of order shall be a misdemeanor, and punishable by a fine in any sum not exceeding two hundred (\$200.00) dollars. This section is cumulative of all other penalties for violations of federal, state and local laws, rules regulation, and ordinances. Each day the violation continues, will be considered a separate offense.



There is no charge for attending the workshop, which has been designed to suggest tips for dealing more effectively with customers.



#### (Continued from Page 1) ly the only available development site we have. Some others are available, but the price is so high, it's discouraging. This area is the most practical and most appealing.

"I get asked every day why we aren't getting what our neighbors are getting," Hanners continued. "Muleshoe is getting a new motel, Tulia is getting a new tortilla factory. In my opinion, if we had the same opportunities, we could not make them work today. We lack available land sites, and the financing is not available. This board holds the key, and the board can turn the key and let us in, let us develop in an. orderly fashion.

"We don't know the risk (on obtaining an option on the extra acreage)," Hanners said. "If we let this area develop by chance, we'll be looking at a No Man's Land. We can see that south of Hereford, and just east of Dimmitt. We can see it south of town, too, unless we see to it there is orderly annexation and positive growth."

The new water line to the new SDHPT building and the Towler site will cost about \$15,420, with SDHPT and Towler to reimburse the city for the cost. SDHPT may reimburse its cost by installing the line. The city will be responsible for obtaining easements for the line.

The aldermen also discussed laying a sewer line to the sites, which could cost an additional \$37,000, but that proposal was tabled.

In the original Monday meeting, the board heard requests for a piece of the \$115,836 Revenue Sharing pie

to be available during the new fiscal year beginning May 1.

Requests included: \$700 for the Mayor's Beautification Council; \$5,000 for the EDC; \$3,200 for the local Central Plains MH/MR Center; \$2,500 for the Castro County Senior Citizens Center; \$21,000 for Plains Memorial Hospital for a new ambulance and a new parking lot on the east side of PMH; \$18,294 for matching funds for a proposed grant from the Federal Aviation Administration for additions to the Dimmitt Municipal Airport; \$28,642 for seal coating; and \$50,000 for drainage work in the city.

All the requests had been included in the budget proposal prepared by City Manager Paul Catoe, except for the \$11,000 for the PMH parking lot, and the \$2,500 for the CCSCC. The city will hold its final hearing on the Revenue Sharing budget, and the proposed \$1.7 million city budget at the next meeting April 22.




