The Statistical Equivalent Of War

Some very grim statistics crossed our editorial desk a few days ago from the Texas Department of Public Safety. It appears that Texans are continuing to slaughter and maim one another in

slaughter and maim one another in record numbers on our highways. For the first five months of this year, traffic deaths jumped eight percent over the same period of 1978. By the end of May, 1,553 persons died and another 75,575 were injured in traffic accidents, about half of them on city streets. Cities the size of Floydada have one small consolation. There was no change

small consolation. There was no change in the rate at which we spread our fellow humans on the pavement.

But how do you console the mother of a lifeless child lying tangled in his crumpled bicycle, or the parents of the

teenage couple who didn't make it home by midnight or a man's family when a state trooper tells them that Daddy was killed by a drunken driver?

Cities like Lockney, however, chalked up an 18 percent increase in fatal accidents. That put them second in total deaths only to cities of more than 250,000 population. Now, that's what we call progress,







The enclosed calculation is a State of Texas required, legal advertisement, that shows only what the tax rate could be set at, without special hearings and other advertisements in the paper. As far as tax rates are concerned there is some information furnished on a local level, because the taxpayer needs to be kept informed. Such as:

A tax rate of 65c would be the same tax on a given piece of property that has had no physical change and no qualified exemptions. Had the State of Texas guaranteed dollar for dollar reimbursement for tax base lost to the recent tax relief amendment, the School could have had a balanced budget at this 65c tax rate, or even slightly less; however, the legislature in their wisdom provided for a guarantee of only 45%, with possible reimbursement above 45%, the information about that above 45% to

be available sometime after November 1, 1979. Obviously the only money the Board can count on for the budget for the 1979-1980 school year is that money guaranteed, not that hoped for. Any monies received over the 45% will be invested in CDs or treasury bills and this held at interest for use in future years to stabilize the tax rate and cover the same situation that will probably continue to occur each year until another method is passed into law by the legislature.


HSA Receives Designation

The Lubbock-based South Plains Health Systems, Inc. recently became a fully designated health systems agency for the South Plains area. Under full designation, SPHS will


