Castro County is faced with the very real possibility of the closing of the local hospital unless the method of operation is changed immediately. In the beginning a number of public spirited citizens sacrified much time and money in order to secure adequate hospital facilities for the county. They pioneered a new type of hospital operation that fairly adequately met the needs of the community, but which has since proved to be incompatiable with the general ethics of the medical profession, a fact that makes it all but impossible to continue operation under the present setup. In casting about for a solution to the delimma the hospital board arrived at the decision that the only democratic method of solving he problem was through the creation of a county hospital, owned by all the people of the county and open to anyqualified doctor who cared to use its facilities.

In order to establish a county hospital, and to clear the title of the property as well as to meet the moral obligations involved, it is necessary that funds be raised through a bond issue to pay off all outstanding indebedness including some \$40,000 in borrowed money, approximately \$30,000 in membership stock and miscelalneous obligations. In return the county will acquire title to all of the hospital properties, including a complete city block with paving, building facilities, and equipment. A conservative estimate on the value of the hospital property would be in the neighborhood of \$150,000 at today's prices. The county will actually be buying a bargain if the bond issue passes, and it is an obligation that we as citizens of the county provide health facilities for ourselves and our neighbors. This will be the best opportunity we will ever have to accomplish that purpose.

There are a number of ways to evaluate the costs and benefits of the hospital. The bond issue will necessitate an increase in taxes of approximately \$5.00 per section of land, a comparable increase will be experienced in personal and business property. The cost is not prohibitive, in fact it is moderate. On the other hand a large number of citizens of the county each year require the services of a hospital. If these people are forced to seek these services in other counties the additional expense in time lost from business and jobs, travelling expense, hotel expense for relatives, and all the other expenses involved in being away from home, will cost the people of the county more money than it would to maintain their own hospital.

Think it over. The doctors bring us the medical skill to care for our illnesses, it is up to us to provide the hospital facilities to may the health service complete.
