## Bobcats, Swifts go after state crowns

The hard part is over now — it's fun week for the Dimmitt Bobcats and the Nazareth Swifts as they enter the State Boys Basketball Tournament Thursday at the Frank C. Erwin Special Events Center in Austin.

The Bobcats are in the tournament for a Conference 3A record thirteenth time and are making their eighth appearance under Kenneth Cleveland's direction, while the Swifts are in the Final Four for the fourth time. It's the third straight appearance in the Class A tournament for the Nazareth boys and their first under Coach Johnny Hampton, who makes his

Super Drum debut as head coach against Laneville.

The Bobcats will face Corpus Christi West Oso at 3:30 p.m. Thursday in the second 3A semifinal. At 2 p.m., Cleveland tackles Hughes Springs. While West Oso has never won a state championship, it has been in the state tourney three times in Class 4A.

Cleveland has also been in the tourney before as a 4A school, while Hughes Springs won the State 2A championship in 1971, including a semifinal win over the Bobcats.

there before in 4A, and I'm sure they'll be tough."

The West Oso club likes to feature six players who will see almost all of the playing time if it follows its season-long form, which includes a 26-game winning streak going into this afternoon's game.

Bryan Yellets, a 6-7 junior, may look a little awkward when he goes out on the court, but scouting reports indicate Yellets has a soft touch and wide range around the basket, and will be joined along the baseline by 6-1 senior forwards Freddy Fillmore and Napoleon Johnson, both averaging about 12 points a game.

The sixth man comes in for either of the forwards and is possibly the most dangerous man on the team.

Randy Haywood, a 6-1 senior, came off the bench in the regional semifinals last Friday and scored 18 points on 9-of-13 shooting. Against Gonzales in the finals, Haywood corralled the best player, Darrin Nelson, in the second and third quarters, holding the high-scoring Nelson to just three shots in the middle two periods.

In the regional finals, Haywood missed 14 of 15 shots before snaring the rebound of a missed shot with five seconds left and putting the ball in the hole to give the Bears a 49-48 win.

The guards include 6-0 junior Richard Tanez and 5-8 sophomore Lance Harper, who average

## Aldermen study insurance, waste

The City of Dimmitt is probably closer to understanding why its insurance rates have skyrocketed and problems local industries are having with wastewater after Monday night's meeting of the City Board of Aldermen.

Carolyn Hassell of Texas Municipal League explained that for several years insurance companies in Texas dropped their rates in order to become more competitive in obtaining municipal business, "but they have tried to make up for losses with these increases in one year. A lot of companies have gone out of business because of the losses they have incurred. The companies just got in a price war with each other, but in the last two years they've started making up for it.

coverage. Those coverages will be about \$9,000 higher for each category than last year's premium, according to Hassell.

"A majority of the city's buildings are considered frame buildings," Hassell said. "Buildings like City Hall have a base rate of 28¢, while frame buildings have a base rate of \$1.27. The rates and building classifications are based on state information, and if the state says a building is frame, that's what it has to be insured as."

Despite a deadline of this Friday for changes in insurance coverage with TML, the aldermen opted to table action on possible changes in the insurance, and will look at other insurance coverages, including some self-insurance, at the March 17 meeting.

I was in the Bobcats' dressing room getting some players' comments when I heard hoo-dat coming from the other side of the room. It was junior Dwight McDonald and my son, Nathan, a sophomore, both of whom had had an excellent sideline view of the game.

"Hoo-dat hoo-dat hoo-dat!" they chanted happily.

"What-dat?" I asked. "Hoo-dat," they answered. "What dat mean?" I asked. "Dunno," they said.

"Snook," they said.

It was something the Snook Bluejays chanted as they psyched up for a game. I think our boys hung around long enough to get the sense of it, then brought it home.

It was a favorite chant of the regional champion Bobcats the next year, but was pretty much a team thing until Cheryl Pybus cracked the boys up by leading they yell, "Hoo-dat, hoo-dat going down to Austin?" at the state send-off breakfast that year.

It's an adaptable chant.

"Hoo-dat, hoo-dat beatin' them Indians?"

"Hoo-dat, hoo-dat scorin' them baskets?"

"Hoo-dat, hoo-dat goin' to regional?"

"Hoo-dat say they can beat them Bobcats?"

Or just "Hoo-dat hoo-dat hoo-dat" for the heck of it.

Who knows where or when it originated?

It's handy, it's fun, and it means things are going right for our team.

I hope we hear a lot of hoo-dats from the Dimmitt and Nazareth fans this week in Austin.

## Lara remains critical after near-asphyxiation

A Dimmitt man remains in critical condition in the Intensive Care Unit at High Plains Baptist Hospital in Amarillo following an incident that claimed the life of 18-year-old Rachel Lara of Dimmitt.

Jesse Lara and Rachel Lara were found inside a car parked in a shop building at the Rafter 3 Feedyard by a Rafter 3 employee Feb. 25 at 6:30 a.m.

According to Justice of the Peace, Marshall Young, Jesse

Lara had been an employee at Rafter 3.

Young said the car's ignition switch was on, the gas tank was empty and the battery was run down when investigating officers arrived at the scene.

Young had pronounced Rachel Lara dead of asphyxiation at 7:20 a.m. Feb. 25.

No new developments have been turned up by officials investigating the case.

## Accident claims life of Hart man

A 57-year-old Hart man was killed Saturday night when the pickup he was driving struck a parked vehicle in the 400 block of Avenue D in Hart.

According to investigating officers, Zaragoza Castillo was driving a 1975 Chevrolet pickup traveling east on Avenue D, when it struck a 1981 Chevrolet pickup legally parked on the north side of Avenue D.

Reports indicate he was not

wearing a seat belt at the time of the accident.

Castillo, a laborer in Hart, was pronounced dead on arrival at Plains Memorial Hospital at 8:30 p.m.

Dr. Dhiraj Patel of Hereford listed the official cause of death as cardiopulmonary arrest from the accident.

Funeral services for Castillo were held Tuesday in St. John's Catholic Church in Hart.

## Swiftettes fall in state finals, 36-33

In a town gone mad with Sesquicentennial fever, Austin will not remember the day before the 150th birthday celebration for the hot air balloon races or the Joe Ely-Kris Kristofferson concert on the river.

Instead, March 1, 1986, when the state was teetering on the brink of Sesquidom will be remembered as the Day The Swiftettes Lost in the Super Drum.

The reaction from most fans was almost enough to cause all of the Texas flags lining Congress Avenue and Guadalupe Street to be lowered to half-mast, and to cause the trinket sellers in the makeshift souvenir shop in the State Capitol to pause in their endeavors for 30 seconds in mourning for a team that probably deserved to win the State Class A championship.

Instead, Connie Cole, who led all scorers with 26 points, led the Snook Bluejays to a 36-33 win over Nazareth in Austin.

"I don't know of a team that deserved to win more than these girls," said a teary-eyed Nazareth coach Sandy Oliver after her team had come back from a nine-point deficit in the fourth quarter, only to come up one shot and 10 seconds short of a ninth state title for the girls and snapping a 17-game winning streak in state tournament play. "I'm disappointed more for the kids than I am for me because they hurt so bad."

The hurt was basically applied by Cole, whom the Swiftettes, 28-5, had wanted to hold to 20 points or less.

"We knew Cole was the key to their offense, and felt like if we held her to 20 points we would be in good shape. It wasn't just one player, though, because they did a tremendous job today." But Cole was the root of all problems for the Swiftettes, who were forced to alter their defense and their shots.

"We had to sag so much on Cole that I think we lost some of the aggressiveness we normally have," Oliver said. "We changed to a zone press in the second half, and that picked us up a little. But the ball wouldn't fall for us — we were taking the shots we wanted, but this was probably the worst we shot this year (38%)."

"We had to change our shots a little to get it over Cole (a six-footer) and probably got stronger with our arms instead of getting stronger with our legs, but it's tough shooting over someone like that, especially when they're sagging so much inside."

Nazareth jumped to an early lead after Charlotte Benford missed two free throws a minute into the game and Mona Heiman, who led the Swiftettes with 11 points, hit from 20 feet and Annette Schmucker hit the first of two straight inside buckets while Cole hit two baskets, one on a follow-up and another on an eight-foot jumper. Snook's Rhonda Thomas tied the score with two minutes to play in the opening quarter before Kelly Schilling hit from the inside to give the Swiftettes an 8-6 lead at the end of the quarter.

Heiman put the Swiftettes ahead three points early in the second quarter when she made the front end of a two-shot foul, but Snook stormed to a 14-9 advantage by the middle of the period on three baskets by Cole and an outside jumper by Rhonda Thomas as the Swiftettes could never employ their full-court press that was planned at the beginning of the

second quarter.

"I told the girls at the end of the first quarter that we wanted to put our '50' press on them when we scored," Oliver said. "But we didn't score for four minutes, and I think that had a lot to do with their big run."

Snook outscored the Swiftettes 14-7 in the period, jumping to a seven point lead twice on baskets by Charlotte Benford while Heiman added four more points on inside baskets and CeCe Kern hit a 16-footer for the only Nazareth field goals in the second stanza.

In the third quarter, the teams traded baskets for the first four minutes before Cole outscored Nazareth 8-2 in the last four minutes, extending a three-point, 24-21, lead with 4:44 left in the quarter to 32-23 by the quarter's end, Snook's largest margin of the game.

Neither team could score in the last two minutes of the quarter as the Nazareth defense, after Oliver called a time out, began to clamp down on Cole, who had just one more basket in the game, but the Swiftettes last-quarter charge was just short, thanks to Cole's defense and rebounding.

Kelly Schilling broke the second half scoring drought with an eight-footer with 6:38 left to pull the Swiftettes back to 32-25, and Missy Brockman's basket a minute later made it a five-point game. After a turnover, Snook coach Leslie Yezak, in his first year as a head coach after serving as an assistant at his alma mater, called time out to settle his girls down.

"Yeah, I had no doubt they could come back because they've always been tough down the stretch," Yezak said. "I had to call that timeout to try to settle our girls down and try to get them back into our press offense."

The timeout didn't help much, according to Yezak, because the Snook girls still didn't handle the ball well, as the Swiftettes forced a bad pass, but couldn't convert the turnover. On the other end, the Bluejays worked the ball inside to Cole, who sank the eventual winning basket with 4:12 left to give the Bluejays a 34-27 lead.

After a timeout with 2:20 left and still trailing by seven, the Swiftettes charged to within a point on a basket by Schilling, two free throws by Traci Hill and Hill's 18-footer with 53 seconds left.

The Bluejays spread out their offense, and junior guard Leola Robertson found an opening but missed on a layup. Brockman ripped down the rebound and the Swiftettes called timeout with 33 seconds left to set up a poten-

## Schilling, Heiman are all-tourney

Nazareth's Kelly Schilling and Mona Heiman have been named to the Class A all-state tournament team released Monday by the University Interscholastic League.

Heiman led the Swiftettes with 42 points and 16 rebounds, while Schilling had 22 points and seven rebounds in the tournament.

## CRP signup is underway

Signup is underway now through March 14 for the Conservation Reserve Program being administered through the Castro County ASCS office in Dimmitt.

"Highly erodible cropland may be volunteered for entry into the program," said ASCS head Charley Hill. "Land that is entered in the program will be taken out of production for at least 10 years and must be planted to a permanent vegetative cover. At the time of signup a bid must be submitted on eligible land. If the bid is accepted, annual rental payments will be made."

Bids for CRP land will be opened at the County ASCS office at 9 a.m. March 17.

Hill said the \$50,000 payment limitation will also apply for 1986, and any determination made on the number of limitations that might apply to a particular partnership, corporation, estate, trust or other group depends upon conditions that existed March 1.

Hill also reminded dairymen that Friday is the last day to submit a bid in the Dairy Termination Program.

Hill urged producers to inquire at the county ASCS office for explanations of any of the programs.

## Stress seminar slated tonight

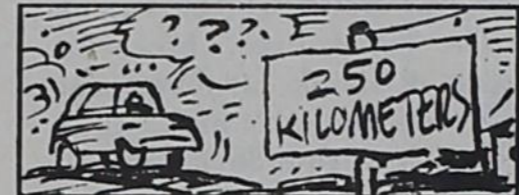

Cole made both ends of the one-and-one to give the Bluejays a three-point lead with just 13 seconds left.

Heiman's last desperation lob over Cole missed, and the Bluejays grabbed the rebound and their first-ever girls state title to join the school's 10 boys titles.

"I imagine they'll be back," Yezak said after the game. "I saw them last year, I've seen them before, and I've sure seen no drop off after Sandy took over. I'm just relieved to beat such a super bunch."

## Swiftettes 60, Cayuga 46

In Thursday's semifinals, the Swiftettes won their 17th straight state tournament game, using Cayuga bricks and their own inside tricks to grab a 60-46 win.

Cayuga had plenty of opportunities at the free throw line, especially in the first half when the Lady Wildcats went to the line seven times and made just three free throws, most of them thudding off the side of the rim. For the game, Cayuga was just 6-of-15 from the line. The Swiftettes had fewer opportunities but made 8 of their 12 charity tosses, 75%.

But the difference was the fewer fouls in the second half plus more inside opportunities as the Swiftettes used definite mismatches against the smaller Lady Eagles to forge their win.

"I think we were a little nervous when we started," Oliver said. "We jumped out and fouled too much, plus we let our cautious do what it wanted. We were sure overcautious in the second quarter."

"But we knew there would be some mismatches somewhere, and we were able to work off screens to Mona and Kelly inside. They tried to drop off our guards completely, but we were still able to work the ball in to our posts underneath."

"The third quarter was the key. We worked our inside game well, stopped their penetration, and we played a little looser. Plus, they had to pull their press off. They had hurt us some with the press in the second quarter, but they had so few people (four of the five Cayuga starters went all the way) they

couldn't press us the whole way, and I think that hurt them."

Cayuga never led in the game, which was tied at four and eight points early in the game, but Nazareth soon jumped to a 12-8 lead and were never less than five points ahead the rest of the game.

The Swiftettes played the last two minutes of the first quarter without Heiman, who picked up two fouls in the first five minutes of the game, but Heiman was able to adjust and picked up just one more foul during the last three quarters.

"I was worried after I got two fouls, but I sat on the bench and saw how the officials were calling the game and adjusted how I played. It was probably my fault that I got the two fouls, but I was able to adjust and get used to how they were calling."

"I was really ready to play, since this is my senior year and my last state tournament. I wanted to do the best I could."

The best she could included a 14-of-21 morning from the floor, and a 9-of-10 spree from the field in the second half when the

Swiftettes outscored the Lady Eagles by nine points, 30-21, and jumped to a 12-point lead late in the quarter before settling for a 41-31 advantage at the end of the period.

Cayuga, meanwhile, suffered from poor shooting from the field and the line in the second half, making just 9 of 26 field goals, 34%, and 3 of 8 free throws, 37%. Nazareth actually cooled a little in the second half, after shooting 70% from the field in the first half. The Swiftettes were 12-of-20 from the field in the second half, 60%.

Nazareth virtually shut down the inside game of the Lady Eagles in the second half, as Cayuga scored just six points in the lane in the second half, after getting 16 points from the inside game of Nancy Kimbrough and Regina Cunningham the first half.

The Swiftettes, meanwhile, got 18 points from Heiman, Schilling and Missy Brockman in the last two quarters.

"I think the big difference was that we quit fouling in the second half," Oliver said. "We knew we couldn't keep giving them chances at the line. Plus, Gail Birkenfeld really came on strong in the second half. She didn't get many points (none), but really played good defense for us. She was the key defensive player, and when she works hard she's really the key to the defense."

# Watch program gaining strength

The first signs are going up in the Bethel area this week, the first tangible evidence of the rural Neighborhood Watch program in Castro County.

"We have gotten something going in just about all of the communities in the county," said Frank Valdez, crime prevention officer for the Castro County Sheriff's Office. "We have organized in Bethel, Frio, Easter, Summerfield, Flagg and Dodd.

"We're urging our rural residents to lock it, mark it and watch it, and I believe if our

rural residents work together they can make the program work and we can see a reduction in rural crime. This program is not going to eliminate crime, but the only way we can communicate with potential criminals is to have the signs posted, warning them property is being watched, and property is marked so as to make it unattractive to steal the property."

Valdez said the program includes the marking of valuables, and marking large equipment, including welders, well motors, tractors and other

large pieces of equipment with a die tool set.

"They can pick up the die marker at the Sheriff's Office, or we can mark it, just so it will be marked."

Valdez said he is working on trying to get the whole county covered by Neighborhood watch.

"We've had a meeting at Sunnyside, and had about 30 persons there, and we are glad that a lot of folks in that area have shown interest. We're hoping to get some people interested in the Hart area, and if

they want to have a meeting we'll have it. We've had some interest shown in Nazareth, but they haven't called back yet to set up a meeting."

Valdez said anyone interested in learning more about the program should call him at the Sheriff's Office at 647-3311.

Tank Lines, the Texas Water Commission and Lubbock Christian College concerning continuing problems at the city's wastewater treatment facility with high Biochemical Oxygen Demand (BOD) readings.

According to the city's permit from TWC, BOD readings at the plant may not exceed 45 in one week and must average no more than 30 for a calendar month. A mid-February sample indicated a BOD reading of 70 at the plant, east of Dimmitt, and city officials indicate they are still receiving heavy concentrations of high BOD waste from one or several sources which have still not been pinpointed.

"The plant was designed for a maximum load of 200 BOD," said Don Manning of TWC's Amarillo office. "Due to the type of industry you have you have exceeded that number, and you must then enforce the

city's Industrial Waste Ordinance. It empowers the city to control the discharges it receives, and you can either eliminate it or surcharge those you know are dumping excessively high BOD waste into the system.

"Even though the city has reduced its load to date," Manning continued, AFC and Steere (BOD readings) are still pretty high, and as long as they are that high, this type of wastewater plant will not run.

"If you keep trying to work things out, we'll back off, but if this keeps on we'll have to take some kind of action."

The action could include a fine of up to \$10,000 per day assessed against the city. Currently, the city can charge up to \$250 per day for effluent it receives that exceeds the 200 BOD maximum in the industrial waste ordinance.

Harry Jones of Steere said he

had problems understanding BOD readings that varied tremendously from day to day in samples taken in his company's holding pond. The BOD samples varied as much as 27,000 parts per million within one week recently.

"It takes super experience to run a BOD test properly," said Mark Gates of TWC. "You have to be very well trained, and sometimes labs will blow it and still report the high numbers."

Gates said there can be a plus-or-minus factor of 25% in the BOD readings if the tests are properly performed.

Blair Leftwich of LCC proposed the city might install an equalization basin at the wastewater plant that would prevent "shocking" the plant, which uses bacteria to break down sewage and would prevent the bacteria from being killed by surges of waste containing high BOD levels. TWC officials said they might allow the city to install a temporary basin, and there could be grant monies available from the Texas Water Development Board for building a permanent basin.

Leftwich also urged AFC officials to run dye tests to see if there could be a cross-connection between the sanitary sewer and lines containing industrial waste.

"The sanitary sewer is the only line still remaining at AFC that is going into the city system," Eric Ekern of AFC said. "... we are trying to get a coordinated effort going between industries and the city, but it hasn't happened yet. We have taken our own samples because the information we were receiving was incorrect. We have the ability to resolve the problem if we are the source. We will certainly try to answer your questions and ours."

"We have every intention of obeying the law and no intention of circumventing the law," Mayor Wayne Collins said. "There is no need to cut industries off if the plant will handle what they give us, and there is no need to cut them off if we can work something out."

In other business, the aldermen passed a new city litter ordinance, named Oleta Walser as election judge for the April 5 municipal elections, replacing Ted Sheffy, whose brother, Don, is a candidate for the Board of Aldermen.

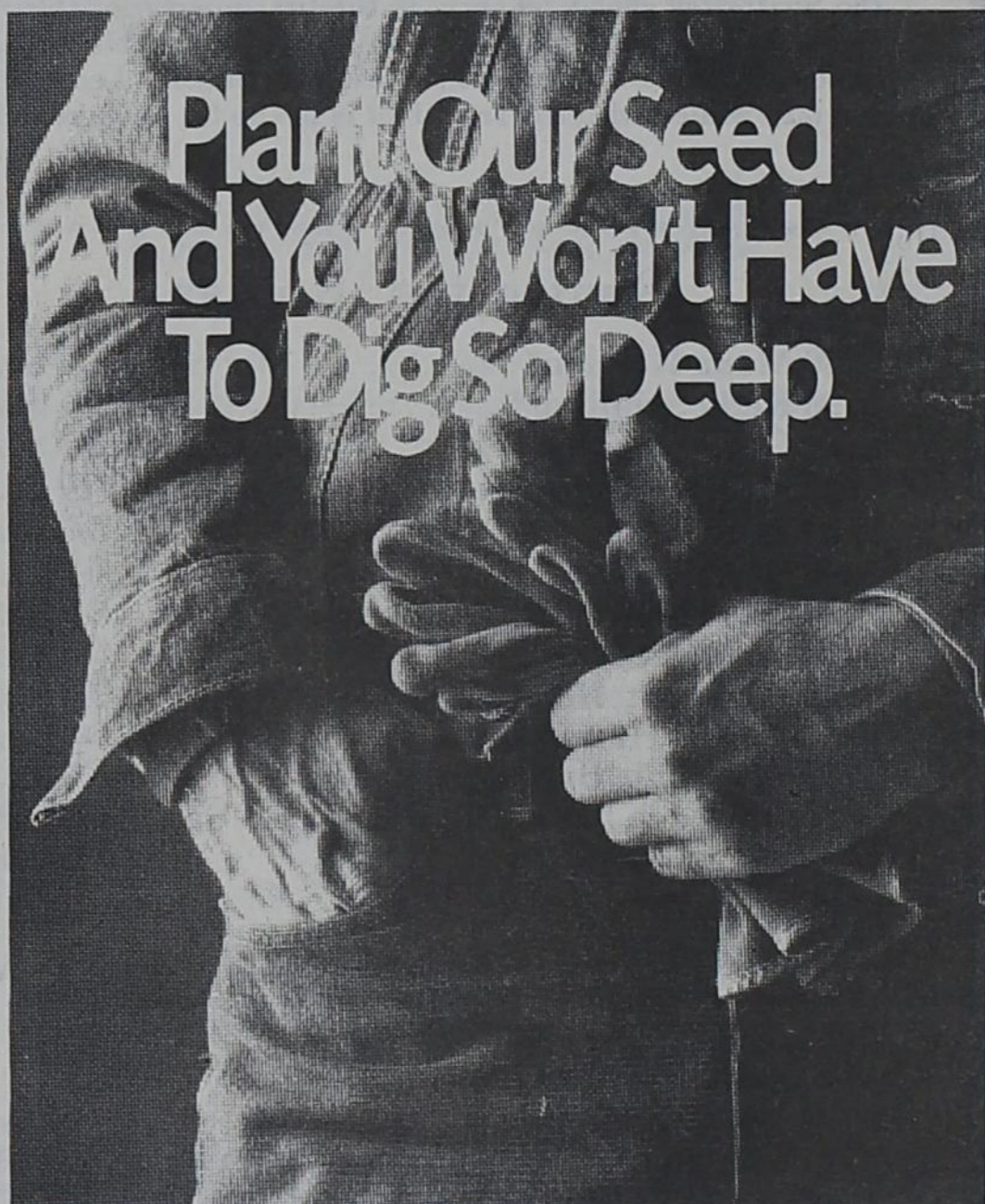

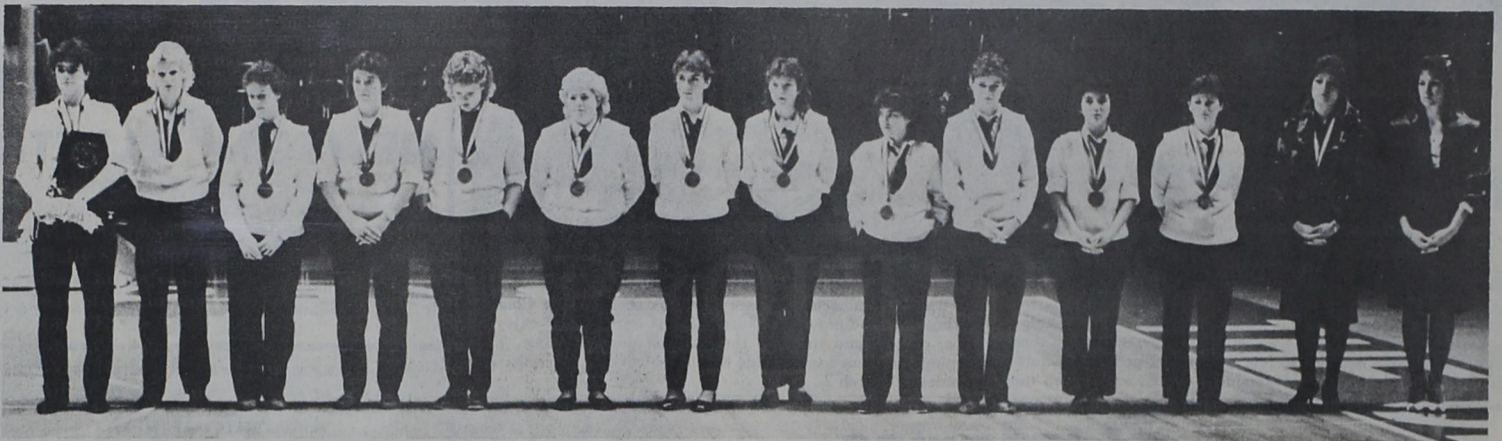

# Cats rip Seminole 88-51 in title game

Remember last year's regional championship game? The Bobcats remembered it with a vengeance Saturday as they gritted their teeth and tore apart a fine Seminole team by a shocking 88-51 count in the Region I-AAA title game in Lubbock Municipal Coliseum.

Now, Coach Ken Cleveland doesn't like to use vengeance as a motivation. In the dressing room before Saturday's game, he didn't mention last year's 67-51 Seminole victory that kept the Bobcats from going to Austin.

"We talked a little bit about intensity, about what it meant to get to go to Austin, and about just doing it," the coach said. "I didn't really talk to them about last year. But I heard the kids saying to each other, 'Let's not let that happen again.'"

They didn't. After Seminole's James Little netted the game's first basket from the corner, the Bobcats owned the floor. Using their 2-3 zone and full-court press, they shut the Indians down and rang up 16 before Seminole could get its next point on a free throw with 1:23 remaining in the first quarter.

Danny Martinez swished one of his patented long shots 45 seconds into the game to knot the score at 2-2, then James Alexander scored from underneath, then Martinez again from 'way out, then Pat McDonald from underneath, then Alexander with a pair of free throws, then Warren McDonald, then Alexander with a pair of free throws, then Pat McDonald on a dippy-doodle....

And they kept it up the entire game. Playing with more intensity than they have all year, the Bobcats were very aggressive under the boards as they blocked shots and rebounded, and their full-court press was eating Seminole alive. The Indians became so intimidated that even layups were rimming out.

"Sometimes a press will

... They remembered with a vengeance work against a team you don't think it will work against," Cleveland said. "With Seminole's quickness, I didn't think we would be able to press them effectively, but our press just tore them up. Mainly, it was the kids making it work — they just decided they were going to do it."

One indication of the Bobcats' intensity showed up when Woody Glass went after a loose ball in front of the Dimmitt bench. He snared the ball in mid-air at the boundary line, hurled it back in, then leaped over a teammate on the bench and disappeared up the ramp. He was halfway to Fourth Street before he came to a halt.

When the first-quarter smoke cleared, the Bobcats owned a 16-5 lead.

The second quarter was even more so. Alexander opened with a basket and Seminole matched it, then Dimmitt reeled off eight unanswered points — by Jeremy Warren, Alexander and Pat McDonald. The Bobcats finished the quarter

with 10 more unanswered points in the final 2:28 to take a commanding 44-25 lead to the dressing room at halftime.

Dimmitt fans loved it, of course, and others watching the game had a hard time believing what they were seeing. Seminole was a smooth, well-coached team with the quickness to gamble on defense, the speed to force a running game, and the poise to keep the pressure on. In the regional semifinals, the Indians had forced a fine Vernon team to fold under the pressure in the fourth for a 67-57 win.

"I think they're as good as they were last year, and maybe even a little better," Cleveland had said after watching the Indians put away Vernon. "I'll tell you — they scare me. I'd gladly settle for one point and not even walk on the floor."

The Bobcats couldn't wait to get back onto the floor in the third, and showed it as they outscored the Indians 12-3 in the first four minutes. When Martinez sank the quarter's

final basket on a fast-break layup with 12 seconds remaining, the scoreboard was tilted at 68-32 and the Bobcats had blistered the Indians 22-7 in the quarter.

"The kids just never did let up," Cleveland said. "I heard several of them say during the game, 'Hey—the score is 0-0.'"

Cleveland rotated his squad like a buffet line in the fourth as the Bobcats finished the slaughter, scoring 20 points to Seminole's 19 for an 88-51 win.

The team hit 62% of its shots from the floor, sinking 32 field goals while holding Seminole to just 15. From the charity stripe, the Bobcats collected 24 free throws on 26 Seminole fouls and the Indians sank 21 free shots off of 15 Dimmitt fouls.

For Coach Cleveland, the regional championship victory was also a personal milestone. Midway in the fourth quarter, Bobcat fans put up a long, computer-made banner that proclaimed, CONGRATULATIONS COACH CLEVE-

LAND ON YOUR 700th VICTORY." On the front row, Norman Hays pulled out a purple-and-white sign that said, "700 and Counting—Thanks, Coach."

## Bobcats 57, Bowie 46

Fourteen seconds into the semifinals game, a bank of overhead lights blew out in the coliseum. After checking out the situation, the referees ordered the game played without them.

The first quarter was as dim as the light, with the Bobcats forging a 10-9 lead against the deliberate, ball-controlling Bowie Jackrabbits (24-8) as both teams had trouble finding the basket.

The Jackrabbits seldom put the ball on the floor when they set up in their overload offense, opting instead for quick passing around the perimeter as they looked for the safe shot. The lead changed hands five times in the first period, with the baskets coming almost a minute apart.

The Bobcats made the Jackrabbits run for a while, but late in the second, Bowie got back into its deliberate, slow-down offense. Dimmitt outscored Bowie 20-17 in the second to take a 30-26 halftime lead.

Against the first slow-down team the Bobcats had faced since early in the season, Cleveland ordered his crew at halftime to switch to its No. 2 zone — a 1-2-2.

The strategy worked as the Bobcats extended their lead to 10 points, 35-25, in the third.

"Our No. 2 zone kind of got them out of their pattern," Cleveland said. "We were ready to go to a half-court press to make them speed it up if we had to, but luckily, we never had to."

Pat McDonald stayed mostly at the top of the key in the third and paced the Dimmitt scoring with nine points. His final basket of the quarter came after a great one-handed

sideline save by Martinez, who side-armed the ball to McDonald in the circle.

Except for a nifty layup by Alexander after a nice feed by Glass, all the Bobcats' field goals in the third came from 12 feet or farther.

The fourth quarter was fast and furious as the desperate Jackrabbits started moving again, hitting their long shots and attacking the boards in their catch-up attempt. They cut the Bobcats' lead to six points, 44-38, with 3:25 to play, but Martinez followed with a three-point play 15 seconds later, and the Jackrabbits could never get any closer.

Using a fast-break basket by Alexander and free throws by Pat McDonald, Glass, Alexander and Blake Brown, the Bobcats extended their lead to 13 points during the stretch before Bowie sank the game's final basket. The Jackrabbits finished the game with 22 field goals to Dimmitt's 19, but the Bobcats got 19 points at the free-throw line to Bowie's two.

The speedy Glass played the best game of his career so far as he hounded the Bowie guards out front and collected a bushel of assists and steals to go with his five free-throw points.

The all-regional tournament trio of Pat McDonald, Martinez and Alexander led the Bobcat scoring with 21, 13 and 10 points, respectively.

# Swifts: clearly the class of Region 1-A

No one came closer than 15 points of them as they shot their way to their third straight Region 1-A championship Friday and Saturday.

Using their trademark style of controlled floor play, precision shooting and tenacious defense, the Swifts blitzed Claude 92-57 in the first round, held off Jayton 50-35 in the semifinals, and swarmed Fort Davis 62-38 in the championship game.

For young head coach Johnny Hampton—who sat calmly on the bench and watched as his big, talented Swifts demolished all comers—it was a heady experience to capture the regional championship his first year at the helm after serving three years as Joe Lombard's assistant.

The Swifts were clearly the class of the eight-team regional field.

## ★ Swifts 92, Claude 57

In their tourney opener against Claude, the Swifts put on a clinic of passing, ball handling and precision shooting as they sank 68% of their field shots (36 of 53) and 86% of their free throws (18 of 21).

If Claude's Mustangs had any plans to pack tight against the Swifts' tall front line, Darryl Hoelting got them out of the notion right away as he sank 10 first-quarter points from long range to pace Nazareth to a 21-14 lead. Hoelting finished with 16 points—all on field goals.

Chris Schmucker opened the second quarter with a long bomb, then sank another following a 10-footer by Kenny Kern.

Then the Swifts' front line took over as 6-5 Randy Leavitt scored nine points in the second period, including a three-point play, while Kern and Darryl Hoelting added long-shot baskets midway to give the Swifts a 40-31 halftime lead.

The Swifts put the game away in the third as they got more aggressive on defense and outscored the Mustangs 23-10 to build their lead to 65-41.

"I told them at halftime that I hoped they'd play a little better defense in the second half," Hampton said. "We don't like to give up 31 points in a half."

He added, "Claude was a lot bigger than Spade (the Swifts' area playoff victim). They hurt us more inside—they got a lot more second shots than we like to give up" with 6-6 Mark Hall and 6-2 Jerry Johnson attacking the boards.

Biggest thorn in the Swifts' side was 6-0 senior Jeff Whelchel, who poured in 23 points from all distances and angles.

In the fourth quarter the Swifts continued their blitz, outscoring the Mustangs 27-16 as the reserves crossed the 90-point barrier to make it a rout.

## ★ Swifts 50, Jayton 35

Although the Jaybirds didn't score on their first six possessions and were down 8-0 before they got their first basket with just 2:59 remaining in the first quarter, they fought back to give Nazareth its toughest battle of the playoffs so far.

With Nazareth shooting below par, Jayton cut the Swifts' lead to 12-8 by the end of the first quarter, then outscored them 10-6 in the

second to knot the halftime score at 18-18.

The game stayed close throughout the third as Nazareth had trouble making its inside game work. Except for two follow shots by Leavitt underneath, all of the Swifts' third-quarter points came on long bombs by Hoelting and Schmucker. Going into the fourth quarter of the low-scoring contest, Nazareth hung on to a 28-24 lead.

Jayton, meanwhile, wasn't getting many points from its front line, either. The Jaybirds tried a lot of baseline pick plays in the third, but the Swifts' defense thwarted them.

The Jaybirds came out in a full-court press in the fourth, but their strategy backfired as they started fouling and the Swifts started collecting. Nazareth was perfect at the free-throw line, hitting 10 of 10—all in the fourth quarter.

Meanwhile the Swifts started getting a lot of transition baskets off of defensive rebounds and steals, and the Jaybirds lost their cool. After Trey Richey and Billy Scogin drew technical fouls, Coach Wendell Neff called his team to the bench for a fatherly chat that could be heard half a court away ("Keep your mouths shut and play ball!").

After the timeout, Todd Hill sank both ends of a one-and-one and Billy Steffens netted a T-shot to give the Swifts their biggest lead so far, 36-26, with 4:17 remaining.

The demoralized Jaybirds kept fouling to get the ball, and the Swifts kept collecting free throws to go with their field goals until they built their lead to 44-26 on a fast-break layup by Schmucker with 2:03 remaining.

"We changed in the middle of the third quarter from a one-post offense to a three-post, and that seemed to open it up a lot," Hampton said. "Also, when they got their two technicals in the fourth, that helped our kids a lot—it loosened them up a lot. We were pleased with our defense."

## ★ Swifts 62, Fort Davis 38

Nazareth's defense was so overpowering in the championship bout that the Fort Davis Indians didn't score for the first 5:40 of the game, and netted only three points in the second quarter to find themselves hopelessly behind by a 29-9 count at halftime.

"I was relaxed at halftime—as much as you can be relaxed," Coach Hampton said. "You can never totally relax until it's over."

He knew how improbable it was that the lads from the Davis Mountains would erase a 20-point Nazareth lead.

But the Indians showed a lot of character as they gave it a hearty try in the second half. They came alive in the third quarter as they started stealing off of a full-court press and hitting their shots.

After the 29-9 first half, the second-half score was a respectable 33-29 as the Swifts coasted to the Region 1-A throne room.

"Fort Davis did pretty much as we expected," Hampton said. "We knew they'd try to lob it in to their big post man (6-4 John Lane), so we fronted him with Randy."

The rest of the Swifts defense did its hard-pressure thing, too, to stifle the Indians throughout the first half. And the offense produced with its customary efficiency.

"I think our defense was the key factor," Hampton said. "When you play defense well, it carries over to your offense."

Fort Davis had squeezed past Southland 50-48 and had overpowered Phillips 51-40 to earn a berth in the title game.

The Swifts were able to increase their lead by only two points in the third, to 45-23, as Fort Davis fought back. Leavitt hit four field goals in a row from underneath for half of the Swifts' third-quarter points to keep the Indians at bay by 20 or more.

Only two Nazareth players scored in double figures — Leavitt with 18 and Kern with 11. For Fort Davis, Lane — who was held to only five points in the first half —

fought back with 13 in the second to finish with 18, while John Henderson scored 10.

With both teams' top two scorers finishing almost in a dead heat, the secret of the Swifts' lopsided victory rested with the other players. For Nazareth, six others—Darryl and Kevin Hoelting, Steffens, Hill, Schmucker and Craig Huseman—contributed 33 points, while only three other Indians found the basket, and two of them for only two points each.

As the clock wound down with Nazareth's reserves on the floor, the starters whirled towels and whooped at the bench, while in the stands Naz fans started chanting "hoodat," knowing they were going

back to Austin for the third year in a row and the fourth in the school's history.

**What? There's sodium even in our drinking water?**

Those whose doctors have told them to follow a low-sodium diet find sodium comes from more places than just the salt shaker. There's sodium in drinking water.

"Most people don't think about the sodium content in drinking water," says Mary K. Sweeten, nutritionist with the Texas A&M University Agricultural Extension Service.

*The Journal of the American*

Dietetic Association reports adults can get 10% of their daily intake of sodium from the two and a half quarts of water that most adults drink each day.

Other "hidden sources" of sodium include distilled and bottled water and carbonated water in soft drinks.

A home water softener is not the solution since it can add even more sodium, she says.

"Those needing to soften water for bathing or washing clothes might consider connecting only hot water lines to the water softener," says Sweeten.

"Or, they might not connect the kitchen lines to a softener."

She says that studies have shown that most water supplies fall within the recommended range of sodium content, but there may be locations where this is not true.

"If you want to know the sodium level of the water you are drinking," she says, "contact your local water company."

Owners of private wells may want to have their water supply checked for sodium since levels fluctuate in the same area, the nutritionist says.

# Broderson selected to review secondary art test by TEA/NES

Sue Broderson of Dimmitt has been chosen by the Texas Education Agency to serve on the committee for the Examination for the Certification of Educators in Texas.

The exam is a requirement for graduate students interested in the area of education. Students must pass the test to receive their teaching certificates.

Broderson was selected to review the test in the field of secondary art.

The Content Validation/Standard Setting Conference was held in Austin Feb. 24 and 25.

Eight educators in each field from public schools and universities throughout Texas met in Austin to evaluate the completed exam and suggest revisions.

Broderson became involved

in the program in 1984 when she met with art educators of the area at West Texas State University in Canyon to suggest what was to be covered on the exam. The ideas were sent to Amherst, Mass., and were made into a test by the National Evaluation Systems, Inc.

The secondary art test she evaluated had 180 questions covering all levels of art education from basic elements through student evaluation by the teacher.

On Feb. 23, her group reviewed the test and made evaluations as to whether each question was evaluated and gave a percentage of the number of students that should be able to answer each question.

The information was fed into a computer and was given back

so they could compare and evaluate with others in the area.

The group were asked if revisions or changes were needed on the exams.

All of the results will be tabulated and completed in time for university students to take the test in May.

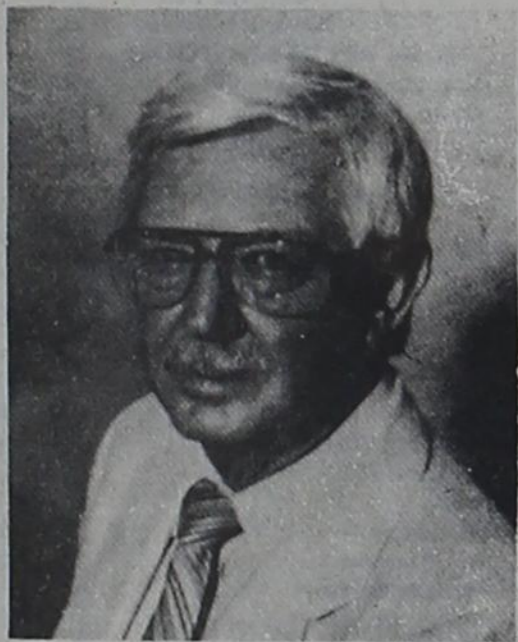

The album is being produced by Upward Productions of Oklahoma City and was recorded at Image Studio, also in Oklahoma City.

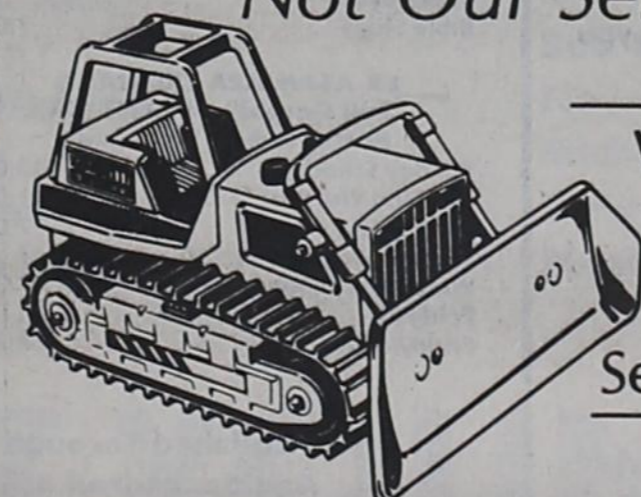

## We Salute OUR TEACHERS

On March 10, 1986 school teachers statewide, holding a valid teaching certificate and currently employed, will be required to take the TEXAS EXAMINATION OF CURRENT ADMINISTRATORS and TEACHERS, more commonly known as TECAT. It is estimated that up to 5,000 teachers will take early retirement as a direct result of TECAT. While TECAT does seem rather unreasonable to some, consider the rules set down for teachers in the Buckeye Farm News in 1915.

- You will not marry during the term of your contract.
- You are not to keep company with men.
- You must be home between the hours of 8 p.m. and 6 a.m. unless attending school functions.
- You may not loiter downtown in any of the ice cream stores.
- You may not travel beyond the city limits unless you have the permission of the chairman of the board.
- You may not ride in a carriage or automobile with any man unless he is your father or brother.
- You may not smoke cigarettes.
- You may not dress in bright colors.
- You may, under no circumstances, dye your hair.
- You must wear at least two petticoats.
- Your dresses must not be any shorter than two inches above the ankle.
- To keep the schoolroom neat and clean, you must: sweep the floor at least once daily; scrub the floor at least once a week with hot, soapy water; clean the blackboards at least once a day; and start the fire at 7 a.m. so the room will be warm by 8 a.m.

qualifications for an academy appointment.

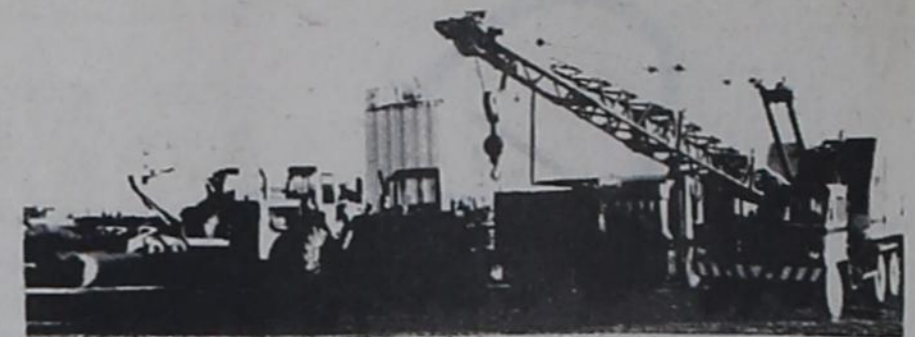
"The academies offer excellent opportunities for young people and they have a long tradition of providing education and training for the future leaders of our armed forces."

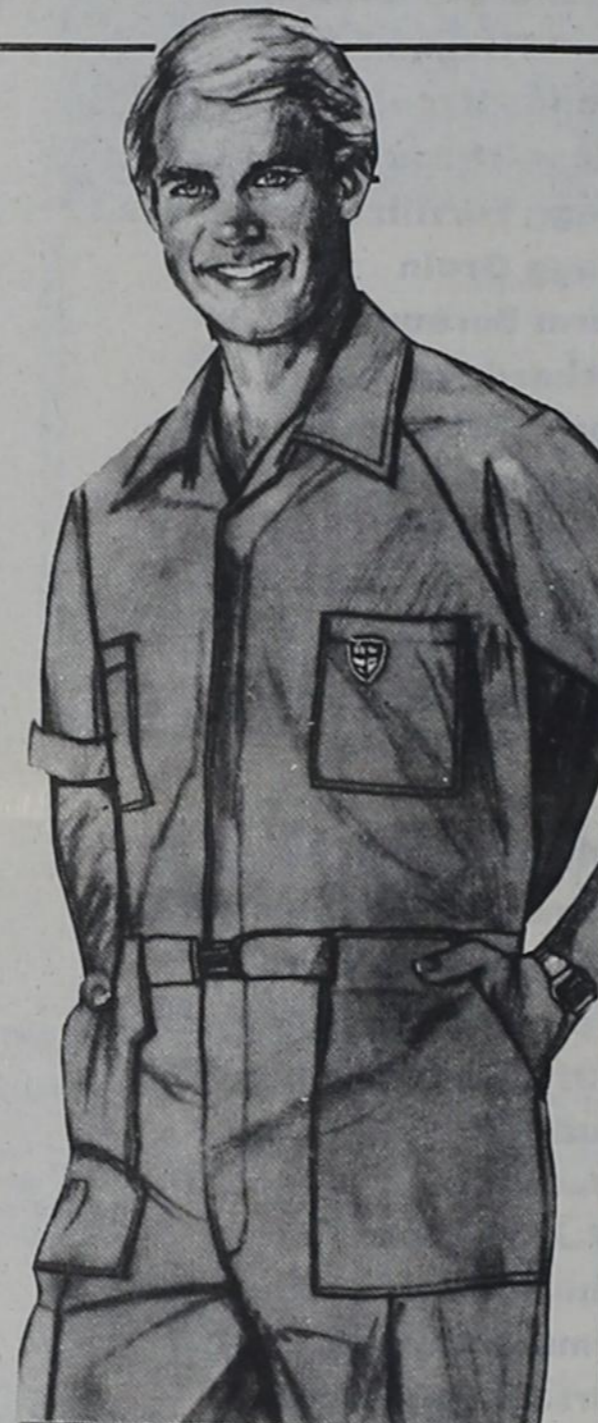

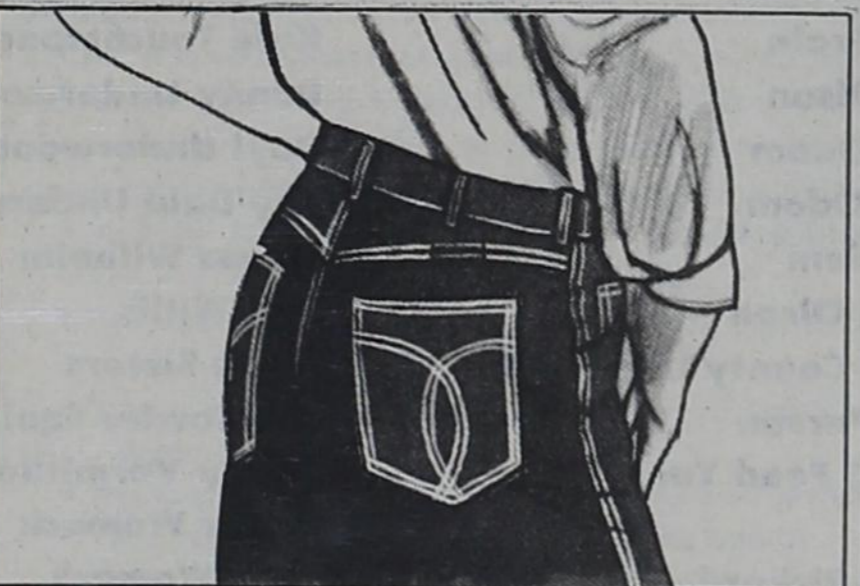

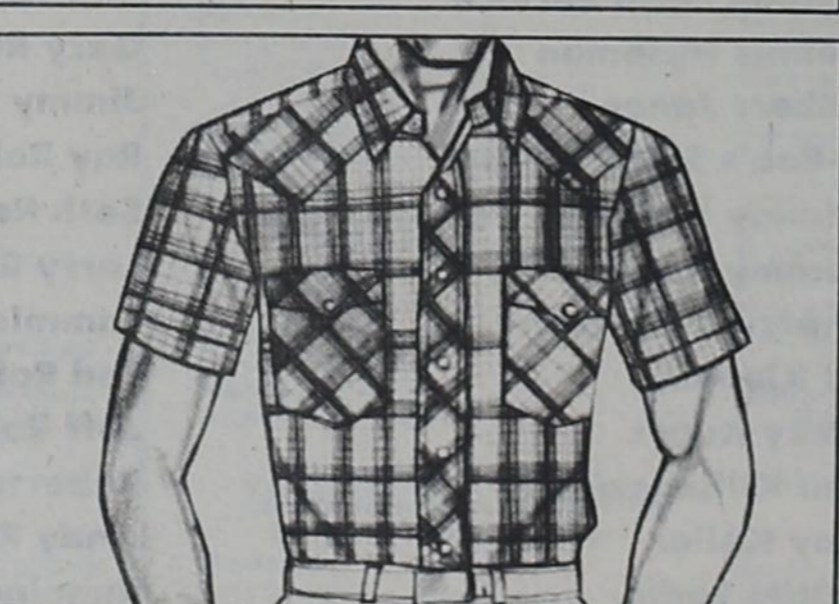
