The first blast occurred at 8:45 a. m. (CST). Its vibration broke windows in houses and stores in a large area of Monmouth County and it could be heard for miles around The wounded were removed to

A police alarm summoning all doctors and ambulances to the scene was cancelled three-quarters of an hour after the blast. The police teletype said the Navy had said it had sufficient Naval and Army personnel.

Milk and its products comprise more than 25 per cent of the foods estimated to be consumed annually by the average American. Con-sumers use more than 50,000,000 quarts of fresh milk and cream a day.






