

Truman Shuns Coal Issue

Former State Employe Faces Theft Charges

15 Cases, Including Forgery, Total \$1,885

AUSTIN - (AP) - The Travis County grand jury Thursday returned 15 indictments against J. M. Del Curto, former employe of the state Department of Agriculture, charging theft from the State of Texas on 11 counts and forgery on four counts

Bond was set at \$500 on each indictment by Judge Roy C. Archer in 126th District Court. Theft charges dated from Dec.

31, 1942, to Aug. 1, 1944, and ranged from \$130.40 to \$145.10 each. Forgeries were charged on promissory notes and assignment of state warrants in amounts ranging from \$49 to \$140.80 each.

The indictments follow a state auditor's report made July 11 to Gov. Coke Stevenson in which it was stated that "apparently illegal" ayments of salaries had been found in an audit of the state Agriculture Department. The report named Del Curto, former head of the Division of Hor-

ticultural Inspection and Quarantine, as supervisor of the employes or former employes "to whom apparently illegal payments of salaries" were made.

pleading can be done is either face to face with Russian and was going ahead. Such pleading, to be successful, must be cloaked with authority and backed by strong popular support. Neither gentle chiding nor fiery denunciation, uttered in America to American audiences, is likely to get far.

Wallace, whatever his desires, was not in a position to make this effective plea. But he was a political figure with a large following. Even a one-sided plea, supported by this following, was certain to gain attention.

It may be that Wallace hoped that this unilateral plea to "give", if heeded, would move Russia to a similar softening attitude. 


'Farce And Delusion'

They know that the plays that worked were correct. and feel that they themselves would have made the same plays. But they also find that the experts do not always do the right thing.

I watched a group of them play today's hand. When the opening diamond lead held, East continued with the queen of diamonds, a normal play were it not for the fact that West had played the duce on the first trick and North the jack. North had made a strong threespade bid despite the fact that dummy had the ace-queen. There-



fore East should have known that his side would take no spade tricks. As a club shift would be dangerous with the long suit in dummy East should have considered shifting to a heart. But he continued with the diamond queen which declarer ruffed. A small club was played to

dummy's queen and West follawed with the six-spot. Declarer then took four rounds of trumps, led another club and went up with the king. West won and now declarer went down two tricks.

When declarer led clubs the second time, he should not have played the king. He should have put on the ten-spot to establish the suit. His only hope of making the contract was to find the jack in East's hand. As long as East had made the mistake of continuing with a diamond, declarer could have made the whole hand.



Comptroller George H. Sheppard has released an analysis of receipts and expenditures for the fiscal year which ended August 31, 1946, showing in detail how each penny of the state's dollar is spent.

Education took the major share-3542 cents of each dollar, for a grand total of \$84,509,604.41. Next was public welfare, pensions, benefits and retirements - .3292

cents of each dollar for a total of \$78,557,865.05.

Highways and road debt took 2024 cents of each dollar for a total of \$48,290,057.26.

The total cost of government for Texans during the fiscal year was \$238,616,434.15. Total revenue receipts for the year were \$301,523,-177:25.

Taxes and licenses in all catagories brought in .6811 cents of each revenue dollar, with motor fuel taxes in first place with .1870 of each dollar and gross receipts and production taxes bringing in .1741 cents of each revenue dollar.
