

When registration closed March 31, there were 2,250 Crockett County voters eligible to vote in the primary. This number was up 182 over the number of eligible voters when the ballots were printed in late March. A request for Precinct 1 numbers broken down according to race was complied with and most recently a request for the eligible voter list for precinct 1 was sent to the lawyer in the Attorney General's office. Late Monday afternoon Judge Troy Williams talked to the attorney and he had not received the list, but he assured him a decision would be forthcoming once the list was received. According to the breakdown, there were 345 Mexican-Americans, 335 Anglos, and 35 blacks registered in Precinct 1. This would indicate that voters of Mexican-American descent had a slight edge, with the Anglos having the second most votes and blacks in a distinct minority. If the Attorney General's ruling depends on racial balance, the lines will no doubt stand as they are at present. Precinct 1 voters will

## **Heavy WindStorm**, **Rain Hits Ozona**

A blustry wind-rainhail storm hit Ozona Thursday afternoon and resulted in . 83 of an inch of rain over a 24 hour period, according to the official gauge at the Water District Office. Skies threatened all week, but unusually high winds seemed to blow any chance the southeast part of the of rain away until Thursday

The moisture seemed to be fairly well distributed over the county, with up to an inch of rain reported in some sections. The Vic Pierce ranch reported .9 of an inch over-all. Some gauges here in Ozona recorded up to 1 inch of rain.

Small hail began to fall during the middle of the storm Thursday afternoon, but soon stopped without causing any damage. The storm raged for a good two hours before abating, beginning at about 3:45. A large volume of dirt in the air caused mud to fall along with the rain, and there are some

who declare "it rained mud. " The appearance of some vehicles Friday morning seemed to bear this fact out.

Temperatures dropped drastically during the storm, and some loss was reported to newly shorn sheep. Buddy Phillips, in county, lost 50 head of newly-shorn ewes, but managed to save 14 affected animals. Monday morning he was trying to save several dozen dogie lambs.

The rain was the first of any consequence for Ozona since March bowed out with a .74 of an inch total. With no rain reported for January and February the yearly total amounts to only 1.57. Much more rainfall is necessary to alleviate droughty conditions in the county.

#### FORD AND REAGAN: THE GREAT DEBATE JOINED

President Ford has charged Governor Ronald Reagan with making "misleading statements" and with "a fabrication and invention" concerning the state of the nation's military power and the views of his Secretary of State. He has accused Reagan, in short, of lying,

It would be more comforting to believe the President, who, asserts that it is Reagan who is merely being political and who has his facts all wrong.


It would be comforting, but not realistic. Unfortunately, the evidence speaks powerfully to the contrary.

Mr. Ford, in his rebuttal to Governor Reagan's television address, slid over the fact that Russia now has a huge superiority over the U.S. in numbers of tanks, artillery, planes, ships, and other conventional weapons. He chose instead to insist that the U.S. still has a lead in "strategic nuclear capability, " and this only because we still have more nuclear warheads than the Russians. While still true, it ignores the fact that the Soviets have a large lead in delivery vehicles and in the megatonnage of their warheads, and that they are fast catching up with us in numbers of warheads. This is what is creating for them a potential first-strike capability, in which they could conceivably destroy many, or most, of our warheads before they could ever be delivered to their targets. It is thus Mr. Ford who is, sadly, misleading the people in his eagerness for reelection. His own new Secretary of Defense, Donald Rumsfeld, admitted in a recent appearance on TV's "Issues and Answers" that former U.S. superiority has now given way to "rough equivalence, " and that, if present trends continue, this will soon become "inferiority, "

As for Reagan's alleged "fabrication, " this refers to Admiral Elmo Zumwalt's revelation that in conversations with Secretary Kissinger in 1970 and 1972. Kissinger told him that "the day of the U.S. is past

Zumwalt says Kissinger compared the U.S. and Russia to Athens and Sparta and said that his job as Secretary of State is "to negotiate the most acceptable secondbest position available." Kissinger denies this, and Ford backs him up. This boils down to one man's word against another, but Zumwalt's version is made more credible by what many other Kissinger intimates have described as his "Spenglerian view" of the decline of the U.S. and the West.

It seems to us that the Reagan speech and the Ford and State Department rebuttals have now brought to center stage the great issues upon which the 1976 election should preperly focus. The American people have the right to become fully informed about, and to render judgment on, the military and foreign policy objectives of their government. Let the debate continue.

#### "MAJORITY RULE" IN SOUTHERN AFRICA?

Much is heard these days about the principle of "Majority rule" in Rhodesia and South Africa. "One man, one vote" is the usual formula espoused for carrying this principle into practice.

If the rest of black Africa is any guide, however, the elimination of white rule will not bring the ballot to the black man of southern Africa. It will merely replace white paternalism with black dictatorship.

Moreover, there may be nothing enlightened or benign about such a dictatorship.

To begin with, the emergence of the dictator is likely to be an extremely bloody affair. Besides the traditional hostility between the Matabele and Mashona tribes in Rhodesia, there is the simmering feud between the various Rhodesian black leaders and factions. Each of them wants power for himself after the white government of Ian Smith is eliminated. Thousands of Rhodesian blacks have already been brutally murdered in factional strife over the years. The Rhodesian whites still enjoy a large degree of black support largely because these peace-loving people know full well the furies that will be unleashed within their country once the restraining white power disappears.

Neither would the political situation in South Africa be easily resolved if white rule were overthrown. The tribal and racial situation there is far more complex than in Rhodesia. The hostility, for example, of the blacks toward the substantial Indian population has been violently demonstrated on more than one occasion.

Those who speak so easily of "majority rule" need to understand that what they are really promoting is merely a different form of racism. The white governments, which have at least kept the peace and brought a relatively high level of prosperity to all, will be replaced by a form of despotism that will have nothing to do with "one man, one vote."



Mums and dahlias should be separated and planted this month.

To grow large dahlia flowers allow only the top bud to develop on each stem. New growth buds occur only at the end of the dahlia tuber connected to the underground stem. When separating, be sure each tuber includes a portion of the underground stem along with a new growth bud. Plant in deep, fertile, well-drained soil in a location that gets full sun for at least 6 hours each day. Carefully cut the tuber apart with a sharp knife. The hole should be about 24 inches wide and 18 inches deep for each plant. Space tubers 3 to 4 feet apart if large flowers are wanted. For smaller types, space 2 feet apart, Plant tubers in a horizontal position about 5 inches deep, with growth bud pointed upward beside a sturdy stake which extends 6 feet above the ground. Cover the tubers with about 2 inches of soil and fill in the remainder of the hole as the plant develops. Each month after planting fertilize with  $\frac{1}{4}$  cup to each plant. As plants grow larger, increase to  $\frac{1}{2}$  cup. A good mixture for planting is 2 parts soil, 1 part organic matter and  $\frac{1}{2}$  cup of complete fertilizer (5-10-5) to fill each hole.

April is the time to plan for a colorful September-October garden, and no plants can rival the many colors and varieties of chrysanthemums. Select modern mums 10 inches to 4 feet high, with flower forms tight as a button or loose as a spray, according to your needs - to edge a shrub or flower bed, accent a flight of steps, to enliven an out-of-bloom shrub planting, bring new life to your late-summer garden of exhausted annuals, or provide a rich abundance of cut flowers for your home or church, Cushion nums are fine low plants with attractive and moundlike growth 18 to 28 inches across. Taller mums up to 3 ft. offer charming flower forms. They are easily transplanted and can be grown in a vegetable garden. The spray types of proven hardiness and ease of culture produce many blooms and need no disbudding. Spoons and spiders, mostly single, bloom early and fine for

Jam and jelly don't have to be "forbidden fruit" to people on sugar-restricted diets. Just use artificial sweetener instead of sugar when making them.

Diet jams and jellies must be refrigerated or frozen unless they are made by the long boil method. And storing them in the freezer keeps the natural color and flavor of Texas strawberries, peaches or dewberries at peak quality. Leave at least one-half inch head space in the container before freezing. Fresh strawberry jam

For jams, the method of combining ingredients varies with the form of pectin used. Powdered pectin is mixed with unheated crushed fruit, and liquid pectin is added to the cooked fruit and sweetener mixture immediately after it is removed from the heat.

Cooking time is one minute at a full boil. Full boil stage is reached when bubbles form over the entire surface of the mixture. James made without added pectin or gelatin require longer cooking

out pectin or gelatin and a thermometer isn't avail-----able, just cook the product until it has thickened slightly. Allow for additional thickening as the product cools. Jams made without sugar tend to be thinner than those made with the addition of sugar.

Also, when preparing jams, be sure to prevent scorching the fruit. STRAWBERRY JAM WITH PECTIN 1 quart clean strawberries 1-3/4 ounce packaged





5 Tbsp. butter 1 thin slice cooked ham or Canadian bacor 2 egg yolks 1 Tbsp. lemon juice 1/8 tsp. salt Dash of cayenne pepper 1/2 of 1 English muffin Butter 1 poached egg

Melt 1 tablespoon of butter in a skillet over moderate heat. Add ham and cook a few minutes on each side. Remove from heat and keep warm. To make sauce, melt remaining 4 tablespoons of butter over low heat in a small saucepan. Combine egg yolks, lemon juice, salt and cayenne in a small bowl; slowly add the melted butter, stirring constantly. Toast muffin and spread with butter. Place the slice of ham and the poached egg on the muffin half and spoon sauce over. (Note: Instead of making the above sauce, one package of hollandaise sauce mix can be substituted. Prepare according to package directions.) Yield: 1 serving.



Q: We are planning to sell our home. If we find a buyer who wants to "assume" our mortgage, instead of arranging for a new mortgage, could our mortgage company come back to us for payment of the mortgage if the buyer cannot make the monthly payments? A: Yes. Any time you sell your home by having someone assume the balance of your mortgage, the mortgage company retains the right to look to you for the monthly payments if the buyer fails to meet them. To protect yourself in a sale of this type, the contract between you and the buyer should be written to include provisions allowing you to have title to the home returned to you in the event the buyer defaults; then, you would resume responsibility for paying off the mortgage. Otherwise, the mortgage company could sell the house and look to you for any balance remaining on the mortgage after proceeds of the sale are applied against the mortgage.

**O:** How can I copyright watercolors I have painted?

A: Artists cannot always prevent unauthorized reproduction and distribution of their work. Their rights are controlled by common law copyright and Federal copyright laws. Before art works are publicly displayed, the artist has absolute control. Once art works are publicly displayed, the artist must comply with federal copyright

laws which require that a statutory copyright notice be affixed to the art work, and a copyright form be filed with the United States Copyright Office. The result of failure to comply is that the artist loses all control over reproduction and sale of his work.





