Budget shortfall puts financial squeeze on county departments

Budget shortfalls will mean layoffs for several departments within Howard County and are expected to adversely impact customer service, according to officials.

County Judge Mark Barr said Wednesday several major cuts have been made to the county's budget and will leave department heads with arduous task of eliminating some positions

FHS Band is tops in Class 1A

FORSAN — Forsan High School Band has earned many superlatives over the years, but this one can't be topped.

The FHS Band was recently named the Texas Music Educators Association Class 1A Honor Band for 2007. The distinction is awarded to the top Texas high school band in its classification.

Director Jim Rhodes said the band entered a CD of its University Interscholastic League concert performance in the TMEA competition. Forsan advanced past the regional and area rounds to qualify, along with seven other bands, for the state TMEA contest in San Antonio last Thursday.

When the winners were announced. Rhodes and Assistant Director Misty Hoelscher learned that their band placed first on all five judges' ballots. Seagraves placed second, while Sundown was third. "We had placed first in the earlier stages, so we got our hopes up that we might do well at state," Rhodes said. "I did feel we had a chance to place in the top five — that was what we were hoping for." It was a case of the third time being the charm for Forsan — the band placed fifth and second, respectively, in its past appearances at the TMEA state contest.

"There's just no other way," said Barr. "We're cutting the county library budget by \$100,000, the road and bridge administration's by \$120,000 and the maintenance department's by one full-time employee and one parttime employee. We've also implemented a hiring freeze.

"We're looking at a budget shortfall of about \$250,000 for the coming year and a shortfall of about \$400.000 the following year," Barr added. "The fund balances have been steadily declining over the past several

dous cost of the county jail being closed simply put it over the edge."

The county jail was shut down by the Texas Commission on Jail Standards in November after it failed to meet several life-safety criteria, forcing county commissioners to not only fund repairs to the facility totaling more than \$250,000, but also to shoulder the expense of housing inmates in other county jails, an expense Barr described as tremendous.



SAN ANTONIO – A half hour before his first training camp practice in charge of the Dallas Cowboys, Wade Phillips strolled out of a tunnel and onto the turf of the Alamodome. As soon as he came into view Wednesday afternoon, about 8,000 fans stood and cheered.

So Phillips smiled, waved and kept walking. He also came to a quick conclusion: "That's the last time I'll get a stand-

ing ovation." Not necessarily. If the Cowboys can live up to the "good feeling" their new coach has about them, Phillips may get used to entering rooms greeted by a chorus of applause. After all, this is "America's Team," a status confirmed by the huge turnouts for a precamp concert Tuesday night and again Wednesday for Day 1 of workouts in helmets, shoulder pads and shorts. "There's not any training camps like this that I know of or that I've been in," said Phillips, entering his 31st season in the NFL and with his seventh franchise. "This was probably the most and the most enthusiastic. It helps because your players practice better. When the fans are out there, they're going to do more, so I think it's a real plus for us.' The Cowboys are coming off a 9-7 season that ended with a playoff loss. Dallas hasn't won a postseason game in 11 vears. a dismal streak that Bill Parcells failed to end in his four years in charge. Now it's Phillips' turn.

Rangers complete series sweep of Mariners

ARLINGTON – With unblemished closer J.J. Putz finally back on the mound, the Seattle Mariners had to anticipate a winning end to a miserable trip.

Except, they only felt worse when it was over.

who hadn't Putz, allowed a run in 16 road appearances this season and hadn't blown a save since last year, gave up a two-run homer to Ramon Vazquez with two outs in the eighth inning as the Texas Rangers rallied for a 7-6 victory Wednesday night to complete a fourgame sweep.

"There's not much I can say. He put a good swing on it," Putz said. "This is not the best time for this to happen. ... Things

aren't going our way. Five of the losses were by We're in a bad cycle."

Having not pitched since Friday, Putz came on with one on and one out in the eighth. He struck out Gerald Laird, but Vazquez hit a 414-foot drive to right-center his fifth of the season.

Putz had converted a majors-best 31 straight save chances, including all 29 this year, and had thrown 22 consecutive scoreless innings.

"He's human," Rangers manager Ron Washington said. "I don't care how good you are, things can turn for you sometimes in the wrong direction."

Seattle lost its sixth straight game since winning the trip opener at Toronto to get within a game of the AL West-leading Los Angeles Angels.

One can look at those accusations and decide that, if true, the young man in question must have more than a couple of loose screws up in the ol' belfry.

One would probably be right. Someone apparently forgot to inform Vick that quarterbacking a NFL team and engaging

in animal torture are not mutually compatible endeavors. People tend to look poorly on such inconsistencies.

If he is found guilty of the charges, he will lose much more than his freedom. He will lose a multi-million dollar career, not to mention additional millions in endorsement deals. Regardless of the outcome, Vick's net worth will probably end up somewhere around mine.

As damning as the case against Vick appears, however, football isn't the sport taking the biggest hit this week. That dubious distinction belongs to basketball.

It was announced recently

that the FBI is investigating allegations that veteran NBA referee Tim Donaghy bet on basketball games over the 2005-2006 and 2006-2007 seasons, including ones in which he officiated.

Now, we can make bad jokes about brain-dead quarterbacks until the cows come home, but referees on the take is serious business.

At the end of the day, the only thing sports franchises can offer their fans is the belief that their games are on the up and up. Take away that belief, take away a sport's credibility and it might as well be pro wrestling.

Despite what some people

might think, I was not around at the time of the infamous Black Sox gambling scandal in 1919, but everyone agrees it was almost the death of baseball. And the same kind of damage awaits basketball unless the NBA Powers That Be jump on this fast.

After all, if there's one crooked ref, there can always be another. And maybe a player or two. Or even an owner. Who knows how widespread this thing is?

NBA Commissioner David Stern said in a Tuesday news conference that it appears that Donaghy was the only referee who apparently bet on games. But Stern needs to go further than reassuring statements. He needs to launch a full-scale investigation to make sure there is no other funny business going on under his watch. And he needs to keep the public informed every step of the

way. It would be a shame if basketball took a permanent hit because of a credibility problem, but it's happened to a major sport before.

You remember boxing, don't you? Like pro wrestling, but with gloves?





House Demos expect drop in GOP support for war, offer bill to bring troops home in 60 days

WASHINGTON (AP) - House Democrats have drafted new Iraq legislation they hope will appeal to Republicans fed up with the war: Start withdrawing troops in two months but leave it up to President Bush to decide when to complete the pullout.

The vote will come next week, as members take up a \$460 billion bill covering military spending for 2008. Another vote could come again in September, after Iraq commander Gen. David Petraeus delivers a longanticipated assessment on the war and Congress considers a \$142 billion measure needed to finance the wars in Iraq and Afghanistan.

"This is big time," Rep. John Murtha, D-Pa., said of the upcoming fall debate. "When you get to September, this is history. This is when we're going to have a real confrontation with the president trying to work things out."

The House has passed similar anti-war measures in the past, but has been unable to push the legislation through the Senate, where Democrats hold a slimmer majority and Republicans have routinely blocked such bills from advancing.

Most recently, the House approved legislation that would have required troop withdrawals to begin this November and finish by April 1.

SAN DIEGO (AP) — Respiratory therapist Wayne Albert Bleyle was in New York state on a wintry day when investigators called him about allegations he had molested patients too sick to defend themselves.

When they asked how many children he molested. investigators said, he looked out his window and asked, "How many snowflakes are there out there?"

On Wednesday, Bleyle didn't turn to look as a succession of parents and family members of victims spoke at his sentencing hearing. Some wept; others shook with anger.

As part of a plea deal, Bleyle, 56, was sentenced to 45 years and eight months in prison for molesting five of his young, disabled patients and for taking pornographic photographs of others. Prosecutors said he targeted those who were comatose, brain-damaged or too disabled to talk.

"You have violated the trust of your patients, you have violated the trust of your employer, and you have inflicted indescribable anguish on your victims and their families," Superior Court Judge Kenneth K. So told Bleyle.

Country singer Mindy McCready taken into custody in Tennessee on probation violation

NASHVILLE, Tenn. (AP) - Country singer Mindy McCready was taken into custody at Nashville International Airport, accused of violating her probation after a scuffle with her mother and authorities in Florida, officials said.

McCready, 31, was arrested last week in Fort Myers, Fla., her hometown, on misdemeanor charges that she scratched her mother on the face and then resisted sheriff's deputies.

She was on probation for obtaining the painkiller OxyContin fraudulently at a pharmacy in 2004. Still pending was another probation violation charge resulting from a drunken driving arrest in May 2005.

Deputy District Attorney General Derek Smith told The Tennessean that she violated probation in three ways: by being charged in a new offense; not reporting those charges immediately to her probation officer; and by the nature of the new assault charges.

An official at the Williamson County sheriff's office just south of Nashville said McCready was being booked Wednesday night.

South Korean envoy heads to Afghanistan in attempt to save 22 hostages held captive

KABUL, Afghanistan (AP) – A top South Korean envoy headed to Afghanistan on Thursday, scrambling to save 22 of his country's citizens held captive by Taliban kidnappers after the militants killed one hostage.

However, a local police chief said that the negotiations with the captors were difficult because their demands were unclear.

"One says let's exchange them for my relative, the others say let's release the women and yet another wants a deal for money," said Khwaja Mohammad Sidiqi, a local police chief in Qarabagh. "They have got problems among themselves."

On Wednesday, authorities found the bullet-riddled body of 42-year-old Bae Hyung-kyu in Qarabagh district of Ghazni province, where the South Koreans were abducted July 19. Church officials said he was killed on his birthday.

Bae was found with 10 bullet holes in his head, chest and stomach, said Abdul Rahman, a police officer. Another Afghan police official, who asked not to be identified because of the sensitivity of the situation, said militants told him the hostage was sick and couldn't walk and was therefore shot.

US commander: Better aim of mortars, rockets into Green Zone appears related to training

BAGHDAD (AP) – The U.S. military has noted a "significant improvement" in the aim of attackers firing rockets and mortars into the heavily fortified Green Zone in the past three months that it has linked to training in Iran, a top commander said Thursday.

Lt. Gen. Ray Odierno, the top day-to-day U.S. commander in Iraq, also expressed cautious optimism over a decline in the number of American troops killed this month. At least 60 U.S. troops have died so far in July after the death toll topped 100 for the previous three months, according to an Associated Press tally based on military statements.

Odierno said it appeared that casualties had increased as fresh U.S. forces expanded operations into militant strongholds as part of the five-month-old security operation aimed at clamping off violence in the capital, but were going down as the Americans gained control of the areas.

"We've started to see a slow but gradual reduction in casualties and it continues in July," he said at a joint news conference with Iraqi military commander Maj.

Gen. Abboud Qanbar. "It's an initial positive sign, but I would argue we need a bit more time to make an assessment whether it's a true trend."

Documents show leaders were briefed on terror surveillance, contradicting Gonzales

WASHINGTON (AP) — Documents indicate eight congressional leaders were briefed about the Bush administration's terrorist surveillance program on the eve of its expiration in 2004, contradicting sworn Senate testimony this week by Attorney General Alberto Gonzales.

The documents underscore questions about Gonzales' credibility as senators consider whether a perjury investigation should be opened into conflicting accounts about the program and a dramatic March 2004 confrontation leading up to its potentially illegal reauthorization.

A Gonzales spokesman maintained Wednesday that the attorney general stands by his testimony.

At a heated Senate Judiciary Committee hearing Tuesday, Gonzales repeatedly testified that the issue at hand was not about the terrorist surveillance program, which allowed the National Security Agency to eavesdrop on suspects in the United States without receiving court approval.

Instead, Gonzales said, the emergency meetings on March 10, 2004, focused on an intelligence program that he would not describe.

N. Korea storms out of military talks with S, Korea; no agreement reached

PANMUNJOM, Korea (AP) - North Korea walked out of military talks with South Korea, ending three days of high-level negotiations Thursday with no agreement amid a lingering dispute over their shared sea border.

"We've come to the conclusion that we don't need these fruitless talks any more," North Korea's chief delegate Lt. Gen. Kim Yong Chol said at the final session in the truce village of Panmunjom.

Kim criticized the South for avoiding discussions of what he termed the "illegal" sea border.

City employee recovering from accidental gunshot wound

said the damage to county coffers has been done.

According to county library director Hollis McCright, those budget cuts will amount to a reduction in personnel, and ultimately, in services provided to county residents.

"I currently have eight full-time employees and one part-time employee in my department," said McCright. "I've managed to make cuts in line items that amount to \$12,000,

to have to make cuts in personnel to cover this.

"We're also planning cuts in subscriptions and book buying, and we're also going to have to look at decreasing the number of hours that we're open. This is going to mean cuts in the services we provide, without a doubt."

While McCright struggles with impending layoffs as a result of the budget cuts, County Road and Bridge Administrator Eddy Jameson said his department is making plans as well.

"We've been very fortunate in this," said we're only going to have to get rid of one part-time position that's currently filled. That position will also remain unfilled as a part of the cuts."

Jameson, whose department is currently made up of 22 full-time employees and one part-time employee, said Howard County residents can services from his department as well.

"We're basically eliminating our road crew because of these cuts," said Jameson. "The road crew is responsible for maintaining the county's caliche roads, so you're going to see a difference in the coming year. Fortunately, everyone that's on that crew will still be with us, so if we have to make some repairs, we'll still have the people, we'll just have to pull them from other parts of the department."

Barr said cuts have not been made to any other



U.S. Attorney should have tried agents

ne of the odder controversies swirling these days is the bitter criticism being flung at Johnny Sutton, the U.S. attorney for the Western District of Texas which is based in San Antonio. Sutton's shortcoming, it appears, is his strict enforcement of the law even when the lawbreakers are Border Patrol agents.

Sutton, appointed by President Bush, prosecuted the two agents for shooting at and wounding a fleeing but unarmed drug suspect and then lying about it in 2005.

However, it wasn't Sutton who convicted them; a West Texas jury did that after a 2 1/2-week trial laying out all evidence. The agents are Jose Alonso Compean, who is serving a 12-year prison sentence, and Ignacio Ramos, who is serving an 11-year sentence.

Among many Americans alarmed about the nation's porous border with Mexico, Compean and Ramos are seen as martyrs, unjustly prosecuted and imprisoned by an over-zealous prosecutor while trying to protect the country from drug runners.

Sutton, though, told the Senate Judiciary Committee in Washington this week that Compean and Ramos "are not heroes. They deliberately shot an unarmed man in the back without justification, destroyed evidence to cover it up and lied about it.'

The agents contended that they saw an object in the suspect's hand that looked like a gun. But they first made that claim a month after the shooting, Sutton said.

The suspect, Osvaldo Aldrete Davila, entered the

It's the cheating, stupid en. David Vitter, R-La., is a disgrace. This month, thanks to porn sleaze-meister Larry Flynt, Americans learned that the alleged prostitution ring run by Deborah Jeane Palfrey — the D.C. madam called Vitter five times between 1999 and 2001. About that time, Vitter was vocal in his criticism of then-President Bill Clinton — he said Clinton was "morally unfit to govern" — yet, at the same time, he was calling call girls.

I would ask, what was he thinking? But, of course, it is clear: Vitter was not overworking his brain.

About the only facts you can put in Vitter's plus column are that he didn't lie about doing busi-

ness with Palfrey's service and he didn't run into rehab.

Those plusses, however, pale next to the sheer arrogance and breathtaking stupidity that enabled Vitter to behave in a manner that discredited his alleged deeply held beliefs.

No doubt about it, Vitter is a big story in part because of the hypocrisy angle.

According to The Associated Press. Sen. Barbara Boxer. D-Calif., criticized Vitter for his hypocrisy. Palfrey told the Advocate, a Louisiana newspaper, that Vitter "is a hypocrite of the highest order."

Flynt's Hustler magazine has made it known that it wants to out "moral hypocrites." Yes, Vitter has made himself a juicy target by advocating abstinence programs for teens while dialing for dalliances. But what does it say about a people who object to adultery only if the cheating spouse has said it is bad? OK. No one wants to be judgmental.

The only person in this story who may not be a hypocrite is Flynt, who proudly crowed to Howard Kurtz of CNN's "Reliable Sources" on Sunday, "That's right, I'm a slimeball." Any value system that puts Flynt on the moral high ground is seriously flawed.

Besides, the thinking behind those who gloat about Vitter's hypocrisy is that of course men cheat on their wives, but the better man does not pretend to value monogamy. All hail the honest adulterer — even if he lies about sex.

United States illegally in a van with more than 700 pounds of marijuana. When the van was stopped, he got out and fled. Compean fired at him 14 times and Ramos once, and Davila was hit once as he ran away to Mexico.

On one point, Sutton seemed grudgingly to agree that it "probably wasn't a very wise move" to grant Aldrete a humanitarian visa to get him back to the United States to testify, under immunity, against the two agents. Critics don't like his grant of immunity from prosecution in the case, either.

Among the critics of the lengthy sentences are Sen. John Cornyn, R-Texas, and Sen. Kay Bailey Hutchison, R-Texas. Cornyn and a Democratic senator from California, Dianne Feinstein, have sent a letter to President Bush asking him to commute the sentences.

The senators are using the word "excessive" to describe the sentence the same word the president used to justify his recent decision to commute the sentence of former vice presidential aide Lewis "Scooter" Libby, who was convicted of lying to a grand jury and investigators.

Some reduction in the sentences of the agents but not a pardon might be justified. The man who was shot recuperated well enough to be arrested several months later in a separate drug smuggling case.

But Sutton was right to prosecute. Law enforcement officers have every right to defend themselves but no right to start shooting suspects who have posed no threat to them or others and flee and then lie about it.

As Sutton told the committee, "If we let our agents just open fire, shooting to kill some innocent person is going to get gunned down execution-style by a cop, and there's going to be an outcry."

Chris Matthews and 'misinformation'

SNBC's Chris Matthews appeared on "The Tonight Show" a week ago Wednesday night pontificating, mostly, about the Iraq war. Those who deny the overwhelming liberal bias of the mainstream media and who are pushing the Fairness Doctrine to muzzle conservative talk radio should be required to watch a tape of Matthews' performance.

To a fawning Jay Leno, Matthews engaged in a nearly uninterrupted soliloauv trashing all things Bush, from his governing according to perceived signals from God to his alleged lies about WMD.

Notably ironic, was Matthews' repeated spewing of misinfor-

mation in the process of characterizing the administration of disseminating misinformation. They talk about men and women occupying different planets. Perhaps, but at least their planets seem to be in closer proximity than the ones inhabited, respectively, by liberals and conservatives.

Leno jump-started Matthews by asking him about New York Times columnist David Brooks' supposed assertion that President Bush has pursued the war in Iraq because God wills it. "God told him that we should fight this war.'

We've heard this bogus charge before. Matthews dutifully responded, "Well, if he was going to play Joan of Arc, we wouldn't have elected him. Getting whispers from heaven is scary business. The guys we're fighting say that, too." Matthews said Bush needed "a little humility." Even Abraham Lincoln, Matthews said, didn't claim to have God on his side in the Civil War.

While I can't prove a negative, I am confident Bush never said that

God is on our side in this war though it wouldn't bother me if he had — or that God directed him to attack Iraq. He has said he continually prays for divine guidance and reads the Bible every day. That is wise, commendable and utterly no different from what Abraham Lincoln and many, probably most presidents in our history did.

This is not a distinction without a difference. Matthews is unequivocally implying that Bush has claimed to get his marching orders directly from God and that that is scary — as if he's in some kind of spiritual trance. It simply isn't true, and Matthews is distorting the truth in suggesting it is.

Contrary to Matthews' depiction, Bush is exhibiting the ultimate humility in prostrating himself before God to ask for His guidance and blessing. Perhaps Chris has his wires crossed. It's the secular humanist types who are more likely to have too much pride: to believe in God, much less ask for His guidance.

Matthews then began a rant, saying "almost half the American people believe that Iraq attacked us on 9/11. The misinformation, the indoctrination that's going on. And the rest of the American people have gotten so skeptical now do you think the American people believe that the brass didn't have something to do with Abu Ghraib? Do you think the American people don't think that we were given a bill of goods to get us in over there? ... I think we gotta be damn skeptical of this crowd, because on WMD, on the connection to 9/11, on the surge, on the torture, on every step of the way we've been given misinformation to the point now, we just did a poll, a fifth of the American people believe we found weapons of mass destruction when we got there. They're still indoctrinated. How do we get all this misinformation? From the top, unfortunately. It's a sad

thing."

There is no question in my mind that Matthews believes this nonsense he is spewing. I think he's a decent enough guy — but he just doesn't think straight. The administration never said Iraq attacked us on 9/11. It never said there was an operational relationship between Iraq and Al Qaeda, just that there was a relationship, which there was.

Only grassy-knoll nutcakes and anti-military types believe the "brass" authorized systematic abuse of enemy combatant detainees. I don't deny that many Americans now mistakenly believe, after being bludgeoned over the head with liberal propaganda for years, that Bush lied us into war — as I've said three billion times, but apparently not often enough.

On all of these points and more it is the Democrats and mainstream media who are responsible for the "misinformation."

If two-fifths of the American people believe Iraq attacked us on 9/11, it isn't Bush's fault because he never said that. And if one-fifth of the people believe we found new WMD stockpiles (we clearly did find old WMD), it isn't because Bush said so. Yet Matthews says this "misinformation" came from "the top," meaning Bush. But he knows that Bush has never said we've found WMD there. Never. He's said quite the opposite. This one isn't even arguable.

Unchallenged, even frequently applauded, Matthews "disseminated" his "misinformation" to the audience. It's no wonder people so many people are so woefully misinformed.

The 3.5-liter Duratec V-6 produces 263 horsepower and 249 lb.-ft. torque. Using regular unleaded fuel, it has an EPA fuel economy rating of 18/17 mpg city, 28/24 mpg highway (FWD/AWD). It is also rated as a Partial Zero Emissions Vehicle.

So in essence, there's a lot more that's new about this platform than just a name.

Including safety. "This is one of the safest full-size sedans on the road," said Steve Kozak, chief safety engineer for the Taurus, announcing the Taurus is the only large family car to earn both a "Top Safety Pick" rating from the Insurance Institute for Highway Safety and the U.S. government's highest available five-star ratings in all crash test categories. "Basically, in terms of automotive safety, we took this car to the Super Bowl and won," Kozak said during the recent

product launch held in Frisco, north of Dallas. Kozak said from the beginning, safety was "priority one" during the

design and planning stages for the new Taurus.

As part of Ford's 360degrees of Protection safety program, the Taurus is the first vehicle in the industry to offer a two-row Safety Canopy side airbag that provides additional protection not only in side impact collisions, but also deploys in rollover

accidents. Another available safety system is the AdvanceTrac electronic stability control to provide more stability and handling in all weather conditions.

Ford worked hand-inhand with Volvo in developing the Taurus safety story.

While I only spent a day with the new Taurus, I was extremely impressed. For those in the market for a full-size, five-passenger sedan, it is an absolutely must test drive.

My comment to the Ford engineers following the program was, "If

folks drive it, they will buy it." It really is that impressive.

Back to the news on Ford's quality.

On June 6, the J.D. Power IQS survey awarded Ford more award for quality than any other automaker.

Five vehicles — Ford Mustang, Mercury Milan, Lincoln MKZ, Lincoln Mark LT and Mazda MX-5 each swept their vehicle segments for top honors for quality.

The Ford F-150, Lincoln MKX and Lincoln Navigator received second place honors for fewest problems in its segment while Ford Motor Company earned six third place quality awards. Ford's Wixom

Assembly Plant (in

Detroit) also received a Platinum Award, recognizing it as the industry's best-quality performing plant worldwide. It also marks the first time since 1999 that a North American plant has received J.D. Power's

top award for producing vehicles yielding the fewest defects. "We are designing and

building world-class vehicles, and it's great to have this affirmation from the customers who drive our cars and trucks every day," said Mark Fields, president of the Americas Ford Motor Company. "While we're pleased that our internal focus on quality is receiving this kind of recognition from J.D. Power and Associates, we will not let up. We will continue to deliver even more high-quality products that customers want."

WASHINGTON (AP) — The House on Wednesday approved a move by conservative Republicans to try to set free two Border Patrol agents convicted of shooting a Mexican drug dealer.

After a long, emotional debate, the House voted by voice to block the Bureau of Prisons from keeping former agents Ignacio Ramos and Alonso Compean in federal prison. Ramos and Compean are serving 11- and 12-year federal prison sentences, respectively, for the 2005 shooting of Osvaldo Aldrete Davila on the Texas border near El Paso.

The case has caused a furor among conservative lawmakers and on talk radio across the country.

The agents shot him in the buttocks as he fled, but got rid of crucial evidence and failed to report the incident as required. They later found a load of marijuana in a van that Aldrete had used to try to elude them. But U.S. Attorney Johnny Sutton said there was no proof to tie the drugs to Aldrete so he could not prosecute him.

HOUSTON (AP) — About 100 people greeted possible Republican presidential candidate Fred Thompson at a Houston airport Wednesday, chanting "We want Fred" as the former senator and actor began a fundraising and campaign swing through Texas.

TXU CEO to quit after \$32 billion sale closes

DALLAS (AP) — Electric utility TXU Corp. has recommended that shareholders approve a \$32 billion buyout and also said its chief executive will resign if the sale to private investors goes through.

Chairman and CEO C. John Wilder said Wednesday that his turnaround of TXU "is essentially complete" and the company has other capable leaders.

Wilder, 49, stands to leave the company with at least \$277 million worth of stock plus millions in other perks, according to a TXU regulatory filing.

Shareholders are scheduled to vote Sept. 7 on the sale of TXU to investors led by Kohlberg Kravis Roberts & Co. and Texas Pacific Group. It would be the largest private buyout ever.

The company said in the filing that higher interest rates and tighter credit made it harder for other buyers to arrange financing. TXU said it solicited bids for several weeks but none surpassed the KKR-Texas Pacific offer.

Judge rules woman accused

of taking newborn competent for trial

LUBBOCK (AP) — A judge ruled Thursday that the 21-year-old woman accused of slipping into a hospital maternity ward wearing medical scrubs and abducting a days-old baby girl is competent to stand trial.

Rayshaun Parson April pleaded not guilty in April to a federal kidnapping charge in connection with the disappearance of Mychael Darthard-Dawodu from a Lubbock hospital.

U.S. District Judge Sam Cummings, who has issued a gag order in the case, sealed the report on Parson's mental evaluation. The trial was set for Aug. 20.

Surveillance footage from Covenant Lakeside Hospital showed a woman wearing blue and flowerprint hospital scrubs and a gray, puffy jacket with a hood walking out of the hospital in the middle of the night March 10. She was carrying a purse as she walked past an unstaffed information desk near the exit.

The baby was found the next day in Clovis, N.M., where Parson lived.

Parson has remained in federal custody since her arrest that day.

This deal occurred in a district semifinal of the 2007 Grand National Open Teams. It might seem that South must lose three trump tricks and the ace of clubs to go down one at four spades, but looks can be deceiving. A harmless-looking defensive slip by East was all the declarer, Rich De Martino, needed to bring his contract home.

De Martino won the opening heart lead with the jack and took an immediate diamond finesse. The ace and king of hearts were led next, and when East ruffed the king low, the contract could no longer be defeated! **Declarer overruffed the deuce** with the five, took a second diamond finesse and cashed the diamond ace, discarding a club. Then came the coup de grâce, dummy's queen of hearts.

What could East do? If he refused to ruff, South would discard his remaining club and lose only the A-K-Q of spades. And if East ruffed low, declarer could overruff, lead a spade and lose only two trump tricks and a club, or he could discard the king of clubs and lose three trump tricks.

In practice, East elected to ruff the queen of hearts with the ace of spades, but the horse was already out of the barn. De Martino simply discarded the king of clubs and conceded two more trump tricks to make his game.

After the opening heart lead, East had only one way to defeat the contract, and that was to ruff dummy's third heart with the ace (or queen) of spades at trick four rather than ruff low. A good case can be made for ruffing high — as evidence the actual deal — but not many players, in the heat of battle, would find the inspiration to make this play.

At the other table, North played in three notrump and could not score more than four hearts, two diamonds and two clubs for down one after an opening heart lead by East.
