## Big Spring soldier killed in action in Iraq

The war in Iraq has claimed the life of another Big Spring native.

Conrad Alvarez, a U.S. Army soldier stationed in the Baghdad area, was recently killed in action while on duty in that war-torn country.

Alvarez's mother, Melinda Garcia, was notified of her son's death Wednesday morning.

The Rev. Joel Miller, speaking for the family, said no details surrounding Alvarez's death have been made available to the family as of this morn-

ing

"They just informed her (Wednesday) morning and there will be U.S. Army personnel visiting with her later today who will able to provide more information, but we really don't know anything right now," Miller said. "Obviously, she is in shock right now."





## Hawks sweep doubleheader with Ranger

Howard College's softball team accomplished a feat Wednesday it hadn't succeeded in doing so far this season. The Hawks put together two solid games back to back, sweeping a doubleheader from Ranger College, 5-4 and 6-2.

"We finally put things together for two games in a row," Howard Head Coach Kelly Raines said. "It's been a bit of a worry up until now."

Ranger struck first in Game 1 with second baseman Theresa Garcia leading off the top of the second inning with a double and working her way around to home courtesy of two well placed fielder's choice balls. Haley Holden picked up the RBI.

As was the theme for the first game of the afternoon, though, Howard had a stronger response. The Hawks knocked in two runs in the bottom of the second, courtesy of a crushing home run by Ashley Calles. Kristy Leal also scored on the blast, making the score 2-1 in Howard's favor.

The Hawks lost that lead in the top of the fourth with Ranger picking up two more runs on fielder's choice plays. However, Calles had another long-ball shot left in her system. This time it was a solo shot that knotted the game up at 3 after four innings.

Ranger grabbed its third lead of the game in the top of the fifth thanks to a solo home run by third baseman Juanita Coleman. Unfortunately for the visiting team, Howard's response proved to be stronger again.



## NFL close to agreement for Walsh's testimony

**INDIANAPOLIS** NFL Commissioner Roger Goodell hopes the NFL is close to an agreement that will allow former New England Patriots employee Matt Walsh to tell the league about the tapes he is said to have made of the St. Louis Rams' walkthrough before the 2002 Super Bowl.

"The lawyers are still talking and we're anxious to speak to him. We're anxious to get an agreement to get him to come forth." Goodell told the Associated Press on Wednesday before the start of the NFL combine.

"We hope to be able to talk to him shortly.'

Walsh, now a golf pro in Maui, did video work for the Patriots

when they won the first of their three Super Bowls after the 2001 season. Three weeks ago, the Boston Herald reported that Walsh claimed he had taped the practice before the Patriots' 20-17 upset of the Rams, who were twotouchdown favorites.

NFL lawyers have been meeting with Michael Levy, Walsh's Washington-based lawyer, who is seeking further protection for his client if he tells what he knows. Levy said last week that the NFL's offer of protection "is highly conditional and still leaves Mr. Walsh vulnerable. I have asked the NFL to provide Mr. Walsh with the necessary legal protections so that he can come forward with the truth without fear of retaliation and litigation."

Goodell has said that Walsh was not interviewed as part of

the NFL's investigation into "Spygate," which involved the NFL confiscating tapes from a Patriots employee who recorded the New York Jets' defensive signals from the sideline during the opening game of the 2007 season.

As a result of that investigation, New England coach Bill Belichick was fined \$500,000 and the team was fined \$250,000 and forfeited its 2008 first-round draft choice.

Six confiscated tapes and other documents pertaining to the Patriots' taping were subsequently destroyed by the league. Goodell has defended the destruction of the tapes.

Last week, Willie Gary, who played seven games for the Rams that season, filed suit in New Orleans accusing the Patriots of fraud, unfair trade practices and engaging in a "pattern of racketeering." Three fans joined in the suit.

On Tuesday, Hugh Campbell, the Cincinnati lawyer who filed Gary's suit, said he wanted to add at least two new classes to the action: all employees and players of all NFL teams who were illegally videotaped by the Pats, plus all fans who bought tickets to any game that the Pats illegally taped. He also said he wanted to join with Sen. Arlen Specter, R.-Pa., who also is looking into the allegations.

Specter told The Associated Press on Wednesday that if Walsh is under subpoena in a suit, it might solve the problem of protection.

"I think now that the lawsuits have been started, that I got the ball rolling, and the plaintiffs' lawyers are picking it up," Specter said.







lunch to the Alon employees – there are 150 of them (employees) — through this Friday, as well as through Wednesday of next week," said ValVerde. "If there's a business that's interested, or if there are two businesses that want to join together, they can be a part of this. All they have to do is give us a call. We have information we can fax you on what needs to be done and how it needs to be done. We'll be glad to help anyone interested in being involved in this effort."

An explosion ripped through the Big Spring Refinery at approximately 8:15 a.m. Monday, sending a shock wave through the surrounding communities.

Five injuries were reported as a result of the explosion, according to Blake Lewis, spokesperson for Alon USA. They include one Alon employee, a trio of contractors and a motorist who was struck by debris while traveling on Interstate Highway 20.

ValVerde said conditions for the employees working to clean up and repair the facility are less than ideal.

"Suzie Teeters, who is with Howard College, is currently contacting the churches," said ValVerde. "We're hoping they can feed the employees on the weekends. These employees are going to be working 24 hours a day, seven days a week. If we can provide just one meal, it's worth it.

"This is just good will. Alon has been the pillar of our community, and that pillar has shifted, kind of fallen over. Now it's time for the community to get out there and rally and support the employees - the people who live here in Howard County and Big Spring — who spend their money here. We need to support them, even if it's just one meal."

# Volunteer chaplains helping all

t's looking for a few good men and women, but it's not the United States Marine Corps. No, it's the local Emergency Services Chaplains Corps program who are looking for persons interested in serving as volunteer chaplains.

The program's coordinators, led by Senior Chaplain Joel Miller, will begin chaplain classes the first of March. The two-week school is scheduled for Monday, Tuesday, Thursday and Friday the first two weeks of March. The classes are set for 6 p.m. to 10 p.m.

While the ESCC's chaplains' tasks are carried out primarily by volunteer pastors, lay people are also eligible to go through training and help serve both the victims of tragic circumstances and emergency services personnel.

Chaplains serve as counselors for members of several different agencies — the Big Spring Police Department, Howard County Sheriff's Department, Big Spring Fire Department, Howard County Volunteer Fire Department, Texas Department of Public Safety, Victim Services and Scenic Mountain Medical Center Emergency Room.

or close to a century, Scouting has planted the values of our founding fathers in the next generation of Boy Scouts, and the next generation of many U.S. leaders. Men like Astronaut James Lovell. Ross Perot, Michael Dukakis,

Gerald Ford, James Stewart, William Bennett and U.S. Secretary of Defense Robert Gates were all Eagle Scouts long before they were prominent, successful public figures.

And yet the organization that produced so many of our nation's leaders the Boy Scouts of

America (BSA) — has been under cultural and legal attack for close to thirty years by a small but dedicated minority of secularists because the BSA has refused to bend to the winds of political correctness

And sadly, groups like the American Civil Liberties Union (ACLU) have refined their tactics and begun to prevail in courts of law even as their actions are largely seen as appalling in the court of public opinion.

I wrote the book — On My Honor: Why American Values of the Boy Scouts are Worth Fighting For - for two main reasons: To espouse the virtues of a movement that has positively shaped the lives of millions of young men, and to expose the virus of secularism that endangers institutions that teach traditional values.

As the culture has increasingly told young people that "moral values are relative," "if it feels good do it," and "look out for number one", it has elevated self as a false idol of worship, and defined our existence as a self-centric pursuit at the expense of serving a higher calling of living for causes greater than self.

Scouting is a rare institution in today's society because it teaches young men that there are causes greater than self, that there is value in hard work and sacrifice, that it is more important to do what is right instead of what is easy, and that there are obligations and responsibilities we share in a free society, such as: being good stewards of the outdoors and one another's trust.

In fact, there are 12 positive attributes Scouting seeks to instill in young men, known as the Scout law: "A Scout is Trustworthy, Loyal, Helpful, Friendly, Courteous, Kind, Obedient, Cheerful, Thrifty, Brave, Clean and Reverent."

Ignoring the enormous positive influence scouting has on our youth, the secularists on the left have aimed to shut the Boy Scouts down on three basic fronts: that BSA requires scouts and scout leaders to believe in God; that it limits adult scout leadership on the basis of sexuality, and; that it limits the participation in troops to boys.

These secularists pursue radical agendas in the name of political correctness, standing up for atheists and militant homosexual groups who would attempt to shut Scouting down if they won't change their membership standards.

While the courts have sided with the BSA on all three issues, it has come at great cost in legal fees. Furthermore, the secularists have refined their attacks and have begun to find success.

Today many suits by the ACLU and their allies focus on public facilities used by Scout troops. Cities that used to offer free park space to Scout troops either charge them for its use or kick them off totally.

The Department of Defense has been sued for making its facilities available.

And in Philadelphia, the city bureaucracy said the Scouts would have to start paying fair market value for their headquarters because the property is city-owned

— this despite the fact that the Scouts built the facility 80 years ago and gave it to the city for free!

The attack on Scouting is part of a larger cultural phenomenon. Secularists seek to drive people of faith from the public square and to sanitize the Pledge of Allegiance, our currency, our government buildings and even the scouting oath from any mention of God. They also seek to open Scout troops to Scout leaders who are openly homosexual.

While I agree with the right of individuals to choose their own sexual orientation and share a "live and let live" view about homosexuality with millions of my fellow Americans, I also don't believe parents enroll their sons in Scouts to get a lesson on human sexuality. They shouldn't be subject to a debate about homosexuality in troop meetings anymore than they should the sexual exploits or proclivities of heterosexual scout leaders. Scouting isn't about sex, period.

In waging a culture war, the secularists take a good cause defending individual liberty and ruin it by defending license. There is a difference between liberty and license: One is the application of freedom with respect for the responsibilities and boundaries of freedom, the other is the indulgence of self with no regard for the greater good of society.


Scouting teaches young men the responsibilities of freedom. It teaches them the traits of leadership. It instills courage and character. And it guides its subjects along the path to proper citizenship. I hope and pray, in telling the story of the Boy Scouts, I might bring greater awareness to the virtues of the Scouting movement and the battle it must win in order to preserve its primacy in the lives of millions of young men.

"When a policeman has to see a small child who's had his head crushed by a car, he needs to be able to relieve himself of that," Miller said in providing a scenario where chaplains play a pivotal role for emergency responders.

But ESCC chaplains do a great deal more. "We're prepared to do whatever we can to help the families in times of crisis, whether they're emergency personnel or victims," Miller explained. "We make telephone calls for them, help them make funeral arrangements. We've also presided over funerals for the families who don't have pastors of their own. Most of all, we try to show them the love of God and that whatever has happened to them isn't the end of the world. That's one of our main goals.

"Also, law enforcement can't always stay there, but we can. We can stay there until other members of the family arrive. One of my chaplains stayed up until 12:30 a.m. at the hospital with a woman who had just lost her husband in a traffic accident. The next morning, he got up and went back to the hospital to stay with her until her family arrived from Nebraska."

Simply put, ESCC chaplains provide counseling and comfort to anyone needing it - clearly a selfless task — and we here at the *Herald* can think of little that could be needed more in any community.

season. Bigger-government Republicans don't seem fully to appreciate the extent to which the differ-

ences between conservative Republicans and liberals are about more than policy.

Conservatives and liberals differ not merely over the level of taxation, protection of the unborn, immigration, the war and other issues though the impor-

tance of these disputes cannot easily be overstated.

Admittedly, conservatives view these policy differences as matters of great urgency.

The power to tax is the power to destroy. Abortion kills human beings. Illegal, unregulated immigration jeopardizes our national security, undermines the rule of law, could bankrupt our government and, because of the negligence concerning proper assimilation, would likely radically change the culture.

Successful prosecution of the war on terror, in Iraq and elsewhere, is essential to our national security.

But at an even more fundamental level, conservatives, being sentimental saps, believe — apparently unlike Michelle Obama — that the United States is not only the greatest nation in the world but also that it owes its greatness largely to its Constitution.

Even if liberals were to concede this point, they would probably have different reasons for believing it is so.

They tout their fondness for the Bill of Rights and little else in the document, but even here, close inspection reveals their affinity is selective.

They're definitely all about the Fourth Amendment protection against unreasonable searches and seizures — to such an extreme that they would extend it to noncitizen enemy combatants.

They also surely fashion themselves as Fifth, Sixth, Seventh and Eighth Amendment enthusiasts,

visions.

But their support gets murkier when it comes to the First, Second, Ninth and 10th Amendments.

They revere the Establishment Clause but are less enamored of the Free Exercise Clause.

They consider themselves freespeech watchdogs but love campus speech codes, the Fairness Doctrine, campaign-finance reform laws and classroom indoctrination.

And I've never heard a liberal wax proudly about federalism or the erosion of states' rights that has accompanied its dilution.

Conservatives, by contrast, not only champion the Bill of Rights – the complete package — but also believe Americans owe our unique liberties to the scheme of governmental power established in the body of the Constitution.

We believe, as did the framers, that the structural limitations on government, like the separation of powers and federalism, are what make possible individual liberties. The pitting against each other of competing levels and branches of government run by imperfect men was designed to deter government from its natural tendency toward absolutism.

That's why conservatives get so exercised about appellate judges who refuse to honor the Constitution as written and insist on rewriting its provisions from the bench.

When they do so, "legislating" certain abhorrent policies from the bench isn't their only sin. They are also tampering with the delicate balance of governmental power that guarantees our freedom.

For example, conservatives couldn't be more passionate about the appointment of judges who would reverse Roe vs. Wade because that would hopefully reduce abortions.

But they are also passionate about judges honoring the Constitution's original intent not because they are mired-in-themud fuddy-duddies but because only by honoring that intent will

between economic and political liberty. Whether or not they've studied Friedrich Havek's "The Road to Serfdom," they understand that expansive government and socialism — no matter how well meaning, in some cases are ultimately incompatible with individual liberties.

Big government Republicans, however, evidently don't have the same distrust of governmental power, believing it is an unstoppable force that can't be beaten and so must be joined and harnessed to "conservative" ends.

No matter how smart these intellectuals are, they just don't get it.

If they did, they wouldn't be happily surrendering to anti-constitutionalist liberals and willingly playing the game on their turf.

Conservatives realize that politics (and the preservation of our liberties) ain't beanbag.

They don't invest their future in the platitudes of "hope," "bipartisanship," or "kumbaya."

In the end, these are just recklessly naive expressions of confidence in the power of government to deliver us from all hardship.

Instead, conservatives believe that government is a necessary evil to establish order and promote the common defense and the like but otherwise must be restrained in order to unleash the power and freedom of the individual.

Conservatives should not be underestimated as mere players in a cynical chessboard game of party politics.

They believe in the power of ideas and will continue to promote their ideas irrespective of the eventual identity of the respective presidential nominees and regardless of how much they are pressured to be silent about first principles.

## Hand-painted mustangs part of rodeo feel in Houston

Houston Chronicle HOUSTON (AP) — The cows came first.

Then the boots had their turn.

This year, mustangs will reign.

By the end of this month, a herd of 28 handpainted horses will go on display across Houston, all part of the pre-rodeo hype organized by the Houston Livestock Show and Rodeo.

The public art part public relations, part charity event is an outgrowth of the 1999 Cow Parade in Chicago, which quickly became a national phenomenon. Two years later, Houston sponsored its first cow parade with local corporations and charities paying artists to fiberglass decorate

bovines. Other cities have organized displays of painted guitars, corn and salmon.

Last year, Houston's rodeo followed suit with larger-than-life cowbov boots scattered around town.

This year, organizers decided on the equally Wild West-themed mustangs.

"The hope is to have them out in the community and just build a little good will, let them know that we embrace our Western heritage in the said Charlene city," Flovd, head of the committee behind the mustang exhibit. A few of the horses will make a showing downtown for a prerodeo event Feb. 26, but the rest will be on display during the rodeo at

Reliant Stadium next month.

"This one was on Jay Houston artist Leno," Kermit Eisenhut said, pointing out a picture of one of his boots that Leno, as part of a joke, showed a picture of on his latenight talk show last year. Eisenhut was working on the exhibit's last mustang, a mare called Towering Bronco, that's sponsored by Hines, an international real estate firm based in Houston. Once completed, the horse will be covered in images of downtown skyscrapers and buildings the corporation helped develop.

ed 14 cows. Usually the

#### U.S. Navy missile scores pinpoint hit on disabled spy satellite

HONOLULU (AP) – A U.S. Navy cruiser blasted a disabled spy satellite with a pinpoint missile strike that achieved the main mission of exploding a tank of toxic fuel 130 miles above the Pacific Ocean, defense officials said.

Destroying the satellite's onboard tank of about 1,000 pounds of hydrazine fuel was the primary goal, and a senior defense official close to the mission said Thursday that it appears the tank was destroyed, and the strike with a specially designed missile was a complete success.

Defense Secretary Robert Gates ordered the shootdown, which came late Wednesday as he began an eight-day, around-the-world trip on which he likely will face questions about the mission.

The elaborate intercept may trigger worries from some international leaders, who could see it as a thinly disguised attempt to test an anti-satellite weapon — one that could take out other nation's orbiting communications and spy spacecraft.

Within hours of the reported success, China said it was on the alert for possible harmful fallout from the shootdown and urged Washington to promptly release data on the action.

#### NATO troops say they killed Taliban commanders

KABUL, Afghanistan (AP) — Afghan and NATO-led troops killed two regional Taliban commanders in southern Afghanistan, and an explosion in the same province claimed the life of a British soldier, officials said Thursday.

"As a result of this successful attack (on the commanders), the Taliban's networks have suffered another severe setback," said Brig. Gen. Carlos Branco, a spokesman for NATO's International Security Assistance Force.

The joint NATO-Afghan forces killed commander Mullah Abdul Matin and his associate, Mullah Karim Agha, in the southern province of Helmand on Monday, the alliance said in a statement.

#### new Pakistani government

WASHINGTON (AP) - President Bush called Pakistani President Pervez Musharraf following his party's loss in parliamentary elections, but the White House says it's up to the Pakistani people to decide the embattled leader's political future.

States is committed to helping restore lives of "hope and peace" to Liberia, a poor African nation that ties its founding and its renewed freedom to America.

Bush landed in Monrovia, the capital city named for President James Monroe. This nation — founded by freed American slaves and ruined by a 14-year civil war that ended in 2003 — is proudly trying to revive itself under a democratic government.

"The U.S. message is we want to help you recover from a terrible period,' Bush said.

Liberia is in depressingly poor shape. Many rotted houses look like they're held together by sheer will. Billboards warn against mob violence, rape, corruption and AIDS.

The U.S. government is pumping in money for education, security, construction and disease prevention. Direct U.S. aid has totaled more than \$750 million since the war ended. The president is to announce that the U.S. aid will provide 1 million textbooks to children by the start of the next school year and desks and seating for 10,000 students, White House press secretary Dana Perino said.

#### Investigators in shooting seeking answers in Baghdad

WASHINGTON (AP) — Federal authorities investigating Blackwater Worldwide contractors are returning to Baghdad this week to revisit the scene of a deadly September shooting that left 17 Iraqi civilians dead.

The two-week trip, by eight prosecutors and FBI agents, marks the latest phase in an inquiry that was limited from the start by the government's promise of immunity for Blackwater bodyguards who provided sworn statements about the shootings.

The gunplay in a crowded Baghdad intersection has strained diplomatic relations and raised questions over whether some contractors can operate without legal consequences.

The Justice Department team left Tuesday night for Iraq, where they planned to interview witnesses and gather evidence from the Sept. 16 shooting. The trip was confirmed by several people close to the case who spoke on condition of anonymity because of the sensitive nature of the investigation.

#### Clinton needs landslide-size wins to erase Obama's delegate edge

WASHINGTON (AP) - Democratic Sen. Hillary Rodham Clinton must win 57 percent of the remaining primary and caucus delegates to erase Barack Obama's lead, a daunting task requiring landslide-sized victories by a struggling presidential candidate. Obama's victories in Wisconsin and Hawaii on Tuesday — his ninth and 10th in a row - left him with 1,178 pledged delegates won in primaries and caucuses in The Associated Press' count. Clinton has 1,024. Another 1,025 remain to be awarded, most of them in contests in 14 states, Guam and Puerto Rico. It takes 2,025 to win the nomination. Further complicating Clinton's challenge, Obama appears particularly wellpositioned to win at least one of the remaining states with ease. Mississippi, with a primary on March 11, fits a pat-

tern of Southern states with large black populations that he has won handily, including South Carolina, Alabama, Georgia and Louisiana.

The rival campaigns maintain their own delegate counts. And while both agree Obama is the leader, they differ on the significance.

#### Study: Strokes among middle-aged women triple;

NEW ORLEANS (AP) - Strokes have tripled in recent years among middleaged women in the U.S., an alarming trend doctors blame on the obesity epidemic. Nearly 2 percent of women ages 35 to 54 reported suffering a stroke in the most recent federal health survey, from 1999 to 2004. Only about half a percent did in the previous survey, from 1988 to 1994.

The percentage is small because most strokes occur in older people. But the sudden spike in middle age and the reasons behind it are ominous, doctors said in research presented Wednesday at a medical conference.

It happened even though more women in the recent survey were on medicines to control their cholesterol and blood pressure — steps that lower the risk of stroke.

Women's waistlines are nearly two inches bigger than they were a decade earlier, and that bulge corresponds with the increase in strokes, researchers said.

In addition, women's average body mass index, a commonly used measure of obesity, rose from 27 in the earlier survey to 29. They also had higher blood sugar levels.

#### Pauly Shore countersues neighbor over property damage

LOS ANGELES (AP) — Pauly Shore is suing neighbor Wes Craven for creating a nightmare on his property in a dispute between the two that began last year.

Shore claimed that a landslide on his Hollywood Hills property in December 2006 was caused by Craven's failure to properly maintain vegetation and landscaping on a hillside on his property, according to a lawsuit filed Monday in Superior Court.

The comedian also alleged that Craven, the director of "A Nightmare on Elm Street" and the "Scream" series, did not eradicate rodents burrowing in the hill and made improvements on his property that "changed the geology, topography and drainage," according to the lawsuit.

A call to Craven's attorney Wednesday was not returned.

#### Oil prices hover above \$100 a barrel after hitting record overnight

SINGAPORE (AP) — Oil prices held near \$100 a barrel Thursday after hitting a record overnight as investors poured more cash into crude and other commodities as a hedge against inflation.

Oil futures on Wednesday pushed briefly past \$101 a barrel after the U.S. Federal Reserve lowered its forecast for U.S. economic growth this year, convincing energy investors that the central bank will slash interest rates further.

"Investors are going into commodities for a safe haven, because they think commodities may perform better than equities and also may be hedges against inflation," said Victor Shum, an energy analyst with Purvin & Gertz in Singapore.

Lower interest rates can help the economy but tend to weaken the dollar, encouraging investors to shift funds into hard assets like gold or oil as a safeguard against inflation. After oil rallied above \$100 a barrel, precious metals such as gold and silver also hit records.

The possible rate cut is also viewed as hopeful of bolstering a flagging U.S. economy, which would assuage fears of weakening crude demand.

## **Obama wins Democrats Abroad global primary**

WASHINGTON (AP) -Barack Obama won the Americans an opportuni-Democrats Abroad global primary in results announced Thursday, giving him 11 straight victories in the race for the Democratic presidential nomination.

The Illinois senator won the primary in which Democrats living in other countries voted by Internet, mail and in person, according to results by released the Democrats Abroad, an organization sanctioned by the national party.

Sen. Hillary Rodham Clinton has not won a nominating contest since Super Tuesday, more than two weeks ago.

More than 20,000 U.S. citizens living abroad voted in the primary, which ran from Feb. 5 to Feb. 12.

Obama won about 65 percent of the vote, according to the results released Thursday.

Voters living in 164 countries cast votes online, while expatriates voted in person in more than 30 countries, at hotels in Australia and Costa Rica, at a pub in tion Ireland and at a Starbucks in Thailand. The results took about a week to tabulate as local committees around the the remaining 2.5 votes. globe gathered ballots.

"This really gives ty to participate," said Christine Schon Marques, the international chair of Democrats Abroad.

There is no comparable primary among Republicans, though the GOP has several contests this weekend in U.S. territories, including party caucuses in Puerto Rico Sunday.

The Democrats Abroad controls seven pledged delegates at the party's national convention this summer.

However, the group's system of dividing the delegates is unique, and could create an anomaly in which Obama and Clinton end up with fractions of delegates.

The party will send 14 pledged delegates to the convention, each with a half vote.

The primary was used to determine nine people, or the equivalent of 4.5 delegates. Obama won 2.5 and Clinton won two, according to Schon Marques.

The Democrats Abroad will hold a global conven-Vancouver, in Canada, in April to select the other five people who will attend the convention. They will represent



## McCain says report suggesting inappropriate relationship 'not true'



TOLEDO, Ohio – John McCain emphatically denied a romantic relationship with a female telecommunications lobbyist Thursday and said a report by The New York Times suggesting favoritism for her clients is "not true."

"I'm very disappointed in the article. It's not true," the likely Republican presidential nominee said as his wife, Cindy, stood beside him during a news conference called to address the matter.

"I've served this nation honorably for more than half a century," said McCain, a four-term Navy pilot. "At no time have I betray the public trust."

"I intend to move on," he added.

McCain described the woman in question, lobbyist Vicki Iseman, as a friend.

The newspaper quoted anonymous aides as saying they had urged McCain and Iseman to stay away from each other prior to his failed presidential campaign in 2000. In its own follow-up story, TheWashington Post quoted longtime aide John Weaver, who split with McCain last year, as saying he met with lobbyist Iseman and urged her to steer clear of McCain.

Weaver told the Times he arranged the meeting before the 2000 campaign after "a discussion among the campaign leadership" about Iseman.

McCain said he was unaware of any such conversation, and denied that his aides ever tried to talk to him about his interactions with Iseman.

"I never discussed it with John Weaver. As far as I know, there was no necessity for it," McCain said. "I don't know anything about it," he added. "John Weaver is a friend of mine. He remains a friend of mine. But I certainly didn't know anything of that nature." His wife also said she was dis-

appointed with the newspaper. "More importantly, my children and I not only trust my husband, but know that he

would never do anything to not only disappoint our family, but disappoint the people of America. He's a man of great character," Cindy McCain said. The couple smiled throughout the questioning at a Toledo hotel.

The published reports said McCain and Iseman each denied having a romantic relationship. Neither story asserted that there was a romantic relationship and offered no evidence that there was, reporting only that aides worried about the appearance of McCain having close ties to a lobbyist with business before the Senate Commerce Committee on which McCain served.

The stories also allege that McCain wrote letters and pushed legislation involving television station ownership that would have benefited Iseman's clients.
