# Robbery suspect jailed

A Big Spring man is in custody after being charged in the robbery of a convenience store Monday.

David Hernandez Montez, 40, was charged with aggravated robbery in connection with a holdup at Star Stop No. 14, 4806 W. Highway 80, according to information released by Sgt. Tony Everett, Big Spring Police Department public information officer.

In addition, Montez is a suspect in



the 7-Eleven shortly after 5 a.m. Monday in reference to a robbery

Reports state that a Hispanic male subject had fled the scene after demanding money and knocking the clerk to the ground.

The clerk was not seriously in-

jured and the subject fled the store empty handed, Everett noted.

Shortly before 6 a.m. that morning, officers were dispatched to the Star Stop convenience store in reference to an armed robbery.

There, they learned that a Hispanic male had entered the store, went behind the counter and into the office. There, he produced a handgun and demanded money from the clerk.

The suspect then took an undis-

Work crews began a \$6 million renovation of city streets Tuesday, a project that is expected to last about 13 months. The street renovation, which was

approved by city voters in 2007, will affect Main, Scurry and Lancaster streets, as well as much of

the downtown area, city officials The first work began Tuesday as

### HC women blast OC, 78-53, qualify for national tourney

The Hawks defeated Odessa College's Lady Wranglers Tuesday, 78-53, claiming the Region V championship advancing to the NJCAA National Tournament in Salina, Kan.


"It's really inspirational," said Howard Head Coach Earl Diddle. "These girls have a lot of emotion. They're always hopping around. They're great. They deserve this. I thought we were always a pretty good team. We went through a part of the season where we were sick and injured, but they really came back. They played with no fear today. They believed they could win this. I'm very proud for this school. I'm very proud of our kids.'

It was a back-and-forth battle in the first half with Odessa taking a 25-24 advantage into the break, courtesy of two Diandra Marquez free throws with no time left on the clock.

Howard finally started to separate with 14:58 left to play in the game. DeAndra Thomas hit back-to-back buckets, drawing a foul on the second one and converting the 3-point play. Thomas' five consecutive points gave the Hawks a 36-32 advantage.

Patricia Malouff followed with a 3-pointer, forcing Odessa to take a time out down 39-32 with 13:23 on the clock.



### Lawyer: Madoff will plead guilty to all charges without deal. faces up to 150 years in prison

NEW YORK (AP) — Bernard Madoff could be facing his final hours of freedom after acknowledging that he will plead guilty to charges that he engineered one of the largest investment scams in U.S. history and was ready to face a prison sentence of up to 150 years.

The revelation came Tuesday in U.S. District Court in Manhattan, where Madoff waited for more than three hours in a conference room to avoid a clash with angry investors before appearing in court for the first time in nearly two months for what was to be a routine hearing.

An attorney for the 70-year-old former Nasdaq chairman told the judge Madoff intends to plead guilty this week to all 11 felony counts, including securities fraud and perjury.

The judge will decide Thursday whether to accept the plea and, if so, whether Madoff should remain free pending sentencing in several months.

Madoff, who was wearing a bulletproof vest, is accused of running a gigantic Ponzi scheme, defrauding billions of dollars from retirees, charities, school trusts and even Holocaust survivors.

### Investigators find federal agency misses, minimizes health hazards

(AP)—The federal agency charged with protecting the public near toxic pollution sites often obscures or overlooks potential health hazards, uses inadequate analysis and fails to zero in on toxic culprits, congressional investigators and scientists say.

A House investigative report says officials from the Agency for Toxic Substances and Disease Registry "deny, delay, minimize, trivialize or ignore legitimate health concerns."

Local communities have voiced frustration and confusion at findings by the agency that are challenged by outside scientists or are ambiguous about whether people living near industrial pollution or toxic dumps or breathe foul-smelling air have reason to worry.

"Time and time again ATSDR appears to avoid clearly and directly confronting the most obvious toxic culprits that harm the health of local communities throughout the nation," said the report from the House Science and Technology investigations and oversight subcommittee.

### NKorea accuses Obama's government of meddling

SEOUL, South Korea (AP) — North Korea accused President Barack Obama's government of meddling in its internal affairs Wednesday and vowed to take "every necessary measure" to defend itself against what it calls U.S. threats.

The statement by North Korea's Foreign Ministry, however, was far less harsh than rhetoric issued by the country's military during the run-up to joint U.S.-South Korean war games that started across the South on Monday. The North's military has threatened South Korean passenger planes and

put its troops on standby.

Still, the Foreign Ministry's statement was significant in that it was the agency's first on the U.S. since Obama's inauguration, an analyst said.

"The Foreign Ministry is Washington's direct negotiating partner and has not engaged in criticizing the U.S. so far," said Kim Yong-hyun, a professor at Seoul's Dongguk University. "This means they have started expressing pent-up complaints."

However, the ministry's less strident tone than other agencies reflects Pyongyang's willingness for negotiation, Kim said.

### Fresh off Obama meeting, U.N. Secretary-General Ban Ki-moon heads to Capitol Hill

WASHINGTON (AP) — Buoyed by President Barack Obama's pledge to work on bringing peace to Darfur, the U.N. chief is making the rounds of Capitol Hill to strengthen cooperation on climate change and other pressing global crises.

Secretary-General Ban Ki-moon was to meet with Rep. Howard Berman, D-Calif., the House Foreign Relations chairman, Wednesday morning and with Sen. John Kerry, D-Mass., chairman of the Senate Foreign Relations Committee, in the afternoon.

Climate change was expected to dominate Ban's meetings. There also has been interest on the Hill about Sudan and the way the United Nations conducts its investigation into Israel's bombing of a U.N. compound in Gaza City.

Explaining his decision, Obama said that future earmarks must have a "legitimate and worthy public pose", and the any earmark for a private company should be subject to competitive bidding rules. Plus he said he'll "work with Congress" to eliminate any the administration objects to.

But he acknowledged that earmarks have bred "cynicism", and he declared, "This piece of legislation must mark an end to the old way of doing business."

White House officials in recent weeks have criticism dismissed of the earmarks in the bill, saving the legislation was a remnant of last vear and that the president planned to turn his attention to fu-

ture spending instead of looking backward.

White House spokesman Robert Gibbs said Obama wouldn't be the first president to sign legislation that he viewed as less than ideal. Asked whether Obama had second thoughts about signing the bill, Gibbs' reply was curt: "No."

"This is necessary to continue funding government," Gibbs said. "It represents last year's business. Although it's not perfect, the president will sign the legislation, but demonstrate for all involved rules moving forward that he thinks can make this process work a little bit better."

During his presidential campaign, Obama promised to force Congress to curb its porkbarrel-spending ways. Yet the bill sent from the Democratic-controlled

House on Tuesday contained 7,991 earmarks totaling \$5.5 billion, according to calculations by the Republican staff of the House Appropriations Committee. The 1,132-page bill has

an extraordinary reach, wrapping together nine spending bills to fund the annual operating budgets of every Cabinet department except Defense, Homeland Security and Veterans Affairs. Among the many earmarks are \$485,000 for a boarding school for at-risk native students in western Alaska and \$1.2 million for Helen Keller International so the nonprofit can provide eyeglasses to students with poor vision.

Most of the government has been running on a stopgap funding bill set to expire at midnight Wednesday. Refusing to sign the newly

completed spending bill would force Congress to pass another bill to keep the lights on come Thursday or else shut down the massive federal government. That is an unlikely possibility for a president who has spent just seven weeks in office.

The \$410 billion bill includes significant increases in food aid for the poor, energy research and other programs. It was supposed to have been completed last fall, but Democrats opted against electionyear battles with Republicans and former President George W. Bush.

The measure was a top priority for Democratic leaders, who praised it for numerous increases denied by Bush. It once enjoyed support from Republicans.

But the bill ran into an unexpected political hailstorm in Congress

after Obama's spendingheavy economic stimulus bill and his 2010 budget plan, which forecast a \$1.8 trillion deficit for the current budget vear.

The bill's big increases — among them a 14 percent boost for a popular program that feeds infants and poor women and a 10 percent increase for housing vouchers for the poor represent a clear win for Democrats who spent most of the past decade battling with Bush over money for domestic programs.

Generous above-inflation increases are spread throughout, including a \$2.4 billion, 13 percent increase for the Agriculture Department and a 10 percent



formed on Main and Scurry streets. Main will be resurfaced from First to 18th, while Scurry will be renovated from First to 24<sup>th</sup>. Portions of Lancaster and other streets also will receive facelifts, officials said.

Resurfacing work will constitute much of the overall work, but other related projects include landscaping of several downtown areas and installing ramps to several sidewalk areas.

The overall project is expected to last about 13 months, with road resurfacing expected to be completed by late September or early October, Wofford said.

"They're going to complete the downtown area first, then work their way south." he said.

Wofford said he hopes residents and businesses accept a certain degree of inconvenience while the projects are ongoing.

"We know there's going to be inconvenience — there's really nothing we can do to prevent it," he said. "But about all we can do is get our work crews in there, get the work done as fast as we can, then get them out."

Wofford also asked residents to avoid work areas if possible.

"During the construction period, if you can avoid those areas, it would be beneficial," he said. "There will be a lot of large equipment out there ... and it could be kind of dangerous."

Work crews are expected to be at work between 7:30 a.m. and 6 p.m. Monday through Friday, Wofford said.

# SkyWarn class a chance to get ready for storms

n ounce of prevention is worth a pound of cure. As we've noted before, few adages could be more correct, ■nor could they apply to more situations in our lives. And that means we should keep it in mind these days with spring — and the prospect of stormy weather — right around the corner.

Spring is when our area traditionally experiences a great deal of the severe weather things like hail storms and tornadoes. While there's no way to prevent such storms, there is a way to learn more about them and to be prepared.

That's why the National Weather Service will conduct SkyWarn classes throughout West Texas in the coming weeks.

The class in Big Spring will be held Thursday, March 19, in an effort to have area residents ready to face potentially violent weather.

Slated for 7 p.m. until 9 p.m. in the Big Spring City Council Chambers, located at 307 E. Fourth Street, the class will be an excellent way to check preparedness at the beginning of the severe weather season.

Other classes will also be held in the area. In Garden City, the class will be Feb. 24 in the community center. And on April 6, a class will be held in Stanton at the Martin County Courthouse.

According to NWS Warning Coordination Meteorologist Pat Vesper, the class will include information on tracking and classifying storms and various weather conditions, but it's not limited to emergency management officials and storm chasers.

"It has a lot to offer everyone," said Vesper. "We offer a lot of information on safety during storms and bad weather the average person can use to protect themselves and their families."

SkyWarn classes' main focus is safety and cover the most common sever weather situations for the Harea in hopes of preparing area residents for worst case scenarios.

"It's really a lot of good information for people to have," said Big Spring Police Department Lt. Terry Chamness. "It gives people a basic knowledge of what severe weather is like in our area. Since we're getting ready to head into the severe weather season, which begins in March and lasts until October, this is really important information to have."

We couldn't agree more, and that's why we encourage local residents to make the most of these opportunities.

What's more, there's no charge for the class-

# Truth becomes an obstacle

n Congress and in the media, Sen. Robert Menendez, D-N.J., was being treated as an obstacle last week. He was telling the truth about Cuba, the land of his ancestors, but sometimes, for some people, the truth becomes an obstacle.

One news story said Menendez sent "Congress into overtime." Another story noted that his "stinging defection" threatened the Democratic leadership's ability to pass the \$410 billion omnibus spending bill, which is meant

to fund the federal government through September.

And yet what Menendez was doing was standing on principle against three sneaked-in foreign policy provisions that have nothing to do with funding U.S. government operations. He also was standing against a very undemocratic way of changing U.S. policy toward Cuba; there was not even an open debate on the subject. "This body is being asked to

swallow these changes in the crudest process I can imagine without analysis, without inclusion and without debate." Menendez charged on the Senate floor last week. "Supporters of these modifications claim to be carrying them out in the hopes of fostering democratic change in Cuba, even as they do so in a way that silences democratic

debate in our country."

But Menendez was not to be silenced. In his impassioned hourlong speech, the New York-born son of Cuban refugees spoke of a brutal dictatorship that has 'gilded the spirit of their people over a rotten core of brutality, deprivation and fear." He spoke of Cuba's countless murders, human rights violations, young men and women forced to do hard labor against their will, and dissidents who have been beaten or sentenced to decades in prison "for the crime of thinking independent thoughts, for the crime of asking for change."

He spoke of the average Cuban worker, who "lives on an income of less than a dollar a day," thanks to a 50-year-old failed revolution, which has made the Cuban people regress.

"The island was not rich in 1959," Menendez said. "Yet Cubans have fewer opportunities to get ahead than they did 50 years ago." The speech was so loaded with vivid examples of the realities of life in Cuba that it already has become a hit on YouTube ("Menendez speech on the Realities in Cuba").

Although the bill's Cuba provisions do not lift the 47-year-old U.S. trade embargo against the Communist island outright, they clearly begin a process of relaxing trade and travel restrictions against the Fidel/Raul Castro regime, without proper discussion in Congress and without first getting a single human rights concession from the world's oldest dictatorship.

Amazingly, the provisions don't even call on the Cuban government to free political prisoners, hold democratic elections, stop persecuting dissidents, show some respect for human rights, or allow the Cuban people to congregate and express themselves freely.

Yet instead of condemning the House opportunists who tucked these provisions into a bill where they don't belong, instead of blasting them for their sneaky way of doing the people's business, some leftist, liberal organizations and very naive bloggers were condemning Menendez for "blocking the work that has to be done in Congress."

They saw him as an obstacle, as if telling the truth about Cuba was getting in the way of their own omnibus funding or their leftist agenda.

While Barack Obama was campaigning for president last year, he vowed to relax some of the restrictions on Cuba, yet he also pledged to use the embargo

as leverage to seek democratic

reforms on the island. Menendez, swimming against the tide in his own party, was, in effect, assisting the GOP leaders wanting to torpedo the entire bill

because it also includes \$7.7 bil-

lion in wasteful earmark spending. Yet Menendez courageously called on President Obama to resist signing the bill with the Cuba provisions intact.

"If the omnibus bill is signed by the president as is, he will be extending a hand, while the Castro regime maintains its ironhanded clenched fist," Menendez said, insisting that the Cuba provisions were placing the whole appropriations package in jeopardy. By not supporting the bill in the Senate, Menendez risked causing the Democrats to fall short of the 60 votes needed to advance the measure beyond a Republican filibuster.

The Cuba provisions ease travel restrictions to the island by Cuban-Americans and by U.S. merchants seeking to sell food and medical supplies to Havana. A sticking point for Menendez was that the provisions also lift the current requirement that Cuba pay for food before it leaves the United States

"That suggested policy change would give the Cuban regime financial credit to purchase agricultural products from the U.S.," Menendez said.

"Considering the serious economic crisis we're facing right now, we need to focus on solutions for hardworking Americans, not subsidies for a brutal dictatorship," Menendez said.

Of course, for those who wanted to flush this bill through the Senate in a hurry, all this talk about Cuba became an obstacle. And instead of blaming those who sneaked Cuba into the bill, they blamed Menendez and described him as a Democratic defector.

On Tuesday, after receiving assurances from the Treasury Department that the bill's language would not impact U.S. policy toward Cuba, Menendez finally dropped his opposition to the bill.

Nevertheless, for telling the truth about Cuba before we blindly jumped into bed with the tyrannical Castro brothers and for standing up to his fellow Democrats to defend the quest for freedom in the land of his ancestors, Menendez deserves respect and admiration.

# An Orwellian bully pulpit

oes the following statement irom Meiody C. Barnes, director of President Barack Obama's Domestic Policy Council, strike you as a) patronizing or b) Orwellian? "The presi-

dent believes that it's particularly important to sign this (presidential memorandum authorizing federal funding for human embryonic stem cell research) so that we can put science and technology back at the heart of pursuing a broad range of national goals."

Your answer should be both a and b, especially when considered in conjunction with another presidential memorandum "aimed at insulating scientific decisions across the federal government from political influence."

The president brazenly sermonizes against scientifically challenged conservatives while triggering federal funding of research that is scientifically controversial and preparing to impose cap and trade penalties on corporate America in deference to global warming junk While you won't hear much

about this in the mainstream media, there is a meeting currently taking place in New York City that serves as an ironic backdrop for Obama's embryonic stem cell order.

OneNewsNow.com reports that more than 70 scientists – representing the views of tens of thousands more scientists are meeting at The Heartland Institute's second annual International Conference on Climate Change to make the case that politically motivated alarmism, not science, is driving climate change activism, which potentially threatens the sovereignty Amen of the United States.

At the conference, European Union and Czech Republic President Vaclav Klaus likened those pushing global warming hysteria to the communists of Old Europe, who refused to listen to opposing views. Their goal, Klaus warned, is to control the public.

Sounds familiar. The Obama administration repeatedly implements policies that are in direct contradiction to its benign rhetoric, which is what I mean by "Orwellian." Consider its fiscal recklessness accompanied by promises of fiscal responsibility, including its staggering denial that it is promoting earmarks. Or its boasts of bipartisanship while shutting Republicans out of the legislative process. Or calling its plan to chill an employee's choice to opt out of union membership the "Employee Free Choice Act.'

But Obama's statements while introducing his embryonic stem cell executive order truly take the cake. He said: "But after much discussion, debate and reflection, the proper course has become clear. The majority of Americans, from across the political spectrum and from all backgrounds and beliefs, have come to a consensus that we should pursue this research — that the potential it offers is great, and with proper guidelines and strict oversight, the perils can be avoided."

It would take several columns to parse that statement alone, but just look at the misleading phraseology: "The majority of Americans ... have come to a consensus." Assuming a majority favors embryonic stem cell research — and even federal taxpayer funding for it — is it not deceptive to imply that a majority constitutes a consensus?

Of course, those who agree on a proposition always share a consensus among themselves, but doesn't "consensus" suggest that there is almost unanimity on the issue?

The answer is yes.

this type of language to manufacture the impression that only a fringe minority disagrees with the overwhelmingly accepted majority view. They declare a consensus when there isn't one and bully the true opposition from voicing their concerns. They do it with global warming, embryonic stem cell research, "intelligent design" theory and

now Kevnesian economics. They have plenty of help from the liberal lapdog media. They dutifully report that Obama is lifting a ban on embryonic stem cell research when there has been no ban on such research, only a restriction on federal funding for it. Nowhere do they acknowledge the genuine ethical objections to or the scientific problems that have been encountered in such research. Instead, they just portray opponents of federal subsidies for the practice as Luddites.

While the left ridicules those who don't buy into their decreed "consensuses," they are the ones who suppress scientific inquiry and debate on various issues. They are the ones who suppress publication of facts.

You'll rarely hear from them about the failures and hazards of embryonic stem cell research, such as a report that embryonic cells injected into a boy caused multiple brain tumors. You'll never hear them speak about the increasing successes of adult stem cell research, even though adult stem cell science is less expensive, more accessible, probably involves less cancercausing risk, and is not ethically controversial.

Beware; when the Obama left mounts its rhetorical high horse and tells us it is advancing science in furtherance of a consensus, it is most likely signaling that it is implementing a highly controversial, scientifically dubious policy whose opposition it intends to intimidate and silence with the formidable force of the presidential bully pulpit.





GONZALES (AP) — Five people were injured Tuesday in a disturbance near Gonzales City Hall that apparently involved guns and cars.

Police said two people were taken to a San Antonio hospital for treatment of gunshot wounds. Three others were treated and released at Gonzales Memorial Hospital. Police did not say how the three were injured.

Three people were in custody Tuesday night, police said. One of those was a 32-year-old man detained for resisting arrest after the parking lot disturbance. An 18-year-old male and 15-year-old male were also arrested and detained for burglary of a habitation after a foot chase following the disturbance, according to a police statement.

The statement did not say the condition of the victims, but said vehicles were used in an alterca-

Texas Department of Public Safety spokeswoman Tela Mange said the people in the disturbance knew each other and the incident was not believed to be gang related.

Gonzales City Manager David Huseman said "a couple folks had some sort of disagreement and apparently tried to settle it in the city parking lot." He said no city employees were involved.

### Austin couple charged with killing woman

AUSTIN (AP) — An Austin husband and wife have been arrested and charged with murdering and burning a 21-year-old woman's body the night of Austin's Mardi Gras.

The body of 21-year-old Christy Lynne Espinosa was found burned beside a road in eastern Travis County. The Austin-area woman had been last seen celebrating Mardi Gras in Austin.

Sheriff's spokesman Roger Wade says 26-year-old Martha Medina-Hernandez and 33-year-old Kenneth Hernandez are charged with murder. Medina-Hernandez was arrested in Eagle Pass on Sunday, while Hernandez was arrested Tuesday in Austin.

Arrest affidavits say Espinosa was riding with the Hernandezes as they drove around Travis County drinking on Feb. 24. Statements differ on the motive behind Espinosa's death, but the arrest affidavits say the husband and wife blame each other for the death.

### Police officer killed during chase

CORPUS CHRISTI (AP) — A Corpus Christi police officer was struck and killed by a sport-utility vehicle police were chasing after a disturbance

Police are withholding the 20-year veteran's identity until relatives are notified.

A police statement says officers went to a house across the street from Laguna Park in southwest Corpus Christi just before midnight. After a brief struggle, a 21-year-old male suspect broke free and sped away in an SUV. During the pursuit, the vehicle hit an officer who was standing on beside Texas 358 westbound. He died a short time later at Spohn Memorial Hospital.

The police statement says officers later shot and wounded the suspect after he rammed their cars with the SUV. He's hospitalized with what police say are non-life-threatening wounds. His identity hasn't been released.

### Three dead in apparent murder-suicide

NORTH RICHLAND HILLS (AP) — Police found four shot, three fatally, in what detectives call an apparent murder-suicide overnight in the Fort Worth suburb of North Richland Hills.

Police say neighbors called about 10:30 p.m. Tuesday with reports of the sound of gunfire coming from the house in the normally quiet neighborhood just off Rufe Snow Road, a block north of Mid Cities Boulevard.

Officers arrived to find two men, ages 38 and 17, and a 55-year-old woman dead. Another woman was wounded and hospitalized. Her condition hasn't

### TV company Belo to cut 150 iobs

DALLAS (AP) — Television company Belo Corp. said Wednesday it plans to cut 150 jobs, reduce some employee salaries by 5 percent and suspend its 401(k) matching contributions to help reduce cash operating expenses by about 10 percent this

The 5 percent salary reduction will affect employees who are part of the Dallas-based company's management-compensation programs. The suspension of the 401(k) matching program, however, will apply to all employees.

Belo, which owns 20 television stations, said the cost-cutting measures will take effect in mid-

President and Chief Executive Dunia Shive said the new steps and past cost-cutting initiatives will reduce 2009 cash operating expenses by about 10 percent, excluding severance costs.

Belo's revenue fell more than 5 percent in 2008 as increased political advertising and higher retransmission and Internet revenue failed to offset overall advertising declines.

In response, the company initiated a hiring freeze, reduced staff in some markets and took other costcutting steps last year.

Last week, Belo said it will indefinitely suspend its dividends after the second quarter to focus on paying down debt and conserving cash. Belo's second-quarter dividend of 7.5 cents will be paid on June 5.

Belo shares fell 18 cents, or 21 percent, to 69 cents

### Neiman Marcus posts loss on write-downs

DALLAS (AP) — Luxury merchant Neiman Marcus Inc. posted a fiscal second-quarter loss Wednesday on a series of hefty write-downs totaling more than half a billion dollars. The results were also hurt by a dramatic pullback in spending among its wealthy customers.

The privately held company, based in Dallas, said it lost \$509.3 million for the quarter ended Jan. 31. That's compared with a profit of \$44.3 million in the same quarter last year. Quarterly revenue fell 21 percent to \$1.08 billion from \$1.37 billion. The results were hurt by several one-time charg-

es, including write-downs on trade names, goodwill and other assets. Those charges totaled \$560.1 million during the quarter.

Adjusting for those items and for other expenses, the company said it earned \$24.6 million compared with \$187.3 million last year.

Luxury sellers like Neiman Marcus have been among the hardest hit retailers as they were caught by the sudden retreat of shoppers who had been willing to pay prices like \$900 for designer shoes and \$5,000 for handbags. The sudden reversal forced Neiman Marcus and other stores to offer unprecedented discounts on coveted brands during the holiday season to try to pull in shoppers.

Rival Saks Inc., which operates Saks Fifth Avenue, last month reported a loss for the fourth quarter and issued a downbeat sales forecast.

To preserve cash, Neiman Marcus and Saks are taking steps to cut costs. Neiman Marcus said in January that it's cutting approximately 375 jobs, or nearly 3 percent of its work force.

Last week, Neiman Marcus said same-store sales declined 20.9 percent in February. Same-store sales are sales at stores open at least a year and are considered a key indicator of a retailer's health.







# Alabama man kills at least 9, including 4 relatives

SAMSON, Ala. — Authorities were working Wednesday to learn why a gunman set off on a rampage of at least nine slayings across two rural Alabama counties. Shocked, grieving residents hoped the answers weren't lost when he killed himself.

Tuesday's shootings in a mostly rural area near the Florida border were believed to be the work of Michael McLendon, who lived with his mother and once worked at a local metal plant.

The bloodshed began when McLendon burned down his mother's house in Kinston, Coffee County Coroner Robert Preachers said. Authorities found Lisa McLendon's body inside, but they have not determined how she died or whether she was a 10th victim of her son's spree.

McLendon then drove a dozen miles southeast to Samson, in Geneva County, where he claimed nine victims, including four members of his family. The rampage ended another 12 miles farther east in Geneva at the metals plant where McLendon worked until 2003. After a shootout with police, McLendon, killed himself.

Investigators declined to comment on a motive for the shootings, in which at least

jured, including a child. The victims' names have not been released.

"He cleaned his family out," Preachers said. "We don't know what triggered it."

Samson Mayor Clay King said he had known McLendon all his life and could not say what triggered the shootings. McLendon's exact age wasn't released, but some authorities estimated he was in his late 20s.

"If you would have asked me two days ago if he was capable of this, I would have said certainly not," King said on NBC's "Today" early Wednesday

Five people were killed on the porch in Samson, along with a 74-year-old woman next door, said Kirke Adams, district attorney for Geneva and Dale counties. Four of the six killed were related to McLendon. A 4-month-old girl was the only survivor from the porch and was being treated at a Florida hospital.

Preachers had said McLendon's victims included his grandparents. But Adams said the 74-year-old victim might have been McLendon's great aunt

The two unrelated victims on the porch were the wife and 18-month-old child of a Geneva County sheriff's deputy. They had stopped by the home to visit.

McLendon fired several shots at a Wal-Mart store in Geneva. No one was killed, but it was unclear if anyone was injured.

"There's a lot of people who had close calls," Adams said.

Samson contractor Greg Mc-Cullough said he was pumping fuel at the gas station when the gunman roared into the parking lot and slammed on his brakes.

"I first thought it was somebody playing," McCullough said. Then he saw the rifle.

McLendon opened fire, killing the woman who walked outside and wounding Mc-Cullough with bullet fragments that struck his truck and the pump. At one point the rifle appeared to jam, then McLendon fired more shots before driving off.

"I'm just in awe that something like this could take place. That someone could do such a thing. It's just shocking," McCullough said.

Products, where he got out of his car and fired at police with his automatic weapon, Police wounding Geneva Chief Frankie Lindsey. He then walked inside and killed himself.

"He had plenty of ammo in his car and other weapons and he appeared to be going to do some damage there, Adams said.

Public Alabama Safety spokesman Kevin Cook said that McLendon resigned from his job at the plant in 2003 and it was unclear what kind of work, if any, he had been doing since. A person who answered the phone at the plant said no one could talk about the shooting.

King, the Samson mayor, said he knew the gunman and the victims. "What I'm focusing on is people here in the town, making sure they feel comfortable," said King, who added the town had opened a crisis center at a local church. "I've lived here 44 years and never, never dreamed of this happening."

State Rep. Warren Beck, a Republican whose office is near the Wal-Mart, said his secretary heard gunfire everywhere.

"This is one of the most tragic events ever in Geneva County," he said.

Among others injured was a state trooper injured by Police pursued McLendon broken glass after McLendon

shot his cruiser seven times. The injured infant was taken to Wiregrass Medical Center in Geneva before being flown to another hospital, Wiregrass administrator John Rainey said.

The hospital's staff was ready to treat more injured victims, but their hopes were dashed as death reports trickled in.

"Unfortunately, we were getting the same bad reports as everyone else: Most people were untreatable," Rainey said. "It's something you'd expect in Atlanta or your bigger cities, but in a little town it puts a lot of people in stress. Our nursing staff broke down in tears hearing what was going on and realizing they weren't going to be able to help them."

One of the spots sprayed with bullets was a hardware store in Samson. Yellow tape was strung across glass windows shattered by at least five bullets. A "closed" sign was on the ground outside atop glass shards.

Tommy Boyles, a 76-yearold security guard who works at the same plant where McLendon killed himself, said he and his wife were on the street nearby.

"We could have been caught up in it just as well as anyone else," he said. "That's what scares you: to be an innocent bystander and some nut walks up with a gun."

Howard shot just 34.5 percent in the first half, but improved to 54.8 percent in the second.

Odessa was good for only 38.5 percent of its shots and turned the ball over 19 times, compared to a mere 10 for the Hawks.

Diddle attributed the improved performance in the second half to the team getting over the first half jitters.

"We relaxed a little bit. We were all a little nervous," said Diddle. "Our defense got better. We sealed the basket. It was all good stuff."



What is it?

Dating violence is controlling, abusive and aggressive behavior in a romantic relationship. It can happen in straight or gay relationships. It can include verbal, emotional, physical, or sexual abuse, or a combination of them.

Controlling behavior includes: Not letting you hang out with your friends

Calling or paging you frequently to find out where you are, who you're with, and what you're doing

· Telling you what to wear

Having to be with you all the time

Verbal and emotional abuse includes:

Calling you names

Jealousy • Belittling you (cutting you down)

 Threatening to hurt you, someone in your family, or themselves if you don't do what they want Physical abuse include:

• Shoving • Punching • Slapping • Pinching • Hitting • Kicking • Hair pulling • Strangling Sexual abuse includes

 Unwanted touching and kissing • Forcing you to have sex  $\bullet$  Not letting you use birth control  $\bullet$  Forcing you to do other sexual things

Anyone can be a victim of dating violence. Both boys and girls are victims, but boys and girls abuse their partners in different ways. Girls are more likely to yell, threaten to hurt themselves, pinch, slap, scratch, or kick. Boys injure girls more, are more likely to punch their partner, and more likely to force them to participate in unwanted sexual activity.

Some teen victims experience violence occasionally. Others are abused more often, sometimes daily. If you are a victim of dating violence, you might...

• Think it's your fault • Feel angry, sad, lonely, depressed or confused

• Feel helpless to stop the abuse • Feel threatened or humiliated Feel anxious
 Not know what might happen next

· Feel like you can't talk to family and friends · Be afraid of getting hurt more seriously

 Feel protective of your boyfriend/girlfriend You're not alone

One in three teenagers has experienced violence in a dating relationship.

 50 percent to 80 percent of teens have reported knowing others who were involved in violence relationships. 15 percent of teen girls and boys have reported being victims of severe dating violence (defined as being hit, thrown

down, or attacked with a weapon). · 8 percent of 8th and 9th grade students have reported being victims of sexual dating violence · Young women, ages 16 to 24 years, experience the highest rates of relationship violence

Being a victim of dating violence is not your fault. Nothing you say, wear, or do gives anyone the right to hurt you. • If you think you are in abusive relationship, get help immediately. Don't keep your concerns to yourself.

• Talk to someone you trust like a parent, teacher, school principal, counselor or nurse. • If you choose to tell, you should know that some adults are mandated reporters. This means they are legally required to report neglect or abuse to someone else, like the police or child protective services. You can ask people if they are mandated reporters and then decide what you want to do. Some examples of mandated reporters are teachers, counselors, doctors, social workers, and in some cases, even coaches or activity leaders. If you want to help deciding who to talk to, call our Helpline at 1-800-FYI-CALL, or an anonymous crisis line in your area. You might also want to talk to a trusted family member, a friend's parent, an adult neighbor or friend, an older sibling or cousin, or other experienced

person who you trust. • If you want to get advice about who to talk to, call our helpline (1-800-FYI-CALL) or an anonymous crisis hotline in your area. Get help

Think about ways you can be safer. This means thinking about what to do, where to go for help, and who to call ahead of time

• Where can you go for help? • Who can you call? • Who will help you? How will you escape a violence situation?

Here are other precautions you can take

Let friends or family know when you are afraid or need help

· When you go out, say where you are going and when you'll be back

• In an emergency call 911 or your local police department

• Memorize important phone numbers like the people to contact or places to go in an emergency Keep spare change, calling cards, or a cell phone handy for immediate access to communication

· Go out in a group with other couples

· Have money available for transportation if you need to take a taxi, bus, or subway to escape If you know someone who might be in an abusive relationship, you can help.

• Tell the person that you are worried • Be a good listener • Offer your friendship and support • Ask how you can help • Encourage your friend to seek help Educate yourself about dating violence and healthy relationships

· Avoid any confrontations with the abuser. This could be dangerous for you and your friend.

everly Lewis has quite a following with her various series that deal with the Amish people. The series "Courtship of Nellie Fisher" ends with the third volume, "The Longing." Nellie has broken up with Caleb Yoder and chose to follow the ways of the New Order. Caleb is

also working through losing the woman he loves because his father was so opposed to Nellie. Gosh, does that sound like something Shakespeare would write? Stop by in the stacks and look for more of Lewis' work.

Toni Morrison (author of "Beloved" and others) has written "A Mercy" (F MOR T). Continuing themes that she has been developing since the start of her career, Nobel Prize-winning author Morrison creates an intense and involving philosophical, Biblical, and feminist novel set in the Atlantic colonies between 1682 and 1690. Her impressionistic story traces slavery from its early roots, using unique voices — African, Native American, and white while moving back and forth in time.
