## Jaramillo found guilty; gets 60 years, fine

A Big Spring man was sentenced to 60 years in prison Wednesday for his part in the June 3 home invasion at a residence in the 600 block of State Street.

Felix Lee Jaramillo, 31, was found guilty of aggravated robbery and sentenced to 60 years in a state prison and a \$10,000 fine following the oneday trial in 118<sup>th</sup> District Court.

District Judge Robert H. Moore III



heard the case, which sentence of 60 years. prosecuted by was District Attorney Hardy Wilkerson. Jaramillo was represented by local attorney Tim Yeats.

Jaramillo is the second suspect convicted for his part in the home Jaramillo invasion, with Clifford

Leon Anglin, 26, having been found guilty of aggravated robbery in mid-September. Anglin also received a

Phillip G. Martinez, 21, was also indicted on charges of aggravated robbery by the same grand jury.

Wilkerson said he's pleased with the jury's verdict, but there's little time to celebrate.

"We're pleased both defendants received 60 years," Wilkerson said. "We're looking forward to trying the other individuals that have been implicated and indicted in this crime, so there's still work to be done."

According to police reports, a number of suspects stormed the home of a Big Spring family, kicking in the side and front doors of the house during the late evening hours.

The suspects were armed with handguns, according to police reports, while one suspect was armed with a shotgun. All were wearing bandanas or masks to conceal their identities, according to Sgt. Tony Everett,

# Slayden injured in wreck

A pair of Texans riding across the state on horseback to raise funding for the American Cancer Society had their trek end in tragedy Monday, as one of the riders was struck by a vehicle and is currently in very serious condition.

Sharon Slayden of Jacksonville, joined by her husband, Bob, set out on the Cowboys Against Cancer Cross Texas Trailride with her horse, Shadow, Sept. 1 to raise funding and awareness for the ACS and the Jacksonville Relay For Life.

Expecting to arrive in El Paso by the end of this month, the pair were involved in an accident near the West Texas city, according to Cynthia Kline, chairman of the Jacksonville Relay For Life. "Sharon was hit by a truck Monday night," Kline said. "She was on her horse at the time. Sharon was seriously injured but is listed in stable condition. She went trough a very long surgery — around six hours, I believe - to begin addressing the multiple





### Texas News Briefs: 14 charged with conspiracy to smuggle

McALLEN (AP) — A south Texas federal prosecutor says 14 passengers on a tour bus have been arrested and charged with conspiracy to smuggle \$3.1

million in cash into Mexico. U.S. Attorney Jose Angel Moreno of Houston said Wednesday that the money was wrapped in deflated air mattresses and placed in 17 pieces of luggage. U.S. Customs and Border Protection officers arrested the seven U.S. citizens and seven Mexican nationals Sunday at the Hidalgo port of entry on the Mexican border near McAllen.

Each is charged with conspiring to smuggle bulk currency out of the United States, which is punishable by up to five years in prison and a \$250,000 fine.

It is a federal offense not to declare more than \$10,000 to a CBP officer when entering or leaving the United States.

#### Man arrestedin 10-year-old Texas slaying

BATON ROUGE, La. (AP) – Federal marshals have arrested a man in Louisiana accused of beating a woman to death with a piece of wood 10 years ago in Austin, Texas.

The U.S. Marshals Service says Juan Reza Ortiz was tracked Wednesday from a home in St. Gabriel

to a job in Baton Rouge, then stopped and arrested. Marshals spokeman Brian Lucio says Ortiz was wanted in connection with the killing of a woman in August 2000. Lucio says Austin police alleged Ortiz beat the woman with a 2-by-6 piece of wood during a fight an an apartment complex.

According to The Advocate of Baton Rouge, Ortiz is jailed in Baton Rouge pending extradition to Texas.

Prosecutor Cliff Herberg says the investigation involves allegations of misused funds since November 2008.

An attorney for Adams, James Rickerson III, did not immediately comment.

The party's new treasurer, Joseph Nazaroff, says an updated system of checks and balances is meant to avoid future financial problems.

#### Daughter convicted in death of father

GRANBURY (AP) — A Hood County jury has recommended 99 years in prison for a woman convicted in the kicking and beating death of her elderly father.

Jurors in Granbury on Wednesday found 60-yearold Deborah Ann Wilson guilty of murder, then the penalty phase began.

Investigators say 82-year-old George Malone was beaten to death in September 2009.

Wilson received the same prison term has her younger brother, 59-year-old David Malone, who earlier was also convicted over the slaving at the family's rural Hood County home.

Wilson attorney Terence Russell, in closing arguments, said the woman was defending herself after her father threw her to the ground and beat her.

Prosecutors say Wilson was drunk and initiated the attack on her father.

TYLER (AP) — A Tyler man must serve 45 years in prison over a fatal stabbing during a party at a Smith County deputy sheriff's home.

Prosecutors say Joshua Dwain Barnes on Wednesday pleaded guilty to murder in a plea agreement. Barnes also apologized over the Dec. 27, 2009, death of James Brandon Lee.

Lindsey was fired after his arrest.

#### New COPS grants to be announced

HOUSTON (AP) — Justice Department officials are announcing a new round of nationwide grants from a popular government program that puts more police officers on the street.

A news conference is set for Thursday in Houston to detail grants to fund the hiring of state, local and tribal law enforcement officers in all 50 states and Puerto Rico. The grants come through the Justice Department's Office of Community Oriented Policing Services, or COPS, program.

Since 1995, COPS has awarded over \$11.3 billion to advance community policing. Those grants have gone to more than 13,600 state, local, and tribal law enforcement agencies and have paid to hire 121,000 officers.

#### EPA, Exxon settle hazardous waste case

HOUSTON (AP) — The U.S. Environmental Protection Agency and ExxonMobil have settled allegations that the Irving, Texas-based oil giant had illegally stored 1 billion gallons of hazardous waste at a Texas facility.

The EPA announced Wednesday that ExxonMobil will invest more than \$150 million to close the impoundments and dispose of the waste stored at Agrifos Fertilizer in Pasadena, about 15 miles southeast of Houston.

Agrifos Fertilizer bought the 509-acre site from ExxonMobil in 1998. The site includes a mineral process facility that ExxonMobil must clean up.

The EPA says such facilities generate more toxic and hazardous waste than any other industry.

# The quest to put ghosts on notice

pparently never tiring of making spectacles of themselves, members of the ruling bloc of the State Board of Education will insist this week on fixing a problem that doesn't exist.

Looking at the bright side, at least they won't be doing any damage to Texas education while they chew on a meaningless resolution that adorns the agenda for their meeting ...

However, the discussion of a resolution to address perceptions of anti-Christian, pro-Islam bias in world history texts will put more dents in the state's reputation as this group pursues its narrow agenda — an agenda that took a beating in two GOP primary contests last March.

Don McLeroy, the Bryan dentist who lost a reelection bid in the Republican primary, now is leading a charge for textbook publishers to "fix" what he perceives to be past anti-Christian bias in world history books. Bear in mind that this is the same fellow who believes dinosaurs shared the planet with people.

Let's suppose just for a minute that he's right, though. Let's just say that the textbooks in question were filled with anti-Christian, pro-Islamic screed so offensive to Texan sensibilities that it required immediate and heroic action. ...

There will be no public comment taken during discussion of a resolution that would warn publishers not to push a pro-Islamic, anti-Christian viewpoint in world history textbooks. And as of late last week, no academic experts on world history, religion or any relevant field had been invited to comment.

That will startle no one who remembers McLeroy saying, "Somebody has got to stand up to these experts." Why ask somebody who might

## Tidal shift in Venezuela

t took them five years to recover from the grave mistake they made in 2005, but members of the Venezuelan opposition finally began to turn the tide against socialist President Hugo Chavez in national congressional elec-

tions Sunday. Hallelujah!

Five years ago, when opposition candidates claimed these elections had been rigged and did not participate, they unwisely gave Chavez supporters almost absolute control of the congress, creating a rubber stamp for Chavez to turn Vane

Chavez to turn Venezuela into a socialist dictatorship.

But a funny thing happened on the way to consolidating Chavez's dictatorship Sunday: The voters took away his rubber stamp!

By winning back 61 seats out of 165 in the Venezuelan congress — a united plank of opposition candidates, the Democratic Unity Table coalition, took away Chavez's power to pass new laws at will.

The runaway train that has been Venezuela recently, on its way down to totalitarian socialism, has been equipped with new brakes — 61 of them!

Although Chavez still will control at least 95 seats, he has lost the two-thirds majority that allowed him to pass sweeping legislation in the past and may have allowed him to complete the task of turning Venezuela into another Cuban-style dictatorship.

If the opposition won more than 50 percent of the popular vote — as projected in some published reports — we may be seeing the beginning of the end of the red-beret-wearing demagogue who has been driving Venezuela into the ground for the past 11 years. If the opposition already is the majority, there is hope that Chavez's bid for re-election will be thwarted in 2012.

After all, it was Chavez who predicted that his allies in congress would surpass the two-thirds threshold and that his "Operation Demolition" campaign would "demolish" his opponents. But his followers fell 15 seats short of the 110 they needed to enjoy the power of a supermajority.

Instead, what Chavez showed is that he is vulnerable, especially if the opposition candidates band together, as they did while campaigning for Sunday's election.

If Venezuelans manage to ban together behind a solid opposition candidate in 2012, Chavez still could be defeated and the Venezuelan people still could pull their country back from the gates of communist hell.

But let's not expect Chavez to take this sitting down. Although the election surely will change the political dynamics of Venezuela, many fear that Chavez will seek a way to stay in power, even by force if necessary. And though unity may have been achieved in the congressional elections — in which many seats were available — agreeing on a single opposition candidate to run for president against Chavez may be much more difficult.

Because the new congress won't be seated until January, some Venezuelans already fear that Chavez and the outgoing legislators will try to jam through a few bills that would be much more difficult to pass once the 61 opposition legislators are seated in 2011. Others fear that Chavez will try to bypass congress and rule by decree and that defeating him in elections will only drive him to become a military dictator — out of the mold of his mentors, Fidel and Raul Castro.

Nevertheless, there will be voices of dissent in the Venezuelan congress again.

And for all who believe in democracy, that has to be considered a major victory, especially because Chavez-manipulated redistricting last year made the playing field much more favorable to the candidates he supported.

Aside from the widespread fear that Chavez will turn Venezuela into another Cuba — where human and civil liberties are nonexistent — Venezuelans also have been growing tired of the huge problems Chavez has been unable to solve: scary crime and inflation rates, electric power outages and blackouts, food shortages, water service cutoffs, etc.

The opposition Democratic Unity Table coalition was able to tap into the growing discontent with Chavez, and the tide finally has turned in Venezuela. Now the majority is clearly with the opposition.

But here's the problem: Is Hugo Chavez capable of peacefully walking away from power?

If opposition leaders manage to remain united, if they can agree on a dynamic new leader to challenge Chavez in 2012, there will be either a true democracy again in Venezuela or a military dictatorship imposed at gunpoint.

Proponents wasting the board's time say the resolutions will put textbook publishers on notice not to malign Christians in future books. However, the resolution, if adopted, won't be binding on future boards of education, so it will have no practical effect.

The discussion, however, will no doubt stir anti-Islamic sentiment that conservatives see as politically advantageous. The Rev. Larry Bethune, senior pastor of the University Baptist Church in Austin, said the resolution "piles on to the fearmongering and anti-Islamic fervor that some political forces in our country are stirring up."

The resolution makes no objective sense, but then the board's ruling bloc is big on making noise, not making sense. Once again, the board rushes into a full frontal embrace of ignorance.

Members of the Senate Committee on Nominations should take notes during this ... discussion. Those notes will come in handy when Chairwoman Gail Lowe, R-Lampasas, appears for her confirmation hearings once the Legislature convenes in January.

## Going well beyond party

S chadenfreude means taking pleasure in the failure of others, which is the Hollywood vocation and, lately, that of Democrats, as well.

When you're part of the party in power and unemployment is hovering near 10 percent, there aren't that many occasions for pleasure. So you can hardly begrudge us the mirth that comes with watching Karl Rove, Rush Limbaugh, Sarah Palin, Christine O'l

Palin, Christine O'Donnell and the rest slug it out.

Could it really be that O'Donnell, the GOP nominee for the U.S. Senate in Delaware, equates looking at porn with adultery and masturbation with sin? Could it be that Alvin Greene is not the most embarrassing major party nominee of the year?

It could. And here's the difference: The GOP could've won in Delaware. Or in Nevada. Or in Colorado.

This is not about the tea party movement, at least not necessarily so. It's about taking politics seriously.

At the core of the tea party movement is the very popular and hardly irresponsible idea that federal spending is out of control, that government has Amen gotten too big, that everything from bailouts to entitlements needs a second look and, potentially, some major cuts.

I don't know whether there's a majority that sees it that way. The devil is in the details, and the details tend to focus on the sacred cows of American politics — Social Security, Medicare and the mortgage deduction.

But certainly there's nothing "nutty" (Rove's description of O'Donnell) about the core platform of the tea party movement. Indeed, by returning to the fiscal conservativism that was the heart of the Reagan message, and by reaching out to those who might disagree with "establishment" Republican positions on such issues as gun control and abortion (which are indeed nutty to a lot of people), the movement not only generates enthusiasm, but also has the potential for greater inclusiveness.

The problem, in short, is not the platform but the people, not ideology but competence and qualifications.

O'Donnell beat former Delaware Gov. Mike Castle because Republican primary voters wanted to send a message to their party — and to Democrats, the media and the establishment — that business as usual just won't do.

You can talk all you want about the narrow base of primary voters (true enough). But to deny that something real is going on "out there," which is to say outside of Washington, is silly. Nominating people who are not qualified to do the jobs they're seeking makes no sense, whether it's tea partiers, the GOP or my own party members doing it. Cutting government is a heck of a lot harder than expanding it. Carrying out the tea party platform would require the acumen of a Newt Gingrich and the savvy of a Rove, not to mention the charisma of a Palin.

Palin's problem as John Mc-Cain's running mate was not that she is a woman or a conservative, but that she doesn't know a single Supreme Court opinion other than Roe, doesn't read newspapers and still gets stuck on a Founding Father other than George Washington. An overwhelming majority of Americans think she's not qualified to be president. If she's smarter than they think she is, she won't put that to a test.

In the long run, a healthy democracy needs qualified and able people of every party to function effectively. The tea party movement's failure to support candidates who meet that standard may help Democrats avert disaster, but it's hardly a recipe for a strong political system.

This isn't a game. It's not a sport. The stakes are too high. I'm not supporting Alvin

Greene. Some things go beyond party.

ARLINGTON (AP) - Nelson Cruz has already hit three game-ending home runs this season for the Texas Rangers. This time, they won when he struck out.

Moreland Mitch raced home from first base with the winning run after a wild pitch and a throwing error on Cruz's strikeout with two outs in the ninth inning, lifting the AL West champion Rangers over the last-place Seattle Mariners 6-5 Wednesday.

"I sent Nelson up there to get it done, and he got it done," manager Ron Washington said.

Though certainly much differently than expected.

Cruz came on as a pinchhitter after Moreland drew a two-out walk against Dan Cortes (0-1). The slugger with 22 homers struck out, but reached on a wild pitch that bounced past catcher Guillermo Quiroz.

Quiroz retrieved the ball, but threw wildly into right field trying to get Cruz at first. Moreland never stopped running and beat the throw home by right fielder Ichiro Suzuki.

"When I checked my swing, I saw the ball went by (Quiroz)," said Cruz, who then heard umpire Wally Bell call strike three. "And I ran hard."

By time Moreland touched second base with the ball in the outfield, third base coach Dave Anderson was already waving for him to keep running.

Neftali Feliz (4-3), the third Rangers reliever, struck out one in a perfect ninth.

The Rangers had scored three runs in the eighth to tie the game at 5-all, scoring on a bases-loaded walk and another wild pitch by Cortes.

"We've seen the good and the bad with young kids," Mariners interim manager Daren Brown said. "I can't remember ever losing a game that way but I just saw it."

It was the first time a game ended on a play that began with a strikeout since Aug. 3, 2005, when Philadelphia beat the Chicago Cubs 4-3, according to Elias Sports. Pat Burrell struck out with the bases loaded in the bottom of the ninth, but Jimmy Rollins scored from third on a passed ball by Michael Barrett.

Cortes had been the first Seattle reliever since 1993 to open his major league career with consecutive appearances without allowing a runner when he struck out four while retiring the first six batters

he faced. Nothing went right in the right-hander's third game.

Taking over for Jamey Wright in the eighth with two runners on, Cortes started with nine consecutive balls. The first walk loaded the bases and the second forced home a run before Julio Borbon hit an RBI single and a wild pitch allowed the tying run.

"I made a few mistakes, walked those two guys, and it cost me," Cortes said. "When you walk two guys like that, it's a sign of some weaknesses and they could tell some pitches weren't working. They take advantage of that.'

Quiroz's throw was to the infield side of the bag, and rookie first baseman Justin Smoak was set up on the foul side. Suzuki made a strong throw home, but Moreland beat it.

Moreland had entered the game in the second when David Murphy left because of a strained left groin. Washington said Murphy was having an MRI exam and they would know more Thursday.

Smoak, sent to Seattle when the Rangers acquired ace lefthander Cliff Lee on July 9, homered for the third straight game against his former team. He hit a two-run homer in the first off Rich Harden, who might have made his last start for Texas.

The Mariners led 5-1 after Quiroz had a double in the sixth and scored when Suzuki reached on an error by shortstop Andres Blanco.

Texas (88-70) can still reach 92 wins, the mark that team president and co-owner Nolan Ryan had set as a goal before the season with a sweep of the Angels.

#### bad meat for positive doping test Contador blames

PINTO, Spain (AP) – Three-time Tour de France champion Alberto Contador blamed contaminated steak Thursday for his positive doping test, vowing to clear his name and not let cycling's latest drug scandal "destroy everything that I have done."

The Spanish rider was provisionally suspended after a World Anti-Doping Agency lab in Germany found a "very small concentration" of the banned substance clenbuterol in his urine sample on July 21 at the Tour, according to a statement from cycling governing body UCI.

"It is a clear case of contamination," food Contador told a news conference in his hometown near Madrid, during which several times he appeared close to tears. "I am sad and disappointed but hold my head high."

"I think this is going to be resolved in a clear way," he added. "With the truth behind you, you can speak loud and clear, and I am confident justice will prevail."

Contador said the beef was brought across the border from Spain to France during a rest day during the Tour at the request of the team's cook.

Contador said the beef was brought by a Spanish cycling organizer, Jose Luis Lopez Cerron. Cerron said earlier Thursday on Spanish radio that he was a friend of the team chef, who had complained of poor quality meat at the hotel where the team was staying.

Lopez Cerron said he bought filet mignon for the team in the Spanish border town of Irun on his way to Pau, France, to watch a few stages of the tour.

Contador said he ate the meat on July 20 and again on July 21. He called the UCI's suspension of him "a true mistake.'

Clenbuterol is sometimes given to cows, pigs and other animals to increase their growth rate.

Contador said he learned of the positive test on Aug. 24 and met with UCI doctors two days later.

"On the 26th we talked at length about how all this had happened. The UCI itself told me to my face that it was a case of food contamination," Contador said.

He said he has been in conversations with the UCI ever since "to handle this the most appropriate way possible and analyze it and see clear-

ly that it is a case of food contamination in which I am the victim."

Contador said it would have been better for cycling's image if the case had not been made public.

"It's almost normal for people to doubt this sport now," he said.

But he added: "The idea of anyone questioning my Tour victory does not worry me. I am not going to let something like this destroy everything I have done."

Contador beat Andy Schleck of Luxembourg by 39 seconds in winning his third Tour in four years.

#### Harrington eager to prove worth at Ryder Cup

NEWPORT, Wales (AP) — Colin Montgomerie and Corey Pavin went all out trying to give their Ryder Cup teams that little extra push, an inspirational nudge that might make the difference between winning and losing at Celtic Manor.

At least one guy, however, didn't need any more motivation.

Since being named to the European team as a captain's pick, Padraig Harrington has endured the grumbling from those who thought a guy with three major titles wasn't deserving of his spot — certainly not ahead of Paul Casey and Justin Rose.

Harrington's critics point out he hasn't won a tournament in two years or a Ryder Cup

match since 2004. Surely Montgomerie would have been better off picking Casey, ranked No. 7 in the world, or Rose, a two-time winner on the PGA Tour this summer.

Don't try telling that to Monty, and don't expect any apologies from Harrington.

"Defend myself? Yes. Apologize?" the Irishman said. "Yes.'

Montgomerie pointed to Harrington's experience as one of the main factors he was seeking, especially on a team with six Ryder Cup rookies. No one else has a resume that includes two British Open titles and a PGA Championship.

"There's no doubt Paul Casey and Justin Rose are good enough to be on

our Ryder Cup team," Harrington said. "It really just comes down to personal preference, the team captain, how he sees it. Thankfully, maybe with the balance of the team — the six rookies and with the age profile of the team - it certainly swung in my favor."

Now he's facing a burden unlike anything else in his career.

If the favored Europeans should lose on their home turf for the first time since 1993, the blame will likely fall squarely on Montgomerie for picking Harrington.

"It obviously puts you under a little bit more focus during the week, and brings certain expectations and certain pressure," he said.

## Fisher-Price recalls more than 10 million items

WASHINGTON — Fisher-Price is recalling more than 10 million tricycles, toys and high chairs over safety concerns.

The Consumer Product Safety Commission said Thursday that two of the products being recalled involved injuries.

In the recall of about 7 million Fisher-Price Trikes and Tough Trikes toddler tricycles, the agency is aware of 10 reports of children being hurt. Six of them required medical attention.

The trikes — some of which which feature popular characters like Dora the Explorer and Barbie — have a protruding plastic ignition key near the seat that children can strike, sit on or fall on, leading to injuries that can include genital bleeding.

Fisher-Price is also recalling more than 1 million Healthy Care, Easy Clean and Close to Me High Chairs, after 14 reports of problems. Seven children required stitches, the commission said.

The pegs on the back of the high chairs can be used to store the tray, but children can fall on them, resulting in cuts and other injuries.

CPSC Chairman Inez Tenenbaum said manufacturers need to do more to build safety into their products before they reach store shelves. But she also offered praise for Fisher-Price for "taking the right steps by agreeing to these recalls and offering consumers free repairs or replacement."

The two other Fisher-Price recalls were:

• More than 2.8 million Baby Playzone Crawl & Cruise Playground toys, Baby Playzone Crawl & Slide Arcade toys, Baby Gymtastics Play Wall toys, Ocean Wonders Kick & Crawl Aquarium toys, 1-2-3 Tetherball toys and Bat & Score Goal toys. The valve of the inflatable ball on the toys can come off and pose a choking hazard to children, said CPSC. The agency said there were more than 50 reports of the valves coming off the balls.

### NATO allegedly kills guards

PARACHINAR, Pakistan (AP) — Pakistan blocked a vital supply route for U.S. and NATO troops in Afghanistan on Thursday in apparent retaliation for an alleged cross-border helicopter strike by the coalition that killed three Pakistani frontier troops.

The blockade appeared to be a major escalation in tensions between Pakistan and the United States.

A permanent stoppage of supply trucks would place massive strains on the relationship between the two countries and hurt the Afghan war effort. Even a short halt is a reminder of the leverage Pakistan has over the United States at a crucial time in the 9-year-old war.

By midmorning, a line of around 100 NATO vehicles was waiting to cross the border into Afghanistan, officials said.

"We will have to see whether we are allies or enemies," Pakistani Interior Minister Rehman Malik said of the border incident, without mentioning the blockade.

NATO said it was investigating Pakistani reports that coalition aircraft had mistakenly attacked its forces. The coalition has on at least one other occasion acknowledged mistakenly killing Pakistani security forces stationed close to the border.

## *Tony Curtis, 85, star of 'Some Like It Hot,' 'Defiant Ones,' dies at Las Vegas-area home*

LAS VEGAS (ÅP) — Tony Curtis, the Bronx tailor's son who became a 1950s movie heartthrob and then a respected actor with such films as "Sweet Smell of Success," "The Defiant Ones" and "Some Like It Hot," has died. He was 85. powers to restrain risky financial practices. Bernanke, Treasury Secretary Timothy Geithner and the other regulators are members of the Financial Stability Oversight Council, a powerful assembly created by the new law. The council is headed by Geithner and is charged with keeping watch over the entire system.

#### 200,000 police patrol northern India amid concerns as verdict over control of holy site looms

LUCKNOW, India (AP) — India sent hundreds of thousands of troops into the streets Thursday as it braced for a potential eruption of violence ahead of a court decision on whether Hindus or Muslims should control a disputed holy site.

The conflict over the compound in the town of Ayodhya, 350 miles (550 kilometers) east of New Delhi, has sparked communal riots that killed thousands of people and challenged India's ethos as a secular, multicultural democracy. Hoping to prevent a new round of violence when the court issues its verdict Thursday afternoon in the 60-year-old case over who rightfully controls the site, the government flooded the streets with troops. and fellow Rutgers freshman Molly Wei, both 18, have been charged with invading Clementi's privacy. Middlesex County prosecutors say the pair used a webcam to surreptitiously transmit a live image of Clementi having sex on Sept. 19 and that Ravi tried to webcast a second encounter on Sept. 21, the day before Clementi's suicide.

A lawyer for Ravi, of Plainsboro, did not immediately return a message seeking comment. It was unclear whether Wei, of Princeton, had retained a lawyer.

#### North Korean state-run media publishes photos, airs video of heir apparent Kim Jong Un

SEOUL, South Korea (AP) — North Korea introduced its heir apparent to the world Thursday, a chubby-faced young man with a serious expression, combed back hair cut high and tight on the sides and wearing a communist-style black suit.

State media published the first official images of Kim Jong Un, the youngest son of leader Kim Jong II and the man appeared destined to inherit control of the impoverished, nuclear-armed state.

North Korean television broadcast video of a meeting of North Korea's ruling Workers' Party held Tuesday, including images of Kim Jong Un, who was positioned in the front row during a speech and shown standing and vigorously clapping with other delegates in the cavernous venue.

North Korean authorities confirmed to TV news agency APTN in Pyongyang that the man shown in the footage is Kim Jong Un.

A photo of senior Workers' Party officials also appeared on the front page Thursday of the authoritarian regime's main Rodong Sinmun newspaper, two days after the party concluded its biggest political gathering in 30 years to elect new leaders.

#### Four years after son's death in Iraq, father and protesters take dispute to Supreme Court

YORK, Pa. ( $\overrightarrow{AP}$ ) — One thing Al Snyder wants to make clear: His boy fought and died for freedom in Iraq, but not for the right of some "wackos" to spew hate at soldiers' funerals under the protection of the Constitution.

"It's an insult to myself, my family and the veterans to say this is what our military men and women died for," Snyder says, barely concealing his anger.

Yet more than four years after the death of his only son, Matthew, Snyder is in the middle of a Supreme Court case that raises almost precisely that issue.

The court is set to decide whether members of a fundamentalist church in Kansas who picketed Matthew's funeral with signs bearing anti-gay and anti-Catholic invective have a constitutional right to say what they want.

Or, in intruding on a private citizen's funeral in a hurtful way, have the protesters crossed a line and given Snyder the right to collect millions of dollars for the emotional pain they caused?

The actor died at 9:25 p.m. MDT Wednesday at his Las Vegas area home of a cardiac arrest, Clark County Coroner Mike Murphy said Thursday.

After a series of frivolous movies that exploited his handsome physique and appealing personality, Curtis moved to more substantial roles, starting in 1957 in the harrowing show business tale "Sweet Smell of Success."

In 1958, "The Defiant Ones" brought him an Academy Award nomination as best actor for his portrayal of a white racist escaped convict handcuffed to a black escapee, Sidney Poitier. The following year, he donned women's clothing and sparred with Marilyn Monroe in one of the most acclaimed film comedies ever, Billy Wilder's "Some Like It Hot."

His first wife was actress Janet Leigh of "Psycho" fame; actress Jamie Leigh Curtis is their daughter.

In later years, he returned to film and television as a character actor after battling drug and alcohol abuse. His brash optimism returned, and he allowed his once-shiny black hair to turn silver. He also became a painter whose canvasses sold for as much as \$20,000.

#### Bernanke says Fed working with other regulators to put into effect big overhaul

WASHINGTON (AP) — The Federal Reserve is working closely with other regulators to put into effect the most sweeping overhaul of U.S. financial rules since the Great Depression, Fed Chairman Ben Bernanke is telling a Senate panel.

The new law, enacted in July, toughens government oversight of Wall Street and banks, provides stronger protections for consumers and gives the Fed and other regulators new Police arrested more than 10,000 people to prevent them from inciting violence, while another 100,000 had to sign affidavits saying they would not cause trouble after the verdict, a top official said.

Helicopters hovered over holy sites in the state as people entering temples were checked with metal detectors, police said.

The 16th-century Babri Mosque in Ayodhya was razed by Hindu hardliners in 1992, setting off nationwide riots that killed 2,000 people. Hindus say the mosque, built in 1528 by the Mughal emperor Babur, was erected at the birthplace of their god, Rama.

Hindus want to build a temple to Rama there, while Muslims want to rebuild the mosque.

#### Rutgers case highlights problem of youth killing selves after being tormented

PISCATAWAY, N.J. (AP) — In his first weeks at Rutgers University, Tyler Clementi was known by some students as a smiling hallmate, while others thought of him as the shyest student in the dorm.

Gay rights groups, however, says his suicide makes Clementi a national example of a problem they are increasingly working to combat: young people who kill themselves after being tormented over their sexuality.

A lawyer for Clementi's family said Wednesday that he had jumped off the George Washington Bridge last week after a recording of him having a sexual encounter with a man was broadcast online.

Clementi's roommate, Dhraun Ravi,

## Fort Hood assessing soldiers in wake of suicides

Associated Press Writer FORT HOOD — Thousands of soldiers stationed at Fort Hood are receiving extra visits from their superiors this week following a recent spate of suspected suicides, the Texas Army post's senior commander said Wednesday. Fourteen suicides among soldiers stationed at Fort Hood have been confirmed so far this year. Six more are suspected, including four in the past week, according to figures released by the Army Suicide Prevention Task Force. The Army reported 11 suicides of Fort Hood soldiers in 2009, down from the previous record high of 14 in 2008. The task force did not return calls from The Associated Press seeking the number of suicides reported at other Army bases so far this year.

Maj. Gen. William Grimsley said Wednesday that Fort Hood soldiers from the rank of sergeant and below — more than 32,000 soldiers — would be visited in their barracks or off-post homes this week to get "a better sense" of how they are doing. Their superiors also will make sure weapons privately owned by soldiers are properly registered, Grimsley said.

He said he does not know what may have caused the rash of apparent suicides, but

that soldiers who take their own lives often are struggling with financial or relationship problems and multiple deployments. Grimsley said Fort Hood leaders also plan to offer more training on how to recognize and help at-risk troops.

"I think the overarching theme is that we as a force are busy doing what we need to be doing on behalf of the nation, and for the first time in our history, we're doing it for the most extended period in our history and with an all-volunteer force," Grimslev said.

The commander sees no correlation between the suicides and the shooting rampage last year that killed 13 and injured dozens more on the sprawling Army post, where 46,500 troops are now stationed. Maj. Nidal Hasan, an Army psychiatrist, has been charged with 13 counts of premeditated murder and 32 counts of attempted premeditated murder in the Nov. 5 attack

"People on the afternoon of the 5th felt their sanctuary was violated ... but the immediate aftermath of that ... is that Fort Hood is incredibly resilient and bounced back immediately," Grimsley said.

In 2009, the Army's 160 reported suicides among activeduty troops was an all-time high, up from 140 in 2008, and the Army has been trying to address the problem.

Fort Hood last year opened its Resiliency Campus, the Army's first multifaceted facility designed to help soldiers and their families prepare better for the stress and uncertainty of being deployed — often for the second or third time.

Before it opened, Fort Hood officials said the facility was not created specifically to combat the Army's rise in suicides. But they said they hoped its various programs would give soldiers and their families many tools to prevent problems that have led to suicides.

## Texas innocence group fights use of 'junk science'

Associated Press Writer DALLAS — A woman convicted of killing her uncle by dousing him with gasoline and setting him on fire asked the Texas Forensic Science Commission on Wednesday to determine whether a crime lab committed professional misconduct when it claimed to have found traces of gasoline on his clothes.

The Innocence Project of Texas, as part of its campaign against what it calls "junk science," filed the complaint on behalf of Sonia Cacy, 63. She has been free on parole since 1998 after the forensic evidence used

to convict her was widely discredited.

John Bradley, the head of the science commission, said in an e-mail that "FSC policy is to avoid public discussion of pending complaints, especially those not yet reviewed or investigated." The medical examiner's office, which is in San Antonio, did not immediately respond to a message from The Associated Press.

The science commission is the same group looking into whether fire investigators were negligent in determining that arson was the cause of a 1991 fire that killed three young sisters in Corsicana. That arson finding helped convict the girls' father, Cameron Todd Willingham, of murder. He was executed in 2004.

Cacv was convicted of murder in the 1991 death of her uncle, Bill Richardson, at their Fort Stockton home. The key evidence came from the Bexar County Medical Examiner's office, which determined there was gasoline on Richardson's clothes.

That evidence was later debunked by nearly a dozen fire experts and numerous attorneys who worked on her case for free. As a result, the **Texas Board of Pardons** and Parole released Cacy after she had served six

years of a 99-year prison sentence.

Her attorneys and many forensic experts say Richardson, a heavy smoker, likely died of a heart attack.

Cacy, however, is still legally considered а convicted murderer and must meet with a parole officer three times a month. She said she is afraid of getting a traffic ticket, because police will run her license and learn that she remains, in the eyes of the law, a paroled murderer.

"I have to be perfect," said Cacy, who now lives in Fort Worth. "I scent identifications.

Attorneys Jeff Blackburn and Gary Udashen, who are Innocence Project of Texas board members, said filing the complaint with the forensic science commission is the first step toward clearing Cacy's name.

"This is the most stark example of what junk science can do to someone," Blackburn said.

Blackburn and Udashen said junk science is most common in Texas in cases involving blood spatter patterns, arson investigations and dog

## Katrina evacuee on death row loses appeal

Associated Press Writer HOUSTON — The **Texas Court of Criminal** Appeals on Wednesday upheld the conviction and death sentence of a Louisiana man condemned for the robberyslaying of a Houston-area woman who had been helping him out after he fled his home state from Hurricane Katrina. Roosevelt Smith Jr., 45, of Napoleonville, La., was condemned for the strangling of 77-year-old

Betty Blair at her home in Pasadena, a Houston suburb, in October 2005.

The Court of Criminal Appeals rejected arguments that the judge at Smith's trial in Harris County improperly allowed into evidence a videotaped confession he contended was involuntary and coerced.

In addition, Smith ar

his mother made and school and hospital records he said could have bolstered his mitigating evidence.

Police said Smith was among three hurricane evacuees Blair had been paying for odd jobs and yard work on her property.

Two people from the Beaumont area - Jim- in the head and stranmy Hoang Le and Stephanie Jacobo, both 18 at the time of the slaying also were charged in her death. They told authorities they were Hurricane Rita evacuees. Katrina hit the Gulf coast in August 2005. Rita made landfall the following month. They were pulled over

at a Houston highway toll booth. The car, a Buick, had been located through an onboard electronic tracking system. Some of the slain belongings woman's were found inside.

One of Blair's three daughters found her dead. Evidence showed the woman had been hit gled, first by hand, then with a telephone cord. Besides her car, her wedding ring, jewelry, purse, computer, television and video equipment were taken. Blair was the widow of former Pasadena school board President Robert "Bob" Blair and an active member of a Catholic church that had been aiding hurricane victims. Before assisting Smith, she had taken three New Orleans women into her home. Le pleaded guilty in the case last year and is serving life without parole. Jacobo had offered to testify against Le, and the disposition of her case was not immediately available late Wednesday. Smith had a lengthy criminal record that began with a theft arrest in Terrebonne Parish, La., in 1982. He had at least two stints in prison in Louisiana and numerous charges for burglary and possession of stolen goods.

Counting out a hand is often thought of as a laborious process, but it is not really that difficult if you put vour mind to it.

Take this case where South is in seven hearts, and his only possible loser is a spade. The grand slam could be made very easily if declarer knew which opponent had the spade

By Steve Becker queen, since he could then take the spade finesse in the right direction. But since he can't see the queen,

declarer should try to assemble all the information he can to assist him in resolving the two-way guess.

Accordingly, declarer wins the club lead with the ace, draws trumps, then cashes the ace of diamonds and ruffs a diamond. A club to the king is followed by another diamond ruff, a club ruff (on which East shows out) and a third diamond ruff, to which both opponents follow suit.

The primary purpose of all these plays is to force the defenders to reveal their distribution. In the actual case, South learns that West started with precisely one heart, four diamonds and six clubs. This in turn means that West was dealt exactly two spades and East five.

The logical conclusion is that East is much more likely to have the queen of spades than West. So South next leads the jack of spades to the king and finesses the ten on the way back. As it happens, the finesse succeeds, and the grand slam is made.

Of course, declarer is not certain the finesse will win — heavy favorites sometimes lose — but, as is nearly always the case, there is no reason not to follow the percentages.



## Immigration check program goes statewide

Associated Press Writer SAN ANTONIO — A federal program that automatically checks the immigration status of suspects booked into local lockups officially went statewide in Texas on Wednesday, two years after the nationwide crackdown began in Houston jails.

The rapidly expanding Secure Communities program, a fingerprintsharing system run by Immigration and Customs Enforcement, was expanded to all 254 counties in Texas this week.

It makes Texas the largest state in the nation to fully implement the program in every county.

Nationally there have been more than 41,000 deportations of illegal immigrants under the program, and nearly 40 percent of those occurred in Texas, according to ICE.

Many Texas counties have had the program in place for months.

Since debuting in Harris County in October 2008, federal authorities swiftly installed the program across Texas without, apparently, the objections met elsewhere.

Just this week in California, officials in Santa Clara County voted unanimously to abandon Secure Communities, saying it creates an atmosphere of fear in the community.

San Francisco has also indicated it wants out of the program. Colorado Gov. Bill Ritter's office was negotiating an agreement with the federal government last month that would make Colorado the first of 29 states to modify the program.

The program has also played into the Texas gubernatorial race, and Wednesday's announcement by ICE led Democratic candidate Bill White to have to tweak a campaign pledge.

White listed helping local law enforcement adopt Secure Communities as part of his six-point border security plan unveiled this month, but with the program now officially statewide, his campaign changed the message to helping "implement" the program.

Critics say the program busies itself rounding up low-level criminals and discourages crime victims from coming forward.

ICE spokesman Carl Rusnok said he was not aware of any Texas counties that have asked to be removed from the program or requested modifications.


