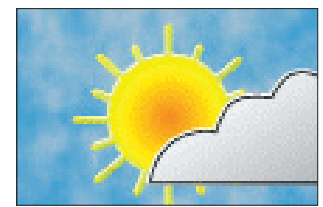

Polls open at 7 a.m. Saturday

Polls are set to open Saturday at 7 a.m. in this year's municipal election, which includes two seats on the Big Spring City Council and the fate of a proposed charter amendment that would place term limits on the mayor and council members.

Polls will be open from 7 a.m. until 7 p.m. at the Dorothy Garrett Coliseum, according to Howard County Elections Administrator Saundra Bloom.

"All registered voters living within the city limits can vote in the charter amendment election," Bloom said. "In the District 1 and District

3 races, only voters living within those districts will be able to cast a ballot. The turnout for early voting was a bit higher than we had initially expected, so we're hoping Saturday will be a strong day at the polls."

The proposed term limits have become a hot topic in the Crossroads area during

the past several months, as the charter amendment — which was spawned by a local petition — will either be approved or rejected by voters.

The amendment would prevent council members from running for re-election after serving two consecutive terms, according to City Attorney Linda Sjogren.

"If the proposed charter amendment passes... the net effect is that council members may only run for two consecutive terms in one position then must sit out one election before running again for that same position," said Sjogren.

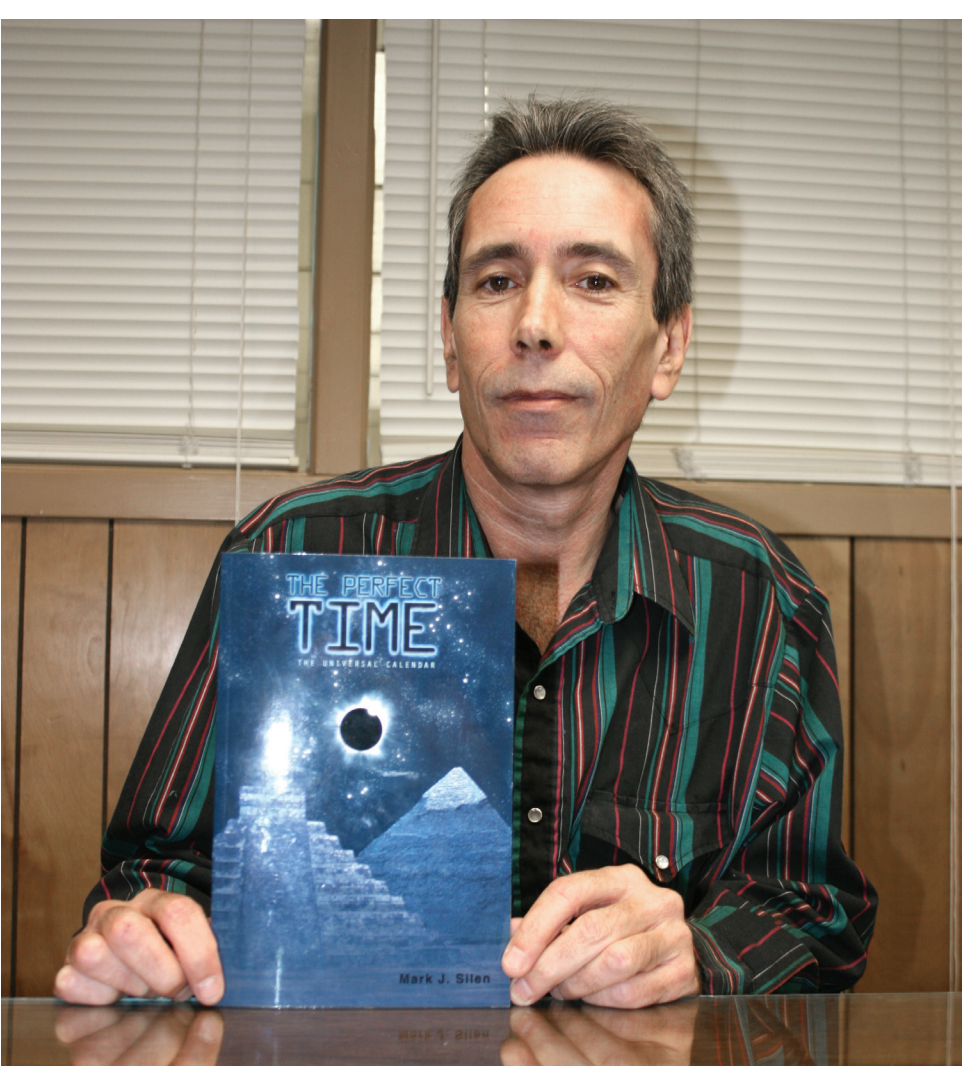
Tea party godfather Ron Paul running for president

AUSTIN — Texas Rep. Ron Paul announced Friday that he will run for the GOP nomination for president in 2012, the third attempt for the man known on Capitol Hill as "Dr. No" for his enthusiasm for bashing runaway spending and government overreach.

"Time has come around to the point where the people are agreeing with much of what I've been saying for 30 years. So, I think the time is right," said the 75-year-old Paul, who first ran for president as a Libertarian in 1988.

Paul made his announcement in an interview on ABC's "Good Morning America" from New Hampshire, where he planned his first event for his presidential campaign on Friday.

Senators criticize raise for UT coach

Several Texas senators on Thursday criticized the recent \$200,000 raise for Texas basketball coach Rick Barnes, calling it "nuts" and "tone deaf" during a state budget crisis that threatens deep cuts to higher education.

The state is facing a budget shortfall that some estimates put as high as \$27 billion. Current spending proposals would cut money for universities and tuition programs for poor students.

Barnes' raise was approved by university regents on Wednesday.

"It's not appropriate, not at a time when we're scraping for money for education," said Sen. Jeff Wentworth, a member of the Senate higher education committee.

Ogden and Wentworth are Repub-

licans with connections to Texas' chief rival, Texas A&M University. Texas A&M is in Ogden's district and Wentworth is an A&M graduate.

But Democrats with connections to Texas also chimed in.

"It is bad timing," said higher education committee chairwoman Sen. Judith Zaffirini, a Texas graduate. "They didn't ask for my advice."

Sen. Kirk Watson, whose district includes the Texas campus, said the raise suggests regents are "tone deaf" to the budget crisis boiling at the Capitol less than a mile away. "I'm a big fan of UT basketball and coach Barnes," Watson said. "But at a time when everyone up here is fighting to come up with money to pay for education, it was disappointing."

Summer program spots filling

Time's running out to have your kid enrolled in B&G Club

Time is running out for area parents looking to utilize the Salvation Army's Boys and Girls Club summer program, as more than half of the spots for the annual program have already been filled, according to project coordinators.

With 80 total spots to fill for the summer-long event, Boys and Girls Club program director Sonnet Hildebrand said approximately 50 have already been filled.

"The spots have been going fairly quickly," Hildebrand said. "Parents who are interested in taking advantage of the summer program need to contact us as soon as possible to avoid being left out this year. We generally have a waiting list throughout the summer, and it's based on first come, first served."

The program will run from June 6 until Aug. 12, according to Hildebrand, Mondays through Fridays from 7:30 a.m. until 5:30 p.m. Children must be between the ages of 6 and 18 to participate.

"For a lot of parents, daycare just isn't an option," said Hildebrand. "The charge will be \$70 for the entire summer program, which is within the reach of most parents."

And while the program is certainly a God-send for many of the area's working parents, Hildebrand said it's also a chance for the

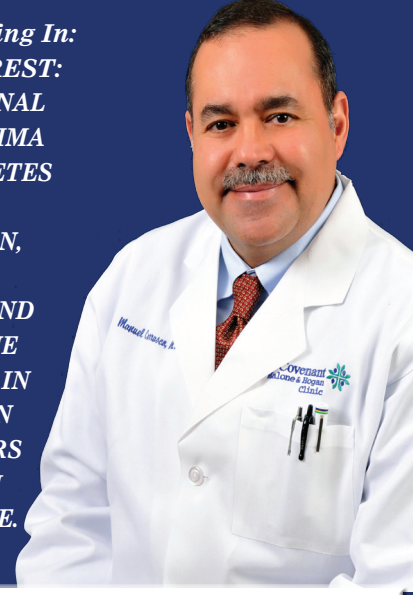

ing.”

RUNNING OUT OF TIME

For those lawmakers who may have thought the state's budgetary woes are solved, Rep. Jim Pitts gave a reality check: Think again.

Pitts, the lead House budget writer, warned his colleagues Thursday that without the passage of certain legislation, schools would close in February 2013. Medicaid would only be funded through March 2013.

House and Senate teams have begun negotiations to find a budget compromise. But to avoid a shutdown of key government services, lawmakers must also pass a

bill that reworks the school funding formulas and other legislation that frees up non-tax revenue.

The legislative session ends in less than three weeks.

TECHNOLOGY FUND

Gov. Rick Perry's technology fund would be subject to more scrutiny and accountability under legislation approved by Texas senators Thursday meant to address concerns from the state auditor about the fund's management.

The vote comes in response to statewide complaints and a lengthy report from State Auditor John Keel criticizing the governor's office for not opening to the public decisions related to the Emerging Technology Fund and its recipients.

“Council members may run for any other position than the one they currently hold if their term is expiring or if they are within the last year of their term, without sitting out a term. Council members cannot be elected to fill a vacancy (unexpired term) in any position on the council within six years of having served in any position on the council.”

Bloom said she believes the proposed term limits are what is driving the election.

“It's become a really hot topic and all the voters — not just some — can vote on the proposition,” Bloom said.

Some local residents have embraced the idea of term

limits in hopes of ousting “career politicians” sitting on the city council. Others, however, have shown sharp opposition to the measure, saying it is a violation of voters' rights to say who can and can not be elected based on arbitrary term limitations.

Voters are also being asked to decide the fates of the District 1 and District 3 seats on the city council.

District 1 Councilwoman Stephanie Horton is defending her seat on the council from challenger Marcus Fernandez, while the race for the District 3 seat has drawn three challengers, as incumbent Councilwoman Joann Staulcup faces challengers Shannon Thomason, Glen Carrigan and write-in candidate Oscar Velasco.

In an area race, Coahoma

Independent School District will be holding its elections at the Coahoma Community Center. Gerald King and Craig Ferguson are seeking to fill a two-year unexpired term on the school board. Patric Robinson and Lori Martinez are running for a full, three-year vacant board member seat.

In Stanton, Justin Burch and Mark Sundry are seeking a city council at-large seat. The election will take place at the Martin County Election Center.

Voters should be sure to bring their voter registration card or picture ID to be able to vote.

Democrats have tried repeatedly to beat him in a congressional district that stretches from the outskirts of Corpus Christi to Galveston. But the independent swath of coastal Texas seems a good fit for the maverick doctor. He has 18 grandchildren, according to his website, and he and his wife of 54 years, Carol, are known widely in Paul's district for the cookbooks they give away to supporters.

“The secret to his success is his authenticity,” said Democratic consultant Jeff Crosby, who grew up in Paul's district. “He's an authentic nut.”

Crosby, who worked

to defeat Paul in 2006 — unsuccessfully — described the difficulty he had trying to persuade voters to reject what he thought were the candidate's radical views.

“Just the mere fact that he does what he says he's going to do, regardless of how nutty or ineffective it may be, they like it,” Crosby said. “A lot of folks along the coast have never expected much from government, and they're getting it.”

Paul, a native of Pittsburgh, is both a spiritual father and actual father in the tea party movement. His son, tea party darling Rand Paul, won a Senate seat in Kentucky last year and has become an ardent proponent of spending cuts and smaller government.

As far back as 2007, long before people were evoking the fabled Boston Tea Party to symbolize their disgust with an overtaxing central government, Ron Paul was hosting a “Tea Party Fundraiser” aboard a shrimp boat near Galveston.

Organizer and Paul campaign volunteer Elizabeth Day remembers that supporters wore period dress and rolled fake barrels of tea into the waters of the Gulf of Mexico.

“When people come to believe in Ron Paul, there is a passion that burns within us,” said Day, a 57-year-old oil company revenue analyst. “To me, Ron Paul is the tea party.”

The elder Paul has built coalitions that include senior citizen

“granny warriors” and pot-smoking libertarians. During his 1988 presidential run, High Times magazine, which caters to marijuana users, published a cover story under the headline, “Ron Paul: Pro-Pot Presidential Candidate.”

Paul has expressed the view that the states, not the federal government, should regulate vices like pornography and drugs.

What sets Paul apart most from his GOP brethren are his views that defense spending needs to shrink and that the U.S. should get out of its two wars. Paul says the conflicts are financially unsustainable — and another drag on a battered U.S. dollar that he believes is on the verge of collapse.

He also disputes a fundamental underpinning of the war in Iraq, namely that Islamic ter-

rorists must be stopped overseas before they can attack the United States.

children to learn and grow.

“For a lot of these children, the alternative is pretty bleak,” she said. “Boys & Girls Club gives them a chance to participate in arts and crafts, sports and other activities that will help them grow as people. If they weren't participating in the program, however, many of them might be getting into trouble or causing problems in the community. So it not only provides a much-needed service to the parents and the children, it also helps keep these kids off the streets and out of trouble. We feel like that's very important.”

Hildebrand said lunches will be provided during the first month, and after that, the children will be expected to bring a sack lunch.

“The first month we'll be busing the kids to the (Big Spring) High School for lunch,” she said. “After that, the children will be responsible for bringing their own lunch, while we'll provide a snack for them.”

The program only has a limited number of spaces, she added

“Sign-ups for the summer program are going on now,” said Hildebrand. “There are no fi-

nancial restrictions to be met or anything like that. Once the program is full, there will be a waiting list in case any of the children drop out. We'll also be hiring summer staff to work with the kids. Anyone who is interested can

contact me for more information.”

Official English promotes ignorance

For at least a couple of decades, they have been lobbying for laws to make English the country's official language. Slowly but surely, English-only zealots have been gaining ground — and taking this country backward!

All over the world, people recognize the huge benefits of speaking several languages. They know it makes them more valuable in a global economy and society. Yet in the "nation of immigrants" that should be leading the world on language diversity and education, official English advocates — and the politicians who cater to them — keep promoting ignorance and polarizing the country!

Over the past few years, "official English" or "English only" advocates have successfully used scare tactics to persuade many Americans that Latinos are trying to impose the Spanish language over English, when, in fact, most of us unfortunately are forgetting our Spanish! Based on false stereotypes, they also have convinced many Americans that Latino immigrants don't want to learn English, when, in fact, all over the country, there are long waiting lists for people trying to get into English as a Second Language classes.

It's hogwash. They know official English laws are not needed. Yet they already have rammed more than 30 official English bills through state legislatures, including some states with Spanish names!

They even managed to fool some Latinos, who were told that making English official was "only symbolic" and not meant to restrict government use of Spanish and other languages. And while some state laws are merely recognition of English as our primary language, at least one was so draconian, in Arizona, that it was declared unconstitutional.

The Arizona amendment declared English "the language of the ballot, the public schools, and all government functions and actions." Yet the Arizona Supreme Court held that "by depriving elected officials and public employees of the ability to communicate with their constituents and with the public," the measure violated their constitutional guarantees of equal protection and the right to petition government and to participate in the political process. It ruled that the law was unconstitutional because it deprived limited-English-speaking citizens from an opportunity to hold "meaningful communications" with their public officials by creating "a linguistic barrier between persons and the government they have the right to petition."

When the U.S. Supreme court refused to hear an appeal to the Arizona ruling in 1999, we thought we were seeing the beginning of the end of the English-only movement. But in spite of what the courts have said, official English advocates,

riding on the country's anti-immigrant wave, are making a comeback, now at the federal level. And unfortunately, they are no longer willing to settle for symbolic recognition of the English language. Their agenda is much more Machiavellian!

Emboldened by the country's recent ideological shift to the right, two of their champions in Congress have introduced legislation that calls for all business and services of government to be conducted only in English.

There's nothing symbolic about the aim of new official English bills that have been introduced in both the U.S. House of Representatives and the Senate this year. H.R. 997 and S. 503, sponsored by Republicans Iowa Rep. Steve King and Oklahoma Sen. Jim Inhofe, are clear efforts to disenfranchise and disempower Latino immigrants by banning government documents, ballots and even U.S. Census forms currently published in Spanish.

They aim to make it more difficult for legal immigrants to vote, defend themselves in court, obtain a driver's license and even be counted by the Census Bureau. It is an excuse to violate the civil rights of thousands of legal immigrants and citizens by excluding them from the political process and preventing them from acquiring crucial government information about the services to which they are entitled.

Not surprisingly, official English advocates frequently are the same people who have been waging a war of insults on undocumented immigrants.

They usually tell us that their problem is only with illegals, until they take off their masks and promote measures that are clearly against legal immigrants.

Their measures are mean-spirited, hostile, unnecessary and discriminatory. While pandering to their conservative constituents, they claim to be solving problems that don't really exist.

"A nation divided by language cannot pull together as effectively as a people," King said in a statement released in March.

How about a nation divided by opportunistic, race-baiting politicians?

Mind you, while this legislation has a shot of passing in the GOP-majority House, it has little chance of clearing the Democrat-majority Senate. And it has even less possibility of getting President Barack Obama's signature, not when Obama already is in trouble with Latino voters for failing to keep his promise to reform our broken immigration system.

Yet, the official English movement persists! Even when Republican politicians know they are introducing legislation that has no chance of passing, they keep introducing bills, just to pander to their xenophobic constituents. It's not unlike Obama, who lately has been pandering to Latinos by promoting a comprehensive immigration reform bill that he knows will not be passed by Congress this year.

King and Inhofe call themselves "champions of promoting English as the official language for the United States." Yet you don't see them fighting for more funding for ESL courses.

They take pride in their efforts to violate the language rights of millions of Americans and they have the audacity to claim that they are doing it to help immigrants assimilate faster.

Clearly, the overwhelming majority of immigrants recognize that English is this country's primary language and that learning it is essential to their well-being. And clearly, no one is trying to impose Spanish or any other language on English speakers.

Those who choose to be monolingual have the right to do so. But they don't have the right to impose their ignorance on others.

Amazingly, they want us to believe that the use of foreign languages in U.S. government affairs is a new phenomenon. In fact, our government has been multilingual since the time of the Continental Congress, when documents frequently were published in English, French and German.

They want us to forget that our Founding Fathers encouraged teaching French, Spanish and German in our schools, or that they were opposed to government telling people what language to use. When they gave us our precious freedom of speech, the authors of our Constitution certainly didn't specify that it had to be in English only!

Yet, when you listen to official English advocates, they make it seem as if their European ancestors started speaking English instantaneously, precisely at the moment when they stepped ashore on Ellis Island and that they left their homeland's culture on the boat. And they refuse to recognize that their ancestors published newspapers and promoted their businesses with foreign-language store signs in our Little Italys, Polands, Germanys and Russias. Some refuse to see the signs in other languages that still are out there today.

Yet they hold new immigrants, especially Latinos, to a different standard. Store signs, billboards, phone messages and supermarket announcements in Spanish — the first European language spoken here — now are annoying to some Americans, especially those who (quite needlessly) feel threatened by the growth in number and political power of the Latino population.

They aim to turn back the clock, to take years away from the progress Latinos have made in this society because their wacky xenophobia tells them that Latinos want to "take over" — and make everyone speak only Spanish!

A federal English-only law would affect only governmental affairs, but since some local politicians have even tried to ban Spanish on commercial billboards, there is good reason to fear that it could lead to massive discrimination against immigrants in the private sector and throughout society.

Many people would assume they could restrict a citizen's right to express himself freely in the language of his choice. It would create a society in which xenophobia is institutionalized and bigots would feel they have the right to stifle anyone speaking a foreign language.

Justice and Grace

It has been more than a week since Osama bin Laden's death. When I first heard the news I felt no joy. I was not sad that he was dead. I am glad he is no longer a threat to innocent people. I believe the world is a better place without him. But, I wondered why I did not feel like dancing in the streets and waving flags. Why did I feel no jubilation at this news?

Perhaps my sadness stemmed from the conflicting world views represented in bin Laden's death. One world view operates on the basis of terror, violence, bloodshed, retaliation and revenge. The other world view operates on the basis of love, forgiveness, kindness, gentleness, goodness and grace. The killing of bin Laden seemed to demonstrate the triumph of the first world view, leaving the questions: Can the second world view exist with out the first or does it exist at all? How do those of us who opt for compassion, forgiveness and grace live in a world that seems dominated by violence, retaliation and revenge?

When I was a youth I shocked my mother by saying, "God is not just." I think she wanted to wash my mouth out with soap. I simply could not reconcile God's justice with God's grace. If God is just, it seemed to me, he could not be loving and forgiving. On the other hand, if he were loving and forgiving, he could not be just. So, I opted for a loving and forgiving God. Of course I was wrong. God is both loving and just. He revealed himself to Moses as "the Lord God, compassionate and gracious, slow to anger,

and abounding in loving kindness and truth; who keeps loving kindness for thousands, who forgives iniquity, transgression and sin; yet He will by no means leave the guilty unpunished." (Exodus 34:6-7).

God's justice and grace intersected on Golgotha. Jesus endured the cross because he knew a penalty must be paid for our sin and that violence, hatred and cruelty must be overcome by God's grace and goodness. Isaiah had predicted this moment: "But he was wounded for our transgressions, he was bruised for our iniquities: the chastisement of our peace was upon him; and with his stripes we are healed. We all, like sheep, have gone astray; we have turned every one to his own way; and the Lord hath laid on him the iniquity of us all." (Isa. 53:5-6).

Our fallen world is filled with violence and hatred, goodness and grace, all at the same time. Somehow we must seek both justice and grace. I have no doubt that Osama bin Laden deserved death. But his death in no way compensates for the thousands of innocent lives lost on 9/11 or the multiplied thousands more brave and innocent men and women killed in Iraq and Afghanistan or the thousands of young Muslims led astray by his radical views. Personally, I am ready to wildly celebrate goodness and grace everywhere it is found. And I am prepared to affirm justice wherever it is necessary and can be achieved.

Making it official...

Anyone who has ever traveled through the State of Texas has probably read the words "Don't Mess with Texas" on a road sign. They also may have seen the Seal of the State of Texas or the Texas flag and figured out that Texas is known as the Lone Star State.

The Texas Constitution, article IV, section 19 states: There shall be a Seal of the State which shall be kept by the secretary of state and used by him officially under the direction of the governor. The seal of the State shall be a star of five points, encircled by olive and live oak branches and the words, "The state of Texas."

Although the current Lone Star Seal was adopted with the state constitution in 1876, the history of the Lone Star can be linked to the Republic of Texas. The star stands for the Republic itself. The ol-

ive branch symbolizes peace, and the live oak, native to Texas, represents strength and fertility.

Tradition, however, claims that the Lone Star Seal was born of necessity before the birth of the Republic of Texas. According to one tale, Henry Smith, the first governor of the Mexican province of Texas deserves credit for the Lone Star. A few days into his administration, the governor received some important papers to be signed and sealed. Lacking an official seal, the ingenious governor took a button from his overcoat, dipped it in some wax, and stamped an official-looking five-point star onto the papers. Thus the Lone Star was born.

According to the New Testament those who believe in Christ also are marked with an official seal. The apostle Paul explains, "In Him, you also after listening to the message of truth, the gospel of your salvation - having also believed, you were sealed in Him with the Holy Spirit of promise" (Ephesians 1:13 NASB).

It's official. Those who have believed in Jesus Christ have been sealed with the Holy Spirit through Christ. The Lone Star Seal has endured more than a century, promising security and productivity for the citizens of Texas in the years to come. But the seal of the Holy Spirit is eternal, providing evidence of salvation for those who have believed in Christ, the lone Savior.

Worn out, Howard falls to Vikes

Smith says he's most proud of his group for coming together as a team

LUBBOCK — Howard College's Hawks managed to survive marathon games and a torrid pace through the loser's bracket to place themselves in position for a trip to nationals during the Region V Baseball Tournament here, but in the end, it may have been fatigue that sent them home Thursday.

It wasn't all fatigue, of course. A scrappy, high-courtesy Grayson County College ballclub had more than a little to do with it.

Heading into the ninth inning tied 6-6, Howard gave up six runs on a stolen base, two bases-loaded walks and a bases-loaded triple to succumb to the Vikings 12-6 in the tournament's championship game at Dan Law Field.

Howard had gone into the contest having played six games in four days — two of them lasted extra innings. In doing so, the Hawks came

together as a team, their coach said, but were worn out physically.

"Our kids are exhausted," Hawks Coach Britt Smith said hours before the title match.

Afterward, he concurred. "We just ran out of arm and still it was 6-6 going into the ninth inning. But they have a really good team and came back on us and it was all we could do to finally get out of the inning."

After three scoreless innings, Grayson got on the board in the top of the fourth when D.J. Boschman doubled and scored on a Trevor Holland single. Holland made it a 2-0 game, scoring from third on a ground out.

Howard got one run back in the bottom of the fifth when catcher Rick Stover was hit by a pitch, moved to second on a Derrick Bleeker single, then took third and home on a couple of wild pitches by Grayson pitcher Steven Okert.

NFL players ask for \$707M in damages in TV dispute

MINNEAPOLIS — Seeking more clout in their fight with the NFL, locked-out players asked a federal judge Thursday to make

\$4 billion in disputed broadcast revenue off limits to the league and to award them at least \$707 million in damages, too.

U.S. District Judge David Doty took the request under advisement after a two-hour hearing

that included arguments from attorneys for the league and the players.

Jeffrey Kessler, an attorney for the players, urged Doty to rule

quickly on the request to put the \$4 billion "war chest" in escrow because of the ongoing lockout. The players have argued that the league can make it through the work stoppage in part because it illegally secured that money by renegotiating TV contracts for 2011 that allows the NFL to get paid even if there are no games to televise.

Gregg Levy, an attorney for the league, said the players have no right to damages, and he accused them of "sandbagging and ambush."

Levy told reporters afterward the league never intended to finance a work stoppage with money from the networks. He said the players don't have the right to access the money, however, and balked at the proposal for an escrow arrangement.

"It would in effect give the players some entitlement to that money which we don't believe they are entitled to," Levy said.

The damages award alone could amount to a huge piece of leverage for the players in their fight with the NFL over the next collective bargaining agreement. And so could making the broadcast money off limits.

"I think that the owners predicated a lot of their strategy in having a revenue stream for 2011," said Marc Greenbaum, a labor law professor at Suffolk University Law School in Boston who is following the case. "If Judge Doty grants the players' request, an important part of their strategy is undermined."

None of the team owners or high-ranking league officials attend-

ed the hearing. Players Ben Leber, Chester Pitts and Steve Smith were present, as was the head of the NFL Players Association, DeMaurice Smith.

Leber is one of the 10 named plaintiffs in the federal antitrust lawsuit against the league pending before one of Doty's colleagues, U.S. District Judge Susan Richard Nelson.

On March 1, 10 days before the lockout began, Doty ruled that the NFL failed to maximize revenues for the players, essentially leaving money on the table for the last two years to gain leverage in the labor fight. He described it as an "unconscionable advantage."

That order overruled a special master's decision in February to award \$6.9 million in damages to the players for an extra Sunday night game given to NBC last season, but it left open the chance for the players to seek more damages over the objections of the league.

"We continue to believe that the special master got it right, that Judge Doty's findings did not give adequate deference to the special master and we are hopeful that Judge Doty will look at this record and see that the players' claims for damages and injunctive relief need not go beyond and should not go beyond what the special master ordered," Levy told reporters.

Thomas Heiden, another attorney for the players, accused the league of manipulating broadcasters to serve as banks for the lockout.

In addition to the \$707 million, the players are also seeking unspecified damages for other alleged breaches, including digital and adver-

tising rights. The extra NBC game, the players argued, was worth \$39 million, which would entitle them to more than \$15 million based on their 57.5 percent share of TV revenue in the CBA that expired March 11.

The players have also asked for at least three times the total amount of compensation awarded by the court.

The TV revenue fight is a separate battle from the court fight over the lockout, though Doty's decisions will almost surely influence the tack of attorneys for both sides.

Nelson ordered the lockout lifted on April 25, saying it is irreparably harming the players and their careers. The 8th U.S. Circuit Court of Appeals has put the order on hold pending a June 3 hearing in St. Louis.

The NFL asked the appeals court for an expedited decision to keep the issue from lingering too far into the summer, but in the broadcast contracts case the league doesn't have such incentive and Levy made that clear to Doty.

"In our view it's most important that you get it right than you race to get it done," Levy said.

The players, meanwhile, asked for a quick injunction that would keep the \$4 billion off limits to the league until the NFL's first work stoppage since 1987 is settled. Doty described that as a request to "put my thumb on the scale" and push along the process.

"They have illegally obtained a very large thumb that they have inserted in the players' eye," Kessler responded. And in concluding his remarks, Kessler waved

his arms and pointed to Leber, Pitts and Smith, saying: "They're being hurt irreparably."

Later, Kessler stressed to reporters the importance to the players of putting the war chest in escrow: "That makes a difference to players, to fans, to communities right now. Damages, we can enjoy a little bit later if the court needs more time, but we do hope we'll get the injunction right away."

Doty has consistently ruled for the players since he began handling NFL labor cases in the late 1980s. He opened the hearing by chiding both sides for their inability to reach an agreement and achieve labor peace to ensure a 2011 season.

"I'll be honest with you. I didn't think we would have this hear-

ing, and I'm a bit disappointed that we are having it," Doty said. "Judges don't like to make decisions in business matters like this. We like you to do it, but if we have to we will."

He also sounded sentimental when noting this could be the last time he presides over such a hearing since Nelson has the new case.

The 81-year-old Doty tried to keep the mood light, jokingly suggesting to Levy at one point during a disagreement that they should continue their discussion over a beer sometime. Doty also teased Kessler about his penchant for exceeding time limits on his arguments: "When he gets wound up like that, it's awfully hard to get him off the stage."

Contract Bridge

Test Your Play

1. You are declarer with the West hand at Four Hearts, and North, who overcalled in clubs, leads the king of clubs. How would you proceed?

WEST	EAST
♠ 10 7 4	♠ A K 6
♥ K J 10 8 5 3	♥ A 9 4
♦ A 10 6	♦ 9 8 3
♣ 8	♣ A 7 5 2

2. You are declarer with the West hand at Six Hearts, and North leads the ace of clubs, which you ruff. How would you proceed?

WEST	EAST
♠ Q 7 6 5	♠ A K 2
♥ A K J 10 3	♥ Q 9 8 6 2
♦ A 8 4 2	♦ K 10 6 3
♣ —	♣ K

1. Win the club lead with the ace and trump a club. Play a spade to dummy's king and ruff another club, followed by a spade to dummy's ace and still another club ruff. Now cash the ace of spades and exit with either a spade or a diamond.

The defenders can cash two diamonds and a spade, but will then have to yield the last three tricks to your K-J-10 of trumps opposite dummy's A-9-4.

This approach makes it totally unnecessary to guess where the queen of trumps is located or how the suit is divided. If instead you tackled trumps at the start of play, you might misguess how to play the suit and end up down one.

2. This is one of those sure-thing hands where the contract is certain to succeed with proper play. After ruffing the club lead, draw trumps and cash the A-K-Q of spades. If the missing spades are divided 3-3, your worries are over, so let's assume the spades divide unevenly.

Ruff your last spade in dummy and return the diamond three. If South follows low, finesse the eight. Let's say this loses to North's nine. North must then either yield a ruff-and-discard or return a diamond. If he returns a low diamond, insert the ten; if he returns a high diamond, play low from dummy and win with the ace. Either way, you're sure to make the slam even if the diamonds are divided 4-1.

If South plays the nine, jack or queen on the first diamond lead from dummy, win with the ace and return a low diamond. If North follows low, insert the ten; if he follows high, all you lose is one diamond trick. If North shows out on the second diamond lead, play the ten, and South must resign.

This Date In History

Today is Friday, May 13, the 133rd day of 2011. There are 232 days left in the year. Today's Highlight in History: On May 13, 1881, Pope John Paul II was shot and seriously wounded in St. Peter's Square by Turkish assailant Mehmet Ali Agca (MEH'-met AH'-lee AH'-juh). On this date: In 1607, English colonists arrived by ship at the site of what became the Jamestown settlement in Virginia (the colonists went ashore the next day). In 1846, the United States declared that a state of war already existed with Mexico. In 1861, Britain's Queen Victoria declared her country's neutrality in the American Civil War, but also acknowledged that the Confederacy had belligerent rights. In 1917, three shepherd children near Fatima, Portugal, reported seeing a vision of the Virgin Mary.

In 1918, the first U.S. airmail stamps, featuring a picture of a Curtiss JN-4 biplane, were issued to the public. (On a few of the stamps, the biplane was inadvertently printed upside-down, making them collector's items.) In 1940, Britain's new prime minister, Winston Churchill, told Parliament: "I have nothing to offer but blood, toil, tears and sweat." In 1958, Vice President Richard Nixon and his wife, Pat, were spat upon and their limousine battered by rocks thrown by anti-U.S. demonstrators in Caracas, Venezuela. In 1961, actor Gary Cooper died in Los Angeles six days after turning 60. In 1985, a confrontation between Philadelphia authorities and the radical group MOVE ended as police dropped a bomb onto the group's row house; 11 people died in the resulting fire that destroyed 61 homes. In 1994, President Bill Clinton nominated federal appeals Judge Stephen G. Breyer to the U.S. Supreme Court to replace retiring Justice Harry A. Blackmun.
