



# Ferguson selected fire chief

City officials announced this week Craig Ferguson will step in as fire chief for the Big Spring Fire Department and Emergency Medical Services, taking over for Brian Jensen, who retired from the position in January.

Big Spring City Manager Gary Fuqua made the announcement Wednesday, ending the search that began when Jensen retired after more than 23 years with the BSFD.

According to Fuqua, Ferguson was chosen by the Big Spring Selection Committee for the position from more than 28 applicants.

Ferguson said he's excited to accept the position and is looking forward to the new opportunity.

"I feel like this is definitely an opportunity for growth and experience," Ferguson said. "We have plenty of challenges to meet in the coming years."

The biggest challenge facing the Big Spring Fire Department, in Ferguson's opinion, is personnel reten-

tion and longevity, a matter he hopes to be able to address in his tenure.

"It's definitely an issue in our industry, especially with the oil boom pulling guys away to the oilfield," Ferguson said. "We have to look at ways to address it, as well as education and training. This isn't something we're going to be able to fix overnight. We only hire the best. However, we're ready to work toward a solution."

Ferguson began his career as a firefighter and para-

## **CISD coping with state shortfall**

COAHOMA — School officials here are trying to be creative in dealing with an anticipated budget shortfall.

With Coahoma Independent School District expecting to lose more than \$275,000 in state revenue support this coming fiscal year, administrators are looking for ways to save money while maintaining current programs and services.

"We haven't received final word from the state as to exactly how much money we'll lose, but it appears as if it will be approximately \$280,000," CISD Superintendent Amy Jacobs said. "So, we're preparing our budget along those lines ... We're looking for ways to reduce our costs without negatively affecting our programs and classroom instruction."

One area CISD is looking at is balancing class sizes.

Jacobs said there is a noticeable disparity in class sizes between the elementary and secondary levels in the district. Part of that disparity is state-mandated — the Texas Education Agency requires there be no more than 22

### **Big Spring cyclist dies in accident**

SAN MARCOS — A Big Spring man was pronounced dead Monday morning after the bicycle he was traveling on was struck by an 18-wheel truck on an I-35 access road here, according to law enforcement officials.

Jeffery David Stevenson, 40, of Big Spring was pronounced dead at the scene of the accident, which was reported in the 5600 block of the southbound access road of Interstate Highway 35 at 2 a.m., according to accident reports.

The driver of the truck told law enforcement he crested the top of a hill and Stevenson was suddenly in front of him in the center of the right lane. He applied his brakes but was unable to avoid hitting the cyclist.

According to investigators, the bicycle did not have a headlight or rear red





#### Sleep in a cab

LONDON (AP) - A London taxi driver has come up with a novel way of solving the Olympic hotel dilemma: Visitors can sleep in his cab for 50 pounds (\$78).

Cabbie David Weekes had feared that busy traffic throughout the Olympics and special road lanes only for Olympic VIPs would mean fewer taxi fares.

So he's converted his traditional black London taxi into a cozy single bed with a Union Jack blanket.

Weekes said some London taxi drivers think working during the Olympics will be "a total waste of time" because of the congestion. But others like himself will be driving during the games, which run from July 27 to Aug. 12.

Outside parliament earlier this week, hundreds of London taxi drivers protested their exclusion from the special Olympic lanes.

#### Phony massage parlor inspector sentenced in California

SANTA ANA, Calif. (AP) – A Mission Viejo man has been sentenced for impersonating a police officer to demand a rubdown and \$200 at a massage parlor.

Orange County prosecutors say 48-year-old Edward Justin LaPorte was sentenced Wednesday to six months in prison and probation.

Prosecutors say LaPorte is a former police officer from Illinois who was wearing a badge when he entered the Golden Spa massage parlor in Lake Forest on Jan. 31. He told the manager he was investigating a complaint.

Prosecutors say he then complained of back pain, and a masseuse gave him a back rub before LaPorte asked for a frontal massage, which was refused.

The manager called city officials, who sent a real inspector who confronted LaPorte. LaPorte fled, but not before his license plate number was recorded.

#### Man allegedly DWI on a Wal-Mart scooter

HOUMA, La. (AP) — Houma police say a 24-yearold man is accused of driving a shopping scooter while drunk.

Police say Thomas J. Phillip's breath tested at more than double the amount considered legal proof of intoxication under Louisiana law when he was pulled over Sunday.

Police say they got a call about a motorized scooter pulling a wheelchair, and found Phillip on the scooter and a friend of his in the wheelchair. They say Phillip was arrested after allegedly telling police he'd been at a Wal-Mart store and decided to take the scooter for a joyride.

Police say he was booked with operating a vehicle while intoxicated and with theft.

Phillip could not be reached for comment because no phone listing was available for him.

Police say the wheelchair occupant was not cited.

# **Obama's aim in Florida? Keep pressure on Romney**

WASHINGTON (AP) President Barack Obama is trying to keep the pressure on Republican rival Mitt Romney, opening two days of campaigning in Florida in search of military veterans, seniors and unaligned voters in the state's crucial midsection. Romney's wife said no more of her husband's tax information would be made public.

Obama was appearing Thursday in Jacksonville and West Palm Beach as his campaign urges Romney to release more years of his tax returns and keeps a sharp focus on the former Masgovernor's sachusetts tenure as the head of a private equity firm.

"We've given all that people need to know and understand about our financial situation and about how we live our life," Ann Romney told ABC News in an interview broadcast Thursday.

Florida is the largest and most coveted of the nation's Election Day toss-up states, a place where Romney could severely damage Obama's chances of winning reelection. Republicans are holding their national convention in Tampa in August in hopes of giving themselves an edge in the state.

Yet, if Obama can lock down Florida's 29 electoral votes, it would be difficult for Romney to mount enough support elsewhere to capture the White House.

Polls have shown Obama and Romney in a dead heat in the state, which has struggled

with an unemployment rate of 8.6 percent, above the national average, and a still-recovering housing market. Florida provided the deciding margin in George W. Bush's victory in 2000 and the state has been closely contested ever since. Obama carried it in 2008.

Obama aides noted that since 1992, Floridians have cast more than 32.5 million votes during the past five presidential elections and only 57,000 votes have separated the two parties in those campaigns. "Florida's always а close state and we don't expect that to change between now and November," said Obama campaign spokesman Ben LaBolt.

Both sides are jockeying for an advantage.

Obama has repeatedly criticized Romney's private equity firm, Bain Capital, arguing that it promoted the outsourcing of jobs to countries like China and India. And Democrats want Romney to make public past tax returns, noting that the one year for which he has released returns showed investments and offshore accounts in Switzerland and the Cayman Islands.

Several Republicans have joined in the call for more transparency, including several GOP senators and Texas Gov. Rick Perry, who challenged Romney for the GOP nomination earlier this year.

In an interview aired Thursday on WTOL-TV in Toledo, Ohio, Rom-

children are long-time residents of Howard ney said one reason not to release more of his returns was that "the Democratic party and the opposition has all these people that comb through and try and find anything they can to distract from the issues people care about, oftentimes in a dishonest way."

In recent days, Romney has pointed to Obama's record on the economy and noted that the Democrat hasn't met with his jobs council in more than six months. Romney was in Massachusetts Thursday, before an event Friday in Bow, N.H.

Romney's team sees an opportunity to seize on what they say is another Obama misstep on jobs. At the White House briefing Wednesday, press secretary Jay Carney said there was "no specific reason" why Obama and the jobs council haven't met for six months "except that the president's obviously got a lot on his plate.'

Romney, under attack for days over his record running Bain Capital and over his tax returns, went on the offensive this week and lashed out at Obama for saying: "If you've got a business, you didn't build that. Somebody else made that happen.' At a town hall in Ohio on Wednesday, Romney asked audience members who had built or were running a business to stand. "Take that, Mr. President," he said as the crowd cheered.

The president was starting Thursday with a campaign event in



Jacksonville, home to a large swath of veterans and military members connected to Naval Air Station Jacksonville. Before military audiences, Obama has talked about his efforts to bring home U.S. combat troops from Iraq, end the conflict in Afghanistan and pressed Congress to promote job opportunities for veterans.

Obama is expected to make a pitch to seniors in West Palm Beach, where he'll visit Century Village, a condominium complex home to thousands of retirees, long a bastion of reliable Democratic voters.

Obama and Democrats have warned that Romney would seek to implement a budget plan authored by Rep. Paul Ryan, R-Wis., that includes an overhaul of Medicare that would change it into a voucherlike program for those who retire in 10 years.



# The war on soda pop



ew York City, ever the leader in healthy living, is about to ban the sale of super-

sized sodas and other sweetened drinks by its

restaurants, movie theaters, and street

As part of a continuing campaign against obesity, it's going to prohibit beverage containers bigger than 16 ounces.

"Obesity is a nationwide problem, and all over

the United States. public officials are wringing their hands saying, 'Oh, this is terrible," said Mayor Mike Bloomberg. "New York City is not about wringing your hands; it's about doing something."

Good luck with that, Mayor. On the one hand, the ban seems a little like passing a law against shoving beans up your nose. I mean, really. Do we have to make stupid actions illegal before people stop doing them?

Apparently so. Recent studies have found that as many as two-thirds of New Yorkers are overweight, with a third of them classified as obese. (And the numbers for the rest of the country are no better.) Part of the reason is that people are encouraged to buy heavily sweetened

soda in containers the size of fire buckets.

Under the new law, if someone wants to wash down his or her double cheeseburger with 32 ounces of Pepsi or Coke's finest, they'll have to buy two 16-ounce servings.

And if that doesn't sound like a big deal, it's because it isn't. But it will make people — and especially kids — think twice before doing something really dumb. After that, they're on their own.

On the other hand, as much as I hate to admit it, there's something almost un-American about forcing people to do the right thing. We're famous for embracing the freedom to do the wrong thing, as often as we please.

Conservatives are particularly vociferous about this. The ban on supersized sweet beverages is another example of the "nanny state," they say, the government thinking that it knows best.

As one college student, with the clarity of mind typical of college students, told The New York Times in response to the proposed ban: "If people want to drink 24 ounces, it's their decision."

What's next, conservatives ask? Loudspeakers mounted in public parks so that the government can lead mass exercise drills? That's North Korea, not us.

On the third hand, how is forcing people to do the right thing

un-American? We do that all of the time. We pass laws to make people wear seat belts and motorcycle helmets and strap small children into car seats. We prohibit them from buying drugs we think are harmful to them, we limit their freedom to smoke in public and private spaces. We've even made suicide illegal in most places (although that seems to me a classic case of locking the barn door after the horse is way gone).

On the fourth hand, the problem with granting people the freedom to act in self-destructive ways is that the damage they do isn't just to themselves. The societal costs of obesity, for example, are enormous in terms of health care costs, insurance premiums, and lost productivity.

On the fifth hand, how much choice do we really have anyway?From the time they are tykes, children are bombarded with messages that sweet is not merely good but the only good. Frosted cereal, syrupy drinks, and candy treats make up a good share of the foodstuffs advertised on kiddy shows. By the time most kids get through kindergarten, they are brainwashed.

New York is simply trying to give those brains a light rinse. After all, who would really choose to be obese?



# **Confessions of a flip-flopper**

#### Ex-school nurse near Waco gets 10 years for fire

WACO, Texas (AP) — An ex-school nurse in Central Texas upset about a poor evaluation has been sentenced to 10 years in prison for setting a campus building on fire.

Mary Lucille Gutierrez on Monday pleaded guilty to criminal mischief of more than \$200,000 over last summer's fire at Speegleville Elementary School in Woodway. A jury in Waco on Wednesday sentenced Gutierrez to prison and also fined her \$10,000.

Nobody was hurt in the Aug. 9 predawn blaze that caused about \$2 million in damage. Video surveillance showed the 56-year-old Gutierrez going in and out of the school.

Investigators say Gutierrez hoped the fire would lead to a transfer for her or the administrator behind her poor review.

#### Mom, child die in fire, cause sought

HOUSTON (AP) - Investigators say a woman and her 7-year-old daughter have died in a Houston-area house fire that left another family member hurt.

The Harris County Sheriff's Office says the fire was reported around midnight Wednesday near Aldine.

Authorities believe the woman's husband tried to rescue her and their child, but was overcome and suffered burns. He was transported to a hospital. Further details on his condition were not immediately available Thursday.

#### Man accused in smuggling by plane attempt

McALLEN, Texas (AP) - A Mexican man has been accused of trying to smuggle five suspected illegal immigrants to San Antonio via charter airplane.

Prosecutors in South Texas say 39-year-old Jorge Luis Gallegos-Avila remains in custody without bond on charges of harboring and transporting illegal immigrants. He appeared Wednesday before a federal judge in McAllen.

Gallegos-Avila, who also faces a conspiracy charge, was arrested June 20 near McAllen-Miller International Airport. Investigators say he was spotted dropping off five immigrants. The individuals were detained while trying to board the charter plane.

Prosecutors say Gallegos-Avila allegedly picked up the immigrants from along the Rio Grande and took them to stash houses.

#### Texas girl's lighter fluid death ruled accident

DICKINSON, Texas (AP) – Police say the death of a 5-year-old Southeast Texas girl after she drank lighter fluid has been ruled an accident.

Dickinson police said Wednesday that no charges are expected against the mother of 5-year-old Kyndal-Rae Eldridge.

Authorities say the girl died Tuesday at a Houston hospital where she was transported following Saturday's incident. Her 5-year-old sister was treated and released from another hospital after also drinking lighter fluid from the unmarked water bottle.

#### Texas leaders to discuss policies at energy summit

IRVING, Texas (AP) — State leaders and private-sector energy experts will meet at the Irving Energy Summit to discuss developing Texas' natural resources.

Officials also will discuss at the Thursday summit whether the current electricity infrastructure is sufficient to supply power to businesses and residents statewide.

Last month, the Texas Public Utility Commission voted to raise the price cap on wholesale electricity rates by 50 percent later this summer. Advocates hope it will spur construction of new power plants.

### Teens who lost kin to terror unite in camp

NEWBURY, Mass. (AP) – On a windowsill at a Massachusetts boarding school, a white candle burned in memory of a man who died half a world away in Argentina

The man's daughter, Astrid Malamud, was a toddler when it happened.

On Wednesday, 18 years later, Malamud, who barely remembers her father's face, was far from home as she marked the anniversary of his death in their homeland's bloodiest-ever terrorist attack. But the 20-year-old Argentine university student was still close to people who understood her loss.

Beside Malamud's candle, a second wick burned to commemorate another of the 85 victims of the July 18, 1994, bombing at the Argentine Israeli Mutual Association in Buenos Aires.

That man's daughter also was nearby, as were more than 70 other teenagers and young adults who have lost family members to terrorism.

They came from the United States and 15 other countries, gathering at Governor's Academy, about 30 miles north of Boston, for a summer camp known as Project Common Bond. The program, now in its fifth year, is part of the New York-based nonprofit Tuesday's Children, which helps families of victims of the Sept. 11, 2001, terrorist attacks.

The nonprofit's executive director, Terry Sears, said Wednesday that the camp is a way for the children of Sept. 11 victims to reach out to children around the world who've suffered similar losses. She and other organizers said it's a chance for participants to heal and to work on becoming the world's next generation of peacemakers.

The curriculum design comes in part from a mediation and negotiation program at Harvard Law School. It's meant to teach conflict resolution and leadership skills that campers can take home to do projects that make a difference in their communities.

Campers, ranging from 15 to 20 years old and some attending with the help of scholarship money, said it's also a chance to be around others their age who understand them. As they sat talking Wednesday below the flags of their countries, each had a story of a childhood that changed because of a loved one who was lost.

"I think you get independent sooner and you grow up faster because you need to understand things little kids don't understand," Malamud said later. "... I wish we all weren't here. If I could take my flag off of there, I would. Or any flag.

For 19-year-old camper Farah Sarrawi, a Palestinian, the program is a chance to make friends with Israelis. That was something she never expected could happen, she said, after she saw her father die in 2001 when Israeli soldiers shot him on the balcony of the family's home.

"At first, it was hard," Sarrawi said. "But I look at them now as humans ... and I believe that in every country we've got some crazy people that make that conflict."

Sarrawi said she grew up wishing that her father, who used to spin her on the dance floor, was still with her. She said she can't imagine that someday she will get married and not have him there to see it.

BEIRUT (AP) — Anti-regime activists say government forces are shelling a number of neighborhoods in and around the capital Damascus a day after a bomb killed three members of President Bashar Assad's in ner circle. The Britain-based Syrian Observatory for Human Rights reported shelling in number of areas Thursday. It says residents are fleeing parts of the Mezzeh neighborhood after troops surrounded it and clashed with local rebels. The group says rebels damaged one helicopter and disabled three military vehicles.

SOFIA, Bulgaria (AP) — A brazen daytime bombing that killed seven people and injured dozens on a bus full of Israeli tourists was most likely a suicide attack, Bulgarian officials said Thursday. Israel stood by its claim that Iranian-backed Hezbollah was responsible and vowed to hit back.

The identity of the suspected bomber was still unknown but a Michigan driving license that he carried was a fake, Bulgarian Prime Minister Boiko Borisov said.

"We worked on this with colleagues from the FBI and the CIA," Borisov said. "They said that there is no such person in their database."

The suspected bomber appeared on security camera tape for nearly an hour before the Wednesday attack, which gutted the bus at the airport in the quiet Black Sea resort of Burgas, 400 kilometers (250 miles) east of the capital, Sofia.

Borisov said he wants a photo of the suspect taken from the tape released and that a DNA expert is checking the

Joe Arpaio would dismiss his critics in his signature brash style at countless news conferences and in numerous appearances on television.

#### More than 3 million older Americans

WASHINGTON (AP) - More than 1.5 million older Americans already have lost their homes, with millions more at risk as the national housing crisis takes its toll on those who are among the worst positioned to weather the storm, a new AARP report says.

Older African Americans and Hispanics are the hardest hit.

"The Great Recession has been brutal for many older Americans," said Debra Whitman, AARP's policy chief. "This shows that home ownership doesn't guarantee financial security later in life."

Even working two jobs hasn't been enough to allow Jewel Lewis-Hall, 57, to make her monthly mortgage payments on time. Her husband has made little money since being laid off from his job at a farmer's market, and Lewis-Hall said her salary as a school

#### Congress can't resist allure of presidential race

WASHINGTON (AP) — The Senate is spending this week debating, and summarily rejecting, Democraticwritten bills to disclose the names of people who give more than \$10,000 to help elect people such as, say, Mitt Romney, and to take away tax breaks from companies taken over by people such as, say, Mitt Romney, who move operations overseas.

Their latest effort, unveiled Wednesday, would make candidates for federal office, like, say, Mitt Romney, disclose any of their financial holdings in offshore tax havens, such as Bermuda or the Cayman Islands.

Senate Democrats certainly aren't alone in devoting congressional workdays to bills attacking the other party's presidential candidate.

House Republicans last week voted to repeal President Barack Obama's health care overhaul. Next week, they plan to vote on freezing all of former President George W. Bush's tax cuts for another year, including those on the top 2 percent, whom Obama says should pay more. On Wednesday, the House passed a GOP bill ordering Obama to specify how many thousands of defense workers will lose their jobs if the deficit-cutting deal

"Mad Men," AMC's saga of ad exec Don Draper and 1960s America, has won four best drama series trophies to tie with "Hill Street Blues," "L.A. Law" and "The West Wing." A fifth nomination at Thursday morning's announcement ceremony would give it a shot at the record.

Newcomers "Girls" and "New Girl" are vying for honors in the comedy series categories.

The nominations by the Academy of Television Arts and Sciences were to be announced by late-night host Jimmy Kimmel and Kerry Washington of "Scandal."

Kimmel, who will host the Sept. 23 Emmy ceremony on ABC, is stepping in for Nick Offerman of "Parks and Recreation," who was delayed on the East Coast by weather problems.

He should have been after he led off the bottom of the ninth with a towering home run to center for his first major league clout, lifting the Oakland Athletics to a 4-3 victory over the Texas Rangers on Wednesday.

Hicks connected off Michael Kirkman (0-1) for Oakland's majors-leading ninth walkoff win. He became the fourth player in franchise history to hit a game-ending homer for his first career longball and the second this year — joining Derek Nor-

### **Big East drops lawsuit** against TCU, will get \$5M

The Big East has dropped its lawsuit against TCU and will receive the \$5 million it was seeking from the school after it bailed out on a commitment to join the conference.

The Big East filed the suit last month in Washington, claiming TCU failed to pay the league the \$5 million it agreed to when the school reneged on an agreement to become a member and instead joined the Big 12.

Bloomberg News first reported the lawsuit had been dropped. The Big East confirmed it in a statement to the AP on Wednesday night.

"TCU has fully discharged its obligations to the Big East and the lawsuit is amicably settled without admission of liability of any party," said a statement from the Big East.

Conditions of the settlement were not released, but a person familiar with it told The Associated Press the Big East will receive \$5 million from that its "administrators were sur-TCU. The person spoke on condition prised by this lawsuit and believe of anonymity because no announcement was to be made on the agreement.

Earlier in the day, Pittsburgh and the conference announced that the school will pay \$7.5 million to join Syracuse in leaving the Big East for the Atlantic Coast Conference on July 1, 2013. The Big East reached a similar deal with Syracuse earlier this week.

Earlier this year, the Big East and West Virginia settled dueling lawsuits, with the school agreeing to pay the conference \$20 million to start competing in the Big 12 this year.

TCU was never an official member of the Big East but accepted an invite in November 2010 to join in 2012. The Big East contended TCU agreed to pay \$5 million if it didn't. TCU accepted an invite to the Big 12 in October and will start playing in the conference this year.

When the Big East filed suit against TCU, the school said in a statement

### Safety under scruitiny after bomb hoax

DETROIT (AP) - Asthey watched a Detroit Tigers baseball game, 40,000 sports fans were unaware that dozens of police, security guards and federal agents were swiftly searching the stadium for a possible bomb after someone phoned in a threat to 911.

Authorities made no announcement over the public address system. Ushers said nothing to the crowd.

Jason Miller, a sub-

urban Detroit rabbi, left the game against the Los Angeles Angels on Tuesday night and didn't learn about the threat until the following day.

"I immediately started thinking, 'What if?"" he said. "What if they had to evacuate?"

concerns Miller's highlighted a vexing question for organizers of major public events: Should large crowds be informed about unconfirmed threats to their

safety? Or is better to keep the matter quiet until investigators can check into it?

If authorities "evacuate every time there is a bomb threat, there will be a lot of empty places," said Steve Layne of Layne Consultants International, a Denverbased firm that specializes in the protection of libraries, museums and other cultural institutions and public

### With Lin back in Houston, Rockets ready to cash in on \$25M investment

HOUSTON (AP) - Jeremy Lin is starting over in Houston. He will have to explain why he said he would have rather stayed in New York.

The 23-year-old undrafted point guard out of Harvard is scheduled to meet the Houston media on Thursday, two days after the Knicks opted not to match the Rockets' bold threeyear, \$25 million offer sheet.

Shortly after the deal became official on Tuesday night, SI.com reported that Lin had acknowledged in an interview, "Honestly, I preferred New York. But my main goal in free agency was to go to a team that had plans for me and wanted me."

The Rockets certainly did.

"They made a very compelling pitch in terms of what I could bring to the team and for the city," Lin said in a

statement released through the team on Wednesday. "I am also impressed with (Houston owner Leslie) Alexander and the management's commitment to improving the team.'

Houston had Lin in training camp in December, but waived him because the Rockets already had Goran Dragic and Kyle Lowry. He got to New York when the Knicks claimed him off waivers, was briefly dropped to the developmental league, was recalled, and then got his chance to play when coach Mike D'Antoni put him in after the Knicks' record dropped to 8-15.

He scored 25 points in a 99-92 win over New Jersey Nets, and "Linsanity" was born. Soon, New York was in playoff contention, and Lin was having drinks named after him.

Lin said Wednesday that he "loved

this past year with the Knicks and truly appreciate the opportunity that New York gave me," even though the team decided to let him go.

"The way the fans fully embraced me and our team was something I'll always cherish forever," he said. "It was an extraordinary and unforgettable time that was easily the best year of my life."

And now it's on to Houston, which made its biggest move in years and got its man.

The Rockets not only filled a position of need, but also snagged a player who might re-establish the franchise in Asia, where the team enjoyed massive popularity during Yao Ming's career.

Lin is American-born, but of Chinese and Taiwanese descent. His

timing is perfect to capitalize on the NBA's explosive growth in China. He will wear No. 7 for the Rockets, a change from the No. 17 he donned with the Knicks. The team began taking pre-orders for Lin jerseys online on Wednesday.

Lin was the buzz of sports radio in Houston on Wednesday and the topic exploded on social media. About 18 hours after the move became official, the Rockets' Twitter page had picked up 3,000 new followers, and the Facebook page added 10,000 "likes."

**Rockets forward Patrick Patterson** is eager to work with Lin, and feels he is an ideal fit for coach Kevin McHale's system.

"With the type of athletes that we

He worked out of the bullpen July 7 against Seattle before the All-Star break, but this was his first start since beating the Rangers on July 1 at Texas with seven strong innings.

And he was thrilled with how things turned out.

"Everyone calls us scrappy," Blackley said. "Don't sleep on us. All 27 outs, we're going to keep coming."

Inge was 0 for his last 11 and mired in an 8-for-63 funk spanning 17 games before connecting for his eighth home run to snap a 27-game homerless streak.

"You have to give them credit for constantly fighting and then pulling it off," Washington said.
