# **Vandals** hit vets memorial

# Reward offered

Local law enforcement is investigating a report of vandalism and theft at the Big Spring Vietnam Memorial believed to have occurred sometime between Friday night and Sunday morning.

Damage was reported in two areas of the memorial, including the helicopter display. According to law enforcement officials, items were also taken from the display, including a World

# Gas prices up

#### Special to the Herald

Average retail gasoline prices in Texas have risen 1.9 cents per gallon in the past week, averaging \$3.55/g Sunday.

This compares with the national average that has increased 3 cents per gallon in the last week to \$3.73/g, according to gasoline price website TexasGasPrices.com.

Including the change in gas prices in Texas during the past week, prices Sunday were 10 cents per gallon higher than the same day one year ago and are 21.8 cents per gallon higher than a month ago. The national average has increased 23.3 cents per gallon during the last month and stands 11.8 cents per gallon higher than this day one year ago. "Well, for those who have noticed, the national average has perked up slightly in the last

# **Council to consider budget** tax rate on initial reading

sues — the proposed budget and tax rate - during the meeting, giving local residents a chance to voice their opinions on the subjects.

The proposed tax rate – presented to the council by City Manager Gary Fuqua during the

increasing its levy going into the 2012-2013 fiscal year.

However, City Finance Director Peggy Walker said during a recent meeting the rate may need to be adjusted due to an ongoing problem with appraisals. City officials said a definitive rate has not been established by the municipality and Walker could not be reached for comment. According to Howard County Tax Assessor and Collector Kathy Sayles, the effective rate for the city of Big Spring is 86.5 cents per \$100 valuation, with the

The Big Spring City Council is expected to consider first reading of ordinances approving the proposed 2012-2013 budget and setting the ad valorem tax rate during its Tuesday evening meeting, moving forward with its fiscal plan for the coming year.

The council is also expected to hold a public hearing on both isAug. 6 workshop — is 89.5 cents per \$100 property valuation, a 5-cent decrease from the current fiscal package.

The proposed levy is the effective rate — the rate which will raise the same amount of tax revenue as the previous year - and would make the city of Big Spring the only local taxing entity not

# Anglin case affirmed by appeals court

A Big Spring man convicted in 2010 of taking part in a home invasion had his case affirmed by the 11<sup>th</sup> District Court of Appeals this week. Clifford Leon Anglin, 27, was found guilty of charges including aggravated rob-

bery, a first-degree felony — stemfrom the ming June 5 home invasion of a family in the 600 block of State Street following a trial in 118<sup>th</sup> District Court in September 2011.

Anglin was sentenced to 60 Frost of Midland – alleged years in a Texas Department of Criminal Justice facility.

The case was officially taken over by the Court of Appeals Sept. 22, 2011, according to case documents, with a motion for a new trial submitted Oct. 11.

Anglin's attorney — Wayne

in the appeal the evidence presented at trial was insufficient to support Anglin's conviction and that, because it was insufficient, the defendant was denied his due process rights under the U.S.





rollback rate clocking in at 94.7 cents per \$100 valuation. It's unclear at this time which "effective rate" the city council will be voting on Tuesday, as the meeting's agenda does not contain the proposed rate.

City officials said Friday they hope to have the necessary calculations completed in time for the meeting, however, if they are not, the agenda item will likely be tabled until the next meeting.

Among other things, the proposed budget features a pay raise for employees (the first in two years), \$500,000 for water line replacement, set-aside money to purchase property for landfill use and almost \$4 million designated for water purchases.

Among the highlights of the proposed budget are:

• Pay raises — The council approved a 3 percent pay raise for all employees (excepting senior staff) and held the door open for even more pay increases. Faced with an annual turnover rate of about 30 percent, Fuqua said the city has to do something in order to retain its employees.

• Water line replacement — Having replaced water lines on Third and Fourth streets and Birdwell Lane during the current fiscal year, the city will take aim at other areas in the coming 12 months. Assistant City Manager Todd Darden said officials are eyeing the west end of town and the area surrounding the water treatment plant as possible sites for future water line replacement.

• Landfill purchases — Fuqua said the city landfill will be full in about four years, and since the permitting process for opening a new landfill also takes about four years, he said the city is reaching a critical stage in deciding the future of the facility.

Also during Tuesday's meeting, the council is expected to consider:

Final reading of partial residence homestead exemptions for 2012.

Final reading of a measure to assess a 20-percent penalty to defray legal fees on the collection of taxes delinquent as of July 1.

Approval of an agreement with Parkhill, Smith & Cooper Inc. for the wastewater and water treatment plant bond project.

War II web belt and canteen which were on display in the Fallen Soldier Memorial case.

Sgt. Tony Everett, public information officer for the Big Spring Police Department, said damage to the memorial was limited mainly to the AH-1 "Apache" helicopter currently on display.

"Whoever did this actually climbed up onto the Apache helicopter and broke out the window on it," Everett said. "The damage to the window is valued at \$2,000. Once they got into the helicopter, they took the mannequin seated in the cockpit and a clock from inside the display. The mannequin is valued at \$2,000 and the clock is valued at \$5,000."

Aside from the obvious damage to the former military helicopter, Everett said the clock which was taken also poses a health risk.

"According to the member of the Big Spring Vietnam Memorial Committee who filed the report, the clock contains radioactive material," Everett said. "If it should somehow come open, it poses a serious health and safety risk."

Everett said investigators will be reviewing video surveillance footage from the site.

"This vandalism is despicable and in every way imaginable," Everett said. "For our local veterans — especially those who served during the Vietnam era — that memorial is much more than a few military vehicles and displays. It represents something much deeper and more personal. For someone to do this isn't just a show of disrespect for local law enforcement, it's taking a cheap shot at all those men and women who served during that difficult time."

According to Everett, Crimestoppers is offering a substantial reward for information leading to the arrest of those responsible for the attack on the memorial.

"Local Crimestoppers will pay up to \$1,000 for information leading to the arrest of these scumbags," Everett said. "You may remain anonymous and no caller ID is ever used."

Constitution. Anglin and Frost also complained of improper jury argument by the prosecutor.

The affirmation came in the form of a memorandum opinion issued by Chief Justice Jim Wright from a panel including Wright, Justice Terry McCall and Justice Eric Kalenak, upholding the conviction.

"The Texas Court of Criminal Appeals has held that the Jackson v. Virginia legal sufficiency standard is the only standard a reviewing court should apply in determining whether the evidence is sufficient to support each element of a criminal offense that the State is required to prove beyond a reasonable doubt," the memorandum reads. "Accordingly, we will not in-

dependently consider appellant's challenge to the factual sufficiency of the evidence.

"Both (victims) identified appellant as one of the assailants who entered their home on the night of the robbery. Their testimony was unequivocal on the matter. They knew the appellant and recognized him immediately. Appellant states in his brief the testimony of the (victims) was 'tainted,' but he does not provide any explanation for this declaration. We do not see any basis for this assertion."

The memorandum also addresses Anglin's assertion his identification by an accomplice — Brian J. Gonzales, who, according to court records, participated in the invasion — to the crime does not meet the guidelines established by the accomplice witness rule, which provides that a conviction cannot stand on an accomplice witness' testimony unless the testimony is corroborated by other, nonaccomplice evidence.

"Gonzales' testimony about appellant's involvement in the crime was corroborated by (the victim's) testimony. Corroborating evidence need not be sufficient by itself to establish guilt, nor must it directly connect the accused to the offense," reads the memorandum. "Rather, the evidence 'need only tend to connect' the accused to the offense. However, in this case, (the victim's) testimony alone would have been sufficient evidence of appellant's guilt to support a conviction. We hold that the evidence was legally sufficient. Thus, appellant's due process rights were not violated.

"In his third issue, appellant argues that the prosecutor's closing remarks to the jury were improper and constituted reversible error. However, appellant did not object to the prosecutor's comments at trial. When a defendant fails to object to jury argument, he forfeits his right to raise the issue on appeal, even if the issue is constitutional in nature."

According to police reports, numerous suspects — witnesses stated there were between five and seven suspects involved — stormed the home of a Big Spring family, kicking in the side and front doors of the house shortly before midnight June 3, 2010.

The suspects were armed with handguns, according to police reports, while one suspect was armed with a shotgun. All were wearing bandanas or masks to conceal their identities.

"The suspects demanded money, and holding the family at gunpoint, ransacked the house," Big Spring Police De-

"The suspects threatened the adults, and pointed their weapons at the couple's children, who were 2 and 3 years old. One suspect pistol-whipped the male victim in the head while his children were present."

Also indicted in connection with the home invasion during the same grand jury were Felix Lee Jaramillo, 31 and Phillip G. Martinez, 21, both of Big Spring.

Jaramillo was subsequently found guilty, receiving an identical 60-year sentence. Martinez was found guilty by a jury Feb. 2, 2011, and sentenced to 14 years in a TDCJ facility.



# Isaac crossing Gulf with New Orleans in crosshairs

KEY WEST, Fla. (AP) -Tropical Storm Isaac targeted a broad swath of the Gulf Coast on Monday and had New Orleans in its crosshairs, bearing down just ahead of the seventh anniversary of Hurricane Katrina.

The potential for a landfall as a Category 1 hurricane as soon as Tuesday prompted evacuations along a wide area of the Gulf Coast and sent people out to stock up on staples.

"I gassed up - truck and generator", John Corll, 59, a carpenter, said as he left a New Orleans coffee shop Monday morning. He went through Katrina in 2005 and

was expecting a weaker storm this time, adding that he thinks the levee system is in better shape to handle a storm surge than when Katrina hit. "I think the state and local governments are much better prepared for the storm surge and emergencies," Corll said. Isaac blew past the Florida

Keys and was rolling northwestward over the open Gulf of Mexico on Monday. The National Hurricane Center predicted it would grow to a hurricane with winds of between 74 and 95 mph over the warm water and possibly hit sometime Tuesday somewhere along a roughly 300mile stretch from the bayous southwest of New Orleans to the edge of the Florida Panhandle.

That would be one day shy of seven years after Katrina struck catastrophically in 2005, although Katrina was a much stronger Category 5 storm with winds over 157 miles per hour. Isaac is expected to have top winds of around 90 mph when it hits land.

At 11 a.m. EDT Monday, Isaac remained a tropical storm with top sustained winds of 65 mph. Its center was about 310 miles (500 km) southeast of the mouth of the Mississippi River, and it was moving northwest at 14 mph .The size of the warning area and the storm's wide bands of rain and wind prompted emergency declarations in four states, and hurricanetested residents were boarding up homes, sticking up on food and water or getting ready to evacuate.

On the Alabama coast, Billy Cannon, 72, was preparing to evacuate with several cars packed with family and four Chihuahuas from a home on a peninsula in Gulf Shores. Canon, who has lived on the coast for 30 years, said he thinks the order to evacuate Monday was premature.

"If it comes in, it's just going to be a big rain storm. I

think they overreacted but I understand where they're coming from. It's safety," he said.

Although Pensacola seemed less and less likely to get a direct hit, the owners of a Ferris Wheel-like beach attraction were busy Monday removing passenger cabins and readying for a storm they hoped would not prove too disruptive.

"We just want to get back open and get the people back out there," said one of the owners, Todd Schneider.

The storm that left eight dead in Haiti blew past the Florida Keys with little damage.

#### Private Neil Armstrong service planned for Fridav

CINCINNATI (AP) — A private service is planned in Cincinnati on Fridav for astronaut Neil Armstrong, the first man on the moon.

He died Saturday in Cincinnati at age 82.

No other information was released immediately, other than that the service would be private. A spokesman for his family said a public, national memorial service at another time is a possibility.

Ohio Sen. Rob Portman plans to speak at Friday's service. Portman has called the Ohio native "a good friend and adviser."

Portman is in Tampa, Fla., for the Republican National Convention. A spokeswoman says his office is working on travel arrangements to get him back to Cincinnati in time.

Armstrong commanded the Apollo 11 moon landing on July 20, 1969.

#### Ga. murder case uncovers terror plot by soldiers

LUDOWICI, Ga. (AP) – Prosecutors say a murder case against four soldiers in Georgia has revealed they formed an anarchist militia within the U.S. military with plans to overthrow the federal government.

One of the accused troops, Pfc. Michael Burnett, pleaded guilty Monday to manslaughter and gang charges in the December slayings of former soldier Michael Roark and his girlfriend, 17-year-old Tiffany York.

Burnett told a Long County judge that Roark, who had just left the Army, knew of the militia group's plans and was killed because he was "a loose end."

Prosecutor Isabel Pauley says the group bought \$87,000 worth of guns and bomb-making materials and plotted to take over Fort Stewart, bomb targets in nearby Savannah and Washington state, as well as assassinate the president.

I do not claim that nurses are one rung down from sainthood, but we're close. -NewJersey R.N.



have probably never held a hand containing 30 high-card points, but South had them on this oceasion. The bidding went as shown when

Phil Feldesman and Ira Rubin held the North-South cards. Two clubs was an artificial strong bid, and two diamonds was negative. Three clubs identified a genuine club suit, and three diamonds (theoretically artificial) was a second negative response.

Rubin thereupon jumped to five notrump, a somewhat risky bid that had the compensating advantage of coming as close as possible to describing his actual values. Five notrump was not forcing; it allowed North to pass with no values at all But Feldesman realized that he had a bit more high-card strength than his first two responses had indicated, so he very correctly bid six clubs.

West led a trump. Rubin won with the ten and returned the queen of spades! This play rendered the defense helpless. West took the queen with the king and did the best he could by returning a spade to dummy's jack.

Rubin then led a trump to his ace, cashed the A-K of diamonds, ruffed the ace of spades with dummy's nine of trumps, discarded his heart loser on the queen of diamonds and so made six clubs

It is interesting to note that six notrump, the contract reached at most tables, could not be made against best defense. This was in accord with the rule that it is usually easier to make 12 tricks in a suit contract than it is to make the same number at notrump. Since it is very difficult to judge when an exception comes along, it is safer to opt for the suit contract once a fit has been found

# Romo doing fine despite top three receivers being out

next game Tony Romo plays, the Dallas Cowboys quarterback expects to be throwing again to Miles Austin and Dez Bryant.

And hopefully Pro Bowl tight end Jason Witten too.

Yet Romo didn't seem bothered that his expected top three pass-catchers were standing on the sideline injured in his last preseason game. He did just fine throwing to Dwayne Harris, Kevin Ogletree and John Phillips.

"Tony is an outstanding player and he's done it with a lot of different kinds of guys. This is the third or fourth time we've turned the receivers over," coach Jason Garrett said. "He's someone who continues to play at a very high level. It's nice to

ARLINGTON, Texas (AP) - The see him play well and play in a good rhythm with the younger guys. He's worked very hard with the different cast of characters he's been playing with and they've been growing together."

> Romo was 9-of-13 passing for 198 yards and two long touchdowns to Harris in a 20-19 victory over the St. Louis Rams on Saturday night. The Cowboys (No. 15 in the AP Pro32) scored 17 of their points in the three series Romo played in the first quarter.

> There is a void to fill at the No. 3 receiver spot behind Austin and Bryant after Laurent Robinson had 11 TD catches last season and got a big freeagent deal from Jacksonville.

The absence of Austin (hamstring)

and Bryant (right knee tendinitis) provided Harris and Ogletree more time with Romo and an extended chance to prove they can play.

"You get a feeling, you get a sensation you think is good, but what happens then is you've got to be able to go out and prove it," Romo said. "You've got to go out into the game and you've got to execute well. I thought our team did that. Our young guys knew what they were doing and it showed."

Harris, a sixth-round draft pick in 2011, got behind the secondary for a 61-yard TD and then split two defenders while finishing a 38-yard score. Ogletree, going into his fourth season, caught two passes from Romo for 40 yards.

Romo completed passes to six differ-

ent players, including running backs DeMarco Murray (two for 16 yards) and Felix Jones (one for 14). Undrafted rookie Cole Beasley had a 19-yard catch.

"I thought all of them had the kind of games that will bode well for them when we're looking at where we are with our roster spots," owner Jerry Jones said. "Obviously the ones that were in there with the first group made some good plays for us and that was good to see, and good to see Tony having confidence in them, and getting the ball to them."

Phillips, the tight end filling in as the starter for Witten (lacerated spleen),

# T.O. released by Seahawks after only 3 weeks

Terrell Owens' NFL return lasted less than three weeks.

Owens was released by the Seattle Seahawks on Sunday, part of the league-mandated roster reductions from 90 to 75 players.

The 38-year-old receiver posted a message on his Twitter account shortly before 11 a.m. that he had been released and the Seahawks made the move official in the afternoon.

"I'm no longer a Seahawk," Owens tweeted. "I THANK the organization 4 the opportunity, I'm truly blessed beyond belief. Mv FAITH is intact & will NOT waiver."

Owens wasn't the only veteran to get cut by the Seahawks. Offensive linemen Deuce Lutui and Alex Barron both had their veteran contracts terminated, while Seattle waived/injured defensive back Roy Lewis (knee), tight end Cameron Morrah (toe),

defensive tackle Pep Levingston (knee) and linebacker Jamison Konz (shoulder).

Owens signed a one-year deal with Seattle (No. 22 in APPro32) on Aug. 7, following a sterling workout that had coaches and Seahawks staff raving about how good he looked for having not played an NFL game in more than 18 months.

"We really liked the group that we assembled. Terrell came in here and busted his tail and he looked really effective right from the start." Seattle coach Pete Carroll said. "But as we just took a look at our guys that are coming through the program and growing up with us we thought that it would be best for us to stay with those guys."

Owens signed just before Seattle's first preseason game and made his debut in the second week against Denver. But his preseason performance was more notable for the passes he dropped than anything he caught.

Owens dropped a potential 46vard touchdown against Denver on a perfect throw from Matt Flynn. He failed to make a catch in any of his five targets against the Broncos and then had another glaring drop against Kansas City on Friday night.

He finished the preseason with just two receptions — a 40-yard catch from Russell Wilson where Owens had to slow down and lean back to haul in the pass and a 1-yard reception on a screen.

For as impressive as his long catch was in Seattle's 44-14 win over the Chiefs, it served as Owens' only highlight in a Seahawks uniform.

Owens was trying to make a comeback after not playing since Week 15 of the 2010 season.


Smith pitched admirably in a tough spot, allowing five runs and seven hits over three innings while striking out three.
