Tuesday at a location in the 2300 block of Wasson Road by Big Spring Police Department officers, arrest reports stated. According to Sheriff Stan

Parker, the local woman was then transported to the county lockup. "Baker was booked into the

detention center," Parker said. "At approximately 3:50 a.m. Wednesday, Baker was found unresponsive. An ambulance was called and responded to the detention center, where it was determined Baker was deceased." Parker said the woman was

alone in the jail cell when she

was found by one of the facility's jailers. "Baker was pronounced dead by Howard County Justice of the Peace Quail Dobbs," he said. "An autopsy was or-

conducted in Lubbock." Parker said the Texas Rangers are in the process of investigating the death.

"Anytime someone dies while in custody, it's normal procedure to have the Texas Rangers come in and make a full investigation," Parker said. "No foul play is suspect-

ed at this time." Parker declined to comment on Baker's apparent health at the time she was booked into the detention center, citing the open investigation.





#### Obama, Cornyn, Perry to speak at West memorial

WACO, Texas (AP) — The town of West, Texas, is preparing to say goodbye to 14 people who were killed when a fertilizer plant exploded and leveled part of the town.

President Barack Obama, U.S. Sen. John Cornyn and Texas Gov. Rick Perry are set to speak at Thursday's memorial at Baylor University's Ferrell Center in Waco.

Firefighters and other first responders were among those killed when a fire at the plant erupted in an explosion last week. Hundreds of people were injured.

Obama has ordered that the U.S. flag at federal buildings and military facilities in Texas be flown at half-staff Thursday in memory of the victims. He had already planned to be in the state for Thursday's dedication of former President George W. Bush's presidential library at Southern Methodist University.

#### Barbara Bush on Jeb run: 'We've had enough Bushes'

WASHINGTON (AP) — Amid the celebration surrounding the opening of son George W. Bush's presidential library Thursday, former first lady Barbara Bush brushed aside talk of a Jeb Bush run for the White House in 2016.

Appearing in an interview from Dallas on NBC's "Today" show, Mrs. Bush was asked if she thought that Jeb, the former governor of Florida, should seek the presidency.

"He's by far the best qualified man," Mrs. Bush said, "but no."

"We've had enough Bushes," she said, saying "it's not just four families, or whatever."

The Bush family matriarch went on to say she thought there were many worthy candidates, telling anchor Matt Lauer, "There are people out there" who are qualified. Mrs. Bush, who had a reputation for bluntness when her husband George H.W. Bush was president, spoke from the site of the presidential library. On Wednesday, George W. Bush told CNN he thought Jeb Bush should run.

#### South Texas teen gets prison for running drugs

MCALLEN, Texas (AP) — A 19-year-old South Texas man who bragged online about running drugs and recruiting dealers must serve nearly 10 years in prison. A federal judge in McAllen on Wednesday sen-

tenced Erick Ochoa-Rodriguez of Pharr and noted the teen repeatedly used his age to manipulate the justice system.

A jury in February convicted Ochoa-Rodriguez of conspiring to possess marijuana and possession with intent to distribute a controlled substance. U.S. District Judge Micaela Alvarez says Ochoa-

Rodriguez "embraced" life as a drug trafficker and continued to disregard the law. Prosecutors say Ochoa-Rodriguez posted Facebook messages bragging about cocaine trafficking, selling guns and recruiting drug dealers.

Ochoa-Rodriguez was arrested in October after a failed attempt to smuggle bundles of marijuana across the Rio Grande.

#### **Embattled El Paso district** principal resigns

EL PASO, Texas (AP) — An embattled administrator in a West Texas school district investigating a testing scandal has dropped efforts to keep his job.

The El Paso Times reported Thursday that Luis Lova has resigned, effective June 30. The principal of the Center for Career and Technology Education previously denied wrongdoing and said he would appeal a school board decision not to renew his

An outside audit made public in early April found systematic test rigging and grade manipulation in the El Paso Independent School District. Three other principals and four assistant princi-

pals who had been put on leave were reinstated. Lova on Monday submitted his resignation.

Ex-El Paso High School superintendent Lorenzo Garcia is serving more than three years in prison after pleading guilty to fraud in the testing scam.

#### Lubbock man linked to bank, credit union holdups

LUBBOCK, Texas (AP) — Federal prosecutors say tips have led to the arrest of a man suspected of robbing three West Texas banks and credit unions since last summer.

Investigators say 42-year-old Jeffrey Hensley was being held Thursday pending an initial court appearance in Lubbock. Hensley was arrested Monday after a search of his Lubbock residence. He's charged with the Feb. 13 robbery of Alliance

Federal Credit Union in Lubbock. A complaint also links Hensley to the Sept. 14 holdup of First United Bank in Lubbock and the Dec. 8 robbery of Plains Capital Bank in Lubbock. Prosecutors say in all three robberies a suspect

with cash. Details on the stolen money wasn't immediately released. Hensley faces up to 20 years in prison if convict-

#### Texas chiropractor convicted of patient sex abuse

MCKINNEY, Texas (AP) — A North Texas chiropractor has been sentenced to sentences of 23 years in prison after a jury found him guilty of sexually abusing female patients.

The Collin County jury deliberated about five hours before sentencing 44-year-old David Allen Russell of McKinney. He had faced up to life in

District Attorney Greg Willis says sentences of up to 15 years would be served simultaneously, but an eight-year sentence for indecency with a child would be served upon completion of the 15-year

Investigators say some victims were teenagers. Russell didn't testify during his trial involving abuse allegations between 2002 and 2011.

#### Ex-officers get probation in Houston teen beating

HOUSTON (AP) — Two fired Houston police officers accused of beating a black teenage burglary suspect during an arrest that was caught on video were each sentenced Wednesday to two years of probation as part of plea agreements.

Ex-officers Phil Bryan, 47, and Raad Hassan, 43 each entered pleas of no contest to a misdemeanor charge of official oppression. The two men had been set to go to trial on Monday. If convicted at trial, each ex-officer had faced up to a year in iail.

State District Judge Ruben Guerrero accepted the former officers' pleas and sentenced them to two years of deferred adjudication, a form of probation. If the men complete their probations without getting into trouble, their convictions will be dis-

The beating of then-15-year-old Chad Holley prompted fierce public criticism of the Houston police department by community activists, who called it an example of police brutality against mi-

Four officers were charged; one was acquitted last May and another officer's case is still pending. Holley was convicted of burglary in juvenile court.

Defense attorneys and the special prosecutors appointed to handle the case all said the plea deal for Bryan and Hassan was fair.

#### Killer in East Texas slaying, abductions set to die HUNTSVILLE, Texas (AP) — The U.S. Supreme

Court is being asked to block execution of a Texas inmate for killing one of three people abducted from an East Texas convenience store. Richard Cobb is set for lethal injection Thursday evening in Huntsville for the death of 37-year-old

Kenneth Vandever. He and two women were abducted during a robbery almost 11 years ago. The women also were shot and one was raped during the attack that began in Rusk, about 120 miles

southeast of Dallas. The women survived and testified against Cobb and his partner, Beunka Adams. Adams was executed last year. Attorneys for the 29-year-old Cobb have told jus-

tices that a prison expert's false testimony during Cobb's trial in 2004 tainted the jury's decision to send him to death row.

#### Texas State Aquarium announces 1st shark birth

CORPUS CHRISTI, Texas (AP) — One of the younger residents of the Texas State Aquarium is the first shark to be born at the tourist-popular site.

Aquarium officials in Corpus Christi on Wednesday offered details on the female white spotted bamboo shark named Joy. Authorities say the shark was hatched in October and is the only shark ever born at the aquarium.

# **America's insane asylum for frauds**

n the aftermath of the Boston Marathon killing spree by foreign-born jihadists, see-no-evil bureaucrats in Washington are stubbornly defending America's

lax asylum policies. DHS Secretary Janet Napolitano told the Senate Tuesday that the screening process is rigorous, effective and extensive. These people can't handle the

"derivative" status through their parents. After entering on short-term tourist visas, the mother and father (an ethnic Chechen Muslim) won asylum and acquired U.S. citizenship. Next, younger son Dzhokhar obtained U.S. citizenship. Older son Tamerlan, whose naturalization application was pending, traveled freely between the U.S. and the jihad recruitment zone of Dagestan, Russia, last year before the bombers' gunfight in Watertown, Mass., last week left the Muslim terrorist dead.

Though they had convinced the U.S. that they faced deadly persecution, the Tsarnaevs' parents both returned to their native land and were there when their sons launched last week's terror rampage. Authorities will not reveal any details of the sobstories the Tsarnaevs originally spun to win asylum benefits for the entire family.

The whole thing stinks. And it's an old, familiar stench. Immigration lawyers have been working the system on behalf of asylum con artists for decades. The racketeers coach applicants with phony stories and documents from "chop shops" and game their way through "refugee roulette."

Asylum and refugee claimants are being rubber-stamped at all-time-high rates. Government data analyzed by the nonpartisan TRAC website show that "the odds of an asylum claim being denied in Immigration Court reached an historic low in FY 2012, with only 44.5 percent being turned down. Ten years ago, almost two out of three (62.6 percent) individuals seeking asylum lost their cases in similar actions. Twenty years ago, fewer than one out of four (24 percent) asylum applicants won their cases, while three out of four (76 percent) lost."

In June 1997, a federal immigration judge ordered Mezer to leave on

a "voluntary departure order." Mezer ignored him. He joined the New York City bombing plot before being arrested in July 1997 after a roommate tipped off local police.

–Mir Aimal Kansi, convicted in 1997 of capital murder and nine other charges stemming from his January 1993 shooting spree outside the CIA headquarters in McLean, Va., also exploited our insane asylum laxity Despite his history as a known Pakistani militant who had participated in anti-American protests abroad, Kansi received a business visa in 1991. After arrival, he claimed political asy lum based on his ethnic minority status in Pakistan. While his asylum application was pending he obtained a driver's license and an AK-47, murdered two CIA agents and wounded three others.

-Somali national Nuradin Abdi, the al-Qaida shopping mall bomb plotter convicted in 2007, first entered the U.S. in 1995 using a false passport. He entered again illegally from Canada in 1997 and secured asylum on false grounds. Abdi then was able to fraudulently obtain a refugee travel document, which he used to fly to Ethiopia and, yes, Chechnya for jihad training. –Among the convicted Fort

Dix (N.J.) jihad plotters were three ethnic Albanian illegal alien brothers, Dritan, Shain and Eljvir Duka, who snuck into the country through Mexico with their parents. In 1984, the father applied for asylum, but the feds ignored them for two decades. In the meantime, as America showed the Dukas' refugee community unmatched compassion and generosity, the Muslim trio returned the favor by planning to massacre U.S.

As always, political correctness and political pandering are the handmaidens of terrorism.

# The bombers and who gets in

**¬** he uncle of the accused Boston Marathon bombers got the boys right. They were unable to settle into American life, Ruslan Tsarni told reporters from his home in Maryland, "and thereby just hating ev-

eryone who did." He called the two brothers "losers." I prefer the term "weaklings."

As the story thickens with detail, it would seem that the older brother, Tamerlan Tsarnaev, now dead, was the ringleader. So let's concentrate on him.

Tamerlan would seem the model of the mentally unfit immigrant. Here was an accomplished boxer who couldn't roll with the punches of American existence.

Fragile personalities often Making peace with the kind of setbacks that ordinary Americans confront on a regular basis would have made Tamerlan ordinary. Hence, he took the well-trod path of latching onto a radical cause, in his case religious, to inflate his importance.

It takes a whole lot of crossed wires to see blowing up a bunch of innocents as a remedy for what ails. And that's why Tamerlan's actual disappointments are so beside the point.

"Life in America Unraveled for Two Young Men," reads a Wall Street Journal headline. But by

the measuring stick of human suffering — even at the higher American scale — Tamerlan was doing OK.

What were his unravelings? The boys' father had a hard time in America making a living as an auto mechanic. The family lived for a while in subsidized housing. These were not unique circumstances given the sorry state of the economy over the last few years.

Tamerlan reportedly dropped out of college for money reasons. Well, so did Steve Jobs.

Then there was his boxing. "He couldn't get into the Olympics," the family's landlord told a Russian newspaper, "and that was the last thing he really worked hard at." Many more boxers try to get onto the U.S. Olympic team than succeed. By virtue of having become a Golden Gloves contender, Tamerlan would have been the envy of high-school boxers everywhere.

An assimilated American in his situation would have gone to the Small Business Administration for a loan, set up a boxing school in the neighborhood and continued from there. We can well believe Tamerlan's statement about Americans, "I don't understand them." A courageous man would have simply returned to a culture he felt at home in. Many immigrants do.

This story bears strong resemblance to that of Faisal Shahzad, the Pakistani in jail for trying to set off a bomb in Times Square. Like Tamerlan, he had obtained

a green card. He had a wife,

children and good jobs. But his real estate investments didn't pan out, and he lost his house to

foreclosure. Had Shahzad made good money in real estate, we probably would have never heard of him.

But he didn't, and rather than try, try again, he turned to radical Islam. Radical Islam provides fragile male egos a class of inferiors to feel superior to. That would be women. One of Shahzad's solutions included pressuring his soon-to-be-ex-wife into wearing a hijab, a modest Muslim head covering.

At his sentencing, Shahzad puffed himself up, invoking the name of a Muslim warrior from the Crusades.

The federal district court judge dryly urged him to spend the time behind bars pondering "whether the Quran wants you to kill lots of people." It is not America's duty to

give such troubled individuals therapy and a pile of Lexapro. It is to keep them out of a country they can't fit into.

The FBI had already talked to Tamerlan about his jihadist interests. We assume the bureau will not shrug at such cases in the future.



#### Boston bomb suspect admits brother recruited him, then goes silent after Miranda warning

BOSTON (AP) — Sixteen hours after investigators began interrogating him, the surviving suspect in the Boston Marathon bombings went silent: he'd just been read his constitutional rights.

Dzhokhar Tsarnaev immediately stopped talking after a magistrate judge and a representative from the U.S. Attorney's office entered his hospital room and gave him his Miranda warning, according to four officials of both political parties briefed on the interrogation. They insisted on anonymity because the briefing was private.

Before being advised of his rights, the 19-year-old suspect told authorities that his older brother, Tamerlan Tsarnaev, 26, only recently had recruited him to be part of the attack that detonated pressurecooker bombs at the marathon finish line, two U.S.

The CIA, however, had named Tamerlan to a terrorist database 18 months ago, said officials close to the investigation who spoke to The Associated Press on condition of anonymity because they were not authorized to discuss the case with reporters.

The new disclosure that Tamerlan Tsarnaev was included within a huge, classified database of known and suspected terrorists before the attacks was expected to drive congressional inquiries in coming weeks about whether the Obama administration adequately investigated tips from Russia that Tsarnaev had posed a security threat.

only other concern was to avoid a trump loser. After playing a low spade to the king, he returned a spade and finessed the ten. The finesse succeeded, but the bad news was that East had started with the Q-x-x-x. South still had a finessing position over East, but dummy had no more trumps to lead through him.

It was here that the possibility of a trump coup entered the picture. The aim in such situations is to time the succeeding plays so as to wind up in dummy at trick 12. The lead of any card then traps East's queen. To be successful, however, declarer must first reduce his trump length to the same number as East's. Since South still has four trumps

at this point to East's two, he has to ruff two of dummy's cards, even though they are winners. So he leads the diamond jack to the queen and trumps the king. He then plays the club five to the queen, trumps the ten of diamonds and leads the king of clubs to the ace. Eleven tricks have now been

played, and the lead is in dummy as planned. Dummy's last two cards are the 8-6 of clubs, while East has the O-9 of spades and South the A-J. A club lead from dummy obliterates East's apparently invincible trump trick, and the contract is home.

#### Fuel barges explode, causing large fire in Mobile, Ala.; 3 critically injured with burns

MOBILE, Ala. (AP) — A large fire that began with explosions aboard two fuel barges in Mobile, Ala., was rocked by a seventh explosion early Thursday and fire officials said they planned to let the fire, which has injured three, burn overnight. Firefighters from Mobile and U.S. Coast Guard of-

ficials responded after 8:30 p.m. CDT Wednesday to a pair of explosions involving the gas barges in an area of the Mobile River east of downtown, authori-As they were responding, a third explosion oc-

curred around 9:30 p.m., Mobile Fire and Rescue spokesman Steve Huffman wrote in an email to The Associated Press. Additional explosions followed over the next few hours. The Coast Guard said early Thursday that a one-

nautical-mile safety zone had been established around one barge, which it said was "at the dock for cleaning."

Authorities said three people were transported to University of South Alabama Medical Center after suffering burn-related injuries. Huffman identified them as workers with Oil Recovery Co. The three were in critical condition early Thursday, according to hospital nursing administrator Danny What-

#### Survey: Americans' confidence in job market improving steadily from Great Recession

WASHINGTON (AP) — Confidence in the U.S. job market has rebounded to roughly a normal level from its record low after the Great Recession, a trend that could help boost the economy.

Americans increasingly feel they could find a new job if necessary, according to the results of the 2012 General Social Survey, a long-standing poll of public opinion. And fear of being laid off dropped last year from its 2010 peak to roughly its average for the 35 years the question has been asked.

The percentage of Americans who said it would be somewhat or very easy to find a job if they lost theirs rose to 54 percent last year from 46 percent in 2010. The 2010 figure was the lowest since 1983, when the United States was also emerging from a deep recession. On average in the survey's history, about 58 percent of respondents have said it would be very or somewhat easy to find a job.

As layoffs have declined, fewer Americans fear losing their job. Last year, 11 percent of adults

threatening rhetoric from the North, South Korea on Thursday promised its own unspecified "grave measures" if Pyongyang rejects talks on a jointly run factory park shuttered for nearly a month. The park in the North Korean border town of Kaesong is the most significant casualty so far in the recent deterioration of relations between the Ko-

reas. Pyongyang barred South Korean managers and cargo from entering North Korea earlier this month, then recalled the 53,000 North Koreans who worked on the assembly lines. South Korea's Unification Ministry on Thursday proposed working-level talks on Kaesong and urged

#### Presidents past and present converge in Texas, saluting **Bush at library dedication**

DALLAS(AP) - All the living American presidents past and present are gathering in Dallas, a rare reunion to salute one of their own at the dedication of the George W. Bush Presidential Center.

Profound ideological differences and a bitter history of blaming each other for the nation's woes will give way — if just for a day — to pomp and pleasantries Thursday as the five members of the most exclusive club in the world appear publicly together for the first time in years. For Bush, 66, the ceremony also marks his unofficial return to the public eye four years after the end of his deeply polarizing presidency.

On the sprawling, 23-acre university campus north of downtown Dallas housing his presidential library, museum and policy institute, Bush will be feted by his father, George H.W. Bush, and the two surviving Democrats, Bill Clinton and Jimmy Carter. President Barack Obama, fresh off a fundraiser for Democrats the night before, will also speak.

In a reminder of his duties as the current Oval Office inhabitant, Obama will travel to Waco in the afternoon for a memorial for victims of last week's deadly fertilizer plant explosion.

Key moments and themes from Bush's presidency — the harrowing, the controversial and the inspiring — won't be far removed from the minds of the presidents and guests assembled to dedicate the center, where interactive exhibits invite scrutiny of Bush's major choices as president, such as the financial bailout, the Iraq War and the international focus on HIV and AIDS.

#### For GOP and Democrats, deficit reduction is more talk than action as neither side compromises

WASHINGTON (AP) — Liberals' loud objections to White House proposals for slowing the growth of huge social programs make it clear that neither political party puts a high priority on reducing the deficit, despite much talk to the contrary.

For years, House Republicans have adamantly refused to raise income taxes, even though U.S. taxes are historically low, and the Bush-era tax cuts were a major cause of the current deficit.

And now, top Democrats are staunchly opposing changes to Medicare and Social Security benefits, despite studies showing the programs' financial paths are unsustainable.

Unless something gives, it's hard to see what will produce the significant compromises needed to tame the federal debt, which is nearing \$17 tril-

"There's not much of an appetite for deficit reduction," said Bob Bixby of the Concord Coalition, which pushes for "responsible fiscal policy."

"We've got to do a better job going forward of taking your lumps early, but developing these guys and putting them in your lineup," executive vice president Stephen Jones said at the team's draft preview

good idea to surrender picks to grab one of the top prospects, the Cowboys seem to be leaning the other way. "Typically you save those big move ups for

your skill players ... whether it's a corner or a pass rusher on defense, a quarterback, running back, receiver," Stephen Jones said in a radio appearance Tuesday. "You're usually willing to give up a player later in the draft to really get a guy you want. I don't necessarily see that for us this year."

The Cowboys have moved up twice in the three drafts since the whiff of 2009, with what appear to be good results.

Dallas jumped three spots to grab a sliding Dez Bryant late in the

first round three years ago, and the receiver had a breakthrough season in 2012. The Cowboys moved way up last year, from 14th to sixth, and took cornerback Morris Claiborne. He had modest numbers for an underperforming and depleted defense, but was one of the reasons the team felt it had the personnel to switch back to the 4-3 after nearly a decade in the 3-4.

The best of the past four drafts for Dallas was the one time Jerry Jones stood pat. In the first three rounds of 2011, the Cowboys got tackle Tyron Smith, linebacker Bruce Carter and running back DeMarco Murray. All three are expected to be cornerstones in the coming years.

The 2009 draft may not have been Jones' worst. Facing similar constraints in 2001 —

no first-round pick thanks to a bad trade — the Cowboys traded down in the second round and took quarterback Quincy Carter at least two rounds ahead of where he was projected.

Carter was one of many post-Troy Aikman failures, and Jones didn't take another quarterback until 2009, his next truly bad draft. Stephen Mc-Gee went in the fourth round and was never more than a thirdstringer behind Tony Romo and a host of backups.

Still, Jones is undeterred on the idea of trading down if that's what fits.

"There's enough depth in this draft that you sure want to keep your ears open for trades, because you very well could get as good or a better player at another level," Jones said. "We will have

our minds open."

Duncan said. "He's getting his rhythm back. He felt good tonight. He shot the ball well tonight. He looked like Tony of midseason tonight and that's great for us." The Lakers shot 37

percent (9 for 24) in the first quarter, a slight improvement over their 7-for-20 performance (35 percent) in the opening quarter of Game 1. Gasol posted early, tip-

ping in a miss by Howard for the game's opening basket and missing a 5-footer before Duncan blocked his 5-foot hook.

Gasol was 5 for 14 overall, including 1 for 6 in the second half.

"I didn't get into a good rhythm out there." Gasol said. "This first half was better, but in the second half I struggled with my shot. I can't be short on my shots; fatigue kicked in a little bit and I'm fighting through some stuff myself physically. But at this point, we're in fight mode; we'll fight through whatever is on the table. Try to stay alive in this series and fight for our lives."

The Lakers went to the perimeter following the block, resulting in consecutive 3s by Blake and World Peace for an 8-6 lead with 8:23 left in the first quarter.

Ginobili once again energized the Spurs, sparking runs of 13-4 and 10-3 to close the first and second quarters. He had 12 points in the first half and was 3 for 4 on 3-pointers.

"He's playing very well right now," D'Antoni said. "There's not a whole lot of adjustments; we try to push him to his weak hand and try to get up in him, but at some point you just have to man up and just do the best you can."

Ginobili had six points with two assists and a block in 6 minutes to bridge the first and second quarters.

He hit two 3s in the final minute of the second quarter, including one off his initial pass that bounced off DeJuan Blair's head but eventually found its way back to him. He also fed a streaking Leonard for a dunk off a turnover.

"You have to give credit to them," D'Antoni said. "When the ball hits somebody in the head, bounced around and went over to the 3, that didn't help any. That's why they are good. They are a better team."

In the first quarter, Ginobili hit a step-back 3 and then drew the defense and fed Gary Neal for an open 3, which he made to give the Spurs a

28-23 lead at the close of the first quarter. The Lakers went on a 9-2 run to close within 33-32 with 8 minutes left in the first half. Nash opened and closed the

run with jumpers. Nash continued to play after tweaking his hamstring, finishing with nine points in 31 min-



past first base, is 5-1 with a 3.83 ERA in eight starts against the AL West-rival Angels whom he has faced more than any other team since coming over from Japan last season.

Los Angeles second baseman Howie Kendrick, who had two homers and four RBIs Tuesday night — including a walkoff homer in the 11th inning — is hitless in 14 career at-bats against Darvish with seven strikeouts.

The first five Texas batters reached base against Roth in the fateful fourth. Pierzvnski, whose ninth-inning homer gave Texas a 7-6 win in the series opener, broke a scoreless tie with an RBI single and David Murphy singled home another run. One out later, David Carpenter relieved Roth and walked Ian Kinsler to force in a run.

"Obviously, you don't count on scoring nine runs in an inning very often," Pierzynski said. "But Adrian got on base, Nellie got him to third and I was just trying to get a ball up and it kind of got us going. Then we got rolling. It was fun to watch and fun to see guys have nights like

Berkman drove in two more with a two-out single, Adrian Beltre walked and Cruz drove the next pitch to leftcenter for his fifth home run and 24th of his career against the Angels.
