
Murder suspect held here on **\$850, 000 bond**

A Stanton man remains in custody after being charged with murder in the early Monday shooting death of 26year-old Car-

los Guerrero, Sean Smith

Smith was charged with murder in the shooting death of Guerrero, which occurred shortly after midnight Mon-

Official reports state Guerrero suffered a single gunshot wound to the chest during an altercation in the 1000 block of Stadium. He was later pronounced dead at Scenic Mountain Medical Center.

Witness statements identified Smith as the shooter, said Sgt. Tony Everett Big Spring Police Department public information officer.

"(Witnesses) advised he had left the scene driving an older model blue Ford pickup," Everett said. "While additional officers were responding, the suspect vehicle was observed in the 600 block of W. Fourth Street. Officers conducted a traffic stop and arrested Smith."

A .17 caliber rifle, believed to be the murder weapon, was recovered from the vehicle, Everett said.

An autopsy was performed on Guerrero Tuesday morning.

Funeral services for Guerrero, a Snyder High School graduate, will be held at 2 p.m. Thursday at the Holy Trinity Catholic Parish in Big Spring under the direction of Nalley-Pickle & Welch Funeral Home.

Commissioners name Halfmann peace justice

Howard County commissioners named Quail Dobbs' long-time secretary to replace him as justice of the peace for the Sand Springs-Coahoma area.

Linda Halfmann, who has worked in the Coahoma office of Dobbs — the incumbent JP for Precinct 2, Place 2 — for the past six years, was selected for the position during the commissioners' regular meeting Tuesday morning.

She will serve the remainder of Dobbs' term, which runs through Jan. 1, 2015, LLC to perform all necessary County Judge Mark Barr said. "She has basically been

doing the job in (Dobbs') absence. She's been a county employee for about 15 years and she's very well-acquainted with the work at the Coahoma office," Barr said. "To me, she was the logical choice."





chin-only beard. Everywhere I turn I'm seeing Grizzly Adams. Watching a bit of the playoffs this past week I could hardly believe how many baseball players have long, thick, almost fakelooking beards that cannot possibly benefit their

concentration when trying to hit a 95 mph fastball. And, of course, we all know where this passion for prodigious facial hair is coming from, don't we? Once again, we are being influenced by celebrities, namely a distinctive Louisiana family named Robertson. I can't help but think of what my good friend Ashleigh Brilliant said, "I refuse to start thinking independently until I see that everyone else is doing it."

Now don't get me wrong. I love the characters of Duck Dynasty. But what parts of professional wrestling are "real" and where are the lines blurred?

With professional wrestling's outlandish storylines and bad acting, many people think it's highly unlikely that anyone over the age of 12 who has a grasp on reality really believes that someone could kidnap, run over, attack with a baseball bat, etc. a competitor for the sake of a championship belt without some

sort of criminal sentence and psychiatric evaluation. It is no big secret that the matches are scripted weeks in advance and characters are picked for each wrestler by management and/or the storywriters and this is why professional wrestling is tagged as "Sports Entertainment."

And, as hard as you try, you will never be able to shake the image of one Jerry Springer from your mind, will you? Now there's "reality" for you.

But I wonder how much of anything that comes into our living rooms via the 60" HD has legitimate value and merit? It's like it has always been in America, give the people what sells. As long as people are fascinated by these trendsetting and influential characters, bearded or not, the money will keep flowing into the producer's pockets and we will all be subjected to their faces on posters, t-shirts and

There always have been, and always will be, trendsetters that people will follow. I don't guess there is anything inherently wrong with that, in and of itself. But I want to remind you of a simple, yet significant, truth about this potentially dangerous herd mentality. Remember that you are bound to end up in the same place as the one you follow

I don't mean that if you want to be rich and famous you start making duck calls or go on TV half-dressed and dance obscenely. I am referring to the mindset and lifestyle that you will inevitably develop from idolizing or admiring celebrities or influential people in your life. If you're going to pattern your walk after someone, make sure they are a worthy leader.

With all the hoopla about Miley Cyrus and countless others who are, wittingly or not, role models in our society, it would be wise to evaluate your path in light of the more important aspects of life than what you see on TV, because the data proves that most of it doesn't qualify as

Bipartisan self-destruction

events to announce his refusal to negotiate with Republicans, the Department of Defense halted death benefits to the families of troops killed in combat. A Pentagon official blamed "a loosely worded law" for the move, but if it is loosely worded, the admin-

istration could have chosen to make the payments.

Instead, the Fisher House Foundation charity volunteered to front death benefits until the shutdown ends. "After losing a loved one in service to our nation, these families should not have to endure more pain as the result of political squabbling," said the foundation's chairman, Ken Fisher.

Democrats warned how the partial shutdown would halt important cancer research that could save children's lives. House Republicans proposed a bill to continue funding for the National Institutes of Health. Senate Majority Leader Harry

Reid said he wouldn't support the bill. CNN reporter Dana Bash asked Reid: "Given what you've said, will you at least pass that? And if not, aren't you playing the same political games that Republicans are?" When Reid balked, Bash asked,

"But if you can help one child who has cancer, why wouldn't you do it?"

Reid responded: "Why would we want to do that? I have 1,100 people at Nellis Air Force Base that are sitting home. They have a few problems of their own." Nasty.

Last weekend, as the drop-dead deadline to raise the debt ceiling loomed, Reid pooh-poohed a bipartisan compromise measure

pushed by Sens. Susan Collins,

R-Maine, and Joe Manchin, D-W. Va. But then the Democrats' war on taxpayers presented a signal moment. The government had placed barriers around the National World War II Memorial. Enraged veterans and tea party protesters tore down the

barriers. There's no public interest in closing off the monument. Indeed, it took manpower and money to erect the barriers. So there's no real saving. There's just a cheap headline.

Now the story has boomeranged on Democrats. The NBC/ Wall Street Journal poll also found that 51 percent of Americans think Obama "is putting his own political agenda ahead of what's good for the country.' And that poll was taken before last weekend's protests and

other similar stories played out. As I write this, Reid says he is "optimistic" that a deal can be reached. Why would the sage of Searchlight, Nev., want to do that? Maybe, now, it's in his interest.

A short-term debt deal won't end fierce dynamics that killed past bids for a bigger accord

WASHINGTON (AP) — Hold the champagne.

Even if Congress reaches a last-minute or deadline-busting deal to avert a federal default and fully reopen the government, elected officials are likely to return to their grinding brand of brinkmanship perhaps repeatedly.

House-Senate talks are barely touching the underlying causes of debt-and-spending stalemates that pushed the country close to economic crises in 2011, last December and again this month.

Late Tuesday, the GOP-controlled House dropped efforts to craft a bill to raise the debt limit and fully open the government. House members will wait for the Democratic-controlled Senate to act, which could push a final resolution past Thursday. That's when administration officials say federal borrowing powers will be tapped out.

Still, many in Congress expect a resolution, even if it's a few days late. At best, however, lawmakers and the White House will agree to fund the government and raise the debt limit for only a few months. They also will call for yet another bipartisan effort to address the federal debt's major causes, including restricted revenue growth and entitlement benefits that rise automatically.

Philippine quake's heavy damage to historic churches deals big blow as death toll rises to 144

LOON, Philippines (AP) — The earthquake that struck the central Philippines and killed at least 144 people also dealt a serious blow to the region's historical and religious legacy by heavily damaging a dozen or more churches, some of them hundreds of years old. As rescuers reached some of the hardest hit areas

on Wednesday and the death toll from the quake a day earlier continued to rise, images of the wrecked religious buildings resonated across a nation where 80 percent of the population is Catholic. The bell tower toppled from Cebu city's 16th-

century Basilica of the Holy Child — a remnant of the Spanish colonial era and the country's oldest church building — becoming a pile of rubble in the courtyard by the front gate. Other churches on the neighboring island of

Bohol, epicenter of the quake and a popular tourist destination, were also damaged, some beyond repair, while the Bohol seaside town of Loon was a jumble of toppled houses, churches and other

"The heritage old churches are also very close to the hearts of the Boholanos," said Bohol Gov. Edgardo Chatto, using the term for residents of the island.

A look inside the Muslim Brotherhood: Propelled to power by discipline, but hurt by dogma

GAZA CITY, Gaza Strip (AP) — On the day of his induction, Baraa Rantisi was told to wait near a

At the appointed time, a white car drove up. Baraa and the driver exchanged passwords — the name and nickname of an early Muslim leader and Baraa got in.

Then a man in a sparsely furnished room instructed Baraa and two other recruits on the values of Islam. Baraa placed his hand on the Quran, the Muslim holy book, and swore "unwavering loyalty and obedience."

With that oath 10 years ago, Baraa joined the Muslim Brotherhood, an exclusive movement that sees itself on a divine mission to establish Islamic rule.

The story of Baraa, 24, and his extended family shows how the Brotherhood's cohesion and discipline have built it up into a successful movement that seized power in the Arab Spring. But some argue that the same closeness and authoritarian nature has worked against the Brotherhood, which now faces challenges in Egypt, Gaza and Tunisia.

Lawmakers feared that spooked financial markets would plunge unless a deal was at hand and that voters would take it out on incumbents in next year's congressional elections though polls show the public more inclined to blame Republicans.

Feeding concerns were a warning Tuesday from the Fitch credit rating agency that due to the budget impasse it was reviewing its AAA rating on U.S. government debt for possible downgrade. Stock markets gave negative reviews as well, with the Dow Jones industrial average and Standard & Poor's 500 index both dropping Tuesday.

San Francisco Bay Area rail strike again averted; Morning commute to proceed as talks continue

OAKLAND, Calif. (AP) — San Francisco Bay Area commuters again waited late into the night before federal mediators announced late Tuesday that a planned rail strike would once more be delayed and negotiations would continue.

Bay Area Rapid Transit trains were scheduled to run Wednesday, averting would likely would have been a crippling morning commute.

Federal mediator George Cohen said Tuesday night that parties have made some progress in the intense negotiations to avoid a second strike in more than three months.

BART trains ran on a normal schedule Tuesday as unions and management returned to the bargaining table just hours after marathon negotiations ended around 5:30 a.m. The parties had agreed to extend labor talks past a midnight Monday deadline.

Girls, aged 12 and 14, arrested after online post in Florida bullying-suicide investigation

WINTER HAVEN, Fla. (AP) — It was a cold-hearted online post that a Florida sheriff said hastened the arrest of two girls, aged 12 and 14, in the bullying-suicide case of Rebecca Sedwick.

Polk County Sheriff Grady Judd repeated the older girl's Facebook comment almost word for word at a news conference Tuesday.

"Yes, I bullied Rebecca and she killed herself but I don't give a ...' and you can add the last word yourself." Judd said.

Authorities in central Florida said Rebecca was tormented online and at school by as many as 15 girls before she climbed a tower at an abandoned concrete plant and hurled herself to her death Sept. 9. But the two girls arrested were primarily the ones who bullied Rebecca, the sheriff said. They have been charged with stalking and released to their parents.

Rebecca is one of at least a dozen or so suicides in the past three years that were attributed at least in part to cyberbullying.

Technology inspires self-tracking devotees to chart daily lives in excruciating detail

WASHINGTON (AP) — Welcome to the measured

When Tim Davis of Beaver, Pa., tipped the scales at 318 pounds two years ago, he bought a Fitbit gadget to track his physical activity and the Lose It! app on his phone to track calories. He bought a Wi-Fi-enabled scale that published his daily weight on his Twitter feed and turned to other apps to track his pulse, blood pressure, daily moods and medications. At one point, Davis said he was using 15 different apps and gadgets, which he said helped him drop 64 pounds by that following year.


A growing category of devices and software applications promises to measure the mundane details of our daily lives: calories burned, diaper changes, how much and how well we sleep, caffeine intake, kids' studying habits, household chores, even whether a baby is nursing more frequently on Mom's left breast versus her right.

The apps have become increasingly sophisticated, tapping into a niche market of everyday consumers and aspiring amateur scientists to conduct mini-experiments on themselves.

"It's the second-by-second, minute-by-minute changes that really did it," said Davis, 39. "If you're the type of person who likes gadgets and devices and to collect metrics, you're also the kind of person who does not like gaps in data."

Judge to rule on evidence on airman's trial

ABILENE, Texas (AP) — A military judge is expected to rule on Wednesday on a motion to suppress evidence in the court martial of a Dyess Air

and neglecting a toddler who died. The Abilene Reporter-News reports that judge

Col. Donald Eller will rule on whether to accept initial interviews by law enforcement as evidence. The defense questioned the procedures used to question defendant Christopher Perez.

At the time of the alleged offenses Perez lived with Tiffany Klapheke, wife of airman Thomas Klapheke. Klapheke has said her husband's deployment made her too stressed to take care of their three children, which led to the death of her 22-month-old daughter from malnutrition and dehydration in August 2012. Upon his return Thomas Klapheke filed for divorce.

Fake officer among 4 sought in Houston-area holdup

MISSION BEND, Texas (AP) — Authorities are seeking a fake police officer who flashed a badge before three other gunmen robbed a Houston-area home and left one victim slightly hurt.

The Fort Bend County Sheriff's Office on Wednesday didn't immediately update the search for four suspects in the Mission Bend crime.

A man with a badge on a chain approached the house around midday Monday. The homeowner refused to let the man into the home but instead directed him to the garage.

Authorities say three other men barged into the house and held the man, his son and his daughterin-law at gunpoint while ransacking the residence. Sheriff's officials say one victim was hit by a suspect but wasn't seriously hurt.

The gunmen fled with some cash, a handgun and two cellphones.

Man's body found in flooded Austin creek

AUSTIN, Texas (AP) — A man's body has been recovered from a flooded Central Texas creek as investigators try to determine whether the death was related to recent storms.

Austin police on Tuesday night were contacted by a man who was out walking and found the unidentified body in Williamson Creek as floodwaters

Police have no recent reports of a missing person matching the description of the body. An autopsy has been ordered.

The National Weather Service says rain that's soaked the Austin and San Antonio areas this week, leading to flash flooding, should move on by late Wednesday. A chance of showers lingers through Thursday. Experts say some rivers in South Texas will likely remain above flood stage for a few days.

Storms were also moving out of North Texas on Wednesday.

At high noon, Texas DOT to shame toll scofflaws

AUSTIN, Texas (AP) — The Texas Department of Transportation is giving toll jumpers until noon to pay up, or their names go on the Internet.

The deadline is noon Wednesday to avoid a public shaming the department says is necessary in order to recover \$27 million in unpaid tolls.

Officials say they've sent notices to 28,000 vehicle owners who have more than 100 unpaid tolls. Those who don't pay up will find their names published on the TxDOT.gov. Some of the offenders have thousands of unpaid tolls.

In addition to publishing the names of the scofflaws, the department may also ban the vehicles from all toll roads and impound the vehicle if police stop it. TxDOT can also notify county tax assessors to block vehicle owners from renewing their registrations.

Texas man could face 3rd trial in wife's death

BROOMFIELD, Colo. (AP) — A Texas man accused of killing his wife in Colorado will be tried a third time.

Two juries have deadlocked on reaching a verdict for Frederick Mueller of San Angelo, most recently last week in suburban Denver. The Denver Post reports that Mueller will be tried a third time in Broomfield, Colo.

Court records show he is currently facing a second-degree murder charge.

Leslie Mueller drowned near the couple's vacation home outside Lake City in May 2008. Mueller says she fell over an embankment and into a creek during a hike. Prosecutors say the evidence sug-

gests that she was held down in the water.

Report tallies Texas nuclear plant violations

GLEN ROSE, Texas (AP) — An unreleased report says two Texas nuclear power plants each experienced more than 150 lower-level safety violations from 2000 through 2012.

The data were included in a Government Accountability Office report obtained by The Associated Press. It is intended to show that safety violations at nuclear plants vary from region to region, in part because of differing rules interpretations. The West region, which includes Texas, had 2 $\frac{1}{2}$ times the Southeast's rate of lower-level violations

per reactor. The Comanche Peak plant in Glen Rose had two

Brad Wilson, a spokesman for Luminant, which owns Comanche Peak, said the company would not comment on a report it couldn't review.

Lower-level violations pose very low risk. Higher-level violations range from low to high safety significance.

Student kills self at **Austin high school**

AUSTIN, Texas (AP) - A student at an Austin high school has shot and killed himself as others gathered nearby for lunch.

School officials say no one else was harmed in the shooting shortly after noon Tuesday at Lanier High School. Junior Alex Hernandez told the Austin American-Statesman that the boy was sitting alone in a courtyard outside the cafeteria when he pulled out a handgun.

Superintendent Meria Carstarphen says in a statement posted on the Austin school district's website that the school was placed on lockdown before students were released to the custody of their

She says counselors will be provided to meet with students.

Carranza was a Houston officer for three years before the attack in June 2012. He had responded to a traffic accident when he handcuffed one of the drivers and put her in his patrol car. The victim told investigators he waited for others to leave before he assaulted her. He then took her to jail for reckless driving.

Kinky Friedman to run for agriculture commissioner

AUSTIN, Texas (AP) — Humorist and erstwhile politician Kinky Friedman says he's going to run for Texas agriculture commissioner as a Demo-

In a statement released Tuesday, Friedman said legalizing marijuana and revitalizing the hemp industry would be his top priorities if elected. Friedman last ran for agriculture commissioner

in 2010, but lost the Democratic primary. He ran for governor as an independent in 2006 and came in third with 12 percent of the vote. So far only three Democrats have announced

their candidacy for statewide office, including Fort Worth Sen. Wendy Davis for governor and Mike Collier for state comptroller.

Four Republicans are vying for that party's nomination for agriculture commissioner, including J Allen Carnes, Brandon Creighton and Eric Opiela.

Former Houston officer sentenced for sex assault

HOUSTON(AP) - Aformer Houston police officer accused of raping a woman handcuffed in the back of his patrol car has been sentenced to 10 years in prison.

The Houston Chronicle reports Adan Carranza pleaded guilty Tuesday to attempted sexual assault in exchange for the prison sentence.

His attorney, Steven Rocket Rosen, said the 33-year-old Carranza had "a major, major lapse in judgment."



When to Draw Trumps



Opening lead — jack of diamonds. Most deals are played in a suit

contract, and the outcome frequently depends on how wisely declarer utilizes his trumps. There is always the question of whether to draw trumps at once, or, if not, exactly when to do so. Unfortunately, there is no hardand-fast rule that governs every situ-

ation, and declarer is best advised to follow whatever the circumstances dictate. For example, take this deal where

spades. One way of proceeding is to win with the ace and start to draw trumps, playing for a normal 3-2 division, and then hope to lose only one club trick. In the actual deal, this method of

play founders quickly. There would be no way to make the slam once South played two rounds of trumps.

But declarer can make the contract by adopting a superior line of

play. He wins the diamond lead with the ace and cashes the A-K-Q of hearts, discarding a club from dummy. Then he plays the ace and another club. East wins but can do nothing to

stop the slam. Even if East returns a trump, South cannot be prevented from ruffing his three remaining clubs in dummy, and dummy's three remaining diamonds in his hand. All told, South scores seven trump tricks, three hearts, a diamond and a club to finish with 12 tricks.

It may be argued that it is risky to play the A-K-Q of hearts before drawing trumps, as either defender might ruff one of the hearts. But this is only about a l-in-5 possibility, and there is no other approach that comes close to offering as good a chance. The best you can do in bridge is to follow the most promising line of play, and leading three rounds of hearts at the outset conforms to that

SECTION 4. As determined by the County Clerk, the presiding judges shall appoint not less than two nor more than five qualified election clerks to serve and assist in conducting said election; providing that if the presiding judge actually serves as expected, the alternate presiding judge shall be one of such clerks.

SECTION 5. Early voting shall be conducted by personal appearance at the locations, dates and times set forth in Exhibit B attached hereto and during the period early voting is required or permitted by law, being October 21, 2013 through November 1, 2013. Exhibit B shall be modified to include additional or different early voting locations designated by the County Clerk and to conform to the Contract. Applications for ballot by mail must be received no later than the close of business on October 25, 2013. Applications for early voting by mail must be submitted to the following address:





Police charged a man Wednesday with trying to carjack baseball great Cal Ripken's mother in a bank parking lot in Maryland. Aberdeen police

charged Jesse Bowen, 33, of Havre de Grace with attempted armed robbery, attempted armed carjacking, possessing a dangerous weapon, first degree assault and several controlled substance related charges. He was being held without bond.

A man with a handgun approached 75-year-old Vi Ripken on Tuesday afternoon near NBRS Bank in Aberdeen, a town about 25 miles north of Baltimore, police said. Ripken activated a key alarm and the man left.

Ripken wasn't hurt and went into the bank to report the crime, Aberdeen police spokesman Lt. Frederick Budnick said. After police identified a suspect from an ATM photo, officers arrested Bowen about two hours later, Budnick said.

Ripken spokeswoman Katy Ford said Wednesday morning that the family has no comment.

On July 24, 2012, Ripken was taken from her Aberdeen home at gunpoint and returned unharmed 24 hours later. At that time, police released a sketch, photographs and a surveillance video that were believed to show a potential suspect.

In August of this year, Cal Ripken announced a \$100,000 reward for information that helped lead to the capture and conviction of the person responsible for the abduction. No one has been charged in that

Budnick said Tuesday night that the two crimes do not appear to be related.




