Council considers parking ordinance

The Big Spring City Council is expected to "put some teeth" in an ordinance banning parked cars on front yards when it holds its regular bi-weekly meeting at 5:30 p.m. Tuesday in council chambers, located at 307 E. Fourth St.

Cars are already banned from front yards in the city, but the existing ordinance has "a lot of holes" which allows residents to avoid effective punishment, City Manager Todd Darden told council members earlier this month.

The current code calls for a \$5 fine (plus court costs) for anyone parking on their lawn, with subsequent fines of \$5 each succeeding week. In addition, the code has several exceptions that render it almost unenforceable, City Attorney Linda Sjogren told the council.

"So, basically, we charge them \$20 a month to park on their lawns?" asked Council member Raul Benavides. "That's nothing." Mayor Larry McLellan voiced his support for a tougher ordinance.

"I don't think we'll ever get where we want (in beautification efforts) unless we put some teeth in the code," McLellan said. "A \$50 fine would be cheap — \$5 is ridiculous."

The new ordinance is expected to include both more expensive fines

for first offenses and a graduating series of fines for subsequent violations. In addition, exceptions to the ordinance will likely be tightened.

• A remapping of a 22-acre section of Kentwood Addition located west of Morgan Ranch Road and south of East 25th Street.


• An agreement with the architectural/engineering firm Parkhill, Smith and Cooper for the 2014 seal coating project.

Candidate filing has been light so far for the upcoming Big Spring municipal elections.

Coahoma voters will elect three city council members this May. At-large seats currently held by Paulette Lindsey, Zach Johnson and Linda Luce are up for election, although no one had filed their candidacy as of Friday afternoon.

Challengers scarce in school board elections

Staff Writer And they're off ... well, not really.

Candidates filing their intent to run for an area school board or Howard College trustee position have been non-existent unless they were already an incumbent. In the Howard College race, Dr. John Freeman, Marie Ethridge, Adrian Calvio and Dr. Charles Warren – all incumbents — filed the first eligible day to return paperwork. So far, none of the four have challengers. Freeman, Ethridge and Warren all serve at-large trustee positions. Anyone who lives in the Howard County Junior College District may run for those positions. Calvio represents District 3, appointed to the position after Larry McCellan opted to resign in June following his election as Big Spring mayor.

Candidates filing for area public school board races are as follows.

Filing will continue through Feb. 29. Packets can be picked up in the individual school district's or college administration office.

Big Spring Independent School District

Irene Rodriguez, current board president, will seek another term serving District 1. Rodriguez has served on the board since 1994.

Newly appointed trustee Fabin Soreno has also tossed his hat into the race for District 7. Fabin was recently appointed to fill the position left by long-time trustee Phil Furqueron. Furqueron, who opted not to run in the last election cycle, served another year because no one turned up to run for District 7. District 3 representative Ken McIntosh has yet to file.

Coahoma Independent School District

Filing for the Coahoma ISD race has been slow to say the least. No one has stepped up to run in either of the two atlarge positions, including incumbents Lori Martinez and Patric Robinson.

Forsan Independent School District

In the Forsan ISD race, all three incumbents - Glen Graves, Becki Walsh and newly appointed trustee Darren Weaver — have filed their paperwork. As for candidate choices currently, the race stops at the incumbents.

Filing will continue through Feb. 29. Packets can be picked up in the individual school district's or college administration office. Early voting for the trustee election begins April 28 and will continue through Tuesday, May 6.

State looks closer at CPS

AUSTIN, Texas (AP) – Mistakes made by Child Protective Services caseworkers contributed to the deaths of two children and the serious injury of another during the past year, according to state records.

The Austin American-Statesman obtained records from 95 child death cases that were reviewed by the Office of the Inspector General between December 2012 and December 2013.The investigatory body began regularly reviewing child fatalities for the first time in December 2012, after a series of child abuse deaths.

Of those 95 cases, 71 indicated that CPS had been involved with the families before the child's death. CPS was cleared of mistakes in all but two of the cases.

According to records in one case, 1-year-old Fredrickson Aiden drowned in a Burleson County hotel bathtub in March 2013 after CPS "recklessly workers omitted a number of the resources that could have protected the life of the child." The investigator wrote that the caseworker knew the boy was living at the hotel with his mother even though she wasn't allowed to reside with him.

The CPS caseworker closed the case saying she couldn't find the family, even though she knew they were staying there. Aiden drowned while his parents were passed out on drugs. The caseworkers were not punished.

"We reviewed the case thoroughly and found that CPS actions were reasonable and policies were followed," said Patrick Crimmins, spokesman for the state Department of Family and Protective Services. In another case, the investigators' report said that in May 2013, 6-week-old Skyler Joslin died from multiple injuries after a caseworker failed to visit her Camp County family in a timely manner.

UT chancellor Cigarroa says he'll resign

AUSTIN, Texas (AP) – University of Texas System Chancellor Francisco Cigarroa says he will resign after five years leading the 15-campus system in order to return full time to the practice of medicine.

In an email to system staff Sunday night, Cigarroa said he was leaving to be the head of pediatric surgery at the University of Texas Health Science Center in San Antonio. A Monday news conference has been scheduled for Cigarroa to make the announcement with Board of Regents Chairman Paul Foster.

"I knew the day would come when I would return to transplant surgery," Cigarroa wrote in the email, which was obtained by The Associated Press. "The time has come for me to return to my lifelong love and passion — saving lives one individual at a time."

Cigarroa, the system's first Hispanic leader, had maintained his job as a surgeon while overseeing nine academic campuses and six health science centers.

Among the highlights of his tenure was regents' recent approval of a new university in South Texas with a medical school and a new medical school at the flagship campus in Austin. But it also has been marked by tensions between the board and University of Texas at Austin President Bill Powers. The power struggle has reached the state Capitol, where lawmakers are considering whether to impeach regent Wallace Hall Jr. over attempts to force Powers out.

Soldier found in stairwell at Texas post dies

SAN ANTONIO (AP) Investigators are trying to determine what led to the death of a South Texas soldier who was found in a stairwell outside his barracks.

Officials at Joint Base San Antonio-Fort Sam Houston on Monday identified the soldier as 28-vear-old Spec. Ian Patrick Morgan. No hometown was immediately provided for Morgan, who was discovered early Sunday and pronounced dead at San Antonio Military Medical Center.

An autopsy has been ordered. Military criminal investigators have taken over the case, saying the nature and circumstances of the death are being investigated. No additional information was released Monday.

Morgan was assigned to U.S. Army North headquarters, 56th Signal Co.

Wheels stolen from 22 new vehicles at lot

TEXAS CITY, Texas (AP) — Thieves have stolen the wheels from 22 new cars and trucks at a Southeast Texas dealership and left the vehicles on unsteady wooden blocks.

Texas City police are investigating the theft of 88 wheels, including tires, from DeMontrond Chevrolet.

The Galveston County Daily News reported Monday that some vehicles fell off the blocks and have frame damage. No damage estimate was immediately released. Investigators believe the theft happened between Saturday night and Sunday morning when the dealership

SPRING, Texas (AP) Investigators say one person has been hurt when a small plane crashed and flipped near a Houston-area airport.


The Harris County Sheriff's Office says the accident happened Sunday afternoon in a wooded area near Hooks Airport in Spring.

Uncle Ben's recalls rice bags sold in Texas

AUSTIN, Texas (AP) State health officials are reminding consumers about a nationwide recall of Uncle Ben's infused rice products in Texas.

The Department of State Health Services said Sunday that the recalled 5- and 25-pound



bags of Uncle Ben's veterans and nonveterrice are primarily purchased by institutional settings such as schools and prisons. Some warehouse club retailers also stock the bags.

Health officials issued the recall Friday after students and staff in Katy who ate the rice at lunch became ill. Their symptoms included burning, itching, rashes, headaches and nausea. The symptoms passed within two hours.

Health officials say the cause of the illness remains undetermined.

Mars Foodservices US says it voluntarily recalled the products "out of an abundance of caution."

Austin employees of national veterans group quit

AUSTIN, Texas (AP) - A veterans' organization banned in South Carolina and fined in Tennessee is drawing more scrutiny in Texas where it has been operating in several cities for years.

The Austin American-Statesman reports that the employees of the Florida-based Veterans Support Organization in Austin resigned as a group in December, because the funds they collected for veterans were not staying in Texas.

The Veterans Support Organization employs

ans to ask for money in front of businesses and at intersections.

Critics of the group say little of the collected money actually makes it to veterans.

"The funds weren't going where they were supposed to be going," said former Austin chapter manager Robin Woods. "We were telling the public the money was staying here to help local veterans, but the money was going to Florida. . What they were doing wasn't right for Texas or for veterans."

VSO President Richard VanHouten – an Army veteran who lives in a \$548,500 South Florida home, according to county records - received \$259,965 in salary.

AP Investigation: Documents show inconsistent judgments in US military sex-crimes in Japan

TOKYO (AP) — At U.S. military bases in Japan, most service members found culpable in sex crimes in recent years did not go to prison, according to internal Department of Defense documents. Instead, in a review of hundreds of cases filed in America's largest overseas military installation, offenders were fined, demoted, restricted to their bases or removed from the military.

In about 30 cases, a letter of reprimand was the only punishment.

More than 1,000 records, obtained by The Associated Press through the Freedom of Information Act, describe hundreds of cases in graphic detail, painting a disturbing picture of how senior American officers prosecute and punish troops accused of sex crimes. The handling of allegations verged on the chaotic, with seemingly strong cases often reduced to lesser charges. In two rape cases, commanders overruled recommendations to court-martial and dropped the charges instead.

Even when military authorities agreed a crime had been committed, the suspect was unlikely to serve time. Of 244 service members whose punishments were detailed in the records, only a third of them were incarcerated.

The analysis of the reported sex crimes, filed between 2005 and early 2013, shows a pattern of random and inconsistent judgments:

Cases abound of commercial pilots mixing up airports, government and media reports show


WASHINGTON (AP) - Do you know the way to San Jose? Quite a few airline pilots apparently don't.

On at least 150 flights, including one involving a Southwest Airlines jet last month in Missouri and a jumbo cargo plane last fall in Kansas, U.S. commercial air carriers have either landed at the wrong airport or started to land and realized their mistake in time, according to a search by The Associated Press of government safety databases and media reports since the early 1990s.

A particular trouble spot is San Jose, Calif. The list of landing mistakes includes six reports of pilots preparing to land at Moffett Field, a joint civilian-military airport, when they meant to go to Mineta San Jose International Airport, about 10 miles to the southeast. The airports are south of San Francisco in California's Silicon Valley.

"This event occurs several times every winter in bad weather when we work on Runway 12," a San Jose airport tower controller said in a November 2012 report describing how an airliner headed for Moffett after being cleared to land at San Jose. A controller at a different facility who noticed the impending landing on radar warned his colleagues with a telephone hotline that piped his voice directly into the San Jose tower's loudspeakers. The plane was waved off in time.

In nearly all the incidents, the pilots were cleared by controllers to guide the plane based on what



Class is back on the rise in Britain but the profile of the elite has changed with the times

LONDON (AP) - For the past three decades, many Britons had hoped the rigid class system that defined their country from Dickens to "Downton Abbey" was finally dying. Now they fear that class, their old bugbear, is back on the rise.

From 1979, Britain was led for more than a decade by Margaret Thatcher, a grocer's daughter. and then by John Major, the son of a music-hall entertainer. The current leader, David Cameron, is a descendent of King William IV whose Cabinet is stacked with men, like him, from the country's toniest private schools and Oxford and Cambridge universities.

Even entertainment has a more upper-crust flavor these days. A recent Sunday Telegraph story with the headline "young, gifted and posh" said Britain's oldest private schools, such as all-male Eton and Harrow, had become a "production line of young talent," including "Homeland" star Damian Lewis, Benedict Cumberbatch of "Sherlock" and Dominic West of "The Wire."

Major, alarmed by the apparent reversals, recently sparked a flurry of debate with a speech that made front-page headlines.

"In every single sphere of British influence, the upper echelons of power in 2013 are held overwhelmingly by the privately educated or the affluent middle class," Major said. "To me, from my background, I find that truly shocking."

Caffeine common for kids, even preschoolers, study shows; soda, tea and coffee main sources

CHICAGO (AP) — Nearly 3 out of 4 U.S. children and young adults consume at least some caffeine, mostly from soda, tea and coffee. The rate didn't budge much over a decade, although soda use declined and energy drinks became an increasingly common source, a government analysis finds.

Though even most preschoolers consume some caffeine-containing products, their average was the amount found in half a can of soda, and overall caffeine intake declined in children up to age 11 during the decade.

The analysis is the first to examine recent national trends in caffeine intake among children and young adults and comes amid a U.S. Food and Drug Administration investigation into the safety of caffeine-containing foods and drinks, especially for children and teens. In an online announcement

about the investigation, the FDA notes that caffeine is found in a variety of foods, gum and even some jelly beans and marshmallows.

The probe is partly in response to reports about hospitalizations and even several deaths after consuming highly caffeinated drinks or energy shots. The drinks have not been proven to be a cause in those cases.

The new analysis, by researchers at the Centers for Disease Control and Prevention, shows that at least through 2010, energy drinks were an uncommon source of caffeine for most U.S. youth.

It's hard to believe this deal was played as described here, but it happened nevertheless. It occurred in the 1974 national mixed pairs championship in San Antonio.

Obviously, something went very wrong with the bidding when South wound up as declarer in seven notrump redoubled, missing an ace.

The fault is not hard to find. It can be traced to North's five-spade response to Blackwood, ostensibly showing three aces. North incorreetly treated his diamond void as the equivalent of an ace, and it was this departure from the straight and narrow that ultimately led South to bid


seven notrump. Despite this indiscretion, however, South made the grand slam and scored 2,930 points!

West had a difficult choice of opening leads and unluckily selected the nine of spades. A heart lead would have settled declarer's hash immediately — down one, 400 points — while the ten-of-clubs lead would have resulted in down five, assuming best defense, for a loss of 2,800 points!

But the nine-of-spades lead handed South the contract, since it established the eight of spades as an entry to his hand. After taking the first trick with dummy's ten, declarer simply crossed to the eight to cash his diamonds, which would otherwise have withered on the vine.

It is rare indeed for a player to lose 5,730 points because of the wrong choice of an opening lead, but that's precisely what it cost West for choosing a spade instead of a club as his opening shot.
