# Ginners upset over 'master plan'

Count at least two people who don't like what Big Spring's "road map to the future" is envisioning for the community's future.

Big Spring's city council passed two sections of the city's comprehensive master plan during their Tuesday night meeting, laying out a guideline to how the community will deal with possible growth at the airport and north of town over the course of the next 20 or 30 years.

The portion of the master plan dealing with the airport sector was agreed upon with little fuss, but Brad Mikeska and Noel Huff of Big Spring Gin, located on Leatherwood Road just off of Highway 87, had major disagreements with parts of the northern sector plan, which covers

thousands of acres (most not even in the current city limits) stretching from Interstate 20 to N. FM 700.

Under the new master plan, the gin would be surrounded on three sides by land designated as either light residential (single family homes) or medium density residential (apartments and townhouses), an idea the two men found unacceptable.

"If you approve this, you tern will develop if future

better believe that we'll move on," Mikeska said. "There's no way you'd want a cotton gin next to a residential area."

Hoff pointed out the gin used to be located near the railroad tracks in Big Spring in the 1980s, before encroaching development forced officials to move the gin to its current location. Now, the men are fearful the same pat-

#### Jakarta Gov. Joko Widodo leads Indonesian presidential election JAKARTA, Indonesia (AP) — Jakarta Gov. Joko

Widodo held a narrow but steady lead Wednesday in Indonesia's presidential election, according to quick-count results, but his Suharto-era opponent said he had poll data showing him ahead, setting up the prospect of a contested outcome in the stillfragile democracy. The more reputable quick counts showed Wido-

do ahead with about 52 percent of the vote, while Prabowo Subianto had around 48 percent, with 80 percent of the votes tallied. The quick counts tally a representative sample of votes cast around the country and have accurately forecast the results of Indonesian national elections since 2004. It will be around two weeks before votes are officially tallied and the results announced in the country of 240 million people.

"At the time being, the quick counts show that Jokowi-Kalla is the winner," Widodo, known by his nickname Jokowi, told a news conference, referring to his vice-presidential running mate, Jusuf

As supporters of Jokowi claimed victory, Subianto's campaign chief, Mohammad Mahfud, said that three internal quick-count results showed Subianto was ahead. He called on supporters to remain calm as the votes continued to be counted.

"Thank God, all the data from the quick counts shows that we, Prabowo-Hatta, gained the people's trust," Subianto told a news conference, referring to his running mate, Hatta Rajasa.

#### Tensions over conflicts in Syria, Iraq push Arab soccer fans to watch World Cup on Israeli TV BEIRUT (AP) — With the World Cup in faraway

Brazil coming at a time of unprecedented sectarian violence and soaring tension in the Middle East, some Arab football fans have been reduced to watching matches in secret or even — and this is where it gets complicated - on a TV channel owned by Israel.

Since the World Cup kicked off three weeks ago, Sunni Muslim extremists have seized territory in Iraq and Syria and declared an Islamic state. Lebanon has been hit by a spate of suicide bombings. Israelis and Palestinians were pushed to full conflict after the murders of four teenagers. Egypt's political divide grew wider as hundreds of people charged with supporting the ousted Muslim Brotherhood group were convicted of terrorism-related crimes — including three journalists for Qatarowned Al-Jazeera network.

Many accuse the Doha-based network of editorial bias in favor of the now banned Islamic group in Egypt and of Sunni insurgents fighting Shiite-dominated governments in Syria and Iraq.

Qatar's media conglomerate owns broadcasting rights to the World Cup in the Middle East, charging viewers from \$110 to \$320 for a three-month subscription that includes the 64 World Cup matches a tournament that should have been a welcome escape for millions of football fans.

Most fans can't afford to pay for the satellite broadcasts of the World Cup, which was previously shown around the region on state free-to-air channels. Some Egyptians refuse to subscribe to Qatar's channel for political reasons.

### **Hundreds line up at Washington** shops as marijuana goes legal

SEATTLE (AP) — Surrounded by thousands of packages of marijuana, Seattle's top prosecutor sought some advice: Which one should he buy?

A new day, indeed.

Twenty months after voters legalized recreational cannabis for adults over 21, Washington state's first few licensed pot shops opened for business Tuesday, catering to hundreds of customers who lined up outside, thrilled to be part of the historic The pot being sold at four stores in Seattle, Bell-

ingham, Prosser and Spokane was regulated, tested for impurities, heavily taxed and in short supply such short supply that several other shops couldn't open because they had nothing to sell. Pete Holmes, Seattle's elected city attorney and a

main backer of the state's recreational marijuana law, said he wanted to be one of the first customers to demonstrate there are alternatives to the nation's failed drug war.

#### For young nuke warriors, responsibility for fearsome missiles 'weighs on your mind' BERTHOLD, N.D. (AP) — 1st Lt. Andy Parthum

spends his workday 60 feet below ground awaiting the order he hopes never arrives: to launch the most powerful weapon ever devised by man. He is a nuclear "missileer" — an airman who does his duty not in the air but in a hole in the ground.

On both counts — the possibility of firing weapons that could kill millions, and the subterranean confinement — a missileer lives with pressures few others know. It's not active combat, although the Air Force calls them combat crew members. Yet no one can exclude the possibility, remote as it may be, that one day a president will deliver the gutwrenching order that would compel a missileer to unleash nuclear hell.

"Absolutely, it weighs on your mind," Parthum, 25, said on a recent afternoon at Juliet-01, a Minuteman 3 missile launch site on a small patch of prairie 9 miles from the village of Berthold and about 25 miles west of Minot Air Force Base, whose 91st Missile Wing controls 150 of the nation's 450 Min-

It may come as a surprise to some that the Air Force still operates intercontinental ballistic missiles, or ICBMs. And therein lies part of the problem for missileers, who feel underappreciated in a military that has long since shifted its main focus to fighting small wars, striking with unmanned drones and countering terrorism and cyberat-

### VA official: 'I apologize to everyone whose voice has been stifled'

WASHINGTON (AP) — A top official at the Veterans Affairs Department says he is sorry that VA employees have suffered retaliation after making complaints about poor patient care, long wait times and other problems.

James Tuchschmidt, the No. 2 official at the Veterans Health Administration, the VA's health care arm, apologized on behalf of the department at a congressional hearing Tuesday night.

"I apologize to everyone whose voice has been stifled," Tuchschmidt said after listening to four VA employees testify for nearly three hours about VA actions to limit criticism and strike back against whistleblowers. "That's not what I stand for. I'm very disillusioned and sickened by all of this.' A federal investigative agency said Tuesday

The council finally approved the two sections of the master plan by a 4-1 vote. Councilman Marvin Boyd voted against the proposal, while members Carmen Harbour and Raul Marquez Jr. were both absent from Tuesday's meeting.

Boyd said the council should have followed the planning and zoning committee's recommendation to accommodate the gin owners.

"I don't feel it was right that they said, 'OK, we're going to do it this way,' and then not have it in the plan (Tuesday)," Boyd said. After the meeting,

McLellan said the master plan was a vital guideline to accommodate future growth, but added it could be tweaked in the future if necessary.

"This is our road map to guide us as we deal with growth," he said. "Nothing is set in stone. Right now, we're looking at potential growth for the city and how we should adjust our thinking on how we address that growth."

about is how to overcome it." Those words were spoken by a man who had just scaled the Matterhorn, a towering 14,692 feet above the pretty town of Zermatt, Switzerland. This legendary mountain in

the Pennine Alps on the border between Switzerland and Italy is a formidable challenge for any mountaineer, but an especially remarkable feat for Jamie Andrew, 44, from Edinburgh, who not only scaled the mighty

peak but, incredibly, did so 15 years after losing his hands and feet to frostbite during a mountaineering accident. "I've wired my brain so when

I come across an obstacle, my first instinct is to think how to get round it," explains the father-of-three, whose story began 15 years ago, when he and his friend Jamie Fisher were trapped half way up a mountain by a storm. Fisher and Andrew had

climbed the north face of Les Droites in the Mont Blanc massif but found themselves beset by deep snow and winds of up to 90 mph. So bad were conditions, the pair were marooned on Les Droites for four days and nights; a length of time that proved too much for Fisher, who died of hypothermia on the last night. Although rescuers eventually managed to come to Andrew's aid, his hands and feet had been so badly affected by frostbite, he was forced to have them amputated.

Stories of men and women who have overcome tremendous odds to become successful or realize a dream serve as an inspiration to all of us. There is so much to be gleaned from observing the lives of others as they strive to succeed in spite of great obstacles.

Benjamin Franklin, the 15th of 17 children of a poor candle maker, had only one year of schooling. Therefore, he taught himself four languages, science, finance, politics, the classics, and how to write for publication. He went on to become a best educated and world famous

school advised Lucille Ball to try another profession because she would never make it as an actress. She went on to have a history-making television series and eventually owned her own movie and television studio.

In 1962, an executive of Decca Records made the following statement about a singing group: "We don't like their sound. Besides, groups playing guitars are on the way out anyway." He was talking about the Beatles.

Jack Canfield and Mark Victor Hansen, co-authors of the world renowned Chicken Soup for the Soul® book series, were turned down by 33 of New York's biggest publishing houses in the first month of their efforts to promote their labor of love. They heard, "Anthologies don't sell." "We don't think there is a market for this book." "We just don't get it." "The book is too positive." "It's not topical enough." All totaled, they were rejected by 140 publishers. To top it off, their agent said, "I can't sell this book -I'm giving it back to you guys."

They finally found someone willing to take a risk on their project, Peter Vegso, president of Health Communications Inc. The first books were published on June 28, 1993, and had become a Christmas favorite by the end of December. Word of mouth soon led to a groundswell of popularity. To meet the demand, the publisher had to subcontract printing.

With more than 60 million copies sold to date, 48 titles in print in the United States and translations in more than 30 languages, Chicken Soup for the Soul® has made international publishing history. At one time or another there have been at least eight Chicken Soup for the Soul® titles simultaneously in the top 50 on the USA Today best-selling books list. Jack and Mark hold the record in The Guinness Book of World Records for having the most books on the New York Times bestseller list at one time; seven books on May 24, 1998.

The heroes just keep coming. Just this week we have been inspired by Helene Neville who won't let four bouts of cancer slow her down. The 53-yearold grandma just finished the

third leg of her 10,000-mile run around the perimeter of the lower continental 48 states. Neville began the third leg of her run 68 days ago in Marathon, Florida, roughly 2,000 miles from where she finished in Portland, Maine. Neville, who has been a nurse for 29 years, said she began running marathons after she was diagnosed with Hodgkin's lymphoma in the 1990s. During that time, she said she underwent three brain surgeries to treat abscesses.

"When they said I wasn't going to get better, my immune system was shot, I went home and signed up for the Chicago Marathon," she said. Though her family was on hand with an ambulance, she finished the 26.2-mile race in about four hours and 20 minutes.

She began realizing her goal to run the perimeter of the United States in 2010, with a 93-day iog from California to Florida. But in 2012, she was diagnosed with T-cell lymphoma, so she didn't start the second leg of the voyage — from Canada to Mexico — until 2013, she said. Now in remission, Neville just has one leg to go, which she plans to complete in 2015.

It has often been said that you're never really defeated until you give up. Theodore Roosevelt said, "It is not the critic who counts, nor the man who points out how the strong man stumbled, or where the doer of deeds could have done them better.

"The credit belongs to the man who is actually in the arena, whose face is marred by dust and sweat and blood; who strives valiantly; who errs and comes short again and again; who knows great enthusiasms, great devotions; who spends himself in a worthy cause; who, at the best, knows in the end the triumph of high achievement, and who, at the worst, if he fails, at least fails while daring greatly, so that his place shall never be with those timid souls who know neither victory

nor defeat." You may not agree with anything I've said, but I column as I see 'em.

### **Obama: I can't work with others**

n January, President Barack Obama outlined his strategy for 2014. "I've got a pen, and I've got a phone," he said. The president planned on using his pen to sign executive and administrative orders and his phone to call outside groups — not Congress — to

rally behind his pet programs.

Obama forgot to mention his third favorite instrument — the teleprompter. Rather than working with Congress, Obama's second term is all about blaming Congress for whatever goes wrong. In that

can't-do spirit, Obama mocked House Speaker John Boehner's threat to take legal action against the White House's imperial ways. "So sue me," Obama said to laughter. As long as House Republicans are "doing nothing, I'm not going to apologize for trying to do something." Pretend for a moment that

George W. Bush had said that. Then imagine what Rep. Nancy Pelosi, D-Calif., would have said. But it's hard to imagine Bush crying uncle, because he was able to woo across the aisle, even to persuade Hillary Clinton and John Kerry to vote for the Iraq War.

"He throws out things he knows we won't go for," noted Don Stewart, spokesman for Senate Minority Leader Mitch McConnell. Then he grouses when the GOP won't go along.

In the "sue me" speech, Obama railed against the GOP for not supporting a minimum wage increase, paid family leave and pay equity for women despite his administration's sorry record in that department. Where Obama could garner bipartisan support approving the Keystone XL pipeline and ending the medical device tax and Obamacare's employer mandate — Stewart added, he is not engaged.

The lawsuit, Boehner wrote in an opinion piece for CNN, would be aimed at Obama's failure at "faithfully (executing) the laws of our country." To wit, the president unilaterally has rewritten parts of his health care law and made recess appointments deemed illegal by the Supreme Court unanimously. The administration's most

well-known act of obstruction is the Deferred Action for Childhood Arrival directive.

In essence, the president enacted the DREAM Act — to stop the deportation of unlawful residents who came to the U.S. as minors — without Congress.

(When Obama visits Texas for three fundraisers this week, he

won't go to the border, where thousands of unaccompanied youths have been detained. Spokesman Josh Earnest told reporters, "The president has a very good sense of what's happening on the border." Translation: There's no opportunity to

blame the GOP.) Walter Olson of the libertarian-leaning CATO Institute told me that he likes some things the administration has done unilaterally but that the statutory authority may be "on thin ice." Olson also observed that after years of railing against activist courts, suit-happy Republicans don't quite have the high ground.

Neither does the can't-workwith-others president. As a constitutional law professor, Obama should not need the House Judiciary Committee to tell him, "If the President disagrees with that law, he must convince Congress to change it." Now he's arguing with himself — gearing up to deport children, encouraged by his own directive.

### Obama heads to Texas with no plans to visit border

For President Barack Obama, the humanitarian crisis at the U.S.-Mexico border is increasingly becoming a political liability, giving Republicans a fresh opportunity to question his administration's competence and complicating the debate over the nation's fractured

immigration laws.

Still, Obama is resisting calls to visit the border during his two-day fundraising trip to Texas, where he arrives late Wednesday afternoon. Instead, Obama will hold a meeting hundreds of miles away in Dallas to discuss the crisis with faith leaders and Texas officials, including Republican Gov. Rick Perry.

Obama's trip comes one day after he asked Congress for \$3.7 billion in emergency spending to get more resources to the border.

The roundtable discussion in Dallas is seen by the White House as a way to address the immigration issue while avoiding awkward optics at the border. Tens of thousands of unaccompanied children have arrived there in recent months, many fleeing violence in Central America, but also drawn

by rumors that they can stay in the U.S. White House officials say most are unlikely to qualify for humanitarian relief and will be sent back to their home countries.

Obama's decision to skip a border visit is likely to provide more fodder for the Republicans and the handful of Democrats who say the president hasn't responded quickly and forcefully enough to the mounting crisis.

Rep. Henry Cuellar, D-Texas, raised the prospect that Obama's failure to take a firsthand look at the border crisis could be akin to former President George W. Bush viewing the devastation of Hurricane Katrina from the air instead of on the ground.

"I'm sure that President Bush thought the same thing, that he could just look at everything from up in the sky, and then he owned it after a long time," Cuellar said on Fox News. "So I hope this doesn't become the Katrina moment for President Obama, saying that he doesn't need to come to the border. He should come down."

Perry, a possible GOP presidential candidate in 2016, has been scathing in his criticism of Obama, saying the White House has failed to respond to his re-

peated warnings about a flood of minors at the border.

"I have to believe that when you do not respond in any way, that you are either inept, or you have some ulterior motive of which you are functioning from," Perry said Sunday.

The president was traveling to Texas from Denver, where he also raised money for Democratic candidates.

Obama spokesman Josh Earnest said the White House wasn't worried about the optics of the president traveling to Texas without visiting the border. Officials also pointed to Obama's request to Congress on Tuesday for additional resources at the border as a sign of the president's engagement in the crisis.

If approved by Congress, the funding would go to increase detention, care and transportation of unaccompanied children, help speed the removal of adults with children by increasing the capacity of immigration courts, and increase prosecution of smuggling networks. The money also would help increase surveillance at the border and help Central American repatriate countries border-crossers sent back from the United

States.

Democrats and some Republicans on Capitol Hill seemed open to the emergency spending request. Senate Majority Leader Harry Reid, D-Nev., said the Senate would act on it this month.

But Republicans criticized Obama for pulling back on plans to pursue legal changes that would allow the administration to send the minors back to Central America more quickly. The proposals had infuriated immigrant advocates, who say the changes could result in

harsh treatment of kids and eliminate their legal protections.

"He just decided not to do that because of the pushback he got from some in his own political base," said Sen. John Cornyn, R-Texas. "We need to solve the problem, but you don't need to just ignore the cause of the current crisis. And that requires more than just appropriating \$3.7 billion for additional judges and the like."

The border crisis has added a new wrinkle to the stalled immigration debate in Washington. With no sign that House

Republicans planned to move forward on a comprehensive overhaul bill passed by the Senate last year, Obama announced that he would seek to address the matter through executive actions.

Republicans say it's that same approach that has led to the current crisis. The GOP argues that Obama's 2012 decision to allow some young people brought to the U.S. illegally to stay in the country has fueled the rumors in Central America that all of the minors crossing the border can stay.

### 2 replica Columbus ships in Texas to be demolished

CORPUS CHRISTI, Texas (AP) — Replicas of two ships used by explorer Christopher Columbus have fallen into disrepair at a Texas museum and will be demolished.

The Corpus Christi City Council on Tuesday learned more about the dire condition of the Pinta and the Santa Maria following a marine survey. The wooden ships are in dry dock at the Corpus Christi Museum of Science and History.

City business liaison Alyssa Michelle Barrera cited repair cost concerns.

City staffers will prepare a contract to demolish the ships, which were donated to Corpus Christi by Spain. The ships have been in Texas since the 1990s as part of the celebration of the 500th anniversary of the Columbus voyage.

The Columbus Sailing Association will be allowed to salvage parts for another replica in Corpus Christi, the Nina.

### Texas man dies in fall at New Mexico state park

DEMING, N.M. (AP) — Authorities in southwestern New Mexico say a 50-year-old Texas man is dead after falling approximately 75 feet from a mountain in Rockhound State Park southeast of Deming.

The Deming Headlight reports relatives of Scott Allen Coleman of Houston had reported him missing Monday night after he went for a walk that afternoon and never returned.

A Deming Police Department report says family friends located Coleman in the park and that Luna County sheriff's deputies then found Coleman was badly injured after falling.

Responders were carrying Coleman down the mountain when he stopped breathing and could not be revived.

Coleman was in Deming to attend a brother's funeral.

### Boat used in rescue as van goes into Houston bayou

HOUSTON (AP) — Seven construction workers have been rescued from a van that crashed through a highway barrier and plunged into a Houston bayou.

Emergency personnel using a boat and extending a ladder reached the victims Wednesday morning.

Authorities did not immediately release names of the men, who were transported to a hospital to be treated for apparent minor injuries. Officials believe the workers were headed for a construction site when the white van went out of control and hit the water. At one point the seven men were seen on the roof or hanging out of the windows of the van left swamped up to the windows.

Authorities are trying to determine what caused the accident.







Taking the stand Tuesday in a role he'll resume on Wednesday, Sterling alternately declared his love for his wife, Shelly, with tears and then demeaned her as a woman intimidated by the "bad NBA" and incapable of handling such a large financial transaction.

Sterling, himself a lawyer, exerted his control over the proceedings in the non-jury civil trial from the moment he took the witness stand and accused lawyer Bert Fields of asking him a compound question. Judge Michael Levanas reminded Sterling that he was appearing as a witness, not an attor-

Fields, one of the best known entertainment lawvers in Los Angeles, spoke so softly that Sterling complained he couldn't hear him.

"Tellme what you want to accuse me of," Sterling told Fields during a 90-minute afternoon appearance. "Stand up and be a man."

The 80-year-old billionaire also called doctors who've declared he has Alzheimer's disease "hired guns," pleaded a faulty memory about some of his most con-

### Astros hit 3 leadoff homers in 8-3 win over slumping Rangers

ARLINGTON, Texas (AP) — Chris Carter is hitting under .200 this season for the Houston Astros. Still, he is hitting the ball hard — and deep.

Carter led off two innings with home runs, Springer had one inning-starting long ball and the Astros beat the Texas Rangers 8-3 on Tuesday night, getting a game closer to escaping the AL West

The Astros go for a threegame series sweep on Wednesday after winning only twice in 19 games against Texas last season. They have won four straight overall against their instate rival for the first time

"It's just nice to beat them this year," Carter said. "They beat up on us pretty bad last

Carter started the sixth with a 409-foot blast into the seats in left field to make it 4-2. Two innings later, his 17th homer of the season was almost as long but just cleared the wall and the outstretched glove of center fielder Leonys Martin for a

6-3 lead. Nine of Carter's last 17 hits have been homers. It was the third multihomer game this

season for the .194 hitter. "He hits them in bunches. Let's hope this is one of those bunches," manager Bo Porter said. "On the home run to left field, he was getting extension. He's a big, strong man and he's hitting the ball well."

Jose Altuve had two hits, two stolen bases and a sacrifice fly. The All-Star second baseman matched Houston's franchise record with 28 consecutive stolen bases without being caught while pushing his AL-leading total to 41. He leads the American League with 126 hits and a .341 batting

Houston went ahead to stay with two runs in the first inning off Phil Irwin (0-1) who was making his Rangers de-

Brad Peacock (3-5) struck out five while allowing two runs and six hits over 5 2-3 innings.

Except for 21 days, and none past mid-April in either of their two seasons since switching leagues, the Astros have been at the bottom of the fiveteam AL West. After taking the first two of this three-game set, they are within a game of fourth-place Texas, which has lost nine of its last 10 games

and 17 of 20. Springer, the rookie center fielder, led off the third with his 18th homer — a 430-foot shot to the hill in center field.

Martin led off the Texas second with his fifth homer before adding a sacrifice fly and a triple. Jake Smolinski had an RBI double in the seventh



> celiac disease can lead to anemia. osteoporosis and lymphoma. In children, celiac disease can slow growth and weaken bones. There is often a genetic component. On the other hand, some folks are simply gluten sensitive. Eating gluten may make them uncomfortable or tired, and when they cut gluten out of their diet, they feel more energetic. "Cheating," however, will not cause the severe symptoms of celiac disease.

Everyone is familiar with the story of the Trojan horse, and the adage about what not to do with a gift horse. Then too, there is the horse of a different color, and just plain horse sense. All of these apply in one way or another to today's deal. North-South would have been

better off in five clubs, which was a shoo-in, but South very reasonably bid three notrump. All would have

been well had South had the queen or six of clubs. As it was, though, a natural block in the club suit prevented declarer from running the suit.

After taking East's jack of hearts with the king, South paused for thought. If he ducked a club and East won the trick, a heart return would sink the contract if West had started with five hearts. This did not appeal to South, a man who did not like taking second money. So declarer decided to try to enlist

West's aid in untangling the clubs. At trick two, he crossed to the king of clubs and returned a heart to the nine, losing to West's ten. South expected West to now cash his good hearts, on one of which he would discard a club from his hand to unblock the suit. But after West took the ten and

cashed the ace, he also paused to think things over. He was wellversed in horse stories, and he thought this smelled suspiciously like at least a couple of them. So, instead of cashing another

heart, he shifted to the ten of spades, and South's well-conceived plan bit the dust. Regardless of how he continued, he could not score more than seven tricks, so East-West ended up plus 200 — and that ain't hay!



"It means everything," Griner said. "Being here in Phoenix, playing in front of the home crowd, that's awesome." Griner was among

ond-year player Elena Delle Donne will be able to join her in Phoenix. Delle Donne, who was the leading vote-getter in the Eastern Conference, has been sidelined with a flare-up of Lyme Disease and has only played once for Chicago in the past 10 games.

"It is really sad that she's dealing with this right now," Griner said of Delle Donne. "We all want her better. I hate that she's going to miss the All-Star game again."

Delle Donne missed last year's All-Star game when she suffered a concussion a few days before the contest.

Joining the Chicago

star in the Eastern Conference starting lineup are New York's Cappie Pondexter, Indiana's Tamika Catchings, and Atlanta's Shoni Schimmel and Angel McCoughtry.

Schimmel will become just the third reserve to start an All-Star game, according to STATS. Sue Wicks did it in 2000 and Ruthie Bolton in 2001.

Schimmel is the third straight first-year player to be voted to start an All-Star game. "For the fans to go out

and vote, I definitely have to give it to them. For them to have my back and sit there and vote for me every day is just something they took pride in."

### **Big-serving Isner** wins on grass courts

NEWPORT, (AP) — John Isner rode his fierce serve to another victory on Newport's grass courts, defeating Wayne Odesnik 6-3, 7-6 (6) Tuesday to reach the second round of the Hall of Fame Tennis Championships. The 6-foot-10 Isner

## Scolari apologizes for team's World Cup failure

(AP) — Brazil coach Luiz Felipe Scolari apologized to fans for failing to lead the host to the World Cup final, saying the "catastrophic" defeat to Germany on Tuesday marked the "worst day" of his professional life.

"I have to apologize for the negative result, for not being able to reach the final as we all wanted," Scolari said, speaking calmly after the humiliating 7-1 loss.

Scolari took full responsibility for the drubbing, and said he knows that it's very

BELO HORIZONTE, Brazil likely that his career may be defined by what happened at the Mineirao Stadium — even though he also led Brazil to the 2002 World Cup title.

> "Naturally, if I think about my life as a player and as a coach, I think this was the worst day of my life," Scolari said. "I know I'll probably be remembered for losing 7-1 to Germany, for Brazil's worst loss. But it was a risk I knew I was taking. I have to take responsibility for it. Life must go on for everybody."

The coach said he has to find a way to learn from the "catastrophic loss" in front of the home crowd. He said there are "no excuses" for what happened, not even the absence of star striker Neymar, who was ruled out of the tournament because of a fractured vertebra sustained late in the match against Colombia in the quarterfinals.

"They (Germany) probably would have done it with Nevmar playing," Scolari said. "I don't think there's any reason for us to suppose that with Nevmar it would have been different."

He said the "very high qual-

ity" of Germany was the reason for Brazil's disappointing elimination at the home tournament.

"They took advantage of their chances, they are very good," he said.

Scolari was vivid on the sideline as Brazil pressured Germany in the first few minutes. After Brazil conceded the third goal, he kept asking players to be calm, but as the Germans scored for the fifth time, the coach sat down on the bench and only sparingly came back to the sideline.

"It was one after the other, I

think everyone blanked out, Scolari said. "There was nothing we could do. We pan-

icked." Scolari declined to discuss his future, and the president of the Brazilian football confederation has always said that Scolari would remain as head of the national team no matter what.

However, the coach is unlikely to remain with Brazil after Saturday's third-place match in Brasilia. He had said in the past that he would like to retire after coaching in the World Cup.
