Are your fair entries ready?

Fair entries should be submitted from 11 a.m. to 5 p.m. next Thursday at the Expo Building. Quilt show entries may be submitted at the museum next Wednesday from 1 to 5 p.m. and next Thursday from 9 to 12 and 1 to 5. (Quilts of all ages, designs and techniques are eligible to be either judged or displayed.)

Fair exhibits will be open for viewing all day Friday and Saturday, Aug. 18 and 19. Ribbons and cash awards will be given in all categories.

Drug trial underway

The trial of Clarence Gregg Nelson on charges of delivery of cocaine continued at press time this week.

A nine-man, three-woman jury is hearing the case in 64th District Court.

Nelson is charged with selling marijuana to an undercover narcotics agent last October on a farm near Dimmitt, and with allegedly introducing undercover agents to another suspect later in a cocaine transaction.

The state started rebuttal testimony Wednesday.

Judy Ann Inman, 29, of Beckham County, Okla., formerly of Dimmitt, pleaded guilty to tampering with governmental records by accepting food stamps to which she was not entitled because of her husband's earnings.

Inman agreed to repay \$2,021 to the Texas Dept. of Human Services during five years of felony probation. She will also pay \$3,183 in fines, court costs, probation reporting fees and other administrative costs. She was ordered disqualified from food stamps for the probation period of five years.

Christopher Brooke Burrus, 19, of Hereford, was assessed ten years of felony probation and was ordered to pay local feed lots and insurance companies \$14,046.30 after pleading guilty to cattle theft last February.

Burrus will also pay \$4,933 in (Continued on Page 5)

Woman suffers severe burns

A woman identified as Sherry Powers of Hereford received second- and third-degree burns over 90% to 100% of her body when fire destroyed a small abandoned house south of Easter Wednesday morning.

An unidentified man who spotted the smoke reportedly pulled the woman from the burning house and turned in the fire alarm at 10:34 a.m. Dimmitt volunteer firemen found the home totally engulfed in flames when they arrived.

After being taken to Plains Memorial Hospital by ambulance, the victim was transported to a Lubbock hospital via CareLink helicopter, County Dispatcher Jerry Jansa reported.

The house was located about a mile north of the Bud Hill Feedlot on FM 1055.

City starts budget work

Preliminary figures, submitted Monday night for the Dimmitt Aldermen to consider as they begin work on the 1989-90 fiscal year budget, balanced out to a slight surplus.

City Manager Reeford Burrus told the aldermen that the "rough draft" estimates presented by department heads show total projected revenues of \$1,408,496 and proposed expenditures of \$1,404,873, leaving the city with an estimated \$3,623 more income than expenses.

Proposed capital outlay items listed in the rough draft included \$30,000 for seal coating of streets, \$22,500 for the police department, \$18,275 for computer hardware/software for the utility department, \$18,000 for the motor grader, \$10,000 for a payment on the track loader, \$7,000 for new dumpsters, \$7,000 for the administrative department, \$6,235 for a back hoe payment, and \$4,500 for the fire department (a portion of which (Continued on Page 5)

Robinson is honored



ter a survey revealed a need for education about drugs and alcohol.

In 1985 the staff at Central Plains MH/MR conducted a survey of teachers, doctors, lawyers, judges, police officers and hundreds of other people in nine area counties including Castro.

"Through the survey, we found out people wanted services for the youth, with an emphasis on drug and alcohol prevention," said Rhonda Wilkins, supervisor of ASAP and YSAPP.

"When we found out what was needed for the area, we began applying for grants. On Sept. 1, 1987, we received a \$70,000 grant from the Texas Commission on Alcohol and Drug Abuse (TCADA). With these funds we started up ASAP," Wilkins said.

ASAP, the first of the two programs to be implemented in this area, is designed to help youth between the ages of 12 and 18 and is featured in Hale, Lamb, Parmer and Castro counties. It is geared

toward "prevention and intervention" rather than a "treatment" program, and the MH/MR staff works with "kids that are high risk," she said. The "high risk" kids do not yet have serious drug or alcohol-related problems, but the potential for those problems does exist, she explained.

"For the fiscal year beginning Sept. 1, 1988, we received another \$140,000 grant, so we could also expand the program to include Floyd County," Wilkins said.

The group continued its efforts toward obtaining additional funds, in hopes of starting a program to work with younger children, and were able to form the YSAPP program this year. The agency received a \$102,000 grant through the Dept. of Education under the Drug-Free Schools program to fund a prevention program for students in kindergarten through eighth grades.

"With these funds we will be offering the YSAPP program in Parmer, Castro and Hale counties. We decide where we'll provide the services by looking at the need in a particular county, the relationship we have with the schools and how the county is utilizing current programs available to local people," Wilkins said.

The three major components of the programs are counseling, education and alternative services, according to Judy Ichtertz, education/alternatives counselor who will be working with the programs in Dimmitt and Friona.

"With YSAPP we're hoping to target younger kids. ASAP goes for older high school kids, about sophomore age," Ichtertz revealed. "The drug and alcohol education for ASAP and YSAPP will be offered to registered clients and their guests after school. The alternative services will be offered after school."

The counseling component is family-based therapy—getting the whole family involved, not just the adolescent or youth.

All registered clients of the program participate in intervention

counseling. Those individuals who require treatment, detoxification or more intensive services are referred to an appropriate source for assistance.

"The education component involves some alcohol and drug education, or use and misuse of drugs, but it focuses mainly on positive peer pressure, coping skills, decision-making skills and self-esteem," Wilkins said.

The drug/alcohol education component is a six-week course, made up of six one-hour sessions. The course is designed to increase awareness of drugs and alcohol and reduce the risk of experimentation and/or abuse; to assist individuals in developing skills for avoiding drugs; and to facilitate the development of decision-making skills, stress management and conflict resolution.

"Alternative services are community-based activities where the registered clients have an opportunity to use the skills they acquire through education," Ichtertz said.

This component features a youth-sponsored activity group that provides weekly events. Each activity is designed to promote self-competency skills and to provide positive substance-free experiences.

Individuals who are registered as "formal clients" are required to participate in all three components of the program; however, participation in education and alternative services is not limited for clients. YSAPP staffers currently provide drug/alcohol education to all secondary schools in three communities. The majority of those in this program do not participate in other YSAPP components and are not formally registered as clients of the program.

The group's organizers will meet with the school boards in the county and plan to offer the education component to two grades in the local elementary schools—probably the third and fifth grades.

"By offering it in the same grades each year, we will be able to hit every child that comes through the school system," Ichtertz said. "Hopefully, we can make a difference!"

Pete Laney is honored

State Rep. Pete Laney received the Texas Association of Extension Home Economists' Friend of the Extension Award at the annual state conference in San Antonio Friday.

Rep. Laney, a strong advocate for the family, was recognized for his outstanding support of family legislation. He has introduced bills for establishment of rural hospital districts, supports rural development, secondary and higher education and anti-drug and drug enforcement legislation.

Rep. Laney is currently serving as chairman of the House State Affairs committee. He serves as a member of six other committees. He has served as speaker pro tem, and chaired and served on several committees.





Sen. Bivins reports on session

The slogan on the new Texas license plates won't be "The Friendship State." Instead, it will be "Texas, the Savings and Loan Star State," Sen. Teel Bivins joked as he started his public "town hall" meeting in Dimmitt's city hall Friday.

Sen. Bivins gave a public report on the major issues which the Texas Legislature dealt with during its regular biennial session and special session this year.

Twenty-three local residents attended the meeting.

Regarding the controversial Public Education Finance Bill — in which the Legislature raised teacher salaries over the next two years but failed to appropriate the money for the raises, throwing the financial burden to local school districts — Sen. Bivins explained that he fought against and voted against the bill.

He said he had introduced a school finance bill "which I thought would have been equitable," and that the bills adopted by the Senate and House were referred to a conference committee to have their differences ironed out.

But he said the bill that came out of the conference committee on the last day of the session "bore no resemblance" to either of the two earlier bills.

"The bill that came out (of the conference committee) heavily favored the Rio Grande Valley school districts... and mandated increases in teacher pay," he said. "I feel like if we are going to do that, we should appropriate the money for it."

"On the last night of the session, I stood on the floor and made these points, but my view did not prevail," he said. "I felt badly about that, but I was not able to convince my fellow members in the Senate."

He said the Panhandle "fared pretty well" in the regular session, and attributed that partly to a team approach taken by the elected representatives from this area. He explained that he and Sen. Dick Waterfield of Canadian had weekly breakfasts during the session with the Panhandle's five state representatives to work out strategies which they felt would benefit the Panhandle as a whole.

He said he also was pleased that for the first time in the last four

sessions, the Legislature lived with in its means by instituting no new taxes and letting the temporary ones expire.

"No one even wanted to refer to the 'T' word," he said.

One of the major issues this year, he said, is "the criminal justice crisis." He reported that the Legislature had authorized 50,000 new prison beds, and decided on general obligation bonds as a means of financing them.

"You'll get to vote on it," he said.

On the issue of rural medical service, he said, "On the Medicaid program, we changed the provisions to give small hospitals direct reimbursement rather than using the controversial DRG (diagnostically related groups) formula" of reimbursement, he said.

Rural hospitals have been fighting the DRG approach, which paid

them less for the same services to Medicaid patients than it paid to metropolitan hospitals.

As to the Legislature's failure to enact reform of the state's Worker's Compensation Act, Sen. Bivins said, "There's no other way to grade the Legislature except give them an 'F' on that issue. He said the Texas Trial Lawyers Association—"without a doubt the strongest lobby in the state"—blocked the reform efforts.

He said he expected Gov. Clements to call another special session on Worker's Compensation.

During a question-answer session, the state government drew sharp criticism from two in the audience.

"The Texas Dept. of Agriculture has greatly raised its rates on scales, to get the operating money that the Legislature didn't appropriate them," said Bill Clark, general manager of Dimmitt Agri Industries.

"You say the Legislature got by without raising taxes, but let's call a spade a spade," Clark said. "Why are the businesses being forced to pay the money to support an agency that should be funded by taxes, if the agency is beneficial? We're getting tired of the people in Washington and Austin telling us what they're doing for us and make us pay for it."


Sen. Bivins said that the new scale fees represent "a rifle approach vs. a shotgun approach" to financing—a "user fee" type of charge.



Police Calls
