# Reliever route ahead of schedule

*TxDOT: Southern* leg should be done by next summer

Beginning Monday, a portion of South Wasson Road will be closed to traffic for a week as construction crews begin re-grading and applying overlay from Dogwood Street to Rockhouse Road.

According to Texas Department of Transportation (TxDOT) officials, the work will lower the road in this area in order to meet the clearance height for the new overpass being constructed for the Highway 87 Truck Reliever Route.

Construction of the reliever route, a fourlane divided highway skirting around the west side of Big Spring, is far ahead of schedule with an estimated completion date of summer 2016, TxDOT officials said. Originally, the \$44.8 million project was projected to be complete by early 2017. Completion of the \$18.4 million Interchange, which will allow traffic from Highway 87 to access Interstate 20, also is expected about the same time as the reliever route.

In the next month, work on the Highway 33 overpass is expected to begin. In order to facilitate the construction, TxDOT will divert construction site. Northbound traffic will be South 87. diverted to a service road while traffic heading south will follow the Highway 87 flyby bridge before rejoining the the main roads.

The flyby bridge, which is still under construction at this time, is expected to be open to traffic by mid- to late-August, TxDOT officials stated.

The southern route is just one part of a longterm goal to shift truck traffic from heading Mexico, the United States and Can- TxDOT to contract approximately through downtown Big Spring to west of the ada. Traffic along Highway 87 is expected to grow in the next several decades as trade increases between trade route reaching from Laredo, Texas, through West Texas to the mid-west United States and on to Canada.

Envisioned almost 30 years ago, funding for the reliever route project seemed elusive until 2011 when the Texas Legislature authorized approval came after the passage of Proposition 12 by the Texas voters. However, the Big Spring project would not have been possible without donation of road improvement funds by several communities in other TxDOT districts.

# **Police: Theater gunman was** 'drifter' who planned to escape

LAFAYETTE, La. — The movie theater gunman who stood up about 20 minutes into the showing of "Trainwreck" and began firing into the crowd, killing two people, was described as a drifter from Alabama whose escape plan was thwarted by police officers who arrived almost immediately, authorities said Friday. The gunman killed himself. Nine people were wounded in the attack

Thursday night. The gunman, identified as 59-year-old John Russel Houser, fired at least 13 times from a handgun, police said. He had parked his car by the theater's exit door and initially tried to escape by blending into the fleeing crowd, but turned back when he saw police heading inside from the parking lot, authorities said. Officers tailing him back into the theater then heard a single gunshot and found him dead inside, police said. "It is apparent that he was intent on

shooting and then escaping," Lafayette Police Chief Jim Craft said. Authorities did not release a motive.

They said Houser had been in the Lafayette area since early July, staying at a mo-

tel where they found disguises, including

glasses and wigs. His 1995 blue Lincoln Continental had a license plate on it that didn't match the car.

Police said the gunman was by himself and started the rampage by shooting the two people sitting in front of him. The victims were identified as 33-year-old Jillian Johnson and 21-year-old Mayci Breaux. At least one theatergoer described the at-

tack, saying an older man stood up about 20 minutes into the 7:10 p.m. showing of "Trainwreck" at the Grand 16 theater in Lafayette and began shooting. "We heard a loud pop we thought was

a firecracker," Katie Domingue told The Advertiser. "He wasn't saying anything. I didn't

hear anybody screaming either," said Domingue, who added that she heard about six shots before she and her fiance ran to the nearest exit, leaving behind her shoes and purse.

Stories of heroism emerged with presidential hopeful Gov. Bobby Jindal, who traveled to the scene within hours of the shooting, telling reporters that a teacher who was in the theater jumped in front of

a second teacher, taking a bullet for her.



The second teacher then managed to pull a fire alarm to alert other moviegoers, he said. "Her friend literally

jumped over her and, by her account, actually saved her life," Jindal said. President Barack

Obama was briefed on the shooting aboard Air Force One by Lisa Monaco, his homeland security adviser, while on his way to Africa for a two-nation visit, the White House said.

Obama asked his team to keep him updated on the investigation and the status of those wounded. He also offered his thoughts and prayers to the community and to the families of those killed.

The shooting took place a week after the man who shot and killed 12 people at a movie theater in Aurora, Colo., was convicted and on the very day a jury was cruel enough to justify the death penalty. But jurors must first hear the defense's arguments for a life term before deciding whether he'll be sentenced to death.

Nine people ranging in age from their late teens to their late 60s were wounded, Craft said. At least one of those was in critical condition. Two were released from the hospital. The condition

of the others was not immediately known.

Houser had been arrested and ticketed for several offenses in the past, ranging from arson to selling alcohol to a minor to speeding, authorities said. In Alabama, records show Houser had four speeding tickets and one noseatbelt ticket between 1981 and 2003. It's not clear where the arson allegedly occurred.

Alabama court records show Houser filed a small claims court lawsuit in 2004 claiming he was injured when he donated plasma at a Phenix City donation center. He asked for \$1,800 to pay his emergency room bill and for a narcotics prescription. The case was settled, according to court records.

He had been married once but did not currently have a wife. Police said they had talked to his family in Alabama but he appeared "seemingly estranged" from them.

"It just seems like he was kind of drifting along," Craft said. He had an uncle that once lived in Lafayette, but he died 35 years ago. "We don't know why he decided to stop and stay in Lafayette."

State police superintendent Col. Michael D. Edmonson said there were about 100 people inside the theater at the time of the shooting. Keys, shoes and purses were all left behind.

Early Friday, about a dozen law enforcement personnel were gathered at a Motel 6 in Lafayette, where Houser had been staying. A bomb squad swept the room before going in as a precaution.

At one point, an officer

carried out a cardboard box from the room and other officers could be seen knocking on neighboring doors. Edmonson added that

police believe the gunman fired shots only at the theater and had not waged an attack anywhere else beforehand. He said police saw

He said police saw something suspicious inside the shooter's car and that a bomb-sniffing dog "hit on three different locations" in the vehicle, "so out of an abundance of caution we brought in the bomb squad."

No explosives were found in the car or in the theater complex.

Lafayette is about 60 miles west of the state capital of Baton Rouge. Outside the movie theater complex hours after the shooting, a couple of dozen police cars were still at the scene, which authorities had cordoned off with police tape as onlookers took photos with their cell-phones.

A small group of theater employees stood outside the police perimeter. A man who identified himself as a general manager declined to be interviewed: "We would appreciate it if you could give us some space," he said.

Landry Gbery (pronounced Berry), 26, of Lafayette, was watching a different movie, "Self/less" at the time of the shooting when the lights came up and a voice over the intercom told everyone there was an emergency and they needed to leave.

Gbery said he never

heard gunshots, and assumed the emergency was a fire until he got outside and saw a woman lying on the ground.
"I was really anxious

for everybody at that point," Gbery said. "Fortunately I was lucky. I took the right exit."

Tanya Clark was at the concession stand in the lobby when she saw people screaming and running past her. She said she immediately grabbed her 5-year-old daughter and ran.

"In that moment, you don't think about anything," Clark, 36, told The New York Times. "That's when you realize that your wallet and phone are not important."



# Did You Ever Wonder: Jacob's burial

oseph had Jacob's body embalmed. It is hard to understand the reason. Embalming was part of an Egyptian idolatrous belief about meeting their gods in their hereafter. Embalming was definitely against

Hebrew beliefs. The Hebrews believed that at death the soul rises to God and the body

should be returned to the dust from which it was formed as quickly as possible.

Pharaoh ordered the traditional Egyptian 70-day mourning period for Jacob, and the whole nation mourned. This was probably because of Pharaoh's friendship with Jacob and because Joseph held such a high position in Egypt. But there may also





Egyptians. God had blessed them because of Jacob's presence in Egypt. Joseph asked Pharaoh for permis-

sion to go to Canaan to bury his father. And his brothers and their families would go up with him.

Pharaoh sent with him all of Pharaoh's household servants and ministers. He also sent many horses and chariots, showing much pomp and ceremony. They gathered on the east side of the Jordan and held a sevenday mourning.

This was in Edom, the land of Esau. The size of this gathering made the people of Edom fear that an army had invaded. However, these men were dressed in royal garments. They also saw Joseph's crown placed on the bier to show homage to his father.

Probably they sent spies into the camp and found that the mourning was for Jacob, who was Esau's brother. Stories have it that Esau and his family also joined the mourning and placed their crowns on the bier.

Esau and his family accompanied Jacob's sons to the Cave of Machpelah in Hebron. Once there, Esau challenged Jacob's right to be buried in the burial cave of the Patriarchs. Esau was the firstborn, even though he was estranged from their father.

The way to dispel Esau's claim was to prove that the deed to Machpelah was in Jacob's possession. But the deed had been left in Goshen in Egypt. Jacob's son, Naftali, was known for his speed as a runner; he ran back to Egypt to fetch the deed.

Tensions must have run high during the long delay while Naftali made the run to Egypt. Cushim, a son of Dan, was deaf. He could not hear the conversation; he could only judge by people's actions and expressions on their faces.

When he understood, he swung a club at Esau so hard that it severed Esau's head from his body. The head rolled inside the cave and landed at the feet of Jacob.

Naftali arrived with the deed. which satisfied Esau's sons that the right belonged to Jacob. However, the head rolling into the cave seemed to be an ominous sign, so it was left there.

Scholars have studied the significance of these events. They reasoned that when Esau studied Torah as a young man, it was only a mental exercise for him. He never believed or internalized the information and teaching that he read. Therefore his head could enter the burial cave of the Patriarchs, but not his body, which had followed the ways of the world...Do you see this happening in our world today?

# Let the word dwell in you

ost of us are blessed to have a home. They can be a variety of Ltypes and styles: house, apartment, condo, RV, etc. It doesn't matter what kind it is. What makes it a home is what you put into it. If you

live in an apartment, there may be 10, 50, or 100 other units that look just like yours when they are empty, but you have filled yours with things that reflect you and your family.

You have made it your home.

Our homes are the places we dwell. Dictionary.com defines the word dwell as 1. to live or stay

as a permanent resident, 2. to live or continue in a given condition or state, and 3. to linger over, emphasize, or ponder in thought, speech, or writing (often followed by on

or upon). There may be several places where you spend a significant amount of time. You might spend much of the day in an office or at a desk, but that is not your home. You might spend a lot of time in your vehicle for your job, but that is not your dwelling place.

In Colossians 3:16-17, the Apostle Paul writes. Let the word of Christ dwell in you richly, teaching and admonishing one another in all wisdom, singing psalms and hymns and spiritual songs, with thankfulness in your hearts to God. And whatever you do, in word or deed, do everything in the name of the Lord Jesus, giving thanks to God the Father through

Paul tells Christians to let the word dwell in them. In other words, this does not happen all by itself. When you moved into your house or apartment, things did not just appear. Tables and chairs, couches and beds, and decorations did not magically materialize in your home. You had to

When someone obeys the gospel according to the New Testament pattern, they are not miraculously zapped so that they know everything. As followers of Jesus, we must allow His word to "move in."

This takes effort.

You have to work at it. You must read and study the bible until it is no longer just trivial knowledge but a part of who you are. You must dwell in the Book so that the Book can dwell in you and furnish you com-

Paul is specific in how we are to let the word dwell in us – richly. My wife and I married right out of high school so we were both leaving our parents' homes to start our own. That meant we did not have much of anything as far as home furnishings. So we started out with a hand-medown couch, a garage sale table and chairs, and things like that.

I remember my two best friends got an apartment together and they found one of those big wooden spools for large wire or cable, and that was their coffee table. We, and they, did not have much money to invest in furnishing our homes so they were not richly furnished, rather they were pretty poorly furnished. Thankfully, it does not matter how much money you have as a Christian! What matters is how much of yourself are you investing in God's word.

How much are you letting the word of Christ dwell in you?

The more time you spend in the word, the more it will transform your life. If you will submit yourself to Christ in faithful obedience and dig into His word, it will fill you up and furnish you to do God's will. And the more you know and understand, the more richly His word will dwell within you and make your heart its



# Reflections: The master potter

few miles north of Waco on the east banks of the Brazos River sits the ►Homestead Heritage, an agrarian community committed to preserving nineteenth century craftsmanship. The commu-

nity offers shops where visitors can observe "artistry-in-action" complete with a pottery barn, blacksmith forge, grist mill and a carpentry shop. George and Laura Bush commissioned the Homestead to construct and furnish their house at the Crawford Ranch.



from Wyoming to the Homestead. When we visited the pottery shop, I marveled at the talent of those who

worked there. The artists applied water and shaped the clay spinning on the potter's wheel in front of them. With nimble fingers and just the right amount of pressure, they brought the clay to life and shaped it into the form they desired.

Pottery is an ancient art. For thousands of years the trade was passed down from generation to generation in cultures around the world. Communities developed around clay deposits in India, China and the Middle East. Archeologists continue to excavate pottery from the earliest sites of civilization.

Jeremiah must have marveled, as I did, when he visited a potter's house in ancient Jerusalem. When he watched the clay spin upon the wheel, he saw the potter's ability to change the shape of the clay in an instant. He sensed God speaking to him, "Can I not, O house of Israel,

deal with you as this potter does?" declares the Lord. "Behold, like the clay in the potter's hand, so are you in My hand." (Jeremiah 18:6).

Isaiah made a similar observation. "Shall the potter be considered as equal with the clay? That what is made would say to its

maker, "He did not make me;" or what is formed say to him who formed it, "He has no understanding?" (Isaiah 29:16). God has made each of us unique.

We are, each and every one of us, special in His sight. He never abandons us or gives up on us. Like the clay, we continue to be molded in His hands. With every pressure, whether success or failure, joy or sorrow. God is fashioning us for His purposes so that we can reflect His glory, bless others and be filled with joy. He wants us to love ourselves and one another just the way He made us.

This is what Paul meant when he said, "God causes all things to work together for good to those who love the Lord, to those who are called according to His purpose." (Romans 8:28) All things work together for good when we realize the Master Potter is shaping us for His purposes on the earth.

He says, "For I am God, and there is no other; I am God, and there is no one like Me, Declaring the end from the beginning, and from ancient times things which have not been done, saying, 'My purpose will be established, and I will accomplish all My good pleasure" (Isaiah 46:9-10).

#### House passes bill to prevent mandatory GMO labeling

WASHINGTON (AP) -Food companies would not have to disclose whether their products include genetically modified ingredients under legislation passed by the House Thursday.

The House bill is backed by the food industry, which has fought mandatory labeling efforts in several states around the country. The legislation, which passed 275-150, would prevent states from requiring package labels to indicate the presence of genetically modified organisms, or GMOs.

So far, Vermont is the only state set to require the labels. That law will take effect in July 2016 if it survives a legal challenge from the food industry. Maine and Connecticut have also passed laws requiring the labeling, but those measures don't take effect unless neighboring states follow suit.

The country's largest food companies say genetically modified foods are safe and that labels would be misleading. They say a patchwork of laws around the country would be expensive for companies and confusing for consum-

"The reality is, biotechnology has time and time again proved safe," bill's sponsor, Kansas Republican Rep. Mike Pompeo, said on the House floor. "We should not raise prices on consumers based on the wishes of a handful of activists."

Advocates for the labels say people have a right to know what is in their food and criticize the legislation for trying to take away states' ability to require the

"What's the problem with letting consumers know what they are buying?" asked Vermont Rep. Peter Welch, a

Democrat. Genetically modified seeds are engineered in laboratories to have certain traits, like resistance to herbicides. The majority of the country's corn and soybean crop is now genetically modified, with much of that going to animal feed. It also is made into popular processed food ingredients like highfructose corn syrup, corn starch and soybean

The food industry says about 75 percent to 80 percent of packaged foods contain genetically modified ingredients.

The Food and Drug Administration has said GMOs are safe, and the federal government does not support mandatory labels. Even so, the House bill would make it harder for the agency require labeling nationally by laying out additional standards for such a policy.



# **Altuve's walkoff homer lifts Astros over Boston 5-4**

HOUSTON (AP) — Craig Breslow summed up the state of the Red Sox succinctly after giving up a walkoff homer to Houston's Jose Altuve on Thursday night that extended Boston's season-high losing streak to eight games.

"We didn't play good baseball this road trip," Breslow said. "That's the bottom line."

Altuve homered with one out in the bottom of the ninth, the last of his four hits, and the Astros beat Boston 5-4.

The game was tied 4-all when Altuve connected off Breslow (0-1) and homered into the seats in left, a ball that barely made it over the wall. The play was reviewed and confirmed.

Marwin Gonzalez and Colby Rasmus both went deep for the Astros, who lead the majors with 135 home

"We had a tough time keeping guys in the ballpark," Boston manager John Farrell said. "The way they are able to go left, right, left throughout their lineup, sooner or later they end up getting a matchup that they are (looking) for."

Josh Fields pitched a scoreless ninth for the win (3-1).

Boston's David Ortiz cut the lead to 4-3 with a solo homer off Will Harris with no outs in the eighth. Mike Napoli's RBI double off closer Luke Gregerson later in the inning tied it.

Houston trailed by one run in the seventh before a pinch-hit homer by Rasmus tied it 2-2 with one out. Altuve singled and stole second base before scoring on a double by Gonzalez.

Gonzalez was thrown out trying to stretch it to a triple before rookie Carlos Correa doubled and scored on a single by Evan Gattis to push the lead to 4-2.

Napoli hit a solo hom-

er in the second for Boston (42-54), which dropped a season-high 12 games under .500.

"There's been times during this stretch where if we've made a mistake, it's been difficult for us to overcome or for our offense to cover any mistakes from the mound," Farrell said. "A lot of that has come with men in scoring position, where we haven't gotten the key base hit, either with two outs or with men on base."

Boston starter Wade Miley yielded four hits and one run in six innings. He was replaced by Alexi Ogando and he gave up the full-count homer by Rasmus before being chased on Altuve's single.

Houston rookie Lance McCullers allowed six hits and two runs in five innings.

Mookie Betts doubled and scored on the double by Ortiz to put Boston up 1-0 in the first.

Houston tied it in the bottom of the inning on the homer by Gonzalez, which landed in the Crawford Boxes in left field. Gattis singled with two outs, but was caught trying to steal second to end the inning.

Napoli's two-out, twostrike homer, which bounced off the wall above the Crawford Boxes, made it 2-1 in the second inning.

Ryan Hanigan singled after that before Betts drew a walk. The Red Sox missed a chance to build on their lead when Hanigan was thrown out at the plate when he tried to score on a single by Brock Holt.

Correa, who extended his hitting streak to a career-long eight games, robbed Xander Bogaerts of a hit when he dived to make the stop on his grounder and made a perfect throw to first base for the first out of the third inning.

# A's trade Kazmir to his hometown Astros for 2 minor leaguers while getting hugs and handshakes

Kazmir is heading to his hometown Houston Astros and into the thick of a pennant race, and the Oakland Athletics are starting their summer sell-

The A's began their expected changes leading up to the July 31 trade deadline, sending the left-hander to the Astros for a pair of minor leaguers Thursday in what could be the first of many significant deals across the majors in the next week. Oakland

received sought-after catcher Jacob Nottingham and righthanded pitcher Daniel Mengden in the swap with its AL West rival and the Astros got a top-tier starter as they chase a playoff berth in the season's second half. Houston hasn't been to the playoffs since being swept in the 2005 World Series by the Chicago White Sox when the Astros were still in the National League.

mediately, starting on Friday night at Kansas City. He went 5-5 with a 2.38 ERA in 18 starts for Oakland. Drew Pomeranz started in Kazmir's place against Toronto, and Oakland

recalled right-hander Arnold Leon from Triple-A Nashville to take Kazmir's roster spot. Later in the day, there was another

trade involving a contender: Pittsburgh acquired third baseman Aramis Ramirez from Milwaukee for a minor league pitcher.

Nottingham and Mengden were at Class A Quad Cities to start the season before being promoted to the organization's higher A club in Lancaster of the California League. They will report to Class A Stockton.

While Kazmir has been reportedly on the move for weeks, Beane said he wasn't actively shopping the starting pitcher. But when the Astros included Nottingham in the deal, he said the trade "came together pretty quick."

Richard Nixon engaged in his famous "Kitchen Debate" with Nikita Soviet leader Khrushchev. In 1969, the Apollo 11 astronauts ,Äî two of whom had been the first men to set foot on the

moon ,Äî splashed down safely

in the Pacific. In 1974, the U.S. Supreme Court unanimously ruled that President Richard Nixon had to turn over subpoenaed White House tape recordings to the Watergate special prosecutor.

In 1975, an Apollo spacecraft splashed down in the Pacific. completing a mission which included the first-ever docking with a Soyuz capsule from the Soviet Union. In 1980, comedian-actor Peter

Sellers died in London at 54.

In 1998, a gunman burst into the U.S. Capitol, killing two police officers before being shot and captured. (The shooter, Russell Eugene Weston Jr., is being held in a federal mental facility.)

In 2002, nine coal miners became trapped in a flooded tunnel of the Quecreek Mine in western Pennsylvania; the story ended happily 77 hours later with the rescue of all nine.

Ten years ago: Lance

Armstrong won his seventh consecutive Tour de France (he was later stripped of all his titles after admitting to doping). Sir Richard Doll, the British scientist who first established a link between smoking and lung cancer, died

Five years ago: A stampede inside a tunnel crowded with techno music fans left 21 people dead and more than 500 injured at the famed Love Parade festival in western Germany. Fourteen-year-old Jim Liu beat Justin Thomas 4 and 2 to become the youngest U.S. Junior Amateur champion at Egypt Valley Country Club in Ada, Michigan.



non-waiver trade deadline. The A's, who made the playoffs the past three seasons, entered Thursday with a 44-52 record — 11 games behind the division-leading Los Angeles Angels.

"We have to be realistic with where we are." Beane said. "The math necessarily doesn't work in our favor given the level of play we need just to get back in it."

Melvin said he didn't have a chance to address players before the game but didn't feel he needed to. He said they know roster turnover is part of the business.

"When you're here in Oakland, you understand that moves are made, whether it's offseason or in-season," Melvin said.

The A's acquired Kazmir as a free agent in December 2013 and he was 20-14 with a 3.12 ERA in 40 starts over parts of two seasons, including making the AL All-Star team last year. Houston (53-43) began

the day in second place in the AL West, two games behind the defending division champion Angels. The Astros were hosting Boston on Thursday night.

"Scott Kazmir is one of the best pitchers in the American League and strengthens our rotation," Luhnow said. "His addition gives the Astros a better chance of reaching and succeed-

ing in the postseason. It has been a while since the Astros have been relevant late in the summer and winning now is a priority."

Kazmir said it's tough to leave the A's behind, but he's excited to help his hometown Astros make a playoff push.

Houston manager A.J. Hinch raved about add ing Kazmir.

"I'm really happy," Hinch said. "I feel like we got better. We were able to get one of the best pitchers that has been rumored to be available and join our team in Kansas City and that's a big boost."

Kazmir was an All-Star with Tampa Bay in 2006 and 2008. He was limited to one start in 2011 with the Angels before going on the disabled list with a lower back strain and being released.

He spent the 2012 season with independent Sugar Land — just outside Houston — before bouncing back to go 10-9 with a 4.04 ERA in 29 starts and 158 innings for Cleveland. He has continued to reinvent himself in Oakland and has returned to his status as one of baseball's most reliable arms.

"It's been crazy, to be honest with you," Kazmir said. "Playing independent ball and I'm thinking I would never be able to play professionally. And now I'm going back to my hometown and going to play for the Astros. It's a complete whirlwind, but I'm excited for the opportunity."

# **HBO signs ex-ESPN** personality Bill Simmons to exclusive deal

NEW YORK (AP) — HBO says it has struck a multi-year, multi-platform deal with the multifaceted Bill Simmons.

Under the deal, which begins in October, HBO will be Simmons' exclusive television home, the network said Wednesday.

Among other projects, Simmons will host a weekly talk show premiering next year. It will feature stories and guests from across the sports and cultural landscapes.

He will also have a production deal to produce content for the network and its digital platforms, delivering video podcasts and features. In addition, he will consult with HBO Sports.

A top personality at ESPN until they parted ways in May, Simmons has served as a sports columnist, TV host and analyst, and best-selling author. He was also the founding editor of the Grantland. com and an executive producer of the "30 for 30" documentary series.

Simmons will have more freedom to speak his mind at HBO, as well as the chance to grow his television persona. Simmons hosted the Grantland Basketball Hour on ESPN, and was a member of NBA Countdown during the NBA Finals for several vears.

There is no question the footprint Simmons left at ESPN, with more autonomy the sky seems to be the limit on what he can accomplish.

# Company with Romo ties sues NFL over canceled fantasy event

DALLAS(AP) - A company partly owned by Tony Romo sued the NFL on Tuesday over a canceled fantasy football event in Las Vegas that was to involve the Dallas quarterback and other star players.

The Fan Expo LLC alleged in a lawsuit filed in Dallas County that the league intimidated players with threats of fines and suspensions if they attended what the NFL said was a gambling-related event because it was to be held at a facility associated with a casino.

The Texas-based company claims the NFL initially approved the event, set for mid-July, by allowing some members of league-owned media outlets to participate. Then in June, according to the lawsuit, players and in some cases family members of players were told they could be disciplined if they showed up.

"This case is about the NFL's blatant and premeditated sabotage of an event designed to bring together the very people who are the backbone of the NFL — the players and the fans," said the lawsuit, which seeks more than \$1 million in damages.

NFL spokesman Brian McCarthy said the league was reviewing the lawsuit and would "respond accordingly."

The Fan Expo created the National Fantasy Football Convention and used Romo as its headliner while getting commitments from Cowboys receiver Dez Bryend Rob Gronkowski and Pittsburgh running back Le'Veon Bell.

DeMarco Murray, Romo's former teammate and the NFL rushing leader who signed with Philadelphia in free agency, also was among the 60 players the lawsuit says had agreed to attend. The suit said there were another 35 players who were considering signing agreements.


The event was to include autograph sessions with players and clinics with fantasy football experts. It was to be held at the Sands Expo, convention center that's part of the Venetian Resort but doesn't have gambling or slot machines.

The lawsuit said the mother of New York Giants receiver Odell Beckham Jr. was among those warned by the NFL that her son would be punished if he participated. It also said NFL senior labor relations counsel Brook Gardiner contacted the Cowboys, prompting the team to call an event organizer.

After failed attempts to persuade the NFL that the event wasn't associated with gambling, it was called off and refunds were offered to fans who had already booked trips. Organizers say they are planning to hold the event in Los Angeles next sum-


**Dallas Cowboys quarterback Tony Romo gives** instructions to a teammate during an organized team activity on May 27.

Romo was critical of the NFL in a radio interview after the cancellation was announced in June, also saying he was disappointed the league waited until a few weeks before the event to make an issue of it. He disputed the league's claim that it raised concerns soon after learning of the event.

Julie Pettit, an attorney for Fan Expo, confirmed that Romo had a stake in the company but wouldn't say whether he approved the decision to sue the NFL.

#### Analysis: Nuke deal that ignores Iran's behavior has precedent in US-Soviet Union agreements

WASHINGTON (AP) — Critics of the Iran nuclear deal claim it is flawed, among many reasons, because it does not demand that Tehran also change its behavior at home and abroad. That complaint ignores the United States' long history of striking arms control agreements with the Soviet Union, a far more dangerous enemy.

Those deals probably made the world a safer place through some of the darkest days of the Cold War and they proved talks could be productive even with a sworn adversary.

Dating as far back as the Limited Test Ban Treaty in 1963 — less than a year after the Cuban missile crisis — U.S. administrations engaged the Soviet Union in agreements to limit nuclear threats while not linking deals to abhorrent Soviet human rights abuses and the active arming and funding of leftist, anti-American revolutionary movements around

As Cold War brinksmanship moved apace, the U.S., the Soviet Union, Britain, France and China signed on to the 1963 Nonproliferation Treaty. That agreement was designed to prevent other countries from developing nuclear weapons, while guaranteeing their rights to civilian nuclear technology the very guarantee that, 47 years later, allows Iran to continue building nuclear facilities for power generation and medical research.

#### In second White House bid, Clinton embraces race as a top issue, denounces 'systemic racism'

GREENVILLE, S.C. (AP) — In her second bid for the presidency, Hillary Rodham Clinton is discussing "systemic racism" and making the issue a hallmark of her campaign as she looks to connect with the black voters who supported rival Barack Obama in 2008.

At multiple stops in South Carolina, Clinton on Thursday bemoaned "mass incarceration," an uneven economy, increasingly segregated public schools and poisoned relations between law enforcement and the black community. She praised South Carolina leaders, including Republican Gov. Nikki Haley, for removing the Confederate battle flag from statehouse grounds after a white gunman's massacre of nine people at a historic black church in Charleston, but she warned that the act is only symbolic.

"America's long struggle with racism is far from finished," the former secretary of state said before a mostly white audience at a Greenville technical college. Hours earlier, with a majority black audience at a West Columbia church, she declared, "Anybody who says we don't have more progress to make is blind."

At both stops, she added some symbolism of her own, trumpeting the mantra "Black Lives Matter," which has become a rallying cry of and name for the activists who have organized protests in several cities amid several high-profile cases of black citizens being killed during encounters with police.

"This is not just a slogan," Clinton said. "This

should be a guiding principle."

#### Authorities point to new evidence of suicide in Bland's death in Texas

HEMPSTEAD, Texas (AP) — While Sandra Bland's family maintains that the woman found dead in a Texas jail cell would not have taken her own life, authorities are pointing to mounting evidence that they say shows she hanged herself.

Marks around the neck of Bland, 28, neck were consistent with suicide by hanging, Waller County prosecutor Warren Diepraam said. Briefing reporters in Hempstead on Thursday, Diepraam said that Bland's body showed no signs of defensive injuries to suggest a final struggle for survival and that she had about 30 small cuts on her wrist that were probably self-inflicted within the last few weeks.

Some lacerations or abrasions were found on her wrists. Those were consistent with a struggle while being handcuffed, Diepraam said.

Bland was arrested in a traffic stop three days before she was found in her cell on July 13. Her family and friends dispute the official finding that she killed herself using a noose fashioned from a plastic garbage bag.

Texas Rangers and the FBI are investigating. The county district attorney has said the matter will be turned over to a grand jury, which does not meet again until August.

#### Turkey says warplanes strike IS targets across the border in Syria

ANKARA, Turkey (AP) — Turkish warplanes struck Islamic State group targets across the border in Syria on Friday, government officials said, a day after IS militants fired at a Turkish military outpost, killing a soldier.

The bombing is a strong tactical shift for Turkey which had long been reluctant to join the U.S.-led coalition against the extremist group.

A government official said three F-16 jets took off from Diyarbakir airbase in southeast Turkey early Friday and used smart bombs to hit three IS targets. The official, who spoke on condition of anonymity because of government rules requiring authorization for comment, said the targets were two command centers and a gathering point of IS supporters.

Turkish media said the targets were the Syrian village of Havar, near the border, but officials would not confirm the location.

The private Dogan news agency said as many as 35 IS militants were killed in the airstrike that targeted the gathering point. The agency did not cite a source for the report.

#### Suddenly a dominant 2016 force, Donald Trump looms over first Republican presidential debate NEWARK, N.J. (AP) — They have been holding

mock debates, hunkering down with advisers and finessing policy answers. But the most pressing concern for many Republican presidential contenders as they prepare for the first debate of the 2016 primary season is one man: Donald Trump. The billionaire businessman has dominated the

2016 Republican race in recent weeks, and he threatens to do the same when the top 10 Republican candidates — as determined by national polls — face each other for the first time on national television. It's a high-risk, high-reward event for candidates eager to stand out in a packed field in which Trump is playing the ultimate wildcard. "It's the No. 1 unavoidability," said former House

Speaker Newt Gingrich, a 2012 GOP candidate who had a knack for standing out in debates four years

"Do not try to match him in anger and in aggressiveness. It's not possible," Gingrich warned Trump's rivals. "He's a very instinctively aggressive guy and if you try to dance with him on his strengths he'll run over you."

Indeed, despite his longshot status, the reality television star has commanded attention and seen his poll numbers rise after firing off provocative comments about immigrants, his presidential rivals and critics in both parties. His supporters love him because he's willing to say what others only think. But that makes him dangerous in a debate setting, says Charlie Black, a leading GOP strategist. who has worked on multiple presidential campaigns.


