

# GOP seeks hearings on FBI decision on Clinton emails

WASHINGTON - Angry House Republicans are announcing plans to investigate after FBI Director James Comey recommended against criminal charges for Hillary Clinton over her handling of classified emails.

House Speaker Paul Ryan, R-Wis., said Comey's decision

defies explanation and leaves many questions unanswered. He said the House Oversight and Government Reform Committee would be calling Comey to testify.

"The FBI should give us all of their findings," Ryan told Fox News Channel's "The Kelly File" on Tuesday. Ryan said Clinton is "competing for commander in chief here,

so I think there's a whole accounting that needs to happen."

Democrats on the committee said Republican leaders of the panel had called an emergency hearing for Thursday. They attacked the decision as political.

"Republican after Republican praised Director Comey's impeccable record of independence — right up until the moment he issued his conclusion," said the committee's top Democrat, Rep. Elijah Cummings of Maryland. "The only emergency here is that yet another Republican conspiracy theory is slipping away."

In a brief interview Wednesday morning, the chairman, Rep. Jason Chaffetz, R-Utah, said he had spoken with Comey on Tuesday and that his testimony had been longscheduled.

The FBI is supposed to be insulated from partisanship, with directors appointed to serve 10-year terms under legislation passed in 1976 following J. Edgar Hoover's ex-

# Power outage

High winds, lightning knock out electrical service for 1,500+Herald Staff Report

It wasn't the rain — it was the lightning.

The storm system that blew through this area Tuesday didn't produce a lot of rain — several stations reported receiving less than an inch of precipitation — but did result in plenty of lighting and high winds, which, in turn, resulted in more than 1,000 utility customers temporarily losing their electricity.

Sharyland Utilities released a statement Tuesday night reporting that crews were working to restore power to more than 1,500 customers in its West Texas service area, which includes Howard, Martin, Glasscock and Mitchell counties. "At this time, we do not have an estimate on when power will be restored to all customers," the news release stated. "However, updates are available through our online system outage map found at outages.sharyland.com." In the immediate Big Spring area, Oncor reported that around 20 customers were without electricity this morning.

Howard College will delay reopening the SouthWest Collegiate Institute for the Deaf (SW-CID) campus for about a week while major upgrades to the air conditioning/heating system

continues. "Current plans indicate the campus will re-open for regular business hours on Monday, July 11, 2016 at 8 a.m.," Cindy Smith, HC director of information stated in a news release Tuesday morning. "During this time of campus closure, all personnel will continue to be located on the Howard College Big Spring campus and will have limited telephone and videophone access." The \$1.9 million project, approved during the last state legislative season, is conducting major upgrades and replacement to the aging system. It is completely funded through state monies and not through local property tax revenue.

### Destination Jupiter: What to expect during the Juno mission

LOS ANGELES (AP) — Now that the Juno spacecraft is settled in orbit around Jupiter, the real work is about to begin.

Juno will fly closer to Jupiter than any other spacecraft, skipping over cloud tops and peering deep inside to uncover clues about the giant planet's formation. Scientists hope that understanding how Jupiter formed can help explain how Earth and the other planets evolved as well.

"Now the fun begins — the science," mission chief scientist Scott Bolton said after Juno's arrival Monday at the end of a five-year journey.

A look at what's coming up during the \$1.1 billion mission:

POST-TRIP CHECKUP

Juno was bombarded with radiation as it neared Jupiter, the largest planet in the solar system. As a precaution, its camera and science instruments were turned off during the arrival. Engineers will flip them back on this week and perform a complete check of the spacecraft to make sure everything is ready to go for the next 20 months.

CHANGING COURSE

To enter Jupiter's orbit, Juno fired its rocket motor, putting it on a long, looping path that takes 53 days to complete. In late August, the spacecraft swings back around Jupiter for its first close-in view. But Juno eventually needs to swoop in closer to do its job. The mission kicks into high gear in chronic pain disease, October when Juno fires its engine again to tighten its orbit. Then every two weeks, the spacecraft will tive group, meets at 213 skim Jupiter's clouds to peek into its stormy atmosphere.

the planet. It will measure how much water is in Jupiter's atmosphere. This will shed light on where in the solar system Jupiter formed. It will also probe Jupiter's gravity and magnetic fields to determine what kind of core it has and what makes the northern and southern lights so intense. Juno will also study how deep the trademark Great Red Spot goes and why the centuries-old storm has shrunk in recent years.

#### FINALE

When Juno finishes its job, it will intentionally plunge into Jupiter's atmosphere and burn up. Galileo, the first spacecraft to orbit Jupiter, met the same fate after a 14-year mission. This fiery end expected in 2018 prevents any chance of accidentally crashing into Jupiter's moons, particularly Europa, considered a prime target in the hunt for microbial life in the solar system.



#### MOON MYSTERY

Juno made a discovery even before reaching its destination. As Juno zeroed in on Jupiter, its camera captured the massive planet appearing half-lit surrounded by its four main moons. NASA stitched the images together and created a time-lapse video showing the moons in action.

There was a surprise: Jupiter's second-largest moon, Callisto, appeared dimmer than scientists imagined. "We don't know why," said Bolton of the Southwest Research Institute in Texas.

#### **CLOSEST LOOK**

Previous missions to Jupiter have revealed stunning views of the planet's thick clouds and vivid auroras. Scientists are expecting the best photos and information yet from Juno.

"We get our first up and close personal look at Jupiter with all our eyes and ears open" later this summer, Bolton said.

The spacecraft carries nine instruments to map

Donald Trump, the presumptive GOP presidential candidate who looks certain to face Democrat Clinton for president, complained

No, it's not time to move on

m I fantasizing even to hope that Hillary Clinton will finally be held accountable for her lies and corruption — to say nothing of her actions in her role

as bimbo-slayer for her libidinous husband?

Perhaps so, but to borrow an underused cliché, hope springs eternal.

Hillary has operated above the law for so many years that her disinclination toward humility has ripened into

and slandered their accusers and then delayed long enough to claim that enough time had passed that we should just move on. For those who care anything about the rule of law, it was a frustrating period.

Over the years, the unglamorous power couple has become even more deceitful, brazen and defiant. Everyone, including Democrats, knows how corrupt the Clintons are, but they just continue to transgress with impunity. Hillary even had a phony smile on her face when she lied that the committee had found no misconduct on her part and

Let me just share a few highlights from the report that shed light on the Obama administration's and Clinton's overt malfeasance during the Benghazi attacks and in covering up their sins. In fact, the State Department had access to eyewitness accounts to the attacks in real time, and there were no discussions about any video.

The Bureau of Diplomatic Security's command center was in direct contact with its agents on the ground in Benghazi and sent out many updates, including a "Terrorism Event Notification." Diplomatic Security well knew that it was terrorism and that there was no mention of the video from the agents on the ground.

 President Obama skipped his intelligence briefing the day after the attacks.

• Also, the morning after the attacks, the National Security Council's spokeswoman emailed some two dozen people from the White House, Department of Defense, State Department and intelligence community directing that they all refer to the released statements of President

Clinton "to ensure" they were "all in sync on messaging for the rest of the day."

• Minutes before Obama's Rose Garden speech on the attacks, Clinton aide Jake Sullivan emailed deputy national security adviser Ben Rhodes and others and informed them: "There was not really much violence in Egypt. And we are not saying that the violence in Libya erupted over inflammatory videos.'

 Surely knowing it was untrue, Rhodes and Obama adviser David Plouffe prepped then-U.N. Ambassador Susan Rice to say on her five Sunday talk show appearances that the attacks had spontaneously occurred and then evolved as a result, in part, of this anti-Islam YouTube video.

 After Rice's command performance mance, Sullivan reassured Clinton that Rice had made clear the "view that this started spontane ously and then evolved." From Clinton's retrieved emails, we know that she knew otherwise.

It is indisputable that the administration, including Obama and Clinton, knew, at the very time these events were unfolding, that this was terrorism and concocted - and then disseminated — the outrageous lie that the attacks were spontaneous and based on a video. Members of the administration coordinated a scheme to deceive the American people and implemented it. Their motives were to cover up their gross negligence in failing to protect American lives and to preserve their bogus narrative that the administration had adequately contained the terrorist threat — in view of the upcoming election. Adding insult to injury, they lied to the parents of the men who died in the attacks.

# **Rethinking naming wild animals**

nimals do not name themselves. The lion illegally hunted down in Zimbabwe last year did not know he was "Cecil."

The western lowland gorilla shot at the Cincinnati Zoo after a 3-yearold fell into his enclosure did not answer to the name "Harambe." We can under-

stand why zoos, nature preserves and animal rescue groups give their headliner animals a name.

It helps humans imagine a bond with the creatures, leading to donations, visits and other support for their institutions.

But naming wild animals is not all good. "It trivializes wildlife and makes it less wild," complains Don Thomas, a wellknown hunting writer and environmentalist based in Montana.

Thomas told me that while writing an article about the zoo controversy, he had used "Harambe" as the original title but then caught himself. There's a long tradition of hunters giving names to "special" game animals, he added.

Naming wild animals makes them seem human and also less dangerous. That can work to the detriment of both the animals and humans. The "beloved Cecil" had become a virtual pet in a game reserve and thus may have lost a natural wariness toward

The outcry over the killing of

"Harambe" included a good deal of fantasy about the gorilla's relationship with the toddler. Many insisted that "Harambe" was actually protecting the boy.

Protective? Aggressive? No one could possibly know, Thomas insists. "The video clearly does show a powerful, agitated animal dragging a small child rapidly through water deep enough to drown the kid and roughly enough to kill it in an instant. intentionally or not."

Expecting wild animals to act with human benevolence is especially risky in the case of primates closest to us on the evolutionary charts. Recall the terrible story of "Travis," the chimpanzee that virtually tore off a Connecticut woman's face and hands.

If any animal deserved the title of honorary human, it was "Travis." He appeared in a Coca-Cola commercial and on TV shows. "Travis" wore a baseball shirt and could operate a TV remote control. But in 2009, he suddenly tore at one of his owner's friends. Police shot him dead.

Facebook is heavy with videos that seem to unite natural enemies, feeding the human dream that all creatures can get along. A cat plays with a parakeet. A chicken cares for a kitten.

A problematic example that has gone viral shows a 1,500-pound Kodiak bear cuddling with its keeper. The bear has a name, of course — "Jimbo."

The video promotes a wildlife rehabilitation center in upstate New York. The center may do good work nursing injured animals, but is it doing the public a service in portraying bears as potential playmates?

The gruesome demise of Timothy Treadwell should have put an end to the idea of bears as trusted companions. Heavily into self-promotion, Treadwell claimed to have forged loving relationships with grizzly bears in Alaska's Katmai National Park. He recorded himself living among these fearsome mammals and playing roughhouse with them.

In a documentary about him, "Grizzly Man," Treadwell is seen talking baby talk with a giant bear he named "Mr. Chocolate."

National Park Service rangers accused him of harassing wildlife.

On Oct. 6, 2003, the rangers found the chewed-up remains of Treadwell and his girlfriend. They killed a large male grizzly near their campsite and found human body parts in his stomach.

Could he have been "Mr. Chocolate"?

We grow up with teddy bears and stuffed lion toys. Ideally, children — and adults — will learn to distinguish between make-believe and biology. Holding back on giving wild animals names might be a good start.





#### University officer presumed drowned in Dallas flooded creek

DALLAS (AP) — Authorities searching for the body of an off-duty university police officer presume he drowned when he was swept away in a flooded creek in Dallas.

The Dallas Morning News reports that the Southern Methodist University officer was working a security job at a construction site near Turtle Creek when a thunderstorm hit the area. The unidentified officer called a dispatcher to say his car was being overtaken by water, but he lost contact with authorities around 1:30 a.m. Tuesday.

Dallas Fire-Rescue officials say they are treating the search as a recovery effort rather than a rescue mission. About 40 people and a K-9 team are participating in the search.

The search was halted for around 7 p.m. Tuesday. Crews will continue the search at 7 a.m. Wednesday.

#### Judge: 22 BP fraud charges against lawyer duplicate others

GULFPORT, Miss. (AP) - The 95-count fraud indictment against a San Antonio lawyer and six co-defendants could be shorter when trial begins in Mississippi on federal charges accusing them of inflating a client list for BP oil spill litigation.

Twenty-two counts of aggravated identity theft appear to be "multiplicitous" — that is, to cover the same alleged offenses as some of the 50-plus counts of identity fraud against Mikal Watts and the others, U.S. District Judge Louis Guirola Jr. told government attorneys Tuesday.

"I'm not sure dismissal of those counts is the remedy ... but there must be a remedy to correct the multiplicitousness — I've just created a word — the multiplicitousness of the indictment," the judge said.

Watts, two non-attorneys with his law firm and four field workers are accused of inventing victims of the 2010 oil spill to land Watts a spot on the lucrative BP litigation steering committee and inflate legal fees he might collect.

Watts, an attorney who has earned millions suing corporations over client injuries, maintains his innocence.

Assistant U.S. Attorney Jerry Rushing said after the hearing he didn't know what might be done other than dropping the aggravated identity theft charges. Attorney Chip Lewis, representing defendant Hector Guerra, said he'd be satisfied with that.

Watts' co-defendants also say they are innocent. They are his brother David Watts and Wynter Lee, both of whom work in his law firm; and BP claim field representatives Hector Eloy Guerra of Weslaco, Texas; Gregory Warren of Lafayette, Louisiana; and Thi Houng Le and her sister-in-law, Thi Hoang Nguyen, both of Grand Bay, Alabama.

#### Friends send big checks for top Texas prosecutor legal bills

AUSTIN, Texas (AP) — Wealthy friends and donors of Texas Attorney General Ken Paxton have chipped in nearly \$330,000 to cover his legal defense against criminal charges of securities fraud, according to state filings made public Tuesday.

The list reveals for the first time those paying Paxton's legal costs while the Republican fights two felony counts of defrauding wealthy investors in the tech startup Servergy Inc. If convicted, Paxton faces 5 to 99 years in prison.

Paxton, who has pleaded not guilty, is also being sued by the U.S. Securities and Exchange Commission in a separate court case over the same accusations: that he lured investors to Servergy, a datastorage company, without disclosing that he was being paid to recruit new backers.

Among those footing Paxton's legal bill are Preferred Medical CEO James Webb, who pitched in \$100,000 and is a longtime donor to the state's top prosecutor. At least one is also a Servergy investor, Keresa Richardson, who gave \$10,000 and told the Associated Press last year that Paxton was "the cleanest guy in the world" when asked about his name being linked to a federal investigation.

A Paxton spokesman said the attorney general followed the law in raising and disclosing the funds.

"The financial burdens of defending against politically motivated prosecutions can be significant and Attorney General Paxton is grateful for the support of his friends in fighting back against these false allegations," Paxton spokesman Matt Welch

said in an email.

Paxton until now had not disclosed how he is paying for a team of high-powered attorneys — which at times included a former federal judge and former federal prosecutor — since being indicted last summer.

Earlier this year, state ethics regulators denied giving Paxton their blessing to let him tap political donors to cover the cost.

McALLEN. Texas (AP) — Federal prosecutors say two former South Texas school board members have been sentenced to prison for extorting a company by threatening to end a contract with the school district if they weren't paid a bribe.

Fifty-four-year-old Eloy Infante was sentenced Tuesday to nearly four years in prison and 45-yearold Elpidio Yanez Jr. was sentenced to more than three years.

Federal authorities said in a release the men were serving on the board in Donna last year when they each demanded \$10,000 from the company to retain its contract with the school district.

A third man, 50-year-old Adrian Guerrero, was sentenced to more than a year in prison for acting as a middleman between the parties.

#### Sheriff's deputy drowns after falling from boat

TEMPLE, Texas (AP) — A Central Texas sheriff's deputy has drowned after falling from a fishing boat at Belton Lake.

The body of 35-year-old Stephen Kay Foster was found Monday following an extensive search of the lake west of Temple.

The Temple Daily Telegram reports the Bell County deputy was with several family and friends in two boats early Sunday when he fell overboard.

A Texas Parks and Wildlife Department dive team helped in the search using sonar equipment.

Game wardens who were searching by helicopter later spotted Foster's body.

It was not clear how he fell overboard and why those in his group were unable to assist him.

# President ready to 'pass the baton' to Clinton

CHARLOTTE, N.C. (AP) — President Barack Obama vigorously vouched for Hillary Clinton's trustworthiness and dedication on Tuesday, making his first outing on the campaign stump for his former secretary of state just hours after his FBI director blasted her handling of classified material.

Shirt sleeves rolled up in campaign form, Obama declared, "I'm ready to pass the baton."

"I'm here today because I believe in Hillary Clinton," he said. "I have had a front-row seat to her judgment and her commitment."

The energetic Obama-Clinton appearance in North Carolina was a show of Democratic unity in a state Clinton is hoping to put back in the party's column. But the moment wasn't what her campaign and the White House imagined during the long primary season.

Shortly before the president and his wouldbe successor flew to Charlotte together, FBI Director James Comey announced he would not recommend charges against Clinton for her email practices — but only after he presented a searing description of her "extremely careless" handling of classified information that ensured the matter won't be going away.

The White House declined to comment on Comey's findings, saying the investigation was not formally closed and it did not want to appear to be influencing prosecutors.

Still, the timing of the trip pulled the president into a controversy he has at times tried to keep at arm's length. His appearance with Clinton was a reminder that it was his appointee who declined to pursue criminal charges.

Yet Clinton and Obama did not veer from their display of lock-step unity. The duo flew to Charlotte together on Air Force One, they rode to the rally together in Obama's armored limousine, known as "The Beast." Clinton shared photos of her grandchildren, Charlotte and newborn Aidan, with the president.

As they were welcomed by a screaming crowd of supporters, the president led chants of "Hillary!" as they stood onstage under banners reading "Stronger Together.'

Referring back to their own primary battle in 2008, Obama said, "We may have gone toe to toe, from coast to coast, but we stood shoulder to shoulder for the ideals that we share."

Clinton's Republican rival didn't let the Democratic duo's outing go unanswered. As the rally began, Donald Trump released a lengthy statement casting the joint appearance as an example of a "rigged" political system.

"It was no accident that charges were not recommended against Hillary the exact same day as President Obama campaigns with her for the first time," Trump said.

Clinton shot back early as she introduced the president, chiding Trump for once leading the questioning of the president's birthplace. She said Obama was a

man that "I was honored to stand with in the good times and the bad times, someone who has never forgotten where he came from. And, Donald, if you're out there tweeting, it's Hawaii."

Obama, too, got in a dig at Trump.

"Anybody can tweet but nobody actually knows what it takes" to be president, he said.

Obama's and Clinton's journey from political opponents to close political allies was a steady theme in the event.

The Clinton campaign hopes Obama can reassure voters about her experience, talent and character - and speak to their questions about her honesty and trustworthiness, some of which stem from the email investigation. Indeed, the president took on the criticism of Clinton directly, casting the negative impressions of her as a result of her many years in the political spotlight. He also noted that he had benefited from Americans' desire for a fresh face.

"Sometimes we take somebody who's been in the trenches and fought the good fight and been steady for granted," Obama said, as Clinton sat behind him. "As a consequence that means sometimes Hillary doesn't get the credit she deserves. But the fact is Hillary is steady and Hillary is true."

Clinton noted that she has been Obama's loyal ally, lavishing praise on

his record in the White House and saying he doesn't get the credit he deserves for overseeing the nation's economic recovery. She recalled her surprising decision to join his team after their bruising 2008 Democratic primary and shared memories of her four years in the administration, from crashing a meeting with the Chinese at a global climate summit to being in the Situation Room during the raid on Osama bin Laden

"He's made difficult. even unpopular, decisions for the good of our country," she said.

Obama and Clinton originally planned to make their first campaign appearance together in Wisconsin, а Democratic-leaning state where Clinton struggled in her primary fight with Bernie Campaign Sanders. aides viewed that as a way to forge Democratic unity and consolidate the party's voters in a state Clinton needs to carry in November.

The June 15 rally was postponed due to the mass shooting at an Orlando nightclub. #### For Clinton, character questions likely to persist

CHARLOTTE, N.C. (AP) — The FBI may have spared Hillary Clinton the worst in wrapping up its investigation into her use of email as secretary of state. But the way in which Director James Comey did so makes it unlikely criticism of her judgment and character will fade before Election Day.

Giving little indication he was about to clear Clinton of wrongdoing, Comey on Tuesday delivered a blistering assessment of the Democratic nominee's missteps in using a personal email account run on private servers.

The FBI determined Clinton sent and received classified information on her private email set-up, he said, contradicting her months of public assurances she had not. He added that agents found "several thousand work-related emails" that Clinton's attorneys failed to turn over, and went on to raise the prospect that people hostile to the U.S. had snooped on her account.

"Although we did not find clear evidence that Secretary Clinton or her colleagues intended to violate laws governing the handling of the classified information, there is evidence that they were extremely careless in their handling of very sensitive, highly classified information," Comey said Tuesday in a rare public airing of a months-long investigation.

When the moment came that Democrats have been waiting on for months Comey concluding his remarks by saying "no reasonable prosecutor" would bring a case against Clinton it almost seemed to be afterthought.

#### Oscar Pistorius sentenced to 6 years in prison for murder

PRETORIA, South Africa (AP) Oscar Pistorius was sentenced to six years in prison Wednesday for the murder of girlfriend Reeva Steenkamp, with the judge who decided the punishment calling the double-amputee Olympian a "fallen hero."

South Africa's minimum sentence for murder is 15 years but the judge said "substantial and compelling circumstances" existed to give Pistorius

a lesser sentence for shooting Steenkamp at his home in 2013.

Judge Thokozile Masipa described Pistorius as a "good candidate for rehabilitation."

Pistorius was asked to stand and face Judge Masipa as she announced his sentence in a courtroom in the South African capital, Pretoria. He was calm after the sentence was announced, embracing his aunt and tearful sister before being led down a courtroom staircase to a holding cell.

Steenkamp's parents, Barry and June, were also present in the courtroom, which was packed with relatives of both Pistorius and Steenkamp, journalists and other observers.

#### **Islamic State** pressured after Turkey tightens jihadi highway

GAZIANTEP, Turkey (AP) – Along the border near the southern Turkish city of Gaziantep, a wall of giant concrete blocks is going up as Turkey tries to seal off a region that for years was a jihadi highway through which thousands of extremist fighters flowed to join the Islamic State group in neighboring Syria.

Turkey has always denied permitting the movement of IS militants into Syria and insists it has been doing its best to stop the transit, even before construction on the massive wall began late last year.

Documents obtained by The Associated Press, however, tell a different story, showing a pattern of porousness along Turkey's 566-mile- (911kilometer-) long border with Syria that has been vital for the extremist group's expansion as it built its selfdeclared "caliphate."

The AP analyzed 4,037 "entry documents" logged by the Islamic State group for its fighters entering from Turkey into Syria between September 2013 and December 2014. Around three-quarters of them entered through three particular crossing areas

Those fighters alone would make up between 25 to 40 percent of the estimated total of IS's foreign recruits, and they likely do not represent all fighters that entered through Turkey during that period. According to CIA estimates, IS had 20,000-31,500 fight-

ers by the end of 2014, around half of them foreigners. The documents were leaked to a Syrian opposition news site, Zaman al-Wasl, which provided them to the AP.

#### Muslims worldwide come to grips with a bloody Ramadan

BEIRUT(AP) - As Muslims aroundthe world celebrate the end of Ramadan, many are struggling to comprehend a wave of attacks that killed 350 people across several continents during the holy month and made urgent the question of what drives the militants to ever more spectacular violence against civilians.

The diverse, high-profile targets including one that struck the heart of Islam in the month's final days — underline the warnings of many experts: the Islamic State group, especially when on the defensive at home, will metastasize far beyond its theater of operations.

The extremist group has always sought attention and recruits through brazen terrorism. The projection of daring, operational competence and utter disregard for the norms of its enemies has proven a winning strategy among its disenfranchised and angry followers around the Muslim world.

But having lost the key city of Fallujah in recent weeks, capping a series of setbacks in Iraq, the group is pushing to project strength while also diverting attention from its battlefield humiliations.

"ISIS is waging an existential fight," said Fawaz Gerges, a Londonbased scholar of jihadi groups, using an alternate acronym for the militant group. "The future of the Islamic State is on the line, and it is trying to maximize the cost for its adversaries and also to inspire this particular segment of young men and women who subscribe to its ideology."

#### Britain, and Blair, await long-delayed Iraq War inquiry

LONDON (AP) — The official inquiry into Britain's role in the Iraq War is releasing its findings Wednesday, more than seven years after hearings began and 13 years on from the 2003

U.S.-led invasion.

Retired civil servant John Chilcot is due to publish his 2.6-million-word report on a divisive conflict that — by the time British combat forces left in 2009 — had killed 179 British troops, almost 4,500 American personnel and more than 100,000 Iraqis.

Iraq descended into sectarian strife after the occupiers dismantled Saddam Hussein's government and military apparatus, unleashing chaos that helped give rise to the Islamic State group.

The war has overshadowed the legacy of Britain's then-leader, Prime Minister Tony Blair. His government has been accused of exaggerating intelligence about Saddam's alleged weapons of mass destruction in order to build support for invasion.

Blair — who declined to comment on the report before publication has always said his government did not invent or distort intelligence.

#### Trump praises late Iraqi leader Saddam as terrorist killer

RALEIGH, North Carolina (AP) — Presumptive Republican presidential nominee Donald Trump, who frequently criticizes U.S. foreign policy under President Barack Obama and former Secretary of State Hillary Clinton, has praised former Iraqi President Saddam Hussein's ruthlessness.

"Saddam Hussein was a bad guy, right? ... But you know what he did well? He killed terrorists. He did that so good," Trump told a campaign rally Tuesday night in Raleigh, North Carolina. "They didn't read 'em the rights, they didn't talk. They were a terrorist, it was over."

Trump has previously said the world would be "100 percent better" if dictators like Hussein and Libya's Moammar Gadhafi were still in power. Prior to the U.S. invasion, Iraq was listed by the U.S. as a state sponsor of terrorism.

Jake Sullivan, a Clinton senior policy adviser, said Trump's "praise for brutal strongmen seemingly knows no bounds."

Sullivan said such comments "demonstrate how dangerous he would be as Commander-in-Chief and how unworthy he is of the office he seeks."



Messi gets 21 months for tax fraud, won't get jail time

MADRID — A Barcelona court on Wednesday gave Lionel Messi and his father suspended sentences of 21 months in prison for tax fraud.

The court found both the Barcelona star and his father, Jorge Horacio Messi, guilty of three counts of defrauding the tax department to the tune of 4.1 million euros (\$4.6 million).

In Spain, sentences of less than two years for first offences are suspended, meaning neither man will go to jail.

The court also fined Messi 2 million euros and his father, 1.5 million euros.

During the four-day trial last month, Messi and his father denied any



as if he can see every card in the defenders' hands. This knack of playing as if all the cards are exposed can be attributed to inferences declarer draws from either the bidding or the early plays by the defense.

To illustrate, examine this deal where declarer should make five diamonds even though he seems certain to lose a club and two hearts. Assume

West leads the nine of spades in response to East's opening spade bid. Since the nine is obviously West's highest spade, declarer knows that East holds the K-10, and he should put this knowledge to good use by covering the nine with the jack. Failure to do so would cost declarer the contract after East followed low to West's nine.

After South takes East's king of spades with the ace, he enters dummy with a trump, leads a spade, and finesses the eight. Next he cashes the queen of spades, discarding a club from dummy, and then ruffs his last spade.

The stage is now set for the kill. Declarer plays dummy's king of clubs, saddling East with the lead, and East has no recourse. He can return a heart to dummy's K-J, or he can lead a club or a spade, allowing South to discard a heart and ruff in dummy. Either way, East's goose is cooked

Declarer's line of play is clearly marked from the start. East's opening bid virtually marks him with the ace of clubs, and West's nine-of-spades lead tells declarer that East has the K-10 of spades. All South has to do is to put this information to good use.



overcoming his disability. Both of Pistorius' legs were amputated below the knees when he was 11 months old because of a congenital defect.

He made history by running at the 2012 Olympics on his carbon-fiber running blades, and was one of the world's most recognizable athletes.

"He's a fallen hero, he has lost his career and he is ruined financially," said Masipa, who originally convicted Pistorius of manslaughter, a ruling that was overturned by an appeals court that instead convicted

him of murder and sent the case back to her for sentencing.

In explaining the sentence, Masipa said there are "substantial and compelling circumstances" to show leniency toward Pistorius because he is a "good candidate for rehabilitation," is unlikely to commit another crime and had shown what appeared to be genuine remorse over Steenkamp's death.
