After a lapse of three years, it has been decided at the last minute to once again have the Dimmitt Picnic, one of the most looked forward to celebrations of the entire Panhandle. As always, the date has been set on the birthday of Castro County, Wednesday, August 14. It was just forty-one years ago that Castro County was founded upon the vast grassed expanses of the plains. Since that time a great change has evolved but through every prosperous period and every depression the true sons and daughters of the pioneer West have taken the bitter with the sweet and builded a substantial empire of prosperous endeavor and happy homes.

Many of the old timers who have fought the battles of modern progress are still with us and the annual picnic will give them an opportunity to visit with their old friends and retell the experiences which grow more interesting with the years. For the younger folk a splendid program of various entertainment has been planned and will be worth the time and effort expended in attending the Forty-First Dimmitt and Castro County picnic.

The main attraction will be the huge basket dinner under the shade trees of the court house at noon. Coffee, sugar, pickles and ice water will be provided by the picnic committee. This will take the place of a barbecue as the time is too short to make the necessary arrangements.

A rodeo with all the flavor and glory of the old west will add its bit to the entertainment and will feature steer riding, bronc riding, goat riding and Brahma steer riding.

Before a large crowd of base ball fans at the local diamond the Dimmitt ball team displayed a powerful batting attack and brilliant hurling combination to down the crack Vigo-Tulia machine by the one-sided score of 10 to 1. It was a real ball game up to the fifth inning with the score standing exactly as the contest started. So tight was the hurling and defense of both machines the home-ings were only able to get two men on the paths while young Art Webb plus some nice fielding was setting the visitors down just as fast and in the order they appeared at the plate. In the fifth the locals loosed a barrage of base hits which netted three runs. The Vigos saw the bases the first time in the next stanza with the aid of an error and two hits but they were denied the privilege of sinking their spikes into pay soil as Roy-Bell throttled the threat with one pitched ball after relieving Webb.

REPEAL IS SHOWN AS BIG FAILURE

BOOTLEGGING AND CRIME IN STEADY INCREASE RATHER THAN DECREASE

"If on August 24th Texas votes to legalize liquor, and on August 25th each citizen in Texas should begin to drink liquor and drink it daily for five years, Texas Democracy would degenerate into a drunken Mobocracy. Drunkenness and Democracy do not go hand in hand," according to Rev. E. A. Maness, Panhandle District Chairman of the Texas League Against Whiskey, who is leading in a vigorous campaign against repeal in Texas on August 24th.

Mr. Maness says: "The Call of the Hour is a call to vote against repeal because repeal has failed. Three years ago the wets said vote for national repeal, and that national repeal would decrease taxes. But Congress is now voting to raise taxes higher than at any time since the close of the World War.

"The wets said vote for the repeal of the 18th Amendment in order to decrease our national indebtedness. But in three years after national repeal the national debt has been increased to the amount of \$14,000,000,000.

"The wets said vote for repeal and bring about real temperance and decrease drunkenness. But drinking and drunkenness has doubled since we voted to repeal the 18th Amendment.

"The wets said vote for repeal and decrease bootlegging. We voted for repeal all right but the treasury department of the U. S. says that bootlegging has increased. A statement was recently given to the press of the nation that more bootleg liquor is being sold in America at this time than legal liquor. More than half of the liquor being drunk in America today is being illegally sold, according to the report of the Federal Government. Just to the extent that a state licenses the sale of liquor it increases bootlegging, because where liquor is legally sold it is well nigh impossible to catch and convict a bootlegger for selling it.

"The wets said vote for repeal and save the boys and girls from drink. But in place of saving our boys and girls from drink, repeal has made bar tenders and bar maids out of them. Half of the wine, and beer and liquor that is being sold in America today, it is said, is being sold by boys and girls between the ages of 14 and

STRONG SPRINGLAKE TEAM WILL INVADE DIMMITT SUNDAY FOR BALL GAME

21. Under the regime of repeal, liquor taverns are becoming more damning in their environment than the old time saloon bar.

"Do not be misled by the pleas of the wets, like that made by C. L. Wakefield, chairman of the Dallas county repeal forces, in the Dallas News of Sunday, July 21. He says: 'Revenue to be gained from the millions of dollars worth of liquor now being sold in the state would enable us to have our tax burdens eased.' National repeal has not eased anybody's tax burden. Any man or woman who is bootlegging liquor in Texas today, will bootleg it after election.

"If Texas votes for repeal and raises \$10,000,000 as a liquor tax, it will then take \$20,000,000 in taxes to enforce the new liquor laws and pay for the added increase in the crime bill of the state, and for the accidental loss of life and property. Repeal means to increase taxes in place of decreasing them. An illustration of this is seen in the states of New York and Kansas. New York collects more liquor tax than any state in the nation and yet it has at this time a \$90,000,000 deficit. Kansas, a dry state, the driest in the union, has balanced its state budget and lowered its taxes.

"Vote against repeal, for repeal has failed to decrease automobile accidents. 5,000 more people are now killed annually in automobile accidents than when we had the 18th Amendment," said Maness.

WTCC TO FAVOR 2 AMENDMENTS

WEST TEXAS BODY FAVORS TEXT BOOK AND FEE SYSTEM AMENDMENTS

In a letter from the West Texas Chamber of Commerce, that body goes on record as favoring two of the proposed amendments, opposed to one and disinterested in four which will be voted upon in the coming election, Saturday, August 24.

The WTCC vigorously endorses the Free Textbook Amendment, S. J. R. No. 24: stating this amendment abolishes a provision in the constitution which ever since 1891 has required our public school funds to be distributed on a scholastic population basis. The scholastic population method of distributing school funds has severely penalized West Texas. Our native white population is 16 per cent greater than the rest of the state, and having but little negro and Mexican population our scholastic population is proportionately less and our enrollment and average daily attendance is proportionately greater than the rest of the state.

A complete analysis shows that West Texas has around 29 per cent of the scholastic population of the state, while West Texas has from 32 to 35 per cent of the school enrollment and average daily school attendance of the state. The proposed amendment makes possible the allotment of school funds on a daily attendance basis instead of the discriminatory scholastic population basis. This change has been recommended by the State Department of Education and by the State Board of Education and the report of 1932 states as follows: "The basic law should be so amended as to provide for the distribution of state school funds on basis of enrollment and average daily attendance; that is on basis of service actually rendered by the schools. The state should no longer subsidize absence from school. Its resources should not be used to the extent of millions of dollars annually to reward non-performance of duty."

If the funds were allotted on an enrollment and daily attendance basis West Texas would secure from 3 to 6 per cent more money than we have been securing for over forty years. On the basis of a thirty million dollar available school fund this means that the West Texas schools would secure from \$900,000 to over \$1,500,000 per year more than she has been securing. WALLACE HEARD BY HUGE CROWD

MANY CASTRO CITIZENS ATTEND SECRETARY WALLACE'S SPEAKING

A large group of Castro County farmers and other interested citizens headed by County Agricultural Agent E. W. Thomas made the trip to Amarillo Monday of this week and heard Secretary of Agriculture Henry A. Wallace offer a plea for an equal set of rules for agriculture and industry alike—guaranteeing the farmer equal economic security, before more than 4,000 men and women from over the southwest seeking direct information from the cabinet member as to what the future holds in store.

The Secretary was greatly in sympathy with the farmers and compared the AAA and its farm processing tax to the tariff which protects American industry. He flayed opponents of the triple-A program, declaring: "There is a certain amount of squalling—and it sounds like a stuck pig—over the alleged centralization of power by the administration in putting into effect the farm policy. But this same type of power was used to build up industry, the source of the present howl. "The farmers should have just as many rights and just as much power."

The cabinet member paid tribute to Congressman Mavin Jones for the courageous stand taken for the farmers of the southwest.

Secretary Wallace appeared before a luncheon of the county agents at noon outlining two courses available to the farmers:

1. Constitutional revision and amendments to legalize the desired changes in farm marketing and production;
 2. The abolition of tariffs now enjoyed by corporate interests.
- The latter was interpreted as a threat by which industry could be brought into line to grant agriculture the same privileges of market protection.

Adjustment was urged with a balance of outgoing and incoming products. The tendency of farmers to "send off everything and bury the money in the cellar" was discouraged by Wallace in comparing it to a national policy of hoarding gold.

Merging of the agricultural program with that of soil erosion was hinted by Wallace, who declared that grass and farm soil bears the same economic relationship.

"The whole problem concentrates in adjustment," he said. "We have come to the point that we must build our civilization within the limits of the United States. We can't go any farther West. Population has ceased to increase. There are fewer children, less immigration.

"Thus, it is made apparent that prices can't continue to increase as it has for so many decades. We must learn new rules. It is toward that end the AAA is designed."

ment abolishes the fee system in all counties with population of 20,000 or more and enables the commissioners courts in counties of 20,000 or less to abolish the fee system and pay for such services on a salary basis. Long have we opposed the pernicious fee system as one which tends to develop inefficiency, injustice and additional costs to the taxpayers. We believe that this amendment should be supported and adopted.

WHAT HATH GOD—AND THE PIONEERS—WROUGHT?

SHOULD WE WEAKEN THE CONSTITUTION?

Suggestions to change the Constitution, in order to give the Federal Government powers the Supreme Court has decided it does not now possess, should be critically weighed by the American people.

Whether we realize it or not, it is the Constitution which protects the ownership and the sanctity of the home. It is the Constitution which safeguards the independence and rights of the worker. It is the Constitution which maintains the sanctity of contract.

Those who would change the Constitution would do so on the supposition that it is out of date—that it is no longer capable of meeting the problems, the conditions, the issues of the times.

Every time we tamper with the Constitution we weaken it. Under the existing Constitution, a delicate balance of power is maintained between the central government and the 48 state governments.

If we broaden the powers of the Federal Government we shall simply be giving bureaucracy a greater free and unchecked field for action—at the expense of the states, of industry, of workers, of every citizen.

ANOTHER HITLER "PURGE"

European observers who can spare time from the Italian-Ethiopian trouble, are casting cynical glances on Germany these days.

Another Hitler "purge" is underway—bloodless as yet, though many fear blood-letting will start soon.

Objects of persecution are, of course, the Jews. And along with them are the Catholics, clergymen of all denominations, and members of the Stahlheim—the German equivalent of the American Legion.

Stricter censorship prevails in Germany. Individual liberties are further proscribed. Concentration camps are jammed. Hitler's sword again hangs above those Germans who think him less than divine.
